The Corporate Authorities of the City/Village/Town of ______ County, Illinois, hereby ordain as follows:

SECTION 1. PART-TIME POLICE.

- A. <u>Employment</u>. The City/Village/Town of ______ may employ part-time police officers from time to time as they deem necessary.
- C. <u>Hiring Standards</u>. Any person employed as a part-time police officer must meet the following standards:
 - 1. Be of good moral character, of temperate habits, of sound health, and physically and mentally able to perform assigned duties.
 - 2. Be at least twenty-one (21) years of age.
 - 3. Pass a medical examination.
 - 4. Possess a high school diploma or GED certificate.
 - 5. Possess a valid State of Illinois driver's license.
 - 6. Possess no prior felony convictions.
 - 7. Any individual who has served in the U.S. military must have been honorably discharged.
- D. <u>Discipline</u>. Part-time officers shall be under the disciplinary jurisdiction of the chief of police. Part-time police officers serve at the discretion of the City/Village/Town authorities, shall not have any property rights in said employment, and may be removed by the City/Village/Town authorities at any time. Part-time police officers shall comply with all applicable rules and General Orders issued by the Police Department.

SECTION 2. That if any section, paragraph, clause, phrase or part of this ordinance is for any reason held invalid, such decision shall not affect the validity of the remaining provisions of this ordinance, and the application of these provisions to any person or circumstances shall not be affected thereby.

SECTION 3. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed insofar as they conflict herewith.

SECTION 4. That this ordinance shall be in full force and effect from and after its passage as provided by law.
