# **Annual Drug Detection Canine Requalification Instructions**

## **Objectives:**

- Standardize the requalification process for all drug detection canines operating within Illinois.
- Demonstrate the ability of the canine to accurately detect illegal drug odor(s) that the canine is reported to have been taught to detect through training.
- Provide consistency among all testing facilities approved by the Illinois Law Enforcement Training and Standards Board.
- Reduce the likelihood of unlawful search and seizure to innocent motorists and citizens by demonstrating the canine's ability to accurately detect drug odor(s.)
- Successfully complete the annual compliance requalification exam.

# **Instructions to Assessor:**

#### A. Assessor:

- 1. Annual drug canine compliance requalification will only be administered by a State recognized assessor.
- 2. State recognized assessors are those individuals approved through the Illinois Law Enforcement Training and Standards Board.

# B. Testing Area:

- 1. The annual drug detection canine requalification will be conducted in a controlled, indoor, environment with a work area consisting of a minimum of 1,500 square feet, as approved by ILETSB.
- 2. Twenty (20) plastic PVC tube containers will be utilized during the requalification. The initial issued of containers will be provided by ILETSB through the Mobile Training Unit sponsoring the requalification.
- 3. All 20 containers must appear similar, with the exception of a 2-inch strip of similarly colored painter's tape affixed to the lid. In lieu of the tape, the assessor can use a dry erase board marker which can be used to affix the number directly on the lid. In that case, no tape

is required. If tape is used, it will be marked with the numbers 1 to 20 consecutively, but containers can be intermixed at the discretion of the assessor.

- 4. The arrangements of the containers will be configured in the following pattern:
  - o Two (2) single file rows of ten (10) containers each.
  - o Each row must be at least ten (10) feet apart.
  - o A minimum of five (5) feet is required between each container.

# C. Drugs Utilized:

- 1. The drugs utilized during the annual canine requalification will be issued by the Drug Enforcement Administration (DEA), and must be rotated every two years, if available.
- 2. Drug types and quantities will include:
  - o One package (15 grams) DEA issued Heroin
  - o One package (15 grams) DEA issued Cocaine Hydrochloride
  - o One package (15 grams) DEA issued Cannabis (either as a distractor or a test drug)
  - o One package (15 grams) DEA issued Methamphetamine
- 3. The drugs used during the requalification will be sealed.
- 4. The assessor has the option of utilizing a "narc bag" (canvas bag, cloth bag, additional plastic packaging not issued by DEA) at their discretion.

## D. Requalification Parameters:

- 1. The compliance requalification shall consist of 20 container screenings, of which:
  - o Five (5) of the twenty containers will be void of any distractionary/proofing odors and eleven (11) of the twenty containers will contain distractionary/proofing odors
  - o The remaining four (4) containers will house the identified DEA issued drugs.
  - o If Cannabis is not being tested, it will be included as a twelfth (12) distractor.
- 2. Set time for placement of the drugs and distractionary/proofing odors will be a minimum of thirty (30) minutes.
- 3. Distractionary/proofing odors are defined as any object/item other than DEA issued drugs/training aides present during the test; e.g. perishable food items, articles such as leather, plastic, wood, latex, etc.
- 4. The assessor must take formidable measures to prevent odor contamination when setting the drugs and proofing odors.
- 5. Once the drugs and distractionary/proofing odors are set, they are not to be removed from the container until the completion of the requalification.
- 6. If the assessor utilizes canvas/cloth bags or additional plastic packaging not issued by DEA, those similar items should be utilized as distractionary objects.

#### **Instructions to Handler:**

# A. Annual Requalification:

- 1. The team will be allotted fifteen (15) minutes to complete this requalification.
- 2. The canine is required to be on lead during the assessment and must screen all 20 containers within the time frame.
- 3. The handler is required to advise the assessor what command he/she will utilize to direct the canine to perform the sniff. The handler must verbally command the canine to sniff for the illegal drug odors with this command.
- 4. The handler is required to verbally "call" the container number when he or she recognizes a canine alert. The assessor will verbally confirm the legitimacy of the "called" alert by repeating the called number. The handler must provide a final response to the assessor prior to completing the test.
- 5. Handlers of canines that aggressively indicate (scratch and paw) will take reasonable care not to allow their dogs to damage the containers.
- 6. The location of drugs for this assessment shall not be discussed or shared with other handlers.
- 7. Handlers will not write containers numbers on their hands. An index card will be provided prior to the test, if the handler chooses to write down the numbers they shall be written on the card. That card must be relinquished to the assessor prior to leaving the test area.

# B. Scoring and Remediation:

- 1. This requalification must be completed with 100% accuracy as reported to the Assessor with a final response.
- 2. If a canine does not successfully complete the requalification with 100% accuracy, the team will be provided a minimum of 15 minutes to make necessary corrections and retake the requalification on the same day. If the canine fails during the second attempt, a performance plan must be devised.
- 3. A two-week retraining period will be provided before another attempt is allowed. The canine should not be utilized as a basis for probable cause searches during this period.
- 4. Second attempt at requalification (after the two-week retraining) must be scheduled through MTU 10 and in most cases will be conducted at the Macon County K-9 facility.
- 5. After two weeks, if the drug detection canine fails the foregoing process again, the drug detection canine shall be required to attend a minimum 160-hour course that meets ILETSB's minimum requirement for the drug detection canine training program prior to retaking the annual compliance test (Annual Drug Detection Canine Requalification Instructions, 2019).

- 6. At the conclusion of the day's requalification's, all scoring documents will be provided to the ILETSB representative (if one is present) or will be provided via email within the next business day to Cara Dasher at <a href="mailto:cara@letac.org">cara@letac.org</a>.
- 7. ILETSB rules require only one (1) successful annual compliance requalification. Any additional requalification tests performed need not be reported to the Board.
