School Resource Officers who hold the ILETSB SRO Certification must complete the continuing education requirement before submitting the application for renewal. Under this requirement, each SRO must complete at least one update course (3-hour minimum requirement) in the following three areas: Juvenile Law, Officer and Youth Interaction, and Active Threat Response. Also available is the 16-hour ILETSB SRO recertification course that will meet all 3 requirements with this 2-day course.
