### Introduction

This 2021 Body Worn Camera Report contains a summary of departments that submitted body worn camera program reports to the Illinois Law Enforcement Training and Standards Board (ILETSB). Each department overview includes narrative information and data provided by the department. Visual charts identify the ten (10) most frequent charges related to incidents; a single incident may have multiple charges. Departments reporting less than five (5) charges exclude visual charts. ILETSB is the repository for department reports.

One hundred and six (106) law enforcement departments submitted body worn camera program reports for the period of January 1, 2021, to December 31, 2021, up from seventy-nine (79) last year. Categorically, nine (9) campus law enforcement departments, sixteen (16) sheriff's offices, and eighty (81) municipal law enforcement departments submitted reports.

Three (3) law enforcement departments utilize body worn cameras but had zero (0) recordings for the period of January 1, 2021, to December 31, 2021. Therefore, this report excludes these departments:

- Illinois Central College Campus Police Department
- Peoria Police Department
- Swansea Police Department

## **Executive Summary**

#### **Technical Issues**


Common technical issues include low battery life, cameras not charging, difficulty uploading footage, and cameras falling off the officer. Departments may list remedies to the issues.

#### **Review Process**

Departments report review policy on body worn camera footage.

#### Incidents

Departments report incidents when prosecutors use body worn camera footage. This section counts and lists incidents and offenses charged. Please note, one (1) incident may contain multiple offenses charged. Between January 1, 2021, and December 31, 2021, one hundred six (106) departments report seventy-two thousand six hundred ten (72,610) incidents leading to eighty-four thousand nine hundred ninety-nine (84,999) offenses charged. Forty-eight percent (48%) of offenses charged were the following ten (10) offenses:

# **Department Overview – Aledo Police Department**

Aledo Police Department began their body worn camera program in 2021, with twelve (12) officers who utilize body worn cameras.

#### **Technical Issues**


Aledo Police Department reports minor issues with a camera malfunctioning and two (2) occasions of the attaching mechanism on the back of the camera being damaged. The cameras have been repaired by the manufacturer.

#### **Review Process**

Aledo Police Department supervisors are authorized to review relevant recordings any time they are investigating alleged misconduct or reports of meritorious conduct, or whenever such recordings would be beneficial in reviewing a member's performance.

#### Incidents

Between January 1, 2021, and December 24, 2021, Aledo Police Department reports seventynine (79) incidents leading to seventy-nine (79) offenses charged. Below is a snapshot of greatest frequency of offenses charged.



# **Department Overview – Aurora Police Department**

Aurora Police Department consists of three hundred ten (310) sworn officers who utilize three hundred ten (310) body worn cameras. The department initiated a soft launch of approximately twenty-five (25) officers in October 2021, and fully implemented the program in January 2022.

#### Technical Issues

Aurora Police Department reports minor issues with a few defective cameras having bad USB ports.


#### **Review Process**

Aurora Police Department utilizes built-in software in Axon's evidence.com, called Axon Performance, to review BWC footage of officers and supervisors, ensuring their proper use and performance. The software is set to automatically select one random video on a monthly basis for each officer in a squad for review. The supervisor one rank above the rank of the officer's video is responsible for these reviews. Any deficiencies in how the camera is utilized, worn, and functions is documented and then an email is directed to the officer or supervisor for correction.

Supervisors do not review recordings to search for violations of policy or law not related to a specific complaint or incident. Supervisors may, per policy, review BWC footage for the following: formal or informal complaint, an encounter could result in a complaint, use of force encounters, as corroboration of evidence of misconduct, or to correct substandard performance or highlight commendatory performance.

#### Incidents

Between October 12, 2021, and December 31, 2021, Aurora Police Department reports nine hundred ninety-six (996) incidents leading to one hundred seven (107) offenses charged. Below is a snapshot of greatest frequency of offenses charged.



# **Department Overview – Bartonville Police Department**

Bartonville Police Department consists of fifteen (15) sworn officers who utilize eight (8) body worn cameras. The Detective, SRO, and CIERT/ILEAS officer each have an additional camera, for a total of eleven (11) Watchguard body cameras.

#### **Technical Issues**


Bartonville Police Department reports issues with four (4) body worn cameras malfunctioning, which were replaced with refurbished units. The department was able to download all video from the impacted cameras prior to them being sent in for replacement.

#### **Review Process**

Bartonville Police Department's review process consists of all use of force incidents being reviewed by the Chief of Police. Every sixty (60) days the Detective reviews at least one (1) taped event from each officer. The reviews ensure that the cameras are being used properly, any malfunctioning of equipment is addressed, and any feedback can be given to each officer.

#### Incidents

Between January 10, 2021, and December 20, 2021, Bartonville Police Department reports forty-nine (49) incidents leading to forty-nine (49) offenses charged. Below is a snapshot of greatest frequency of offenses charged.



## **Department Overview – Batavia Police Department**

Batavia Police Department utilizes forty-one (41) body worn cameras. The department activated and deployed its body worn camera program on May 10, 2021.

#### **Technical Issues**


Batavia Police Department reports zero (0) technical issues.

#### Review Process

Batavia Police Department supervisors are authorized to review relevant body camera recordings at any time, to include: when they are investigating misconduct or reports of meritorious conduct, or whenever such recordings would be beneficial in reviewing an officer's performance. Monthly, supervisors randomly review ten (10) recordings pertaining to their area of responsibility to ensure that the equipment is operating properly and that officers are using the cameras appropriately and in accordance with policy and training.

#### Incidents

Between May 10, 2021, and December 28, 2021, Batavia Police Department reports three hundred sixty-eight (368) incidents leading to one thousand thirty-three (1,033) offenses charged. Below is a snapshot of greatest frequency of offenses charged.



# **Department Overview – Bedford Park Police Department**

Bedford Park Police Department consists of thirty-seven (37) sworn officers who utilize thirty-four (34) body worn cameras. All thirty-four (34) of the body worn cameras were issued to Lieutenants, Sergeants, the Investigations Division, and the Patrol Division.

#### Technical Issues


Bedford Park Police Department reports minor technical issues, including cameras randomly turning off and battery longevity issues.

#### **Review Process**

Bedford Park Police Department's Deputy Chief and a sergeant randomly select a video each month from each police officer to review. The video is reviewed to ensure that each officer is following the Bedford Park Police Department body worn camera policy. Each month, the sergeant forwards their review to the Chief of Police and Deputy Chief for further review.

#### Incidents

Between January 8, 2021, and December 27, 2021, Bedford Park Police Department reports seventy-eight (78) incidents leading to eighty-four (84) offenses charged. Below is a snapshot of greatest frequency of offenses charged.



# **Department Overview - Belvidere Police Department**

Belvidere Police Department utilizes forty-three (43) body worn cameras.

#### **Technical Issues**


Belvidere Police Department reports zero (0) technical issues.

#### Review Process

Belvidere Police Department supervisors and administrators utilize the body worn cameras in accordance with the laws of the State of Illinois. They are used as evidence in criminal cases, and the videos are not reviewed for discipline purposes unless citizen complaints are filed.

#### Incidents

Between January 1, 2021, and December 21, 2021, Belvidere Police Department reports one hundred seventy-five (175) incidents leading to four hundred thirty-four (434) offenses charged. Below is a snapshot of greatest frequency of offenses charged.



# **Department Overview – Bloomington Police Department**

Bloomington Police Department utilizes one hundred fifteen (115) body worn cameras, used by all sworn personnel when required.

#### **Technical Issues**


Bloomington Police Department reports issues with uploading and their CAD integration tool.

#### **Review Process**

Bloomington Police Department supervisors review footage on an as-needed basis, including calls for service, complaints, or other relevant issues. Supervisors also review a minimum of two random videos per officer per month.

#### Incidents

Between January 1, 2021, and December 31, 2021, Bloomington Police Department reports one thousand four hundred nineteen (1,419) incidents leading to three thousand four hundred thirty-eight (3,438) offenses charged. Below is a snapshot of greatest frequency of offenses charged.



# **Department Overview – Bond County Sheriff's Office**

Bond County Sheriff's Office consists of fourteen (14) officers who utilize fourteen (14) body worn cameras. The sheriff's office began utilizing body worn cameras that were obtained through the grant program in June of 2021.

#### Technical Issues


Bond County Sheriff's Office reports zero (0) technical issues.

#### **Review Process**

Bond County Sheriff's Office's report does not include a formal review process.

#### Incidents

Between August 1, 2021, and December 12, 2021, Bond County Sheriff's Office reports twenty-four (24) incidents leading to twenty-four (24) offenses charged. Below is a snapshot of greatest frequency of offenses charged.



# **Department Overview – Bourbonnais Police Department**

Bourbonnais Police Department consists of twenty-six officers (26) who utilize twenty-four (24) body worn cameras. The department consists of one (1) chief, one (1) deputy chief, one (1) patrol commander, six (6) sergeants, two (2) detectives, one (1) school resource officer, one (1) special agent, and thirteen (13) patrol officers. All officers wear a body camera during their regular shift and any overtime details; detectives wear body cameras when taking statements or meeting with victims, witnesses, and suspects.

#### Technical Issues


Bourbonnais Police Department reports user error, battery, clip, and syncing issues.

#### **Review Process**

Bourbonnais Police Department shift supervisors and administrators have the right to review body camera videos any time they are investigating alleged misconduct or reports of meritorious conduct, or whenever such recordings would be beneficial in reviewing an officer's performance or training exercise.

#### Incidents

Between January 1, 2021, and December 30, 2021, Bourbonnais Police Department reports two hundred thirty-three (233) incidents leading to two hundred eighty-six (286) offenses charged. Below is a snapshot of greatest frequency of offenses charged.



# **Department Overview – Broadview Police Department**

Broadview Police Department implemented its body worn camera program August 1, 2016. The Department has thirty-one (31) body worn cameras utilized by twenty-three (23) of the twenty-seven (27) sworn officers (the Chief, Deputy Chief, and two (2) Lieutenants are exempt).

#### **Technical Issues**

Broadview Police Department reports an issue with continuous low battery alerts that require the units to be shipped out for repair and reprogramming.


#### **Review Process**

Broadview Police Department supervisors review body worn camera footage of each officer at least once every sixty (60) day period and log this review in a database. The Deputy Chief verifies the body worn camera review is completed every sixty (60) days.

Supervisors review footage for quality control measures. Footage may be used for discipline only if a citizen formally or informally files a complaint, an officer uses force during an incident, an incident may result in formal investigation under the Uniform Peace Officers' Disciplinary Act, or as corroboration of other misconduct.

#### Incidents

Between January 3, 2021, and December 31, 2021, Broadview Police Department reports six-hundred eighty-one (681) incidents leading to one thousand eighty-five (1,085) offenses charged. Below is a snapshot of greatest frequency of offenses charged.



# **Department Overview - Brookfield Police Department**

Brookfield Police Department has thirty-one (31) sworn officers who utilize body worn cameras.

#### Technical Issues


Brookfield Police Department reports issues with pairing docks, charging and syncing cable failure due to wear and tear, video import issues, footage sharing limitations, and officers misclassifying footage.

#### **Review Process**

Brookfield Police Department supervisors randomly review body worn camera footage for quality, and after use of force incidents. Additionally, supervisors review footage of officers before writing reports, to ensure policy and compliance, after complaints, for FOIA requests, and to ensure that department members use body worn cameras consistent with department directives.

#### Incidents

Between November 9, 2021, and December 31, 2021, Brookfield Police Department reports eighteen (18) incidents leading to nineteen (19) offenses charged. Below is a snapshot of greatest frequency of offenses charged.



# **Department Overview – Bunker Hill Police Department**

Bunker Hill Police Department's report does not provide department or body worn camera information.

### **Technical Issues**


Bunker Hill Police Department reports zero (0) technical issues.

#### **Review Process**

Bunker Hill Police Department's report does not include a formal review process.

#### Incidents

Between June 1, 2021, and December 31, 2021, Bunker Hill Police Department reports thirty-four (34) incidents leading to thirty-one (31) offenses charged. Below is a snapshot of greatest frequency of offenses charged.



# **Department Overview - Champaign County Sheriff's Office**

Champaign County Sheriff's Office consists of fifty-six (56) sworn deputies who utilize fifty-six (56) Axon Body 3 body worn cameras.

#### **Technical Issues**


Champaign County Sheriff's Office reports zero (0) technical issues.

#### **Review Process**

Champaign County Sheriff's Office Patrol Division Lieutenant, the Investigations Division Lieutenant, and the Administrative Support Lieutenant view at least four (4) videos, one (1) from each shift, and review them from a management standpoint of quality control. If an issue is discovered, the Captain of the Law Enforcement Division is to be contacted and a determination will be made for the best course of action to remedy the problem. Each week, the Shift Supervisors choose at least six (6) videos from their shift and review the videos from a supervisory standpoint for quality control. If an issue is discovered, which cannot be addressed at their level, they are advised to contact the patrol Division Lieutenant to determine the best course of action to remedy the problem.

#### Incidents

Between March 3, 2021, and December 30, 2021, Champaign County Sheriff's Office reports two thousand twenty-nine (2,029) incidents leading to three thousand eight hundred sixty-six (3,866) offenses charged. Below is a snapshot of greatest frequency of offenses charged.



# **Department Overview – Champaign Police Department**

Champaign Police Department consists of one hundred twenty-four (124) officers who utilize body worn cameras. In July 2017, the City of Champaign Police Department completed its full implementation of body worn cameras to all sworn law enforcement officers in every division of the department. The Champaign Police Department continued with its fully implemented deployment of Panasonic Arbitrator Mark 3 body worn cameras throughout 2021.

#### **Technical Issues**

Champaign Police Department reports several issues for body worn cameras:

- Officers misclassify footage;
- SD card errors;
- Failure to operate;
- · Camera recording failure;
- · Camera synchronization failure;
- Charging/syncing cable failure due to normal wear and tear. Department replaces these at a rate of two (2) to three (3) a month;
- Video import issues; most are resolved in-house while remaining are resolved with the assistance of the manufacturer;
- Camera mount failure;
- Footage sharing limitations. State's Attorney's Office unable to access shared folder; department provides videos on discs and portable hard drives to ensure the State's Attorney's Office receives copies of the videos.

### **Review Process**

Champaign Police Department supervisors:


- Randomly view footage for quality;
- Review use of force incidents above normal handcuffing;
- Review footage officers flag and note footage reviewed before writing report;
- Randomly review footage to ensure policy compliance;
- Review footage before debriefings;
- Review footage of complaints; and
- Review footage for FOIA requests.

# **Department Overview - Champaign Police Department, Continued**

Deputy Chief reviews accidental footage to maintain officer's privacy. City of Champaign Legal Department, Champaign County State's Attorney's Office, and defense attorneys review footage for legal proceedings. The video program manager (City of Champaign Police Department Lieutenant) reviews random videos on a consistent basis to ensure compliance with the Department's policy and procedures, as well as state law. The City of Champaign Police Department's Administration and Professional Standards Division reviews videos related to allegations of misconduct. Beginning May 2019, the City of Champaign Human Relations Commission Citizen Review Subcommittee began reviewing videos related to citizen complaints involving a formal complaint investigation.

#### Incidents

Between January 1, 2021, and December 10, 2021, Champaign Police Department reports three hundred (300) incidents leading to four hundred forty-nine (449) offenses charged. Below is a snapshot of greatest frequency of offenses charged.



# **Department Overview - Channahon Police Department**

Channahon Police Department's report does not provide department or body worn camera information.

### **Technical Issues**


Channahon Police Department reports zero (0) technical issues.



# **Department Overview – Chenoa Police Department**

Chenoa Police Department consists of ten (10) officers, four (4) full-time and six (6) part-time, who utilize seven (7) Vievu LE-5 body worn cameras.

#### **Technical Issues**


Chenoa Police Department reports malfunctions during upload of video, water damage, and low battery life issues.

#### **Review Process**

Chenoa Police Department reviews all use of force incidents and most felony and DUI arrests, as well as performing periodic random reviews to assess policy and procedure compliance in the use of body worn cameras.

#### Incidents

Between January 2, 2021, and December 22, 2021, Chenoa Police Department reports one hundred forty-five (145) incidents leading to one hundred forty-five (145) offenses charged. Below is a snapshot of greatest frequency of offenses charged.



# **Department Overview – Chicago Police Department**

Chicago Police Department is the largest municipal police agency in Illinois with approximately eleven thousand five hundred (11,500) sworn officers. The Chicago Police Department is divided into two (2) offices: the Office of Operations and the Office of Constitutional Policing and Reform. The Chicago Police Department has prioritized body worn camera deployment in the Office of Operations Patrol Districts and Units within the Special Operations Group. Chicago Police Department purchased 1,800 additional pool cameras to be assigned to officers and detectives during deployments, special events, and temporary field duty.

The Chicago Police Department consists of twenty-two (22) patrol districts, as well as Area Community Safety Teams. These districts and teams are staffed by approximately seven thousand five hundred (7,500) sworn officers; all of the officers are equipped with body worn cameras. There are another approximate eight hundred (800) body worn cameras assigned to the Mass Transit Unit, SWAT, Traffic, Detail Unit, Fugitive Apprehension, and Investigative Response teams. As of April 30, 2022, approximately ten thousand (10,000) body worn cameras are utilized by the Chicago Police Department.

#### **Technical Issues**

Chicago Police Department reports that 2020/2021 upgrades to a newer model of cameras offered by their body worn camera vendor has resulted in no major technical issues.

#### Review Process

Chicago Police Department supervisors ensure:


- Department members use body worn cameras consistent with Chicago Police Department directives;
- A report is entered in a Chicago Police Department application whenever any member is unable to use the body worn camera or download digitally recorded data due to technical problems. This application is monitored twenty-four (24) hours and seven (7) days a week by trained field technicians who respond to repair or replace any defective equipment;
- An investigation is initiated when notified of a missing, lost, or damaged body worn camera;
- The distribution, charging, and uploading of the body worn cameras are consistent with Chicago Police Department directives;
- Officers who reviewed a body worn camera recording prior to writing an arrest report document this fact in the narrative portion of the arrest report prior to submitting the report for approval;
- The Watch Operations Lieutenant reviews at least one (1) random recording per watch to ensure Chicago Police Department policy is properly adhered to;
- For use of force incidents, all pertinent body worn camera videos are reviewed by the Watch Operations Lieutenant and separately by the Force Review Unit.

# **Department Overview - Chicago Police Department, Continued**

District commanders/unit commanding officers, or their designee, receive weekly reports
on officer body worn camera usage and the number of unmatched videos to ensure
compliance with Chicago Police Department policy.

#### Incidents

Between January 1, 2021, and December 31, 2021, Chicago Police Department reports twenty-nine thousand nine hundred ninety-nine (29,999) incidents leading to thirty-one thousand one hundred thirty-six (31,136) offenses charged. Below is a snapshot of greatest frequency of offenses charged.



# **Department Overview - Christian County Sheriff's Office**

Supervisors may review footage to discipline an employee when:


- A citizen files a formal or informal complaint of misconduct;
- The encounter in the footage could result in a formal investigation under the Uniform Peace Officer's Act;
- A use of force incident occurs; or
- As corroboration or other evidence of misconduct.

Supervisors shall not use footage for performance evaluations, but for the purpose of correcting substandard employee performance or highlighting commendatory performance of an employee.

Supervisors do not review recordings to search for violations of policy or law not related to a specific complaint or incident.



# **Department Overview – Springfield Police Department**

Springfield Police Department consists of two hundred fourteen (214) sworn officers who utilize one hundred sixty-seven (167) Axon Body cameras. The majority of the cameras are assigned to the Operations (Street) Division, with several of those cameras being assigned to the Criminal Investigations Division's (CID) Street Crimes Unit and Emergency Response team members who may be currently assigned to the CID.

#### **Technical Issues**



# **Department Overview - Sycamore Police Department**

Sycamore Police Department consists of thirty-one (31) officers who utilize twenty (20) WatchGuard Vista Wi-Fi cameras.

#### **Technical Issues**


Sycamore Police Department reports issues with battery life, a broken LCD screen, transfer agent application failure on desktop, and a camera not staying on/issues with docking.







# **Department Overview – West Chicago Police Department**



# **Department Overview – West Dundee Police Department**



Recordings are reviewed when: a formal or informal complaint of misconduct has been made, the encounter on the recording could result in a formal investigation under the Uniform Peace Officer's Act, a use of force incident occurred, and/or as corroboration or other evidence of misconduct.

#### Incidents

Between January 1, 2021, and December 31, 2021, West Dundee Police Department reports one thousand three hundred eighteen (1,318) incidents leading to one thousand three hundred eighteen (1,318) offenses charged. Below is a snapshot of greatest frequency of offenses charged.



# **Department Overview – Wheaton Police Department**

Wheaton Police Department consists of sixty-nine (69) sworn police officers who utilize sixty-nine (69) body worn cameras.

#### Technical Issues



Every twenty-eight (28) day deployment period, supervisors will randomly review one (1) body worn camera recording from each officer pertaining to the supervisor's direct area of responsibility to ensure that the equipment is operating properly and that officers are using the cameras appropriately and in accordance with policy and training.

Between July 4, 2021, and September 13, 2021, Wheaton Police Department reports eleven (11) incidents leading to thirty (30) offenses charged. Below is a snapshot of greatest frequency of offenses charged.



# **Department Overview – Willow Springs Police Department**

Willow Springs Police Department consists of nine (9) full-time police officers and twelve (12) part-time police officers who utilize utilizes eleven (11) Axon Body 3 cameras.

# Department Overview - Winnebago County Sheriff's Office

A total of ninety-six (96) deputies and supervisors are currently assigned body worn cameras, and one hundred nine (109) are assigned to the corrections officers and supervisors. Additionally, members of the Uniform Services Bureau, and Administration and TAC Unit, are assigned body worn cameras.

#### Technical Issues



#### **Technical Issues**


