## Introduction

This 2022 Body Worn Camera Report contains a summary of departments that submitted body worn camera program reports to the Illinois Law Enforcement Training and Standards Board (ILETSB). Each department overview includes narrative information and data provided by the department. Visual charts identify the ten (10) most frequent charges related to incidents; a single incident may have multiple charges. Departments reporting less than five (5) charges exclude visual charts. ILETSB is the repository for department reports.

One hundred seventeen (117) law enforcement departments submitted body worn camera program reports for the period of January 1, 2022, to December 31, 2022, up from one hundred six (106) last year. Categorically, seven (7) campus law enforcement departments, fourteen (14) sheriff's offices, and ninety-six (96) municipal law enforcement departments submitted reports.

It is important to note: due to a change in the underlying statute, some towns no longer need to provide incident reports. Additionally, a small number of towns submitted reports in a format that was ultimately unrecognizable by the compilation system. For these reasons, exclusion from this report is not itself indicative of non-compliance. Seven (7) law enforcement departments submitted non-standard reports with respect to requirements for the period of January 1, 2022, to December 31, 2022. Therefore, this report excludes these departments:

#### **Technical Issues**


Common technical issues include low battery life, cameras not charging, difficulty uploading footage, and cameras falling off the officer. Departments may list remedies to the issues.

#### **Review Process**

Departments report review policy on body worn camera footage.

#### Incidents

Departments report incidents when prosecutors use body worn camera footage. This section counts and lists incidents and offenses charged. Please note, one (1) incident may contain multiple offenses charged. Between January 1, 2022, and December 31, 2022, one hundred four (104) departments report seventy-six thousand five hundred fifty-one (76,551) incidents leading to eighty-nine thousand nine hundred fifty-five (89,955) offenses charged. Fifty percent (50%) of offenses charged were the following ten (10) offenses:



# **Department Overview - Aledo Police Department**



#### Incidents

Between January 1, 2022, and December 31, 2022, Aledo Police Department reports fifty-seven (57) incidents leading to seventy-three (73) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



# **Department Overview – Antioch Police Department**

Antioch Police Department consists of thirty-one (31) officers who utilize thirty-one (31) body worn cameras.

#### Technical Issues

Antioch Police Department reports several minor issues, including: syncing to the in-car system, charging issues, software issues, and hardware issues.

#### **Review Process**

Antioch Police Department supervisors review all videos related to use of force and vehicle pursuits, reports of alleged misconduct, performance review, and training. Supervisors are authorized to review relevant recordings any time they are investigating alleged misconduct or reports of meritorious conduct or whenever such recordings would be beneficial in reviewing a member's performance. Shift sergeants shall ensure that officers are using body worn camera equipment appropriately and in compliance with policy. Supervisors are required to periodically review a sample of body worn camera recordings made by each of their subordinate officers to verify compliance with policy and identify any potential training needs.

#### Incidents

Antioch Police Department's report does not include incidents data.

## **Department Overview – Aurora Police Department**

Aurora Police Department consists of three hundred twenty (320) sworn officers who utilize three hundred twenty (320) body worn cameras. The department initiated a soft launch of approximately twenty-five (25) officers in October 2021, and fully implemented the program in January 2022.

#### **Technical Issues**

The Aurora Police Department experienced very few technical issues, with the main technical issue for 2022 being intermittent issues with Redaction Studio.

#### **Review Process**


The Aurora Police Department utilizes built-in software in Axon's evidence.com, called Axon Performance, to review body worn camera footage of officers and supervisors, ensuring their proper use and performance. The software is set to automatically (monthly) select one random video for each officer in a squad for review. The supervisor one rank above the rank of the officer creating the video is responsible for these reviews. Any deficiencies in how the camera is utilized, worn, and functions is documented and then an email is directed to the officer or supervisor for correction.

Supervisors do not review recordings to search for violations of policy or law not related to a specific complaint or incident. Supervisors may, per policy, review BWC footage for the following: formal or informal complaint, or encounter could result in a complaint, use of force encounters, as corroboration of evidence of misconduct, or viewed to correct substandard performance or highlight commendatory performance.

#### Incidents

Between January 1, 2022, and December 31, 2022, Aurora Police Department reports three-thousand four hundred thirty-seven (3,437) incidents leading to three-thousand four hundred thirty-seven (3,437) offenses charged. # **Department Overview – Bartonville Police Department**

Bartonville Police Department consists of fifteen (15) sworn officers who utilize eight (8) body worn cameras. The detective, SRO, and CIERT/ILEAS officer each have an additional camera, for a total of eleven (11) WatchGuard body worn cameras.

#### **Technical Issues**

Bartonville Police Department reports issues with eight (8) body worn cameras malfunctioning due to battery and locking clips issues; installing new batteries and clips solved the issues. One (1) camera stopped recording, but there was no data loss.

#### **Review Process**

Bartonville Police Department's review process consists of all use of force incidents being reviewed by the chief of police. Every sixty (60) days the detective officer reviews at least one (1) taped event from each officer. The reviews ensure that the cameras are being used properly, any malfunctioning of equipment is addressed, and any feedback can be given to each officer.

#### **Incidents**

Between January 1, 2022, and December 31, 2022, Bartonville Police Department reports sixty-six (66) incidents leading to sixty-eight (68) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.

## **Department Overview – Batavia Police Department**

Batavia Police Department utilizes forty-one (41) body worn cameras. The department activated and deployed its body worn camera program on May 10, 2021. Getac was selected as the camera vendor and model BC-2 is the camera used by all officers during this annual report cycle.

## **Technical Issues**


Batavia Police Department reports zero (0) technical issues. There were a few occasions where there were issues with the camera charging stations not connecting with the server which caused delays in charging and in uploads of videos. No loss of data was reported.

#### **Review Process**

Batavia Police Department supervisors are authorized to review relevant body worn camera recordings at any time, to include: when they are investigating misconduct or reports of meritorious conduct, or whenever such recordings would be beneficial in reviewing an officer's performance. Monthly, supervisors randomly review ten (10) recordings pertaining to their area of responsibility to ensure that the equipment is operating properly and that officers are using the cameras appropriately and in accordance with policy and training.

#### **Incidents**

Between January 1, 2022, and December 31, 2022, Batavia Police Department reports one thousand thirty-six (1,036) incidents leading to one thousand forty-one (1,041) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



# **Department Overview – Bedford Park Police Department**

Bedford Park Police Department consists of thirty-seven (37) sworn officers who utilize thirty-five (35) body worn cameras. All thirty-five (35) of the body worn cameras were issued to lieutenants, sergeants, the investigations division, and the patrol division.

#### **Technical Issues**


Bedford Park Police Department reports minor technical issues, including some of the body worn cameras creating multiple videos on calls, and battery life not lasting throughout the 12-hour shift.

#### **Review Process**

Bedford Park Police Department's Deputy Chief and a sergeant are responsible for the body worn camera review process. Each month, the number of videos created for each police officer is entered into Frontline Quality Assurance Evaluation. Frontline shuffles the videos, randomly selects a video, and then a sergeant views the video in its entirety, to ensure that each officer is following the Bedford Park Police Department Body Worn Camera Policy. The reviewing sergeant then submits each monthly review to the chief of police and deputy chief. The deputy chief then enters the monthly videos into Frontline, and reviews a video that is selected by Frontline, to complete the review process.

#### Incidents

Between January 1, 2022, and December 31, 2022, Bedford Park Police Department reports sixty-five (65) incidents leading to sixty-seven (67) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



# **Department Overview – Bellwood Police Department**

Bellwood Police Department consists of ten (10) supervisors, four (4) detectives, and twenty-eight (28) patrol officers who utilize forty-three (43) body worn cameras.

#### **Technical Issues**


Bellwood Police Department reports zero (0) technical issues.

#### **Review Process**

Bellwood Police Department's report does not include a formal review process.

#### **Incidents**

Between January 1, 2022, and December 31, 2022, Bellwood Police Department reports one hundred sixty-two (162) incidents leading to two hundred thirty-nine (239) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



# **Department Overview – Belvidere Police Department**

Belvidere Police Department utilizes forty-three (43) body worn cameras.

#### **Technical Issues**


Belvidere Police Department reports zero (0) technical issues.

#### **Review Process**

Belvidere Police Department supervisors and administrators utilize the body worn cameras in accordance with the laws of the State of Illinois. They are used as evidence in criminal cases, and the videos are not reviewed for discipline purposes unless citizen complaints are filed.

#### Incidents

Between January 1, 2022, and December 31, 2022, Belvidere Police Department reports three hundred fifty-seven (357) incidents leading to six hundred eighty-nine (689) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



# **Department Overview – Bensenville Police Department**

Bensenville Police Department utilizes forty-one (41) body worn cameras, used by thirty-six (36) full-time officers and four (4) part-time officers. Two (2) body worn cameras remain unassigned to be utilized as a spare if a camera malfunctions or has technical difficulties.

#### **Technical Issues**

Bensenville Police Department reports twenty-three (23) technical issues. Of those issues, five (5) body worn cameras were replaced to resolve the problems. Most of the issues stemmed from faulty batteries. These battery issues were caused by a "bloating" or enlargement of the middle of batteries causing the body worn camera to either go into a "system recovery mode," which can cause issues with recording an event, or simply fail to secure to the officer's mount.


#### **Review Process**

On a monthly basis, supervisors review an event captured by their officer's body worn camera. This audit is to ensure that the body worn camera is operating properly and that officers are using the camera appropriately and in accordance with policy and training. The supervisor completes the Bensenville Police Department BWC Supervisor Monthly Audit form and reviews it with their officer. Those audits are then turned into the Body Worn Camera Administrator for review.

#### Incidents

Between January 1, 2022, and December 31, 2022, Bensenville Police Department reports three hundred forty-one (341) incidents leading to five hundred seventy-six (576) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.





# **Department Overview – Bloomington Police Department**

Bloomington Police Department utilizes one hundred fifteen (115) body worn cameras, used by all sworn personnel when required.

#### **Technical Issues**


Bloomington Police Department reports issues with uploading and their CAD integration tool.

#### **Review Process**

Bloomington Police Department supervisors review footage on an as-needed basis, including calls for service, complaints, or other relevant issues. Supervisors also review a minimum of two (2) random videos per officer per month.

#### Incidents

Between January 1, 2022, and December 31, 2022, Bloomington Police Department reports one thousand six hundred twenty-eight (1,628) incidents leading to three thousand four hundred thirty-nine (3,439) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



# **Department Overview - Bond County Sheriff's Office**

Bond County Sheriff's Office's report does not provide department or body worn camera information.

#### **Technical Issues**


Bond County Sheriff's Office reports zero (0) technical issues.

#### **Review Process**

Bond County Sheriff's Office's report does not include a formal review process.

#### **Incidents**

Between January 1, 2022, and December 31, 2022, Bond County Sheriff's Office reports fifty (50) incidents leading to fifty (50) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



## **Department Overview – Bourbonnais Police Department**

The Bourbonnais Police Department consists of twenty-seven (27) sworn officers who utilize twenty-four (24) Getac body worn cameras. All officers assigned to patrol wear a body worn camera during their regular shift and any overtime details. Detectives wear body worn cameras when taking statements or meeting with victims, witnesses, and/or suspects. The SRO is issued their own body worn camera to always keep and use during certain encounters while in the schools as deemed necessary.

#### **Technical Issues**


Officers experienced low battery alerts before the end of their shift, which has been resolved by internal programming and USB charging cords in the squads as well as the ability to swap out for a fully charged camera during the shift. Other minor issues encountered were videos uploading issues and the body worn camera not synching to in-car cameras.

#### **Review Process**

Supervisors randomly review body worn camera videos of officers on their shifts to document training issues and policy compliance that should be addressed at their level. Administrators have the right to review body worn camera videos any time they are investigating alleged misconduct, reports of meritorious conduct or whenever such recordings would be beneficial in reviewing an officer's performance or a training exercise.

#### Incidents

Between January 1, 2022, and December 31, 2022, Bourbonnais Police Department one hundred sixty-three (163) incidents leading to one hundred sixty-three (163) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.

#### **Technical Issues**


Bradley Police Department reports zero (0) technical issues.

#### **Technical Issues**


Broadview Police Department reports zero (0) technical issues.

Broadview Police Department's report does not include a formal review process.

Between January 1, 2022, and December 31, 2022, Broadview Police Department reports two hundred thirty-one (231) incidents leading to two hundred forty-three (243) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



# **Department Overview – Burr Ridge Police Department**

Burr Ridge Police Department consists of twenty-seven (27) officers who utilize twenty-seven (27) body worn cameras. The department began using body worn cameras in August 2022.

#### Technical Issues

Officers reported an issue with the camera batteries running out well before the end of their 12-hour shift. The video resolution was lowered from 1440p to 720p, which helped extend the battery life. A charging cable was added to each squad car to allow for mobile charging, when needed. Two (2) officers each reported one occurrence where their body-worn camera spontaneously shut down and rebooted during a recording. The cameras were docked to download the latest firmware update, and the issue has not recurred in either camera.

#### **Review Process**

Per General Order 4.14, monthly documented review of video data for every employee shall be conducted to assist in periodic assessment of performance and to determine whether the equipment is being properly used. This review will be completed by the patrol sergeant for each watch and shall include at least two separate instances per employee.

#### Incidents

Burr Ridge Police Department's report does not include incident data.

# **Department Overview – Champaign County Sheriff's Office**

Champaign County Sheriff's Office consists of fifty-six (56) sworn deputies who utilize fifty-six (56) Axon Body 3 body worn cameras.

#### **Technical Issues**


Champaign County Sheriff's Office reports zero (0) technical issues.

#### **Review Process**

Champaign County Sheriff's Office Patrol Division Lieutenant, the Investigations Division Lieutenant, and the Administrative Support Lieutenant view at least four (4) videos, one (1) from each shift, and review them from a management standpoint of quality control. If an issue is discovered, the captain of the law enforcement division is to be contacted and a determination will be made for the best course of action to remedy the problem. Each week, the shift supervisors choose at least six (6) videos from their shift and review the videos from a supervisory standpoint for quality control. If an issue is discovered, which cannot be addressed at their level, they are advised to contact the patrol division lieutenant to determine the best course of action to remedy the problem.

#### **Incidents**

Between January 1, 2022, and December 31, 2022, Champaign County Sheriff's Office reports seventy-six (76) incidents leading to one hundred thirty-six (136) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



# **Department Overview – Champaign Police Department**

Champaign Police Department consists of one hundred twenty-six (126) officers who utilize body worn cameras. In July 2017, the City of Champaign Police Department completed its full implementation of body worn cameras to all sworn law enforcement officers in every division of the department. The Champaign Police Department continued with its fully implemented deployment of Panasonic Arbitrator Mark 3 body worn cameras throughout 2021.

#### Technical Issues

Champaign Police Department reports several issues for body worn cameras:

- Officers misclassify footage
- SD card errors
- Failure to operate
- Camera recording failure
- Camera synchronization failure
- Charging/syncing cable failure due to normal wear and tear. Department replaces these at a rate of two (2) to three (3) a month
- Video import issues: most are resolved in-house while remaining are resolved with the assistance of the manufacturer
- Camera mount failure
- Footage sharing limitations. State's Attorney's Office unable to access shared folder; department provides videos on discs and portable hard drives to ensure the State's Attorney's Office receives copies of the videos.

#### **Review Process**


Champaign Police Department supervisors randomly view footage for quality and to ensure policy compliance. Reviews are also conducted for use of force incidents above normal handcuffing, when officers flag and note footage reviewed before submitting a report, before debriefings, and for FOIA requests.

The Deputy Chief reviews accidental footage to maintain officer's privacy; City of Champaign Legal Department, Champaign County State's Attorney's Office, and defense attorneys review footage for legal proceedings. The video program manager (City of Champaign Police Department Lieutenant) reviews random videos on a consistent basis to ensure compliance with the Department's policy and procedures, as well as state law. The City of Champaign Police Department's Administration and Professional Standards Division reviews videos related to allegations of misconduct. Beginning May 2019, the City of Champaign Human Relations Commission Citizen Review Subcommittee began reviewing videos related to citizen complaints involving a formal complaint investigation.

# **Department Overview – Champaign Police Department, Continued**

#### **Incidents**

Between January 1, 2022, and December 31, 2022, Champaign Police Department reports two hundred ninety-three (293) incidents leading to four hundred sixty-seven (467) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



# **Department Overview - Chenoa Police Department**

Chenoa Police Department consists of seven (7) officers, four (4) full-time and three (3) part-time, who utilize seven (7) AXON Body-3 body worn cameras.

#### **Technical Issues**


Chenoa Police Department reports that while using VIEVU LE-5 cameras, several devices were experiencing short battery life, including one (1) device that locked up completely and could not be reset. In June of 2022, Chenoa Police Department switched to AXON cameras and have not experienced any technical or equipment issues at this time.

#### **Review Process**

Chenoa Police Department reviews all use of force incidents and most felony and DUI arrests, as well as performing periodic random reviews to assess policy and procedure compliance in the use of body worn cameras.

#### **Incidents**

Between January 1, 2022, and December 31, 2022, Chenoa Police Department reports one hundred fifty-two (152) incidents leading to one hundred sixty-one (161) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



# **Department Overview – Chicago Police Department**

Chicago Police Department is the largest municipal police agency in Illinois with approximately eleven thousand five hundred (11,500) sworn officers. The Chicago Police Department is divided into two (2) offices: the Office of Operations and the Office of Constitutional Policing and Reform. The Chicago Police Department has prioritized officer worn camera deployment in the Office of Operations Patrol Districts and Units within the Special Operations Group. Chicago Police Department maintains a pool of 1,800 additional cameras to be assigned to sworn officers during deployments, special events, and temporary field duty.

The Chicago Police Department consists of twenty-two (22) patrol districts, as well as Area Community Safety Teams. These districts and teams are staffed by approximately seven thousand five hundred (7,500) sworn officers; all of the officers are equipped with body worn cameras. There are another approximately eight hundred (800) body worn cameras assigned to the Mass Transit Unit, SWAT, Traffic, Detail Unit, Fugitive Apprehension, and Investigative Response teams. As of May 1, 2023, approximately ten thousand (10,000) body worn cameras are utilized by the Chicago Police Department.

#### **Technical Issues**

Chicago Police Department reports that there have been no major technical issues with their cameras and are currently in the process of replacing their older cameras with new cameras of the same model

#### **Review Process**


Chicago Police Department supervisors ensure:

- Department members use body worn cameras consistent with Chicago Police Department directives.
- A report is entered in a Chicago Police Department application whenever any member is unable to use the body worn camera or download digitally recorded data due to technical problems. This application is monitored by trained field technicians who respond to repair or replace any defective equipment; there are also a small number of cameras at each location that can be assigned to an officer on a temporary basis.
- An investigation is initiated when notified of a missing, lost, or damaged body worn camera.
- The distribution, charging, and uploading of the body worn cameras are consistent with Chicago Police Department directives.
- Officers who reviewed a body worn camera recording prior to writing an arrest report document the review in the report before submitting it.
- The Watch Operations Lieutenant reviews at least one (1) random recording per watch to ensure Chicago Police Department policy is properly adhered to;
- For use of force incidents, all pertinent body worn camera videos are reviewed by the Watch Operations Lieutenant.
- District commanders/unit commanding officers, or their designee, receive weekly reports
  on officer body worn camera usage and the number of unmatched videos to ensure
  compliance with Chicago Police Department policy.

Between January 1, 2022, and December 31, 2022, Chicago Police Department reports thirty-two thousand fifty-seven (32,057) incidents leading to thirty-two thousand seven hundred fifty-three (32,753) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



Labeling, redacting, and duplicating of any recordings shall only be done by the support services manager, operations deputy chief, support services deputy chief, and chief of police. Recorded files may be viewed: upon approval by a supervisor as part of an official investigation, pursuant to a lawful process, by media personnel, in compliance with public records request, by the recording officer's field training officer for training purposes, and/or by any detective or investigator involved in the investigation of a matter.

#### Incidents

Des Plaines Police Department's report does not include incidents data.

## **Department Overview – Downers Grove Police Department**

Downers Grove Police Department consists of seventy-one (71) sworn officers who utilize seventy-seven (77) body worn cameras.

#### Technical Issues

owners Grove Police Department reports that there were eight (8) reported technical issues with their body worn cameras. The primary issue was cameras turning off on their own. Other issues include a camera not connecting to the vehicle, audio issues on playback, and a camera recording while docked.

#### **Review Process**

Downers Grove Police Department's report includes a body worn camera review process as follows:

- Department members utilize the officer worn body camera consistent with police department directives.
- Recordings are assigned in Evidence.com to the member who created the recordings.
- A civilian staff member is assigned to monitor and review all the digital files within Evidence.com to ensure they are properly identified and categorized. When a digital file is not in compliance, the officer and their supervisor are made aware of the situation so that it can be remedied.
- An investigation is initiated when a staff member determines that an officer worn body worn camera is missing, lost, or damaged.
- The distribution, charging, and uploading of the officer worn body cameras and their digital files are consistent with police department directives.
- Officers who reviewed an officer worn body camera recording prior to writing a report document this information in the narrative portion of the police report.
- Quarterly, supervisors review both officer worn body camera and in-car camera recordings, if applicable. Supervisors review four (4) incidents per officer per quarter. If an officer is assigned a squad car equipped with an in-car camera, the reviews shall include two (2) officer worn body camera recordings and two (2) in-car camera recordings. If an officer is not assigned a squad car equipped with an in-car camera, the review shall be of four (4) officer worn body camera recordings. The reviews are performed to ensure officers utilize the body worn cameras in compliance with police department policy and procedures. This review process is documented on a standardized form and saved for future reference.

#### Incidents

Downers Grove Police Department's report does not include incidents data.

## **Department Overview – DuPage County Sheriff's Office**



After the review, the supervisor can add comments or click several pre-determined responses such as no issues/concerns observed, late activation, poor video/poor sound, or unsatisfactory behavior. The deputy then gets an email response with the results of the review. Each team supervisor is required at minimum to review four (4) videos from their team per month.

#### **Incidents**

Between January 1, 2022, and December 31, 2022, DuPage County Sheriff's Office reports eight hundred nine (809) incidents leading to nine hundred fifty-one (951) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



# **Department Overview – East Moline Police Department**

Between January 1, 2022, and December 31, 2022, Loyola University Chicago Department of Campus Safety reports two (2) incidents leading to two (2) offenses charged, which include one (1) Driving Under the Influence and one (1) Assault offense.

# **Department Overview - Manteno Police Department**

# **Department Overview – Mundelein Police Department**

Mundelein Police Department consists of fifty-five (55) police officers and three (3) community service officers who utilize body worn cameras.

#### Technical Issues

Mundelein Police Department reports minor issues with battery replacements, one (1) camera not charging, and one (1) camera with stuck buttons. Replacements were made under warranty through the manufacturer.

#### **Review Process**


Mundelein Police Department supervisors ensure officers utilize body worn cameras in accordance with policy and training. In cases where footage has the propensity to generate community interest, the supervisors review footage in their investigative scope, conduct further investigation they deem appropriate, and forward the information via the chain of command. Supervisors randomly review and document at least one (1) body worn camera recording quarterly for each officer they supervise to ensure equipment operates. In use of force incidents, the employee's direct supervisor will review body worn camera recordings.

Recordings are not used to prepare performance evaluations unless used for commending exemplary performance or correcting substandard performance. Supervisors review footage to determine possible disciplinary action when: a citizen files a complaint of misconduct; an officer uses unauthorized or incorrect use of force; the encounter may result in a formal investigation under the Uniform Peace Officer's Act; or for corroboration of misconduct.

#### Incidents

Between January 1, 2022, and December 31, 2022, Mundelein Police Department reports two hundred thirty-three (233) leading to seven hundred sixty-four (764) offenses charged. On the following page is a snapshot of the greatest frequency of offenses charged.



# **Department Overview – New Lenox Police Department**

New Lenox Police Department consists of thirty-seven (37) officers who utilize thirty-seven (37) body worn cameras.

#### **Technical Issues**

New Lenox Police Department reports user errors, as well as wear and tear issues.

#### **Review Process**

New Lenox Police Department shift supervisors and administrators have the right to review body worn camera videos any time they are investigating alleged misconduct, reports of meritorious conduct, or whenever such recordings would be beneficial in reviewing an officer's performance or training exercise. Shift supervisors conduct daily random spot checks of officer's recordings.

#### Incidents

Between January 1, 2022, and December 31, 2022, New Lenox Police Department reports seventy-eight (78) incidents leading to eighty-seven (87) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



#### **Technical Issues**



# **Department Overview – Park Forest Police Department**

Park Forest Police Department consists of forty-four (44) sworn officers who utilize twenty-nine (29) body worn cameras. Body worn cameras are assigned permanently to six (6) detectives, four (4) members of administration, and to the one (1) K-9 officer, while sixteen (16) are assigned at the beginning of the shift to each officer of the patrol division.

#### **Technical Issues**

Park Forest Police Department reports thirty-five (35) incidents of body worn camera malfunction, mainly consisting of clip and slider top breaking, and issues with recording audio and video uploading. There were nine (9) replacement cameras.


#### **Review Process**

# **Department Overview – Park Ridge Police Department**

#### **Technical Issues**


Park Ridge Police Department reports zero (0) technical issues.

#### **Review Process**

Park Ridge Police Department supervisors randomly review ten (10) recordings each month pertaining to their area of responsibility to ensure that the equipment is operating properly and that officers are using the cameras appropriately and in accordance with department policy and training. Supervisors document their review using the Body Worn Camera Supervisor Review Form, which is forwarded to the body worn camera coordinator through the chain of command.

#### Incidents

Between January 3, 2022, and December 31, 2022, Park Ridge Police Department reports two hundred ninety-four (294) incidents leading to three hundred twenty-four (324) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



# **Department Overview - Parkland College Police Department**

Parkland College Police Department consists of thirteen (13) sworn officers who utilize thirteen (13) body worn cameras. There are fifteen (15) total WatchGuard VISTA body worn cameras owned by the department.

#### **Technical Issues**

Parkland College Police Department reports technical issues with the body worn camera activating unprompted, battery failure, and multiple instances of booting/syncing problems. These issues were addressed through replacement by the manufacturer.

#### **Review Process**

Parkland College Police Department supervisors randomly review officer footage once per quarter to ensure that the equipment is operating properly, and the devices are being used appropriately and to identify additional training or guidance needed. If a complaint is lodged against an officer where a body worn camera exists, a supervisor will immediately ensure the recording is secure. The recording is copied and given to the chief for review.

#### Incidents

Between January 1, 2022, and September 31, 2022, Parkland College Police Department reports five (5) incidents leading to five (5) offenses charged.

# **Department Overview - Pekin Police Department**

Pekin Police Department consists of fifty-five (55) sworn officers, with an additional two (2) full-time code enforcement officers, who utilize forty-one (41) body worn cameras. The departmental body worn camera policy requires all uniformed officers to utilize body worn cameras, while detectives and administration are not currently required to utilize cameras.

#### **Technical Issues**


Pekin Police Department reports an issue with one (1) broken screen on a body worn camera which was replaced through the manufacturer.

#### **Review Process**

Pekin Police Department shift commanders, or their designee, will review a sampling of recordings monthly for each officer assigned to their shift to ensure that the equipment is operating properly and that officers are using the cameras appropriately and in accordance with policy and training. Supervisors shall document their review in the Guardian Tracking Program under officer statistics. The responsibility for this task falls upon the shift commander to make sure it is being completed each month and entered into Guardian Tracking.

#### **Incidents**

Between January 1, 2022, and December 31, 2022, Pekin Police Department reports eighty-seven (87) incidents leading to eighty-nine (89) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



# **Department Overview - Pittsfield Police Department**

Pittsfield Police Department consists of thirteen (13) officers, including both full-time and parttime, who utilize nine (9) body worn cameras. The departmental body worn camera policy requires all uniformed officers to utilize body worn cameras; detectives and administration are not currently required to utilize cameras.

#### **Technical Issues**

Pittsfield Police Department reports issues with camera batteries not lasting a full shift, no technical support, and repair facility provided by the manufacturer of the camera. They also reported lack of storage for the large amounts of footage.

#### **Review Process**

Pittsfield Police Department's Chief of Police frequently reviews body worn camera footage at random to monitor the progress of new officers, after a complaint is made against an officer, and during other criminal investigations.

#### Incidents

Between January 1, 2022, and December 31, 2022, Pittsfield Police Department reports seventeen (17) incidents leading to seventeen (17) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.

# **Department Overview – Quincy Police Department**

Quincy Police Department employs sixty-four (64) sworn law enforcement and one (1) civilian animal control officer. Sworn personnel consists of one (1) chief, two (2) deputy chiefs, four (4) lieutenants, ten (10) sergeants, and forty-seven (47) officers. At any given time, approximately thirty-six (36) officers are assigned to the patrol division as either a patrol officer, K-9 officer or housing officer. The Quincy Police Department leases fifty-nine (59) Motorola Moto G7 body worn camera systems. Every uniformed patrol officer and patrol sergeant is issued their own body worn camera that they are responsible for maintaining. The administrative services lieutenant and the animal control officer are also issued a body worn camera. The department has five (5) cameras that are kept on hand in case an officer's issued camera is not able to be used, or an officer did not assign a body worn camera, such as a detective or lieutenant, would need to use a body worn camera for any reason.

#### **Technical Issues**

Quincy Police Department reports minor technical issues with videos not uploading or swollen batteries. These issues have been addressed by contacting the manufacturer for assistance or camera replacement. No loss of footage has been reported.


#### **Review Process**

Quincy Police Department supervisors are allowed to view media specifically brought to their attention where there is a citizen complaint, a review of tactics, an ongoing investigation, reported technical issues, for report writing purposes, reported or suspected misconduct, reported or suspected policy/procedure violations, internal affairs investigations, etc. Supervisors are prohibited from reviewing body worn camera footage randomly for the sole purpose of locating infractions of policy/procedure to take disciplinary action against an officer.

#### Incidents

# **Department Overview – Rock Island County Sheriff's Office**

Rock Island County Sheriff's Office consists of sixty-five (65) sworn deputies who utilize sixty-seven (67) body worn cameras. Two (2) extra cameras are used as spares in the event of a camera malfunction.

#### **Technical Issues**


Rock Island County Sheriff's Office reports two (2) technical issues: a camera that showed an internal error and a camera with distorted audio. Both cameras were replaced with spare cameras and the inoperable cameras were sent to the vendor for repair.

#### **Review Process**

Rock Island County Sheriff's Office supervisors randomly review body worn camera footage of deputies on their shift, as well as anytime there is a use of force incident, squad car accident, pursuit, or an internal/external complaint.

#### **Incidents**

Between January 1, 2022, and December 31, 2022, Rock Island County Sheriff's Office reports one hundred sixty-seven (167) incidents leading to one hundred sixty-seven (167) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



# **Department Overview – Rock Island Police Department**

Rock Island Police Department consists of one hundred eight (108) employees, with eighty-one (81) sworn positions and twenty-seven (27) civilian positions. The department has seventy-five (75) Axon Body III cameras in use, with fifty-two (52) being used by members assigned to the patrol division, three (3) used by the administrative division, six (6) used by technical services division, and fourteen (14) used by the criminal investigations division. In addition, seventeen (17) Axon Flex II are used by the emergency response team. The department began their body worn camera program in April 2017.

#### **Technical Issues**



# **Department Overview – Rockford Police Department**

Rockford Police Department consists of two hundred seventy (270) sworn officers who utilize three hundred twenty (320) Axon Body 3 cameras. The department issues body worn cameras to every sworn officer of the department for use.

#### **Technical Issues**

Rockford Police Department reports sixteen (16) body worn camera hardware failures. These devices were returned to Axon for repair and officers were issued replacement body worn cameras from the inventory.

#### **Review Process**

Rockford Police Department Patrol Sergeant shall review two (2) body worn camera recordings per month from each officer under their direct supervision, with the purpose of assessing officer performance, identifying material that may be appropriate for training, etc. Lieutenants also conduct one (1) body worn camera digital recording review per month from patrol sergeant under their direct supervision.

#### Incidents

Rockford Police Department's report does not include incidents data.

# **Department Overview – Roselle Police Department**

Roselle Police Department consists of thirty-two (32) sworn officers, including one (1) chief, two (2) deputy chiefs, four (4) sergeants, twenty (20) patrol officers, two (2) detectives, and two (2) school resource officers, as well as four (4) community service officers, who utilize body worn cameras.

#### **Technical Issues**



Between January 1, 2022, and December 31, 2022, Roselle Police Department reports forty-one (41) incidents leading to ninety-nine (99) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



# **Department Overview - Round Lake Beach Police Department**

Round Lake Beach Police Department consists of forty (40) sworn officers who utilize twenty-eight (28) body worn cameras.

#### **Technical Issues**

Round Lake Beach Police Department reports seven (7) issues with the body worn cameras consisting of powering up issues, error 37 code, and/or a defective screen. Malfunctioning cameras were replaced by Motorola.

#### **Review Process**

Round Lake Beach Police Department commanders and deputy chiefs may review footage at any time; review is required by the commander and deputy chief of operations for use of force incidents reported by the shift supervisor.

#### **Incidents**

Round Lake Beach Police Department's report does not include incidents data.

# **Department Overview – Rushville Police Department**

Rushville Police Department consists of five (5) full-time officers and five (5) part-time officers who utilize eight (8) body worn cameras. Each full-time officer has a camera assigned to them, and when a part-time officer works, they utilize the two (2) cameras reserved for them.

#### **Technical Issues**



Citizen complaints and major violations of policy are referred to the chief deputy.

### Incidents

Between January 1, 2022, and December 31, 2022, Sangamon County Sheriff's Office reports zero (0) incidents.

# **Department Overview – Spring Grove Police Department**

Spring Grove Police Department utilizes ten (10) body worn cameras for full-time and part-time officers. Full-time officers have their own cameras, while part-time officers share cameras.


















Zion Police Department reports one (1) technical issue with camera video not downloading, which was resolved by the manufacturer with no data loss.
