## Introduction

---

This 2024 Body Worn Camera Report contains a summary of departments that submitted body worn camera program reports to the Illinois Law Enforcement Training and Standards Board (ILETSB). Each department overview includes narrative information and data provided by the department. Visual charts identify the ten (10) most frequent charges related to incidents; a single incident may have multiple charges. Departments reporting less than five (5) charges exclude visual charts. ILETSB is the repository for department reports.

Two hundred fifty-nine (259) law enforcement departments submitted the Body Worn Camera Program reports for the period of January 1, 2024, to December 31, 2024, up from one hundred eighty (180) last year. Categorically, Illinois Department of Revenue, two (2) forest preserve district, seventeen (17) campus law enforcement departments, thirty-five (35) sheriff's offices, and two hundred four (204) municipal law enforcement departments submitted reports.

Two (2) law enforcement departments implemented the Body Worn Camera Program in the year 2024. Therefore, this report excludes these following departments:

- Oakton College Police Department
- Rolling Meadows Police Department

## Executive Summary

---

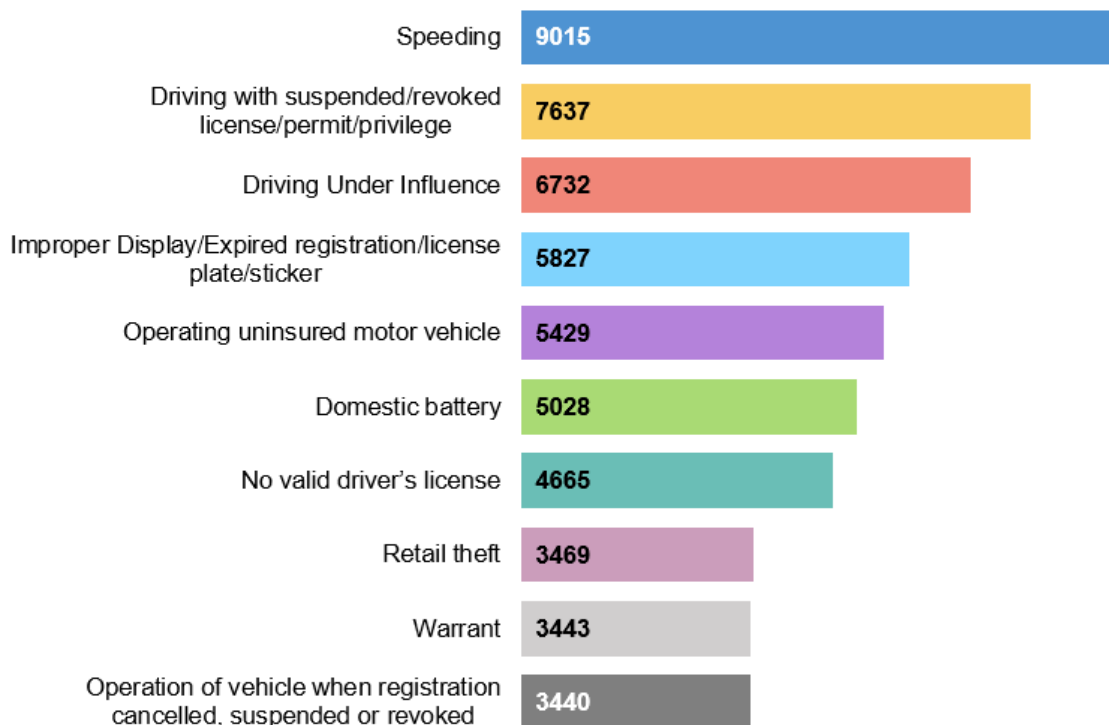
Section 10-25 of the Illinois Law Enforcement Officer-Worn Body Camera Act requires all law enforcement agencies utilizing body worn cameras are required to submit annual reports. Departments must provide a brief overview of their agency, including the number of officers in the department, the number of body worn cameras in use, and the number of officers who use those cameras. Agencies must also report any technical issues with the equipment and how those issues were remedied, a brief description of the review process used by supervisors within the law enforcement agency, and any other information relevant to the administration of the program. 50 ICLS 706/10-25.

Common technical issues include low battery life, cameras not charging, difficulty uploading footage. Departments may list remedies for the issues. Departments report their review policies on body worn camera footage. Some agencies periodically review recorded footage for equipment performance analysis and others incorporate these recordings into officer evaluations.

Agencies that receive ILETSB Camera Grant Funds must also report all incidents in which camera recordings were used in the prosecution of an offense. 50 ICLS 707/20.

When applicable, this comprehensive report counts and lists incidents and offenses charged as reflected into the agency submissions. Please note, one (1) incident may contain multiple offenses charged. Between January 1, 2024, and December 31, 2024, one hundred sixty-two (162) departments reported seventy-seven thousand one hundred thirteen (77,113) incidents leading to one hundred one thousand eight hundred six (101,806) offenses charged. Fifty-four percent (54%) of the offenses charged were the following ten (10) offenses:

## Department Overview – Addison Police Department

---

Addison Police Department consists of sixty-seven (67) officers who utilize sixty-seven (67) Axon body worn cameras.

### Technical Issues

Addison Police Department reports that the body worn cameras with issues were replaced by Axon. The department does not provide specific details of the issues.

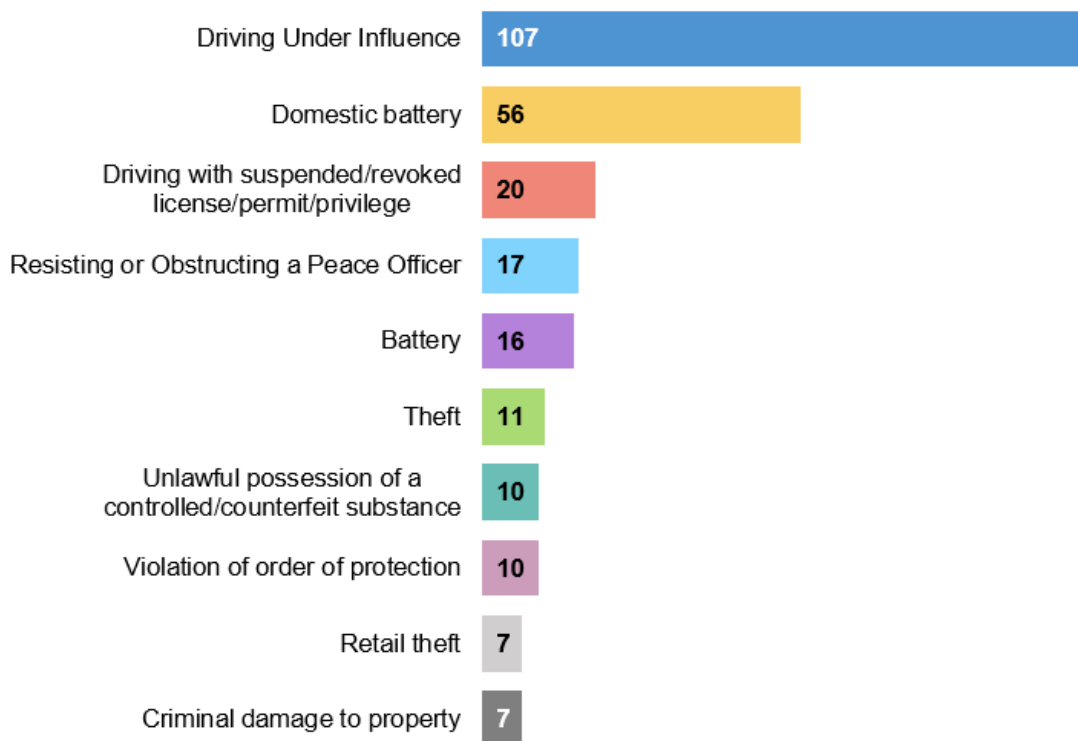
### Review Process

Addison Police Department's every sergeant conduct, at a minimum, one (1) documented review of the body worn camera for each officer under his/her command at least twice a year and record their observations using the body-camera software. If additional action is taken, the supervisor makes the appropriate notification through the chain of command. The review of an incident is added to the officer's evaluation/training file for his/her annual evaluation.

### Incidents

Between July 1, 2024, and December 31, 2024, Addison Police Department reports two hundred seventy-eight (278) incidents leading to three hundred seventy-eight (378) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.

## Department Overview – Aledo Police Department

---

Aledo Police Department consists of seven (7) full-time officers, one (1) part-time officer and one (1) auxiliary officer who utilize Axon Body 4 body worn cameras.

### Technical Issues

Aledo Police Department reports zero (0) technical issues.

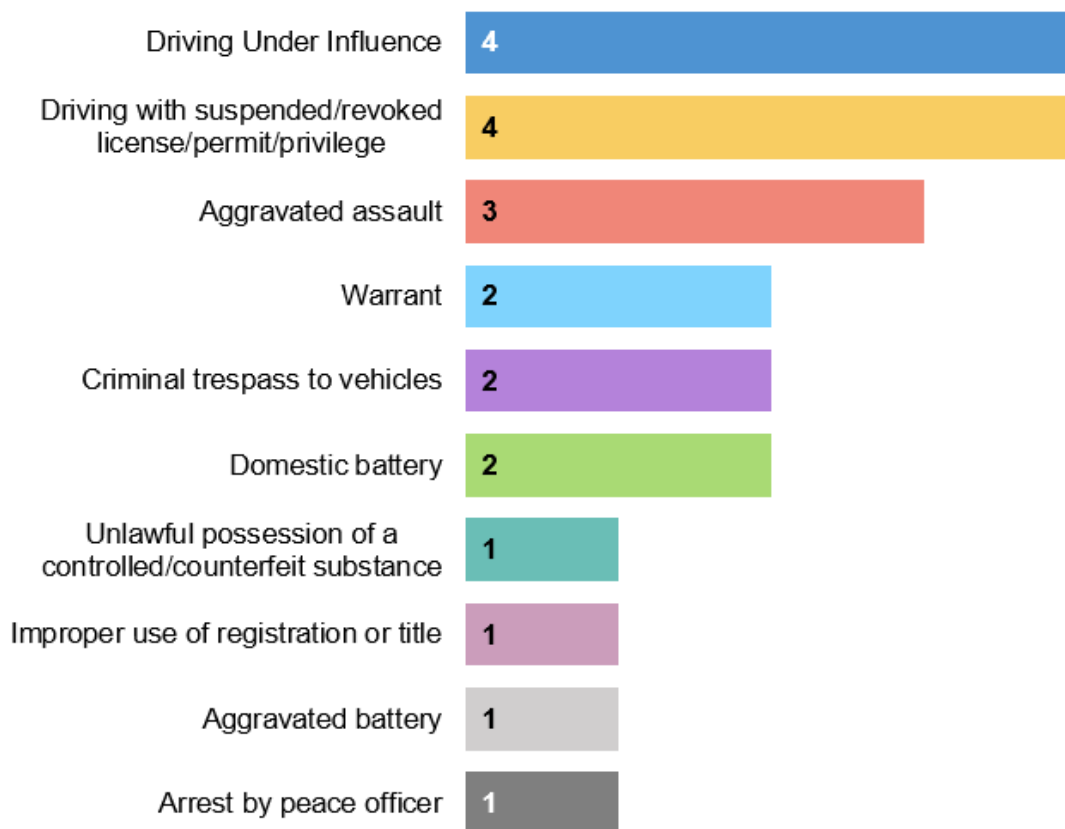
### Review Process

Aledo Police Department's supervisors are authorized to review relevant recordings any time they are investigating alleged misconduct or reports of meritorious conduct, or whenever such recordings would be beneficial in reviewing a member's performance.

### Incidents

Between January 1, 2024, and December 31, 2024, Aledo Police Department reports twenty-five (25) incidents leading to twenty-five (25) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.

## Department Overview – Algonquin Police Department

---

Algonquin Police Department consists of fifty-three (53) officers who utilize fifty-three (53) body worn cameras. There are three (3) additional body worn cameras which are unassigned. The department implemented Body Worn Camera Program on December 3, 2024.

### **Technical Issues**

Algonquin Police Department reports zero (0) technical issues.

### **Review Process**

Algonquin Police Department's supervisors are authorized to review relevant recordings any time they are investigating alleged misconduct or reports of meritorious conduct or whenever such recordings would be beneficial in reviewing a member's performance. The supervisor of the recording member document in the report or other documentation, if the supervisor or the recording member reviewed body worn camera recordings prior to completing the report or other documentation.

### **Incidents**

Algonquin Police Department's report does not include incidents data.

## Department Overview – Alsip Police Department

---

Alsip Police Department consists of forty-four (44) sworn officers who utilize forty-four (44) Axon Body 3 body worn cameras.

### **Technical Issues**

Alsip Police Department reports minor issues with body worn cameras. The issues encountered were related to firmware updates and battery charging which were quickly resolved by cycling the body worn cameras and returning the body camera docking stations for replacements.

### **Review Process**

Alsip Police Department's supervisors are authorized to review relevant recordings where they are investigating alleged misconduct or reports of meritorious service that would require the review of said footage. Supervisors are required to review at least one (1) body worn camera video from each officer on their shift each month. The reviews are completed to ensure proper functioning of the body worn camera and proper recording per the department's policy.

### **Incidents**

Alsip Police Department's report does not include incidents data.

## Department Overview – Alton Police Department

---

Alton Police Department consists of sixty-two (62) officers who utilize seventy (70) body worn cameras.

### Technical Issues

Alton Police Department reports zero (0) technical issues.

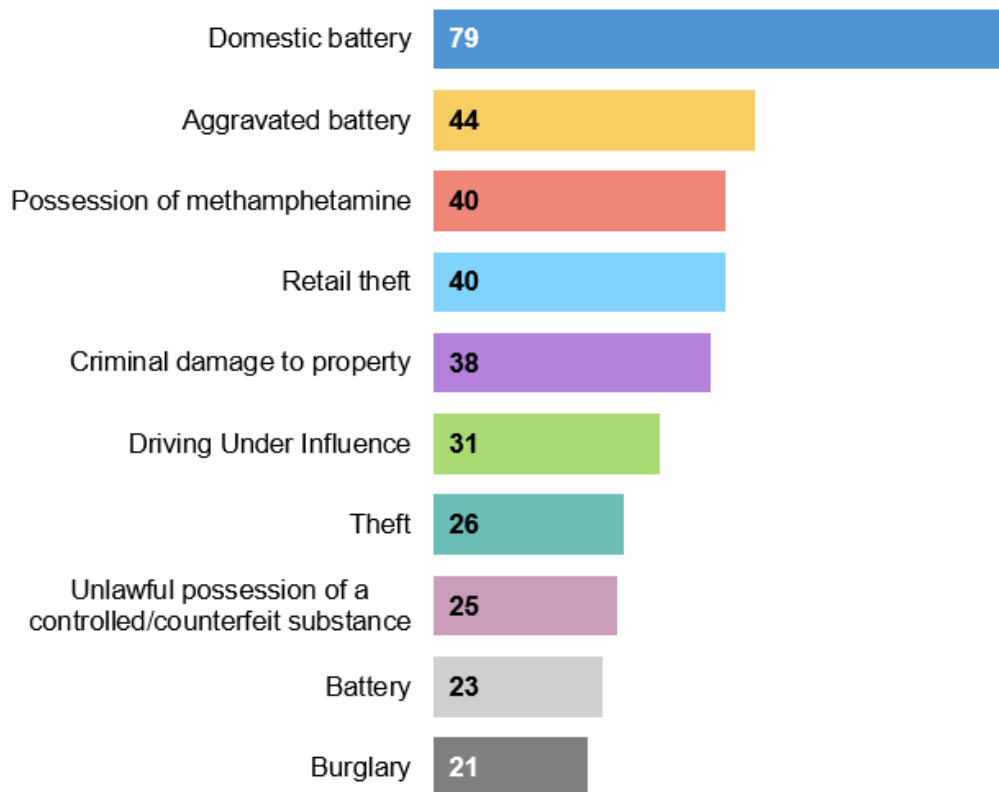
### Review Process

Alton Police Department's supervisors ensure officers equipped with body worn cameras utilize them in accordance with policy and training. Monthly, patrol supervisors randomly review four (4) body worn camera recordings pertaining to subordinates under his/her responsibility. They document their review in a Guardian Tracking entry. Recordings are not reviewed indiscriminately for disciplinary purposes.

### Incidents

Between January 1, 2024, and December 31, 2024, Alton Police Department reports six hundred forty-five (645) incidents leading to six hundred sixty-two (662) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.

## Department Overview – Arcola Police Department

---

Arcola Police Department consists of seven (7) full-time police officers and three (3) part-time police officers who utilize ten (10) Motorola body worn cameras. The department implemented the Body Worn Camera Program on December 27, 2024.

### **Technical Issues**

Arcola Police Department reports minor trouble with the evidence management software of the body worn camera which was resolved by calling Motorola.

### **Review Process**

Arcola Police Department's administration utilizes its own separate logins to the management software. Each officer is only able to see their own body worn camera videos and cannot change, alter, splice, cut, or purge any recordings or footage on their end. Only administrative logins can view all officer's footage and review for complaints, compliance, duplication, export, and make changes to any video footage in compliance with law and policy of this department's policy.

### **Incidents**

Arcola Police Department's report does not include incidents data.

## Department Overview – Athens Police Department

---

Athens Police Department consists of a Chief of Police, one (1) patrol sergeant, three (3) patrol officers, one (1) full-time school resource officer, two (2) part-time school resource officers, and five (5) part-time officers who utilize eight (8) ProVision body worn cameras.

### Technical Issues

Athens Police Department reports several issues with body worn cameras including cameras not activating, corrupted files, and excessive battery drainage. These issues were resolved by working with the manufacturer to restore recordings, constantly replacing batteries, and continually checking cameras.

### Review Process

Athens Police Department's first line supervisors review a taped event of each officer at least once every (60) sixty-day period. Thus, each officer should have at least one review in any given (60) sixty-day period, commencing with the full implementation of the policy. Supervisors use these reviews as a quality control measure. Following such a review, the supervisor holds a meeting with the officer and provides the officer with either positive reinforcement or constructive criticism with respect to the stop reviewed. Constructive criticism may relate to officer safety issues, demeanor, policy issues or legal issues related to the stop as well as any other supervisory observation relative to performance.

### Incidents

Athens Police Department's report does not include incidents data.

## Department Overview – Barrington Hills Police Department

---

Barrington Hills Police Department utilizes nineteen (19) Axon body worn cameras. The department does not provide details of the number of officers.

### Technical Issues

Barrington Hills Police Department reports zero (0) technical issues.

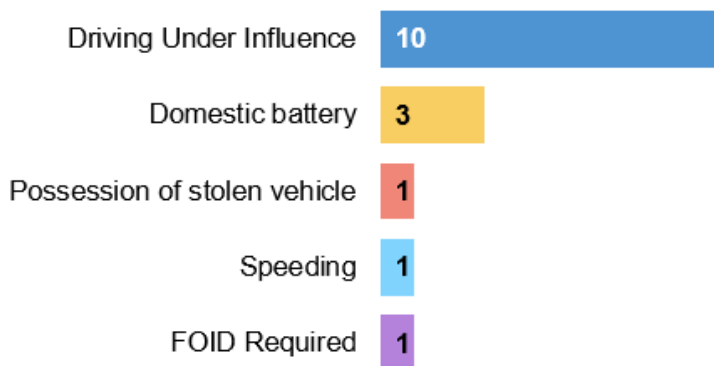
### Review Process

Barrington Hills Police Department's supervisor reviews randomly selected body worn camera videos of each person by the performance module of Evidence.com monthly.

### Incidents

Between January 1, 2024, and December 31, 2024, Barrington Hills Police Department reports sixteen (16) incidents leading to sixteen (16) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.

## Department Overview – Barrington Police Department

---

Barrington Police Department consists of twenty-five (25) sworn officers who utilize twenty-five (25) Motorola body worn cameras. The department maintains two (2) additional body worn cameras as backups.

### Technical Issues

Barrington Police Department reports a few technical issues with the body worn cameras including cameras not turning off, association failure, scratched lens, video displaying pink/green lines in view, charge fault, issues with top button, and syncing issues. These issues were remedied by the body worn cameras being replaced by Motorola, or through firmware updates.

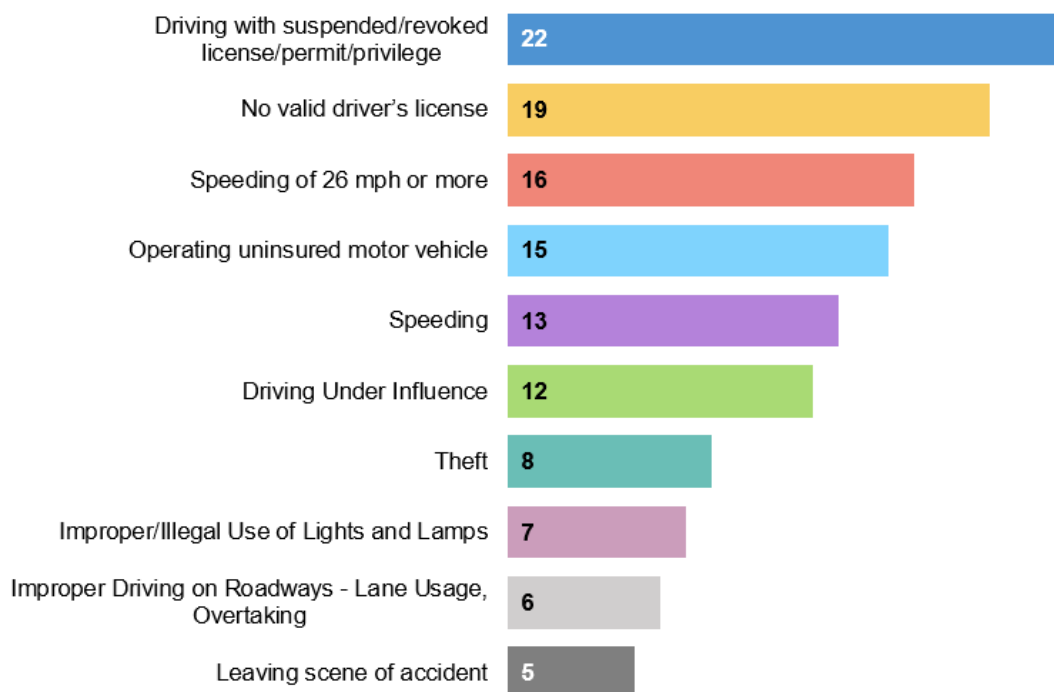
### Review Process

Barrington Police Department's supervisors conduct documented reviews of their subordinate's body worn camera media at least annually to evaluate the member's performance, verify compliance with the department's procedures, and determine the need for additional training. The review includes a variety of event types when possible. Supervisors review body worn camera media that is tagged as a significant event or that the supervisor is aware pertains to a significant event.

### Incidents

Between July 1, 2024, and December 31, 2024, Barrington Police Department reports one hundred two (102) incidents leading to two hundred five (205) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.

## Department Overview – Bartlett Police Department

---

Bartlett Police Department consists of sixty-three (63) sworn officers who utilize an Axon body worn camera each. The department implemented the Body Worn Camera Program in February 2024.

### **Technical Issues**

Bartlett Police Department reports zero (0) technical issues.

### **Review Process**

Bartlett Police Department's body worn camera videos that contain any use of force are reviewed by a sergeant, commander, deputy chief, and chief to ensure adherence to laws and policy. Other videos are reviewed randomly for monthly video checks or when complaints arise.

### **Incidents**

Bartlett Police Department's report does not include incidents data.

## Department Overview – Bartonville Police Department

---

Bartonville Police Department consists of twelve (12) sworn officers (eleven (11) full-time and one (1) part-time) who utilize sixteen (16) Axon body worn cameras.

### Technical Issues

Bartonville Police Department reports one (1) body worn camera malfunction which was taken out of service.

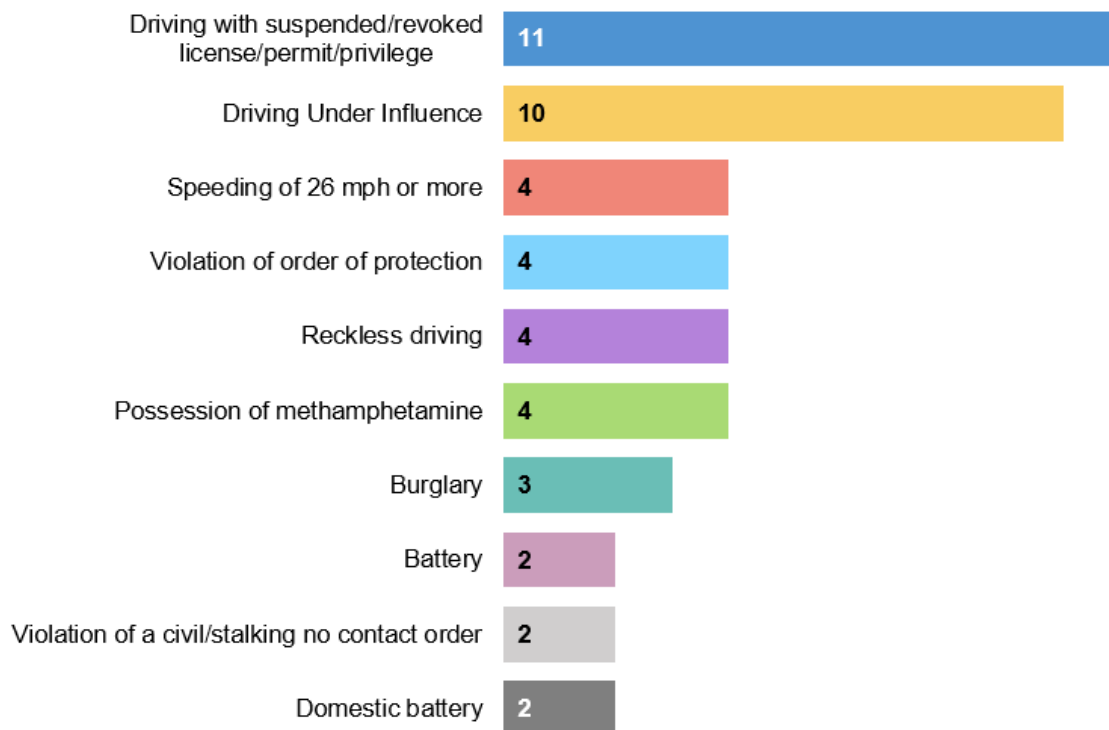
### Review Process

Bartonville Police Department's Chief of Police reviews all the use of force incidents. Every sixty (60) days the Deputy Chief or Detective reviews at least one (1) body worn camera taped event from each officer. These reviews are meant to determine if the cameras are being used properly, any malfunctioning of equipment and any feedback, whether positive or negative, to be given to each officer. This feedback is given to the Chief who holds a meeting with each officer to provide either positive reinforcement or constructive criticism.

### Incidents

Between January 1, 2024, and December 31, 2024, Bartonville Police Department reports sixty-three (63) incidents leading to sixty-three (63) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.

## Department Overview – Batavia Police Department

---

Batavia Police Department reports a few occasions where there were issues with body worn cameras failing to sync to the squad cameras and failing to activate when expected. 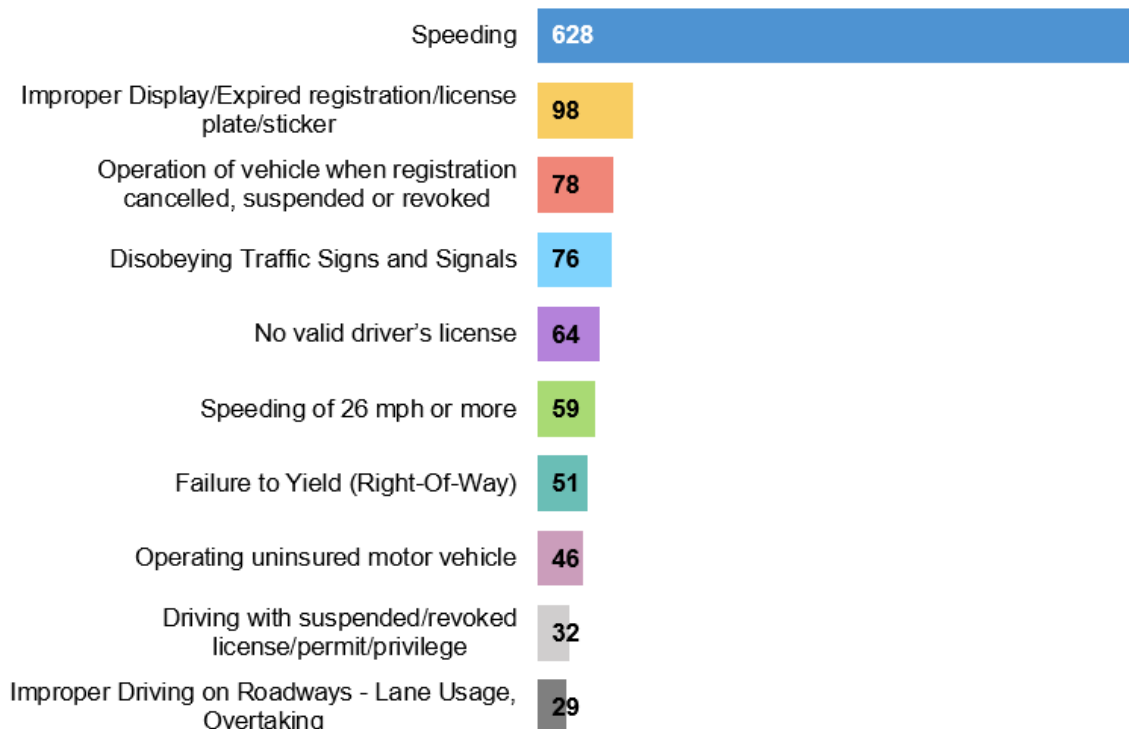
### Review Process

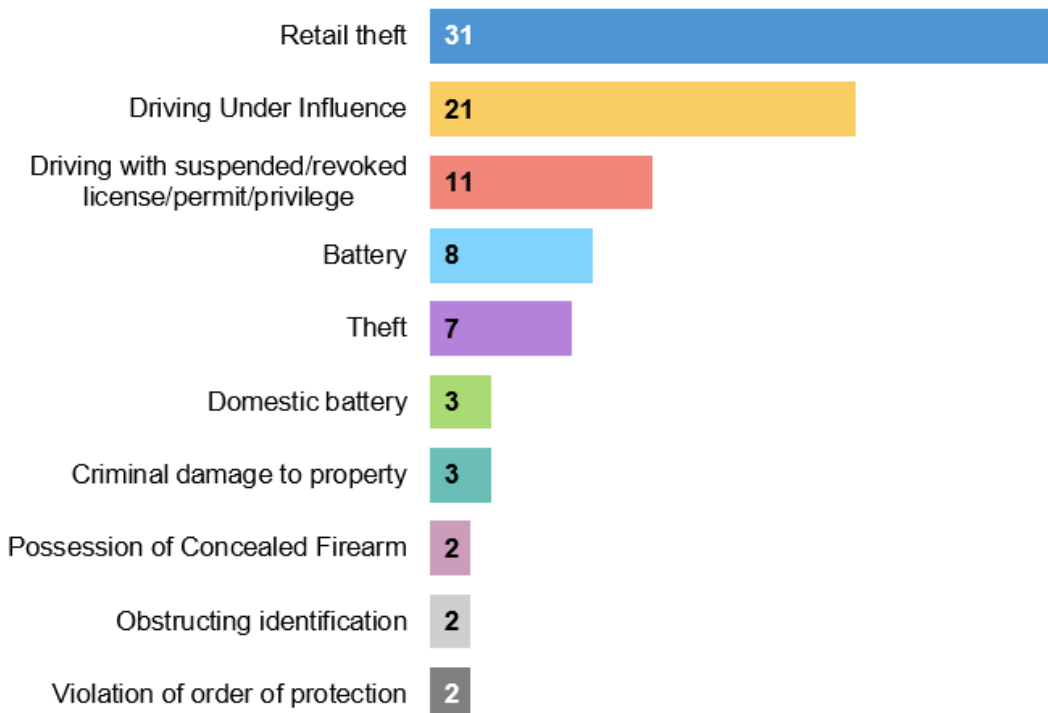

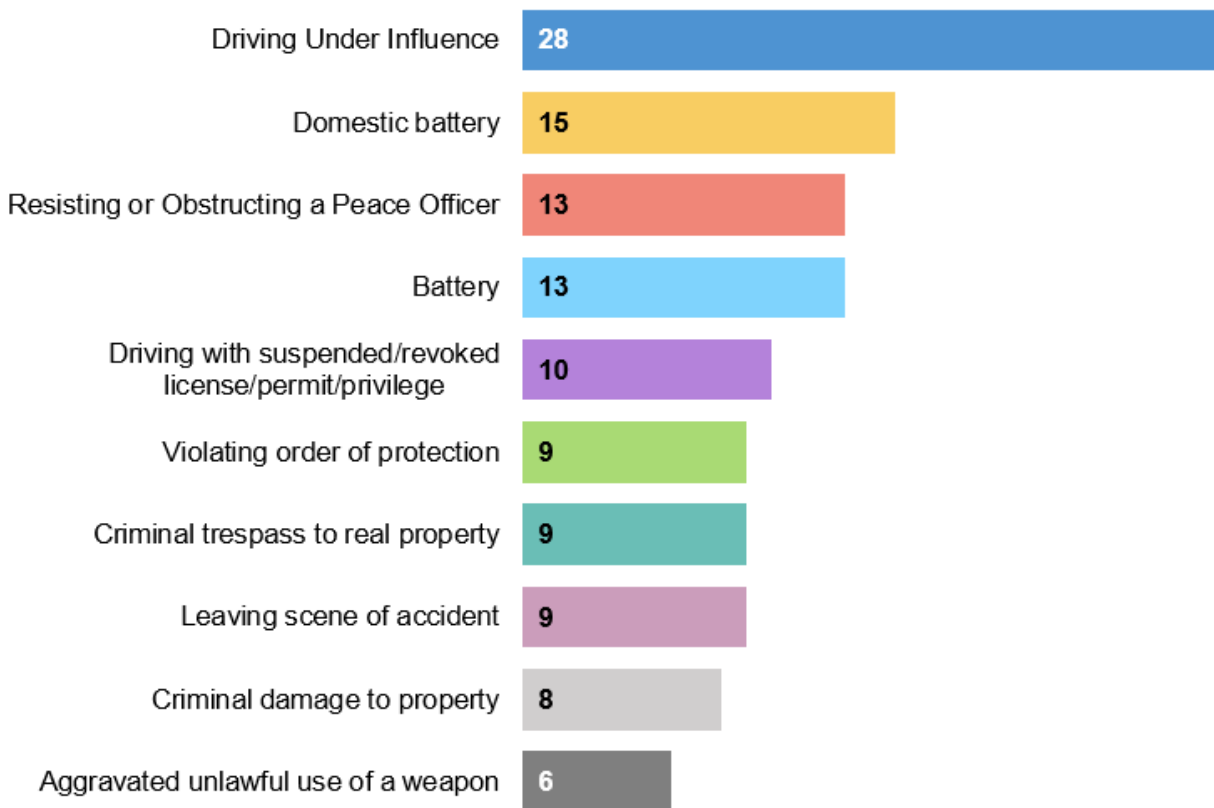

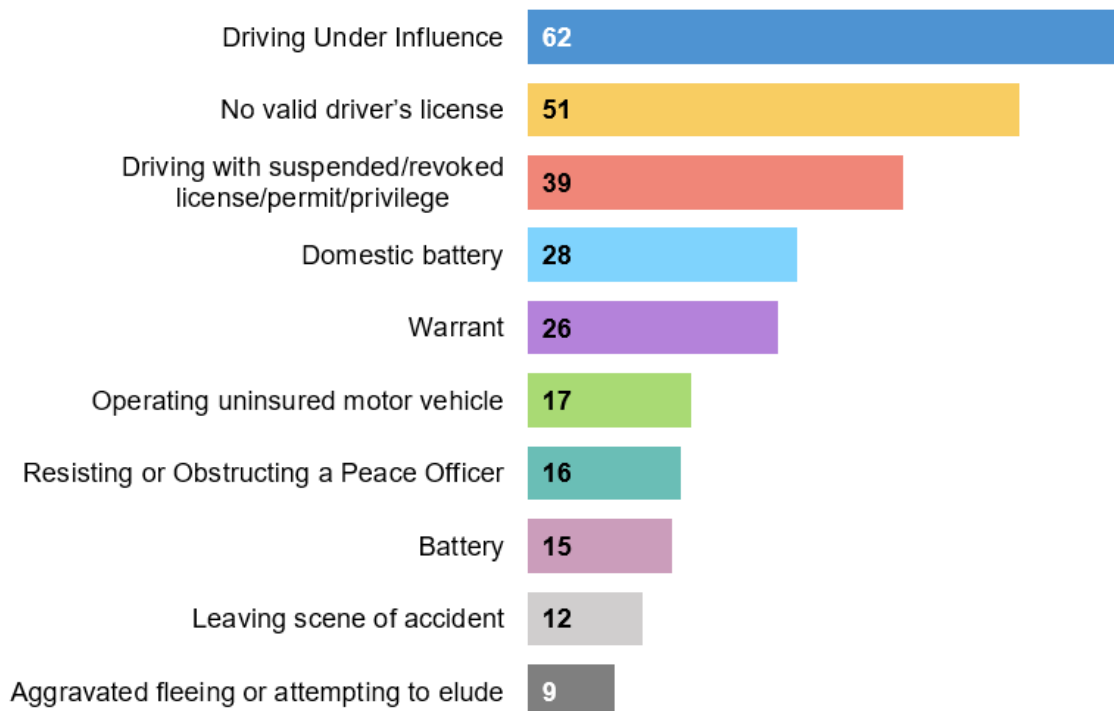

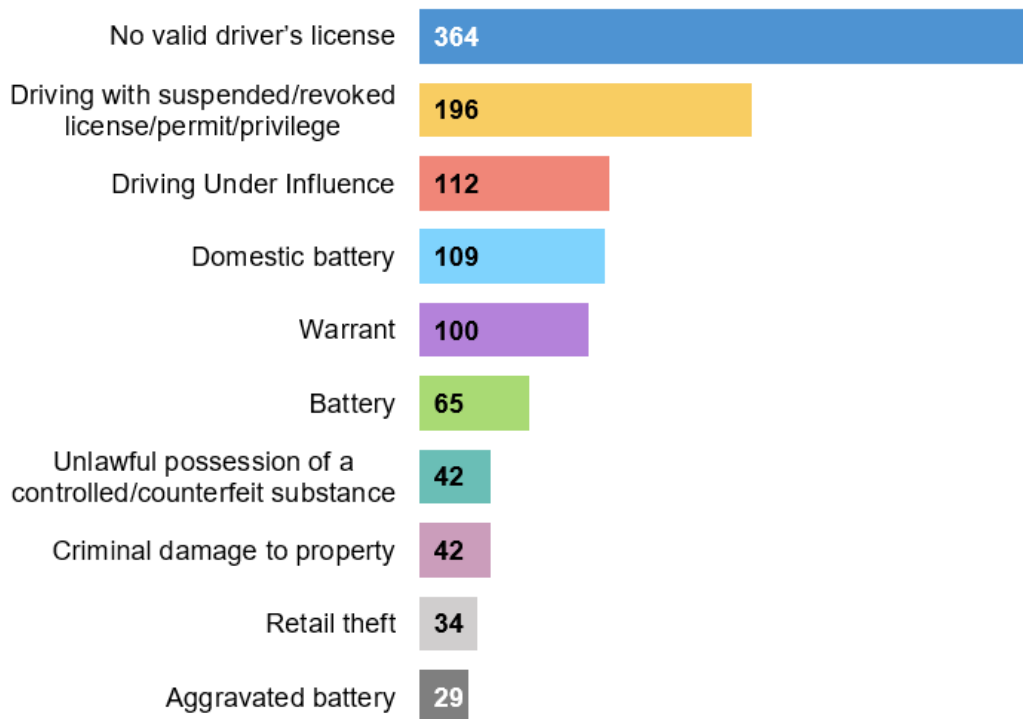

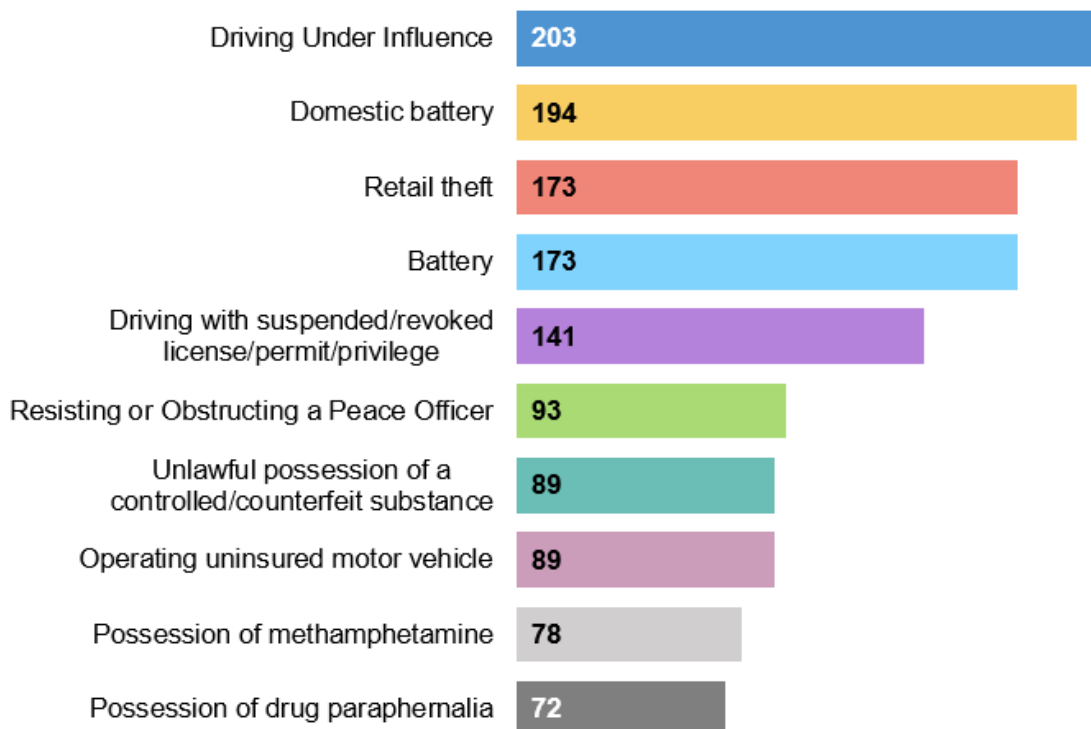

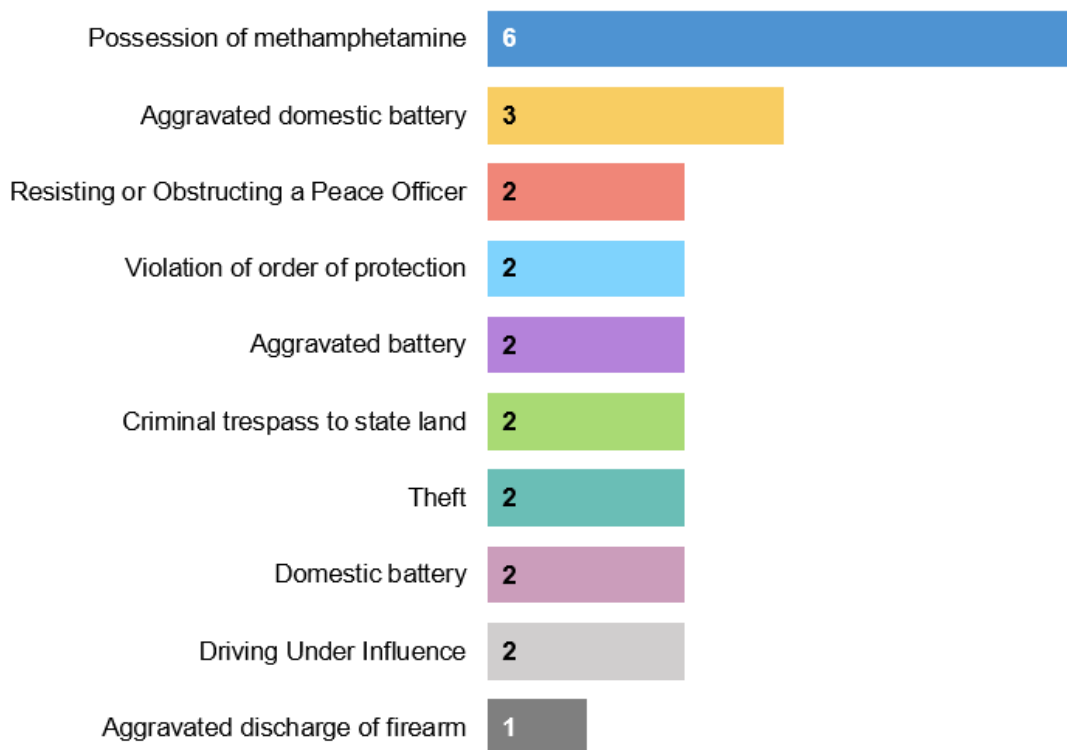

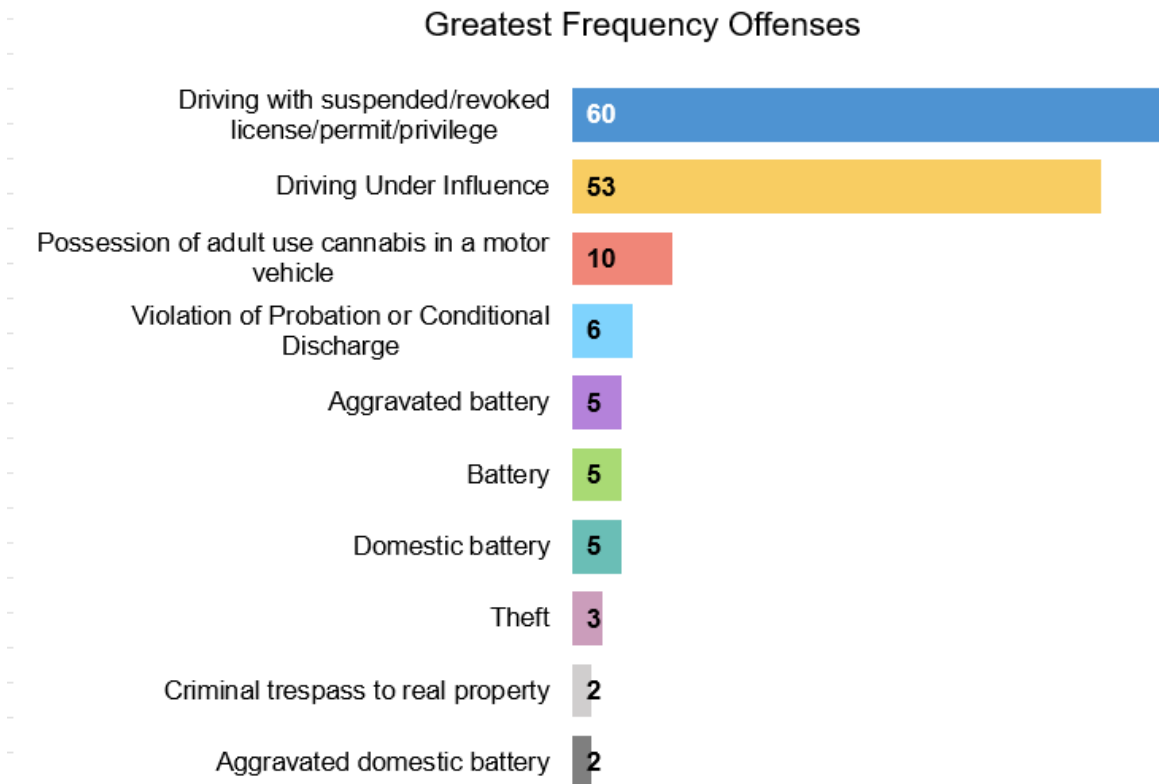

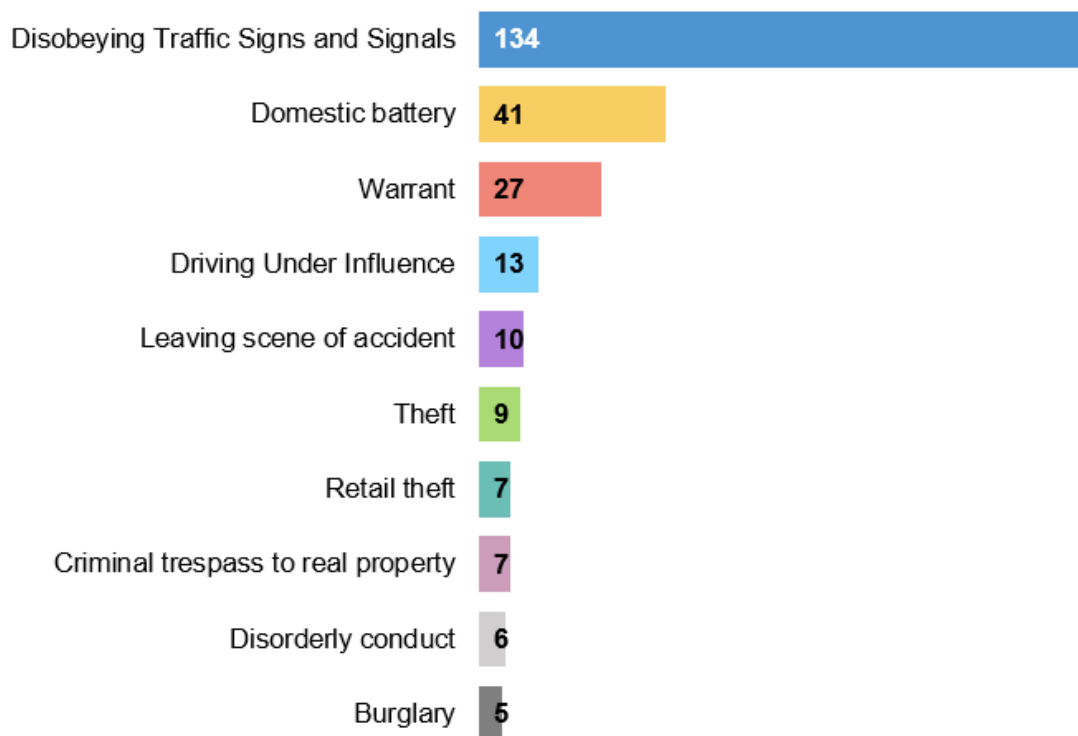

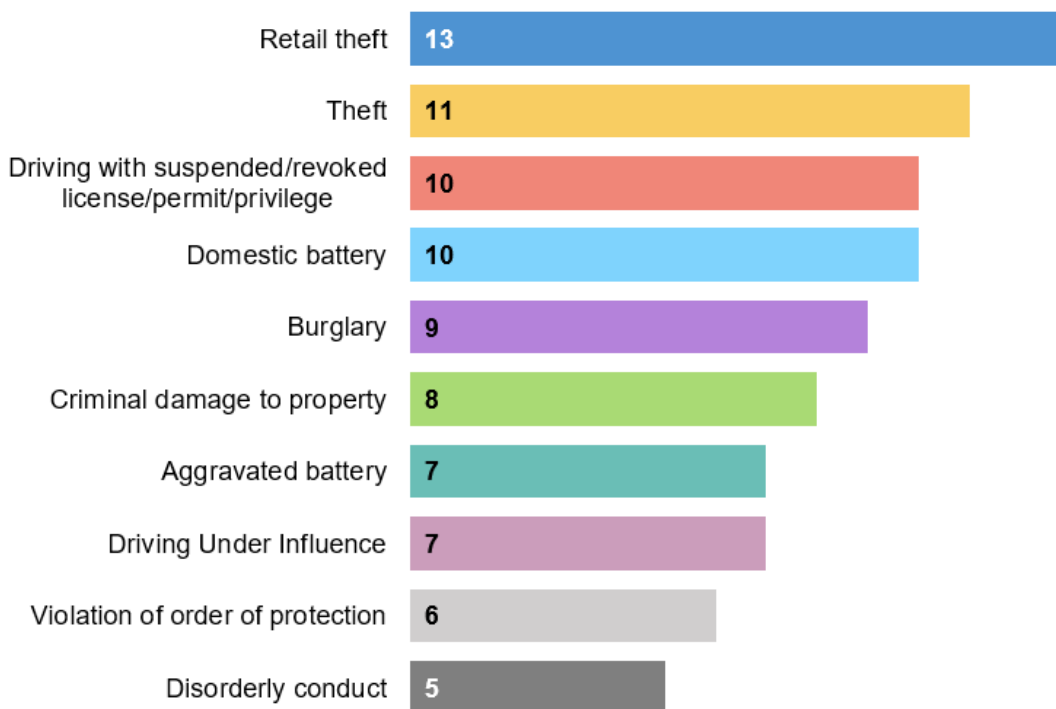

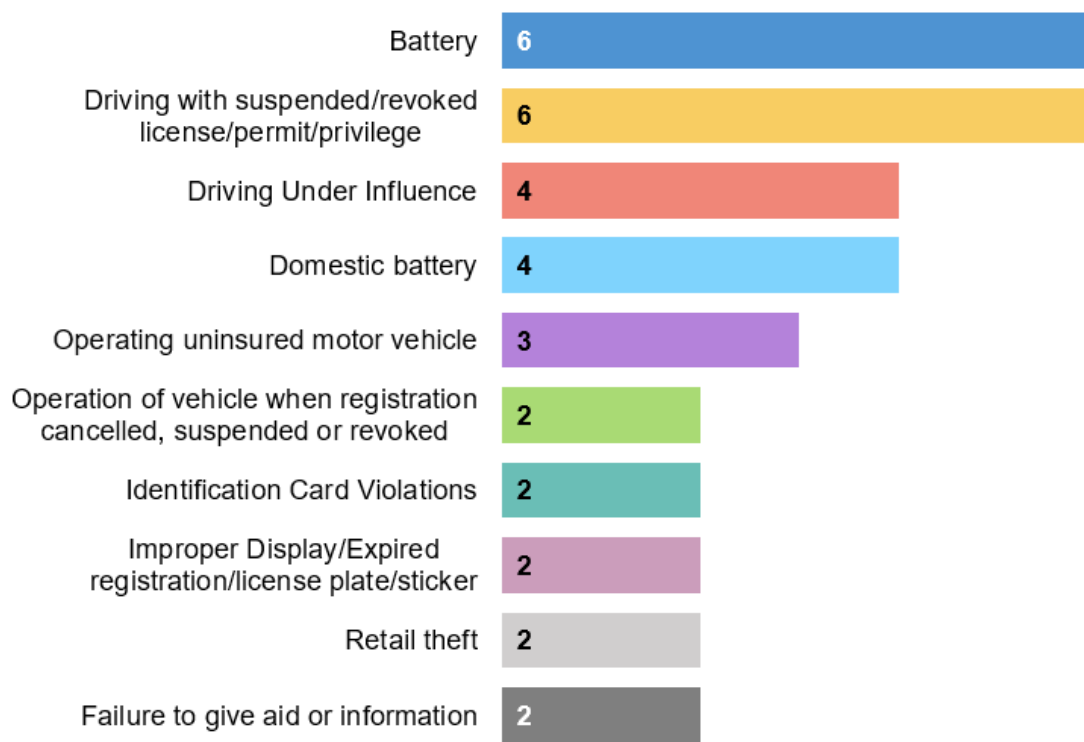

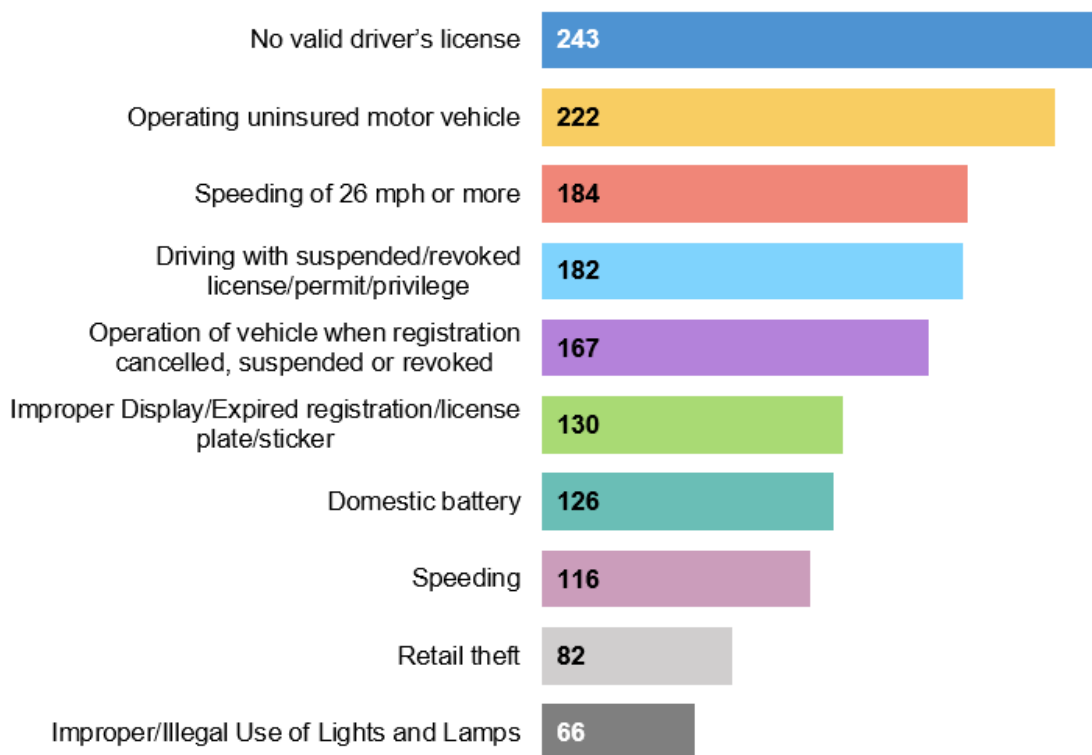

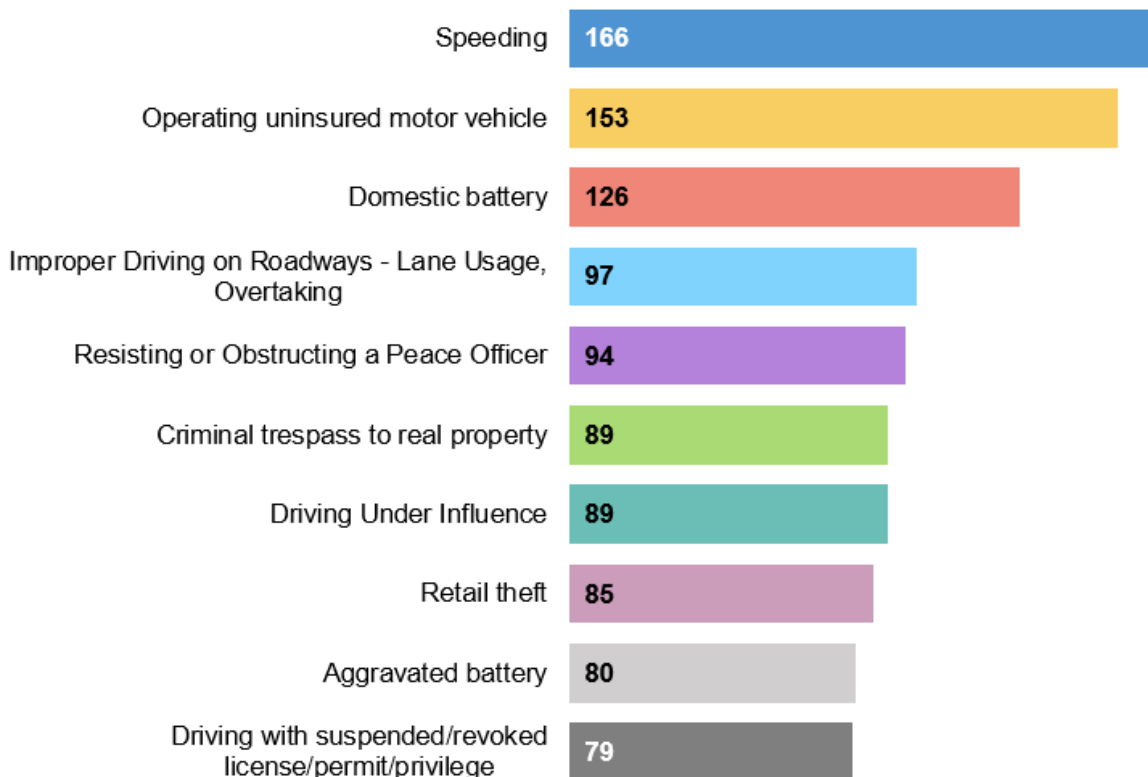

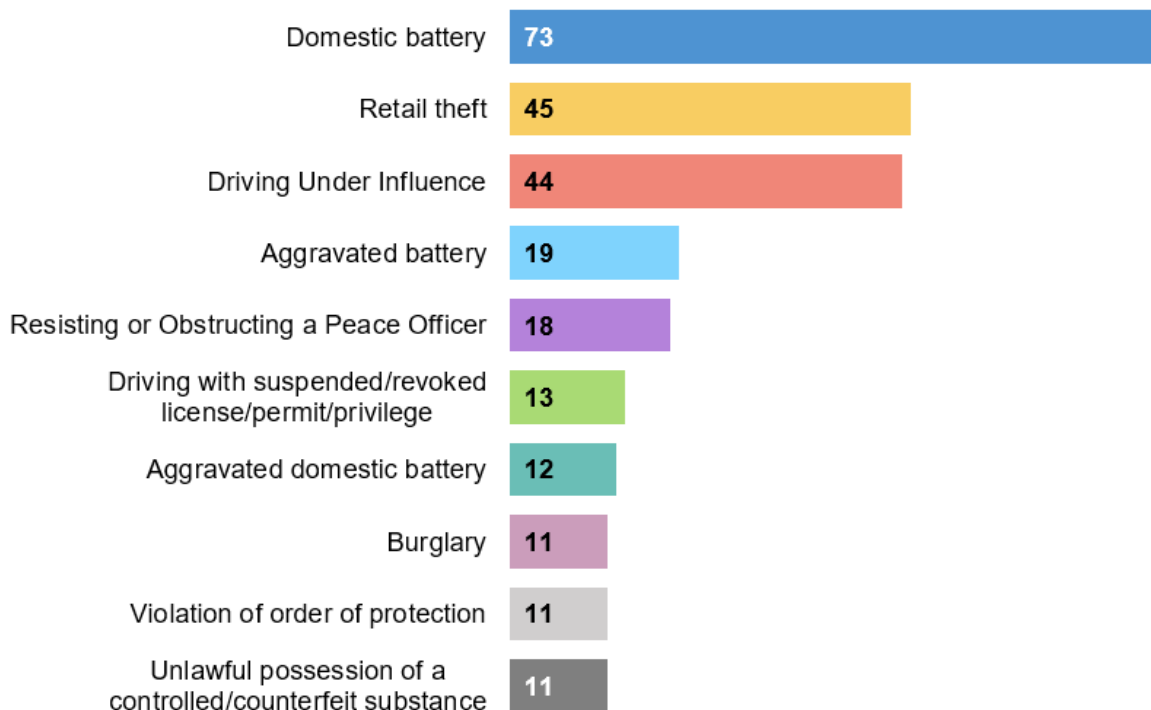

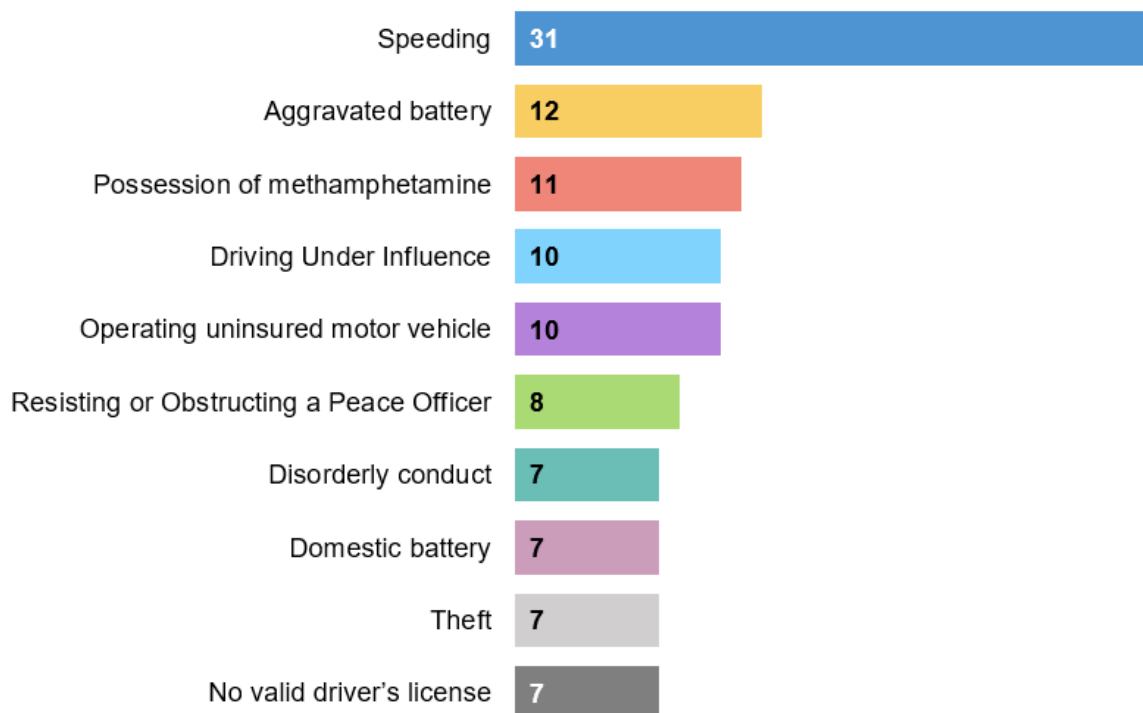

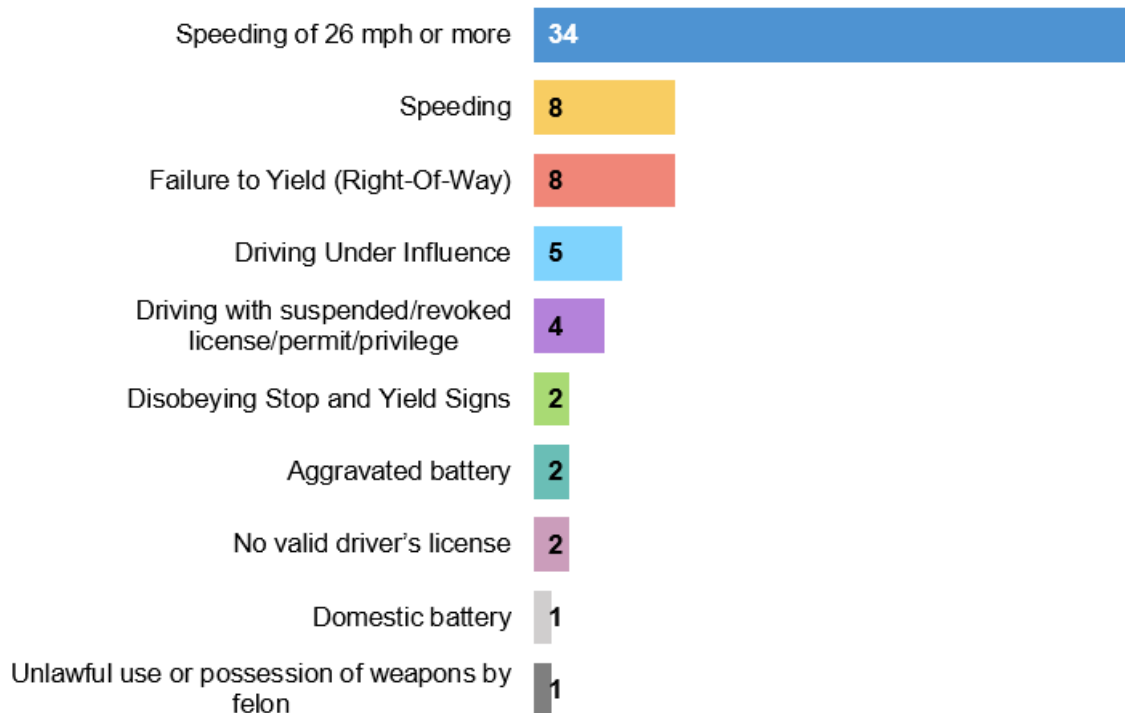

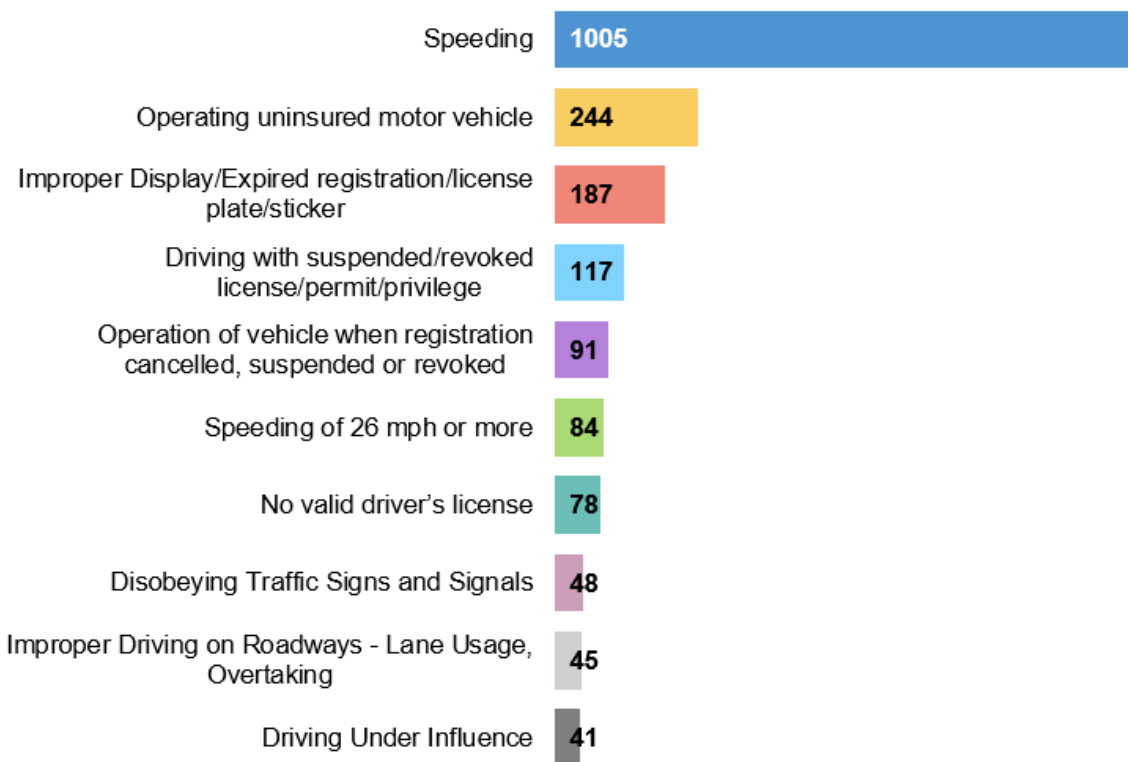

## Department Overview – Chicago Police Department

Chicago Police Department is the largest municipal police agency in Illinois with approximately twelve thousand (12,000) sworn officers. The Chicago Police Department is divided into two (2) offices: the Office of Operations and the Office of Constitutional Policing and Reform. The Chicago Police Department has prioritized officer worn camera deployment in the Office of Operations Patrol Districts and Units within the Special Operations Group. CPD acquired a second round of one thousand eight hundred (1,800) Flex cameras ahead of the Democratic National Convention (DNC) to make the pool roughly around three thousand six hundred (3,600) additional cameras but due to RMA's and other reasons (broke, lost, etc.) the number may be lower for sworn officers during deployments, special events, and temporary field duty. The Chicago Police Department consists of twenty-two (22) patrol districts, as well as Area Community Safety Teams. These districts and teams are staffed by approximately seven thousand five hundred (7,500) sworn officers; all the officers are equipped with body worn cameras. There are another approximate eight hundred (800) body worn cameras assigned to the Mass Transit Unit, SWAT, Traffic, Detail Unit, Fugitive Apprehension, and Investigative Response teams.

Extensive data from 2024 was submitted by the Chicago Police Department but was unable to be compiled in time for the submission of this report. A complete summary of this agency's responses and citation data will be provided in a supplemental publication.

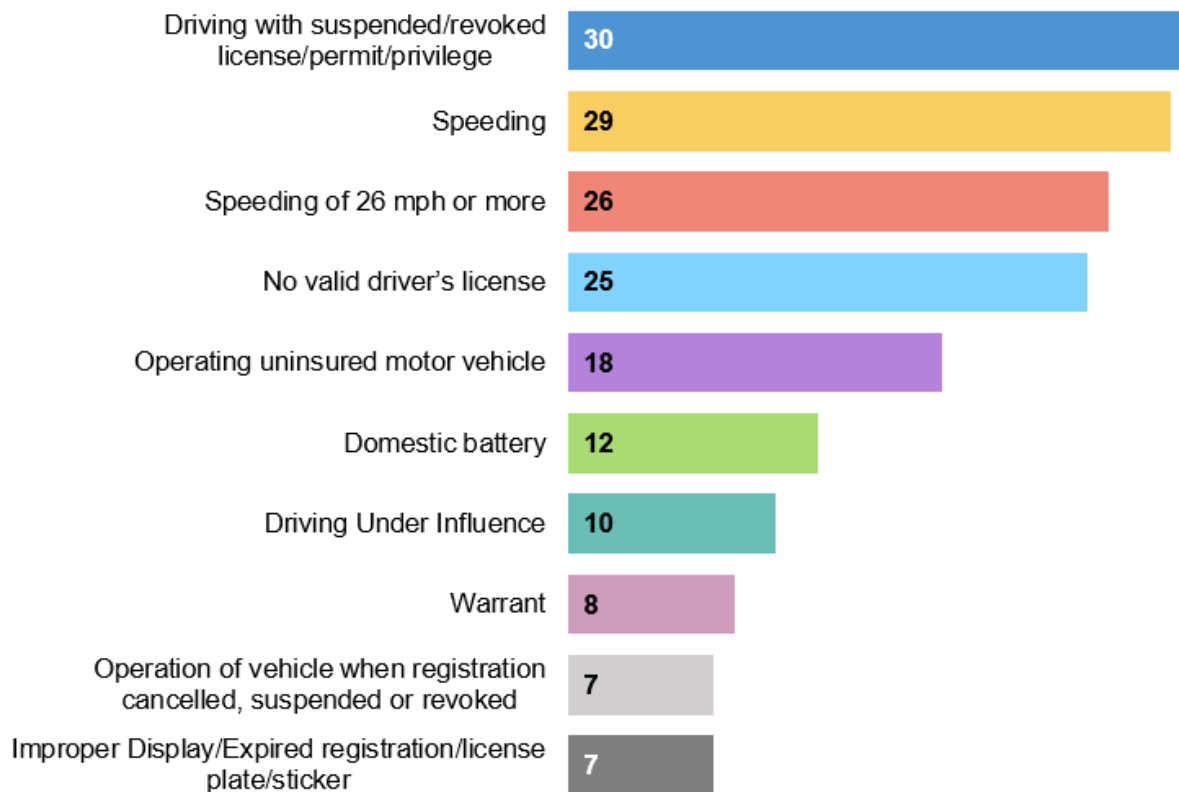

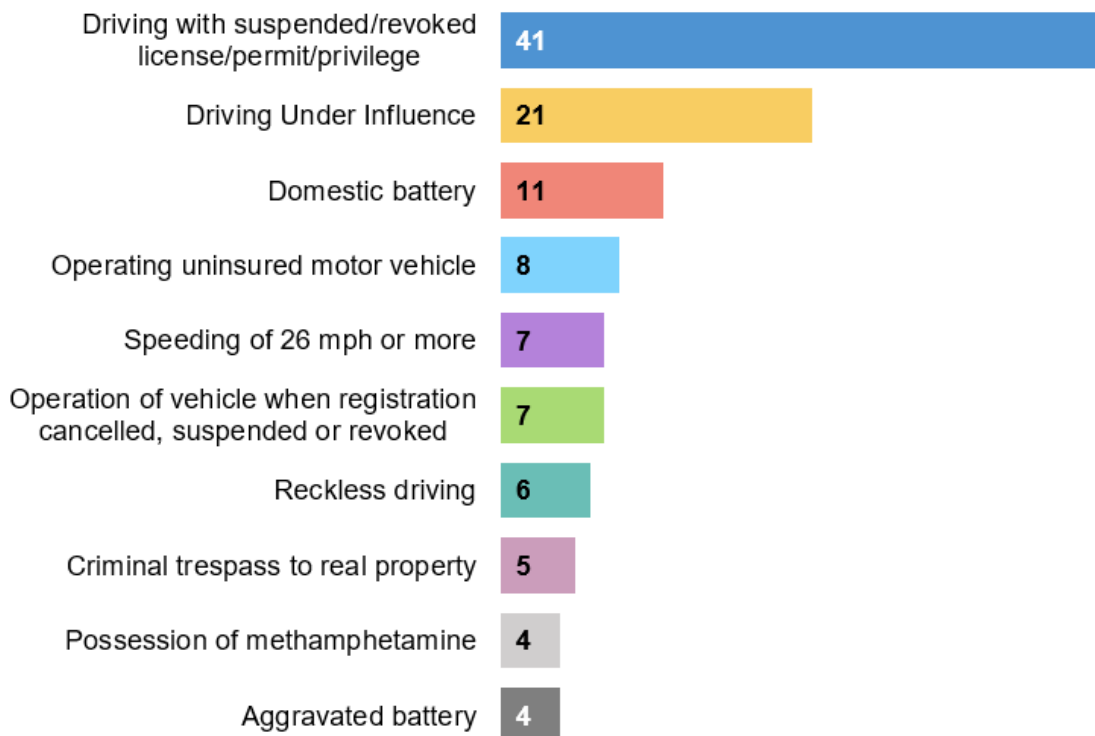

The supervisor of the recording member document in the report or other documentation if the supervisor or the recording member reviewed body worn camera recordings prior to completing the report or other documentation.

### Incidents

Between January 1, 2024, and December 31, 2024, Coles County Sheriff's Office reports one hundred twenty-six (126) incidents leading to one hundred forty-five (145) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.

College of DuPage Police Department consists of seventeen (17) officers who utilize sixteen (16) body worn cameras.

### **Technical Issues**

College of DuPage Police Department reports zero (0) technical issues.

### **Review Process**

College of DuPage Police Department's supervisors perform monthly random reviews of body worn camera recordings which consist of one (1) incident's footage of each officer. Supervisors coordinate the selection of officers with one another to ensure there are no duplicate reviews. They perform monthly audits of body worn camera recordings to ensure cameras are being activated for calls for service that require body worn camera activation.

### **Incidents**

Between January 1, 2024, and December 31, 2024, College of DuPage Police Department's Office reports five (5) incidents leading to eight (8) offenses charged which include four (4) instances of disorderly conduct, two (2) instances of aggravated battery and one (1) instance each of battery and criminal sexual abuse.

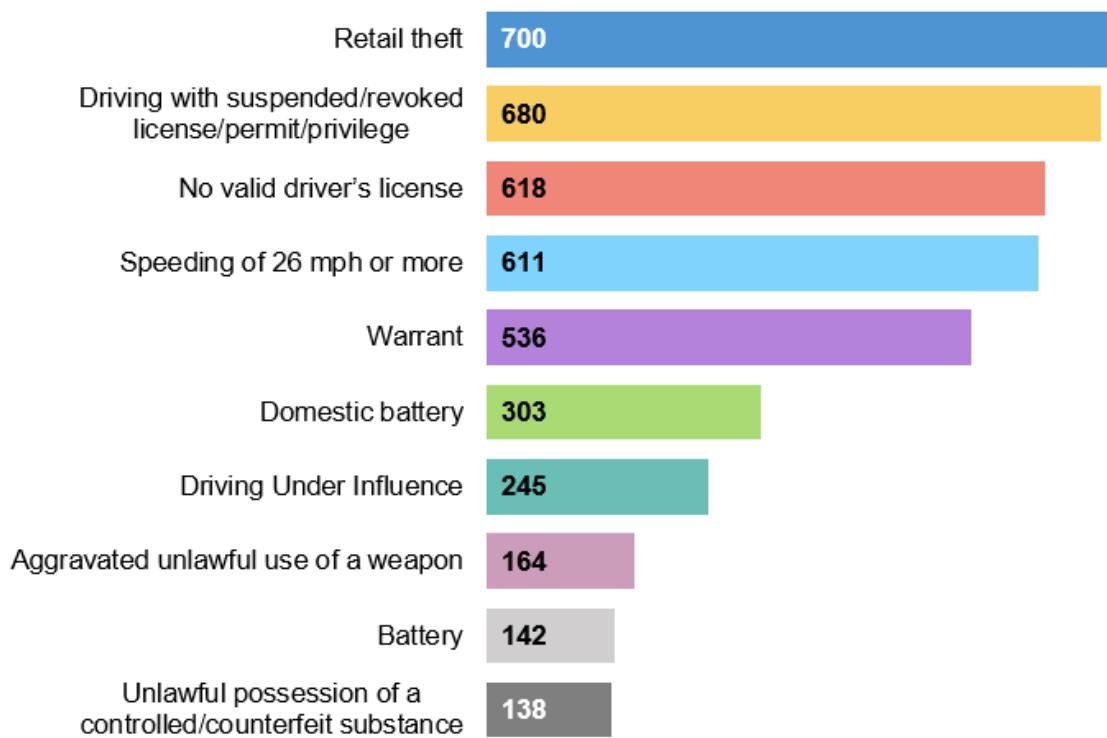

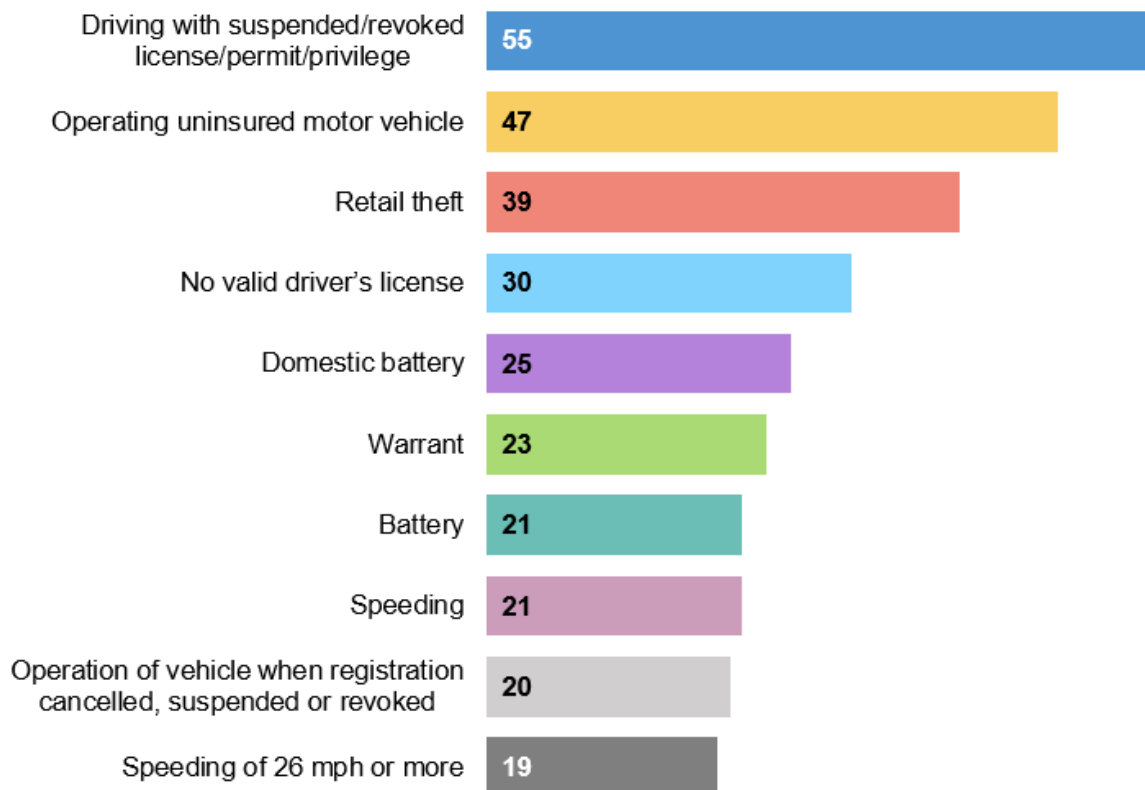

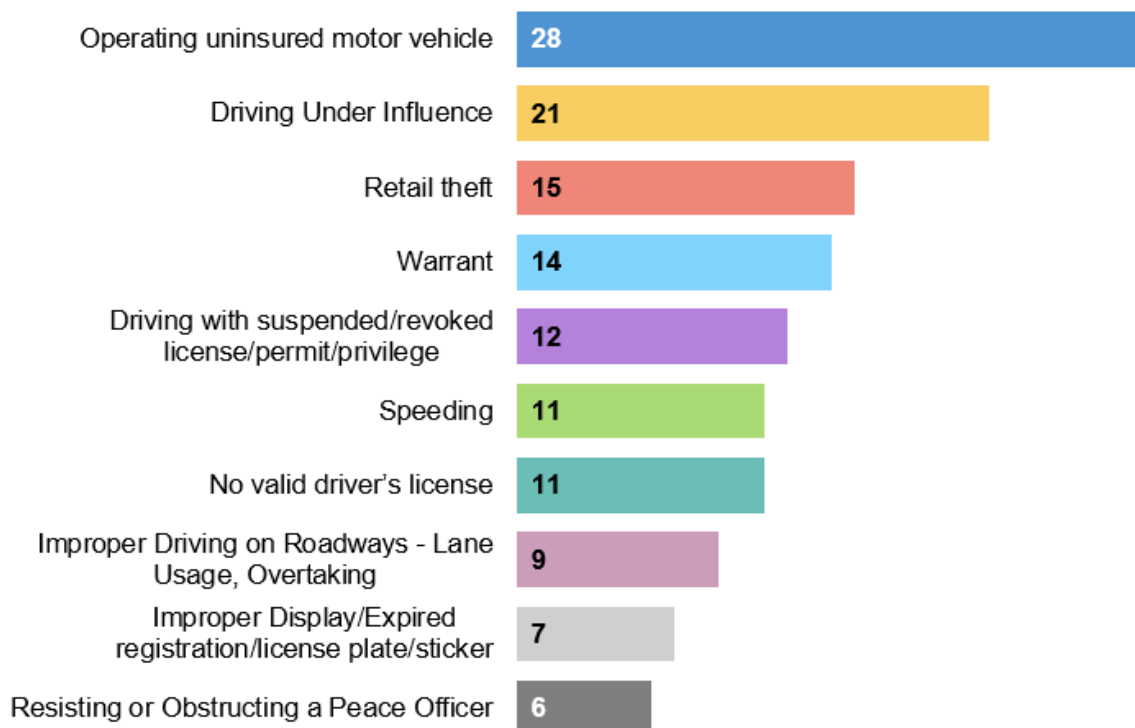

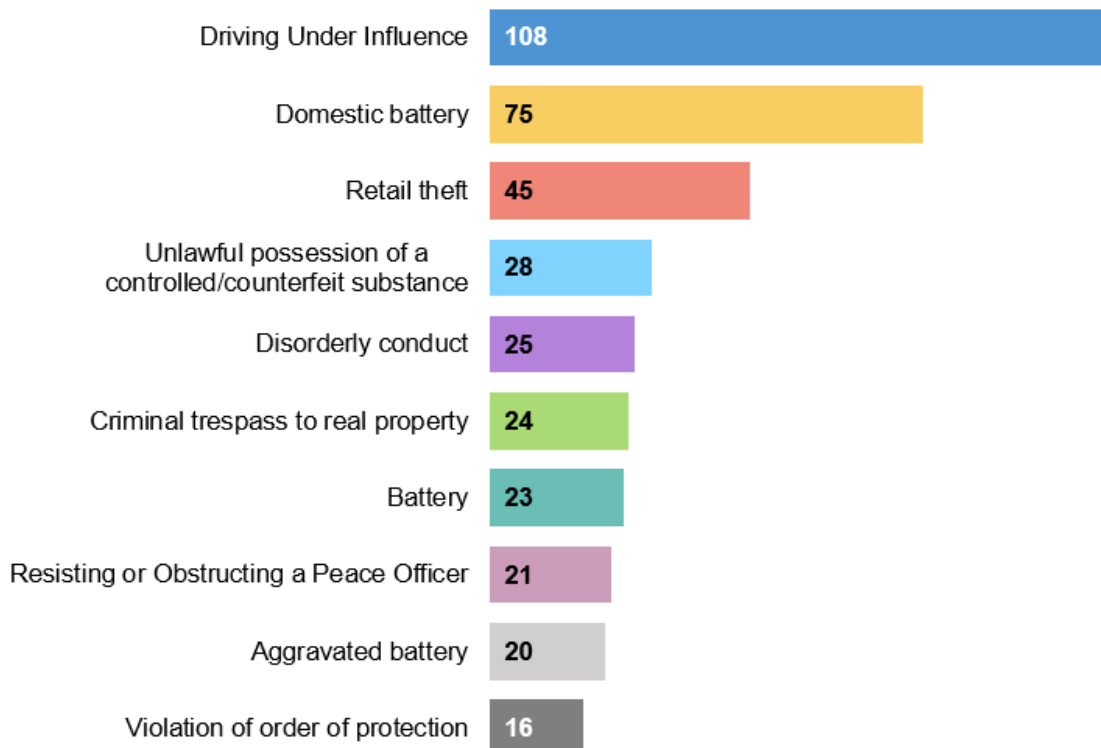

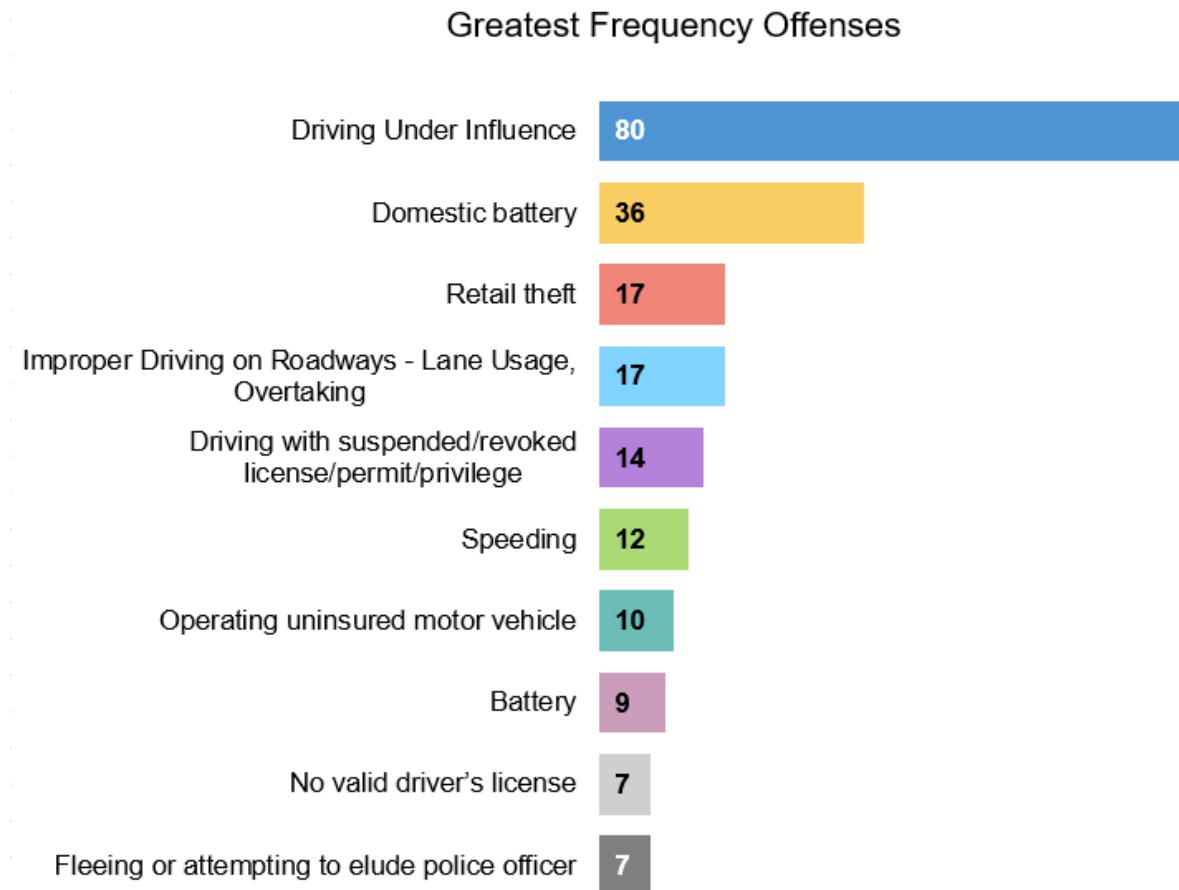

Des Plaines Police Department's report does not include incidents data.

## Department Overview – Downers Grove Police Department

---

Downers Grove Police Department consists of seventy-one (71) sworn officers and seventy-six (76) body worn cameras, of which sixty-seven (67) are assigned to officers.

- Recordings are assigned in Evidence.com to the member who created the recordings.
- A civilian staff member is assigned to monitor and review all the digital files within Evidence.com to ensure they are properly identified and categorized. When a digital file is not in compliance, the officer and their supervisor are made aware of the situation so that it can be remedied.
- An investigation is initiated when a staff member determines that an officer-worn body camera is missing, lost, or damaged.
- The distribution, charging, and uploading of the officer-worn body cameras and their digital files are consistent with police department directives.
- Officers who reviewed an officer-worn body camera recording prior to writing a report document this information in the narrative portion of the police report.
- Quarterly, supervisors review both officer-worn body camera and in-car camera recordings, if applicable. Supervisors review four (4) incidents per officer per quarter. The reviews are performed to ensure officers utilize the body worn cameras in compliance with police department policy and procedures. This review process is documented in a computer program designed to conduct random body worn camera video review and provide feedback to the officer.

### Incidents

Downers Grove Police Department's report does not include incidents data.

## Department Overview – DuPage County Forest Preserve District Police Department

---

DuPage County Forest Preserve District Police Department consists of twenty-five (25) sworn officers who utilize twenty-six (26) Axon body worn cameras.

### Technical Issues

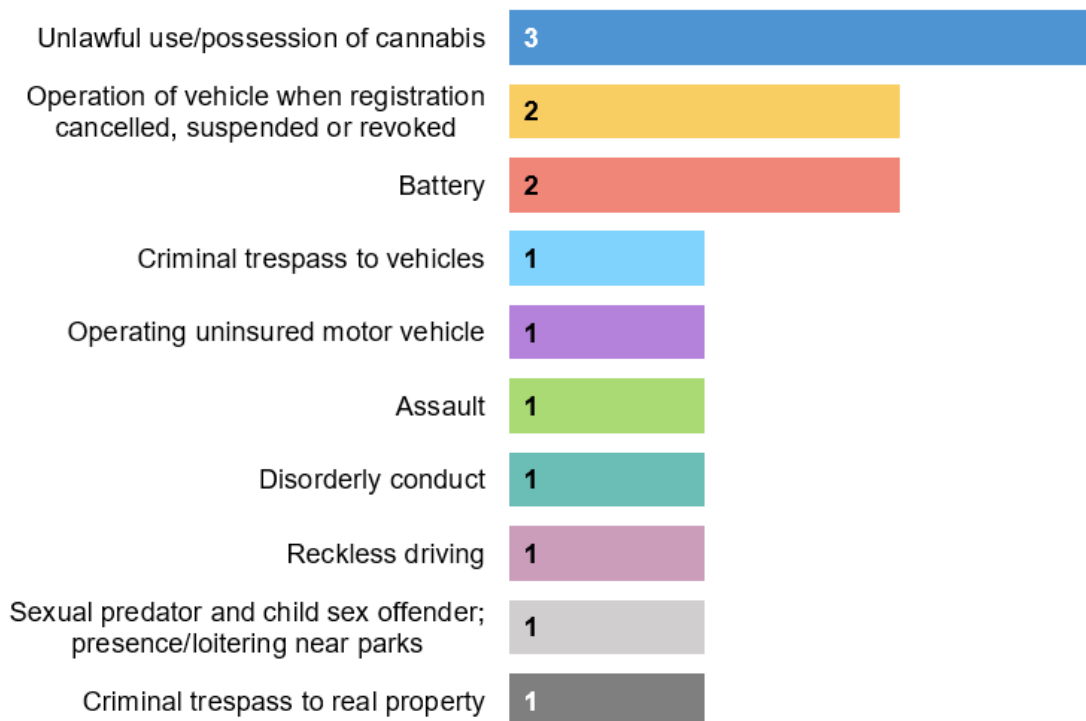

## Department Overview – DuPage County Sheriff's Office

---

DuPage County Sheriff's Office consists of one hundred five (105) sworn law enforcement personnel who each utilize an Axon body worn camera.

### Technical Issues

DuPage County Sheriff's Office reports a few technical issues including normal equipment wear and tear, and occasional Bluetooth connectivity issues with the Axon Fleet Dashboard application. These issues were typically resolved on their own or required intervention from the Sheriff's Office IT team to update applications. When problems could not be resolved internally, spare body cameras were issued, and a Return Merchandise Authorization (RMA) was initiated with Axon for replacement.

### Review Process

DuPage County Sheriff's Office's Body Worn Camera Program is managed by both sergeant and civilian personnel. Both individuals organize and manage the Evidence.com data, the labeling of videos, citizen shared evidence, sharing videos with the state attorney's office, and conducting FOIA and subpoena requests. Axon Performance randomly selects a video and then plays it for the supervisor. After the review, the supervisor can add comments or click several pre-determined responses such as no issues/concerns observed, late activation, poor video/poor sound, or unsatisfactory behavior. The deputy then gets an email response with the results of the review. Each team supervisor is required at minimum to review four (4) videos from their team per month.

### Incidents

DuPage County Sheriff's Office's report does not include incidents data.

## Department Overview – Durand Police Department

---

Durand Police Department consists of two (2) full-time officers, and three (3) part-time officers who utilize three (3) body worn cameras.

### **Technical Issues**

Durand Police Department reports zero (0) technical issues.

### **Review Process**

Durand Police Department's Chief or a designee is required to review a sample of the use of body worn cameras by every officer. They are to review three (3) videos per officer within the time frame to confirm their adherence to policy and statute.

### **Incidents**

Durand Police Department's report does not include incidents data.

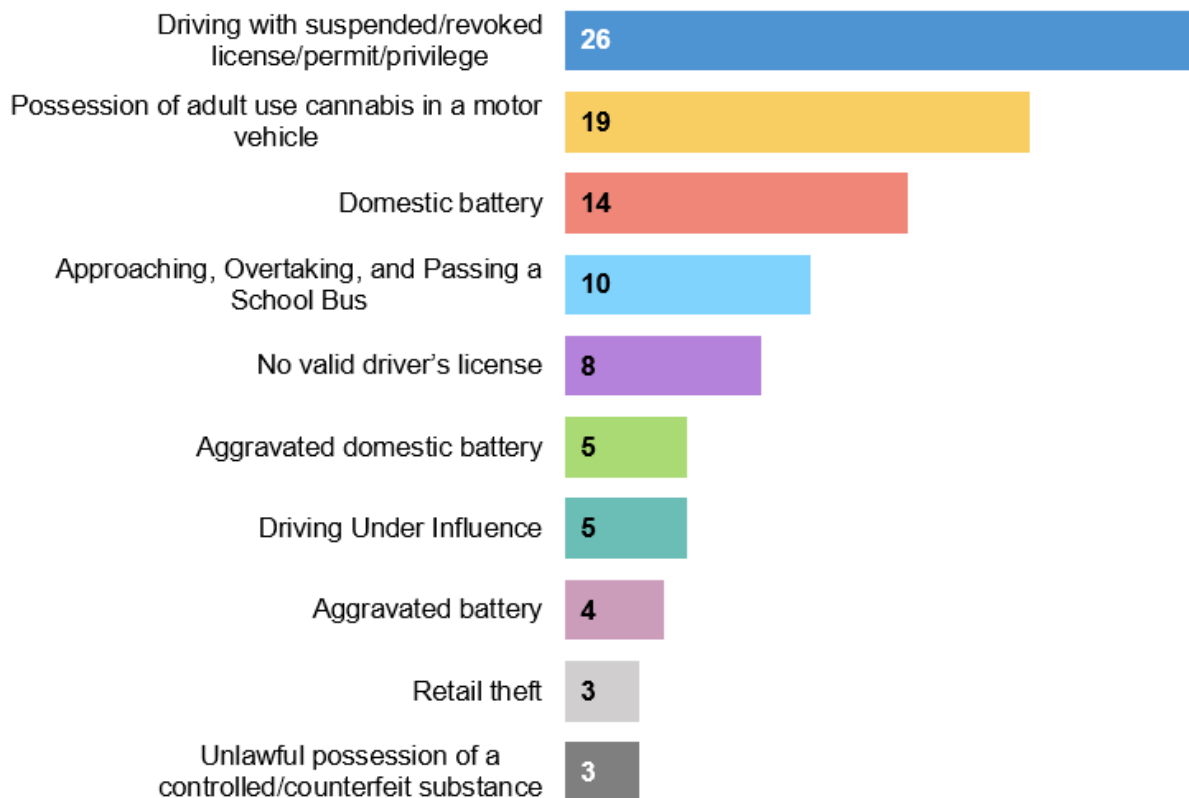

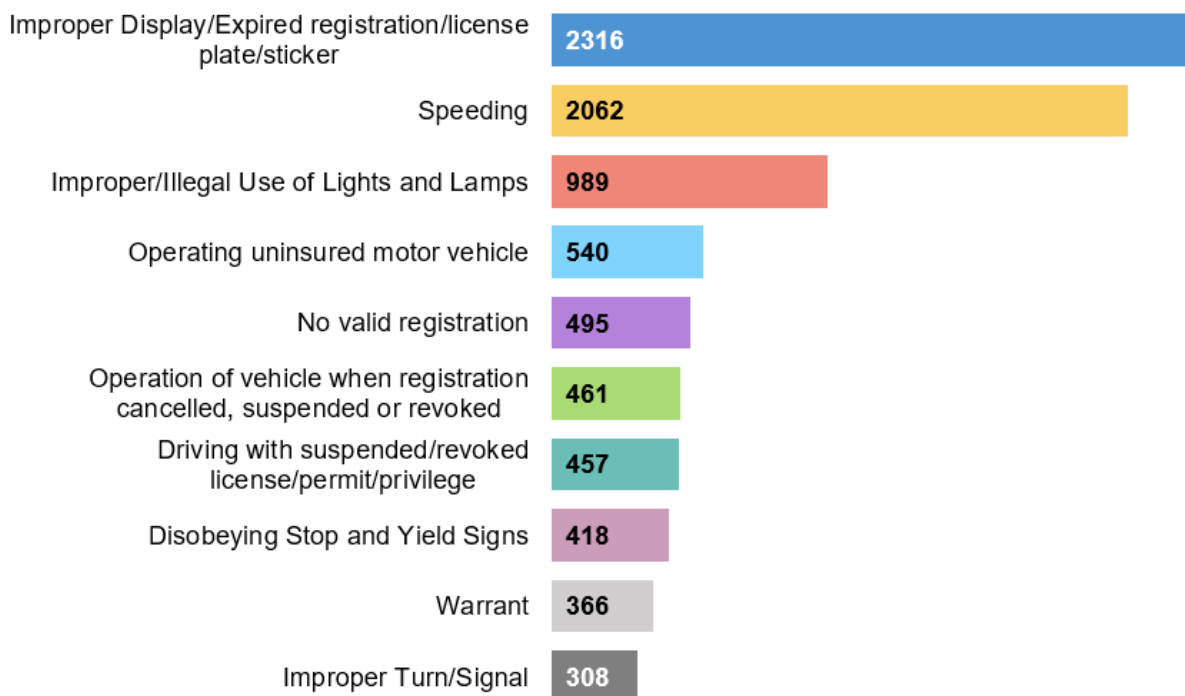

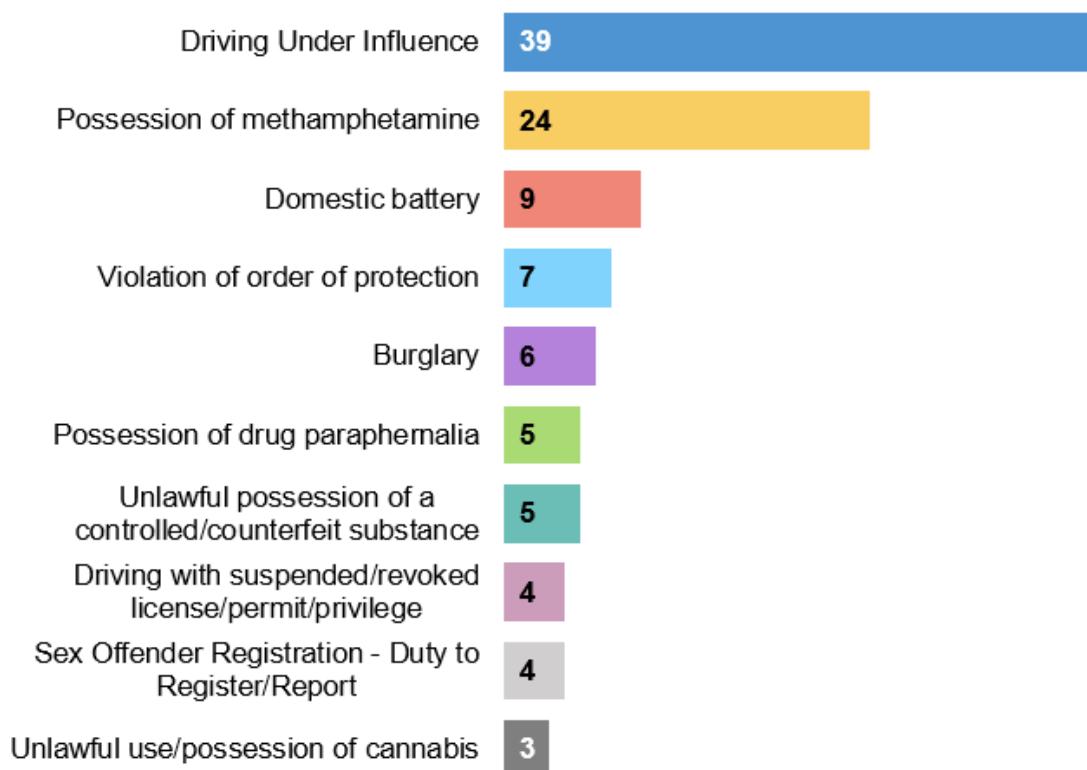

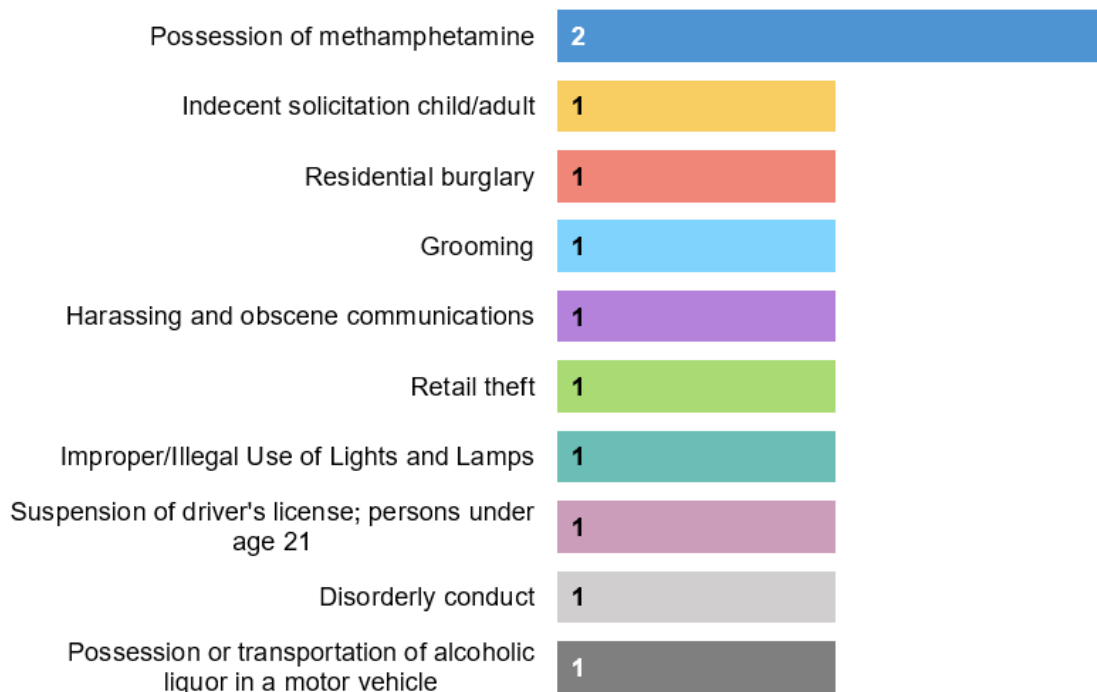

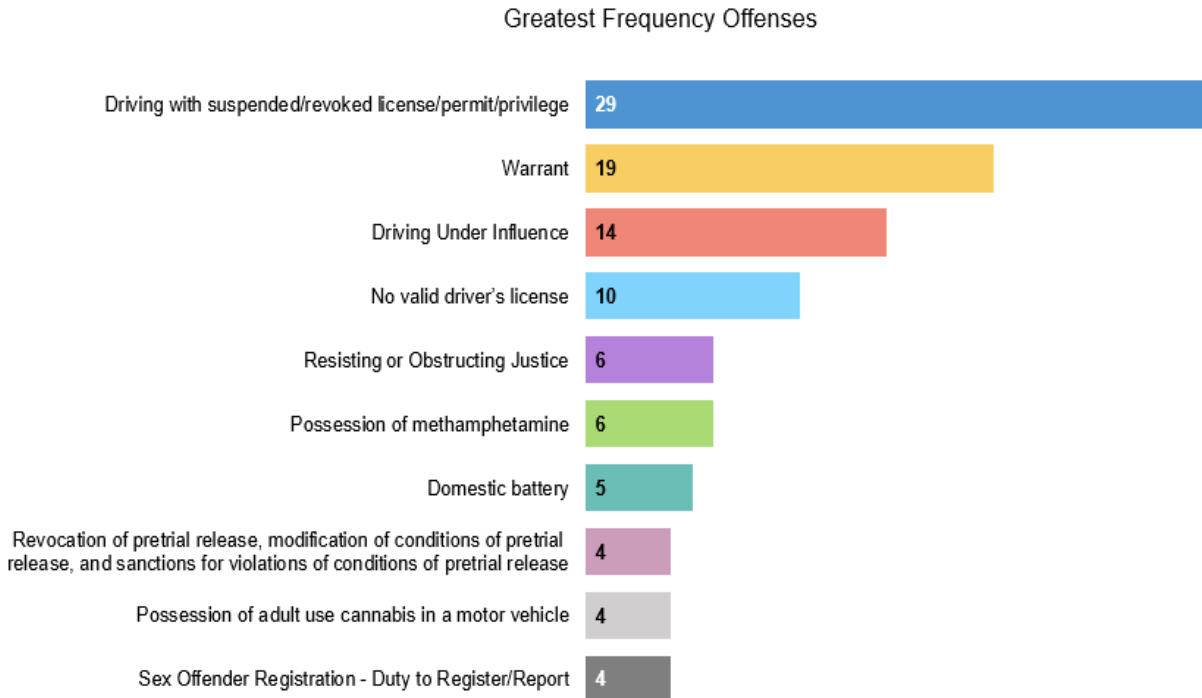

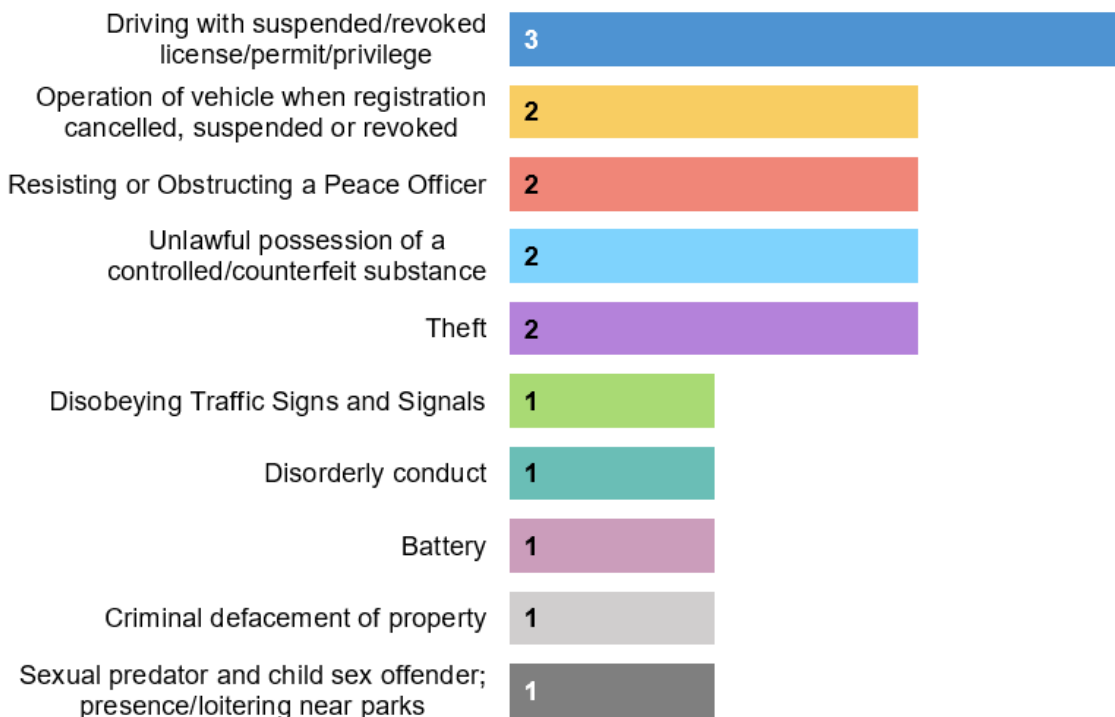

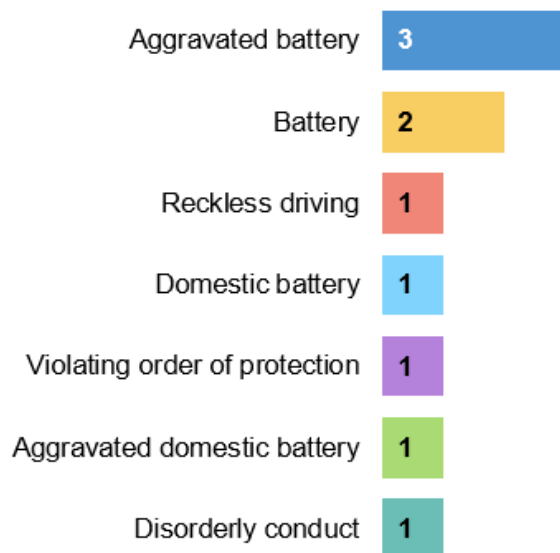

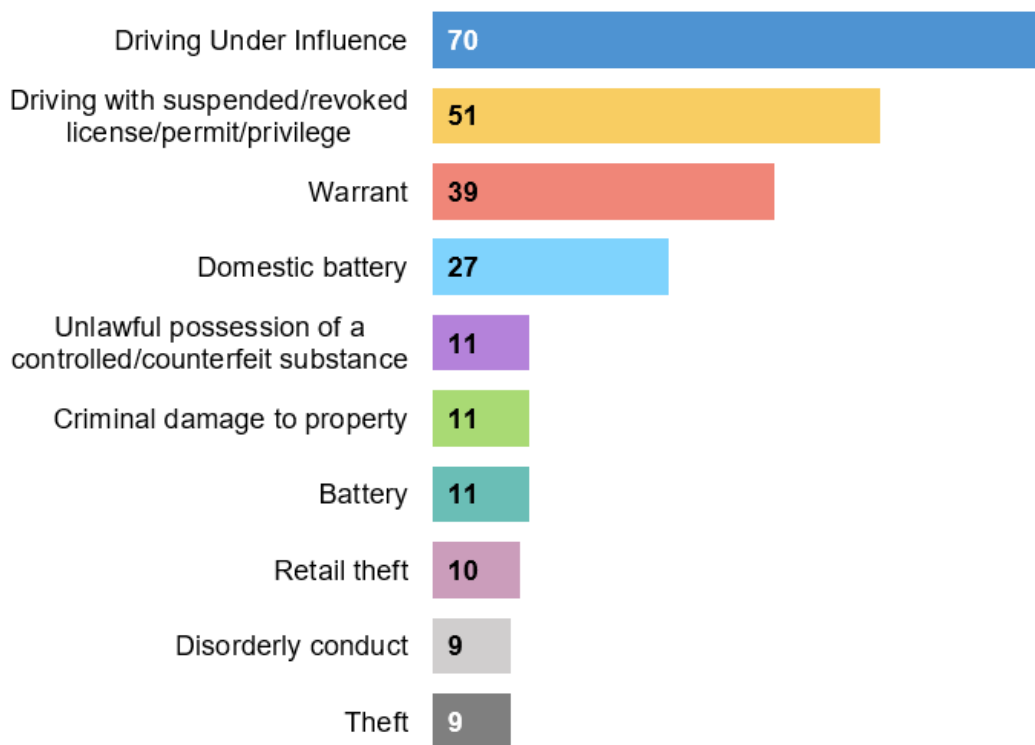

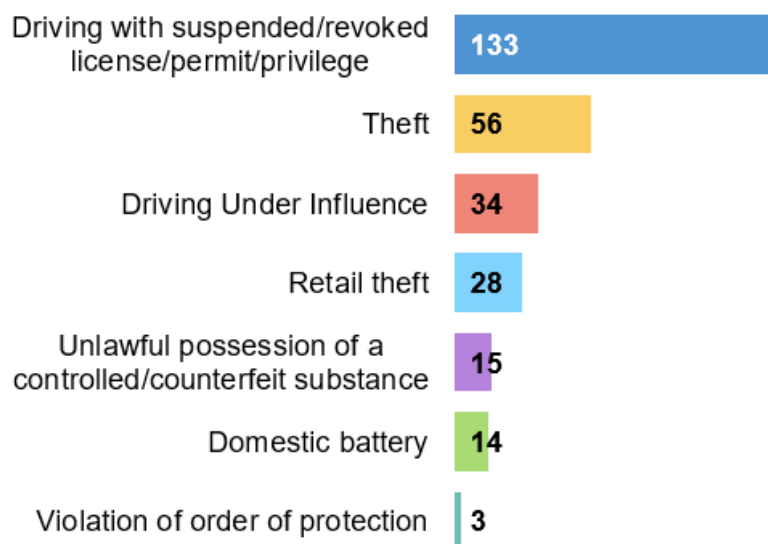

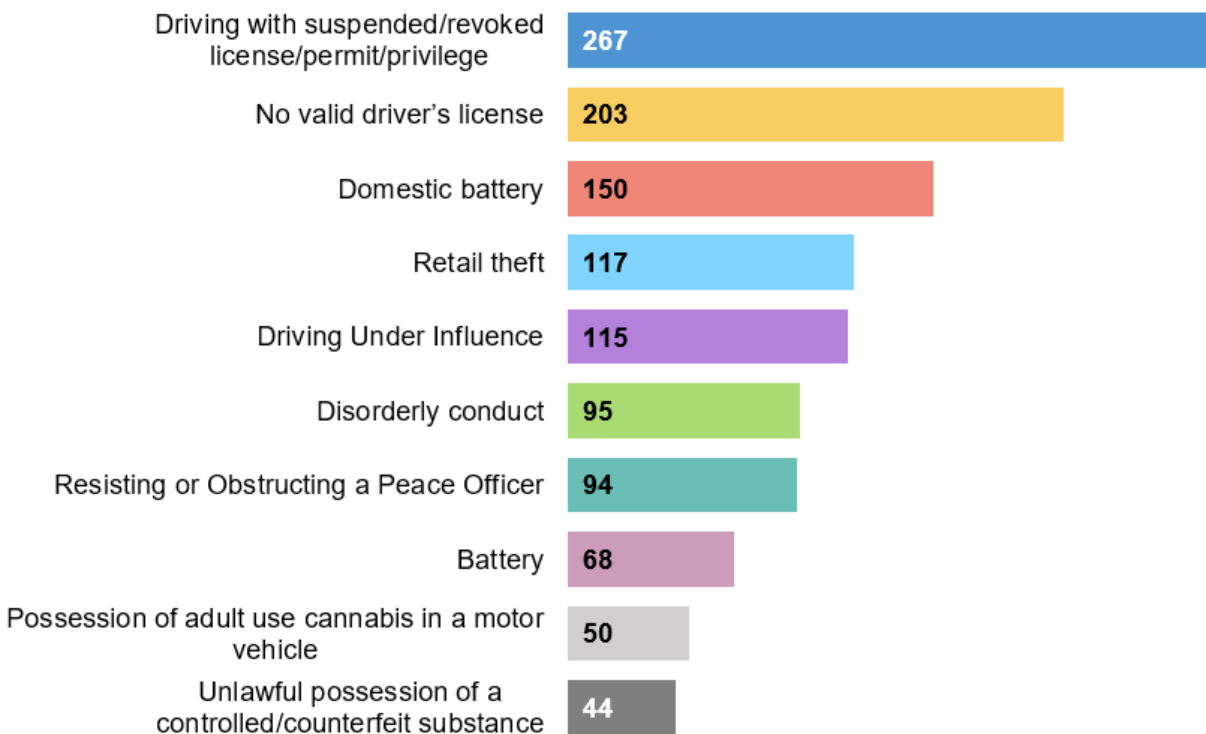

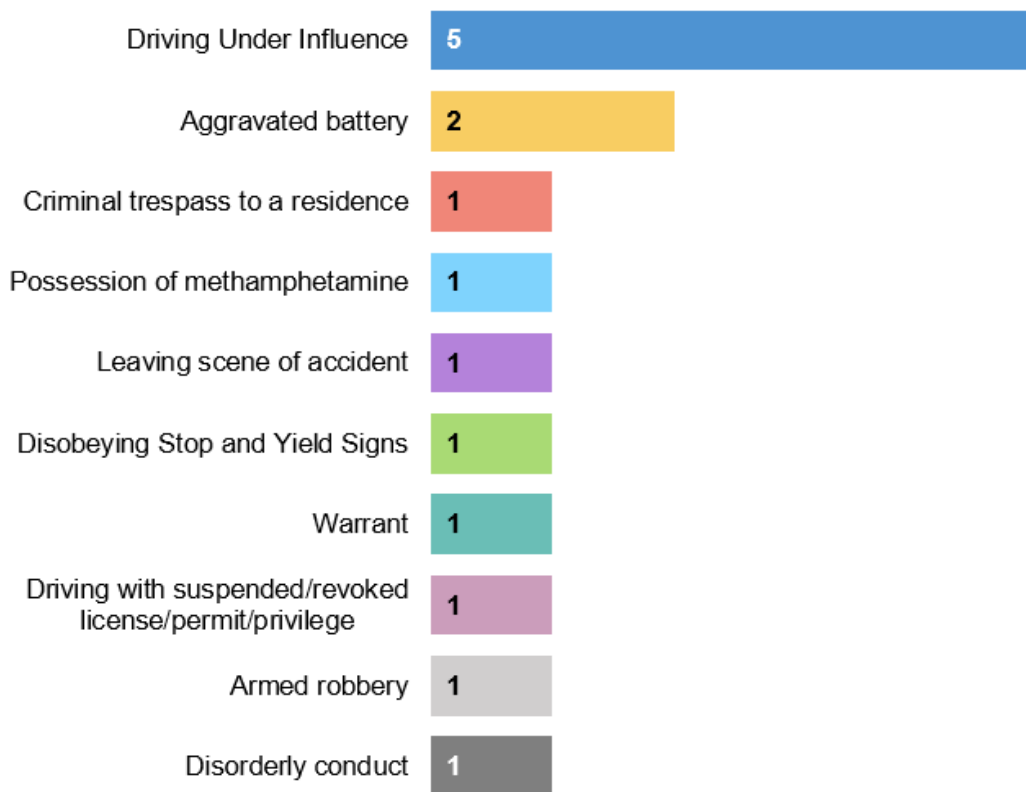

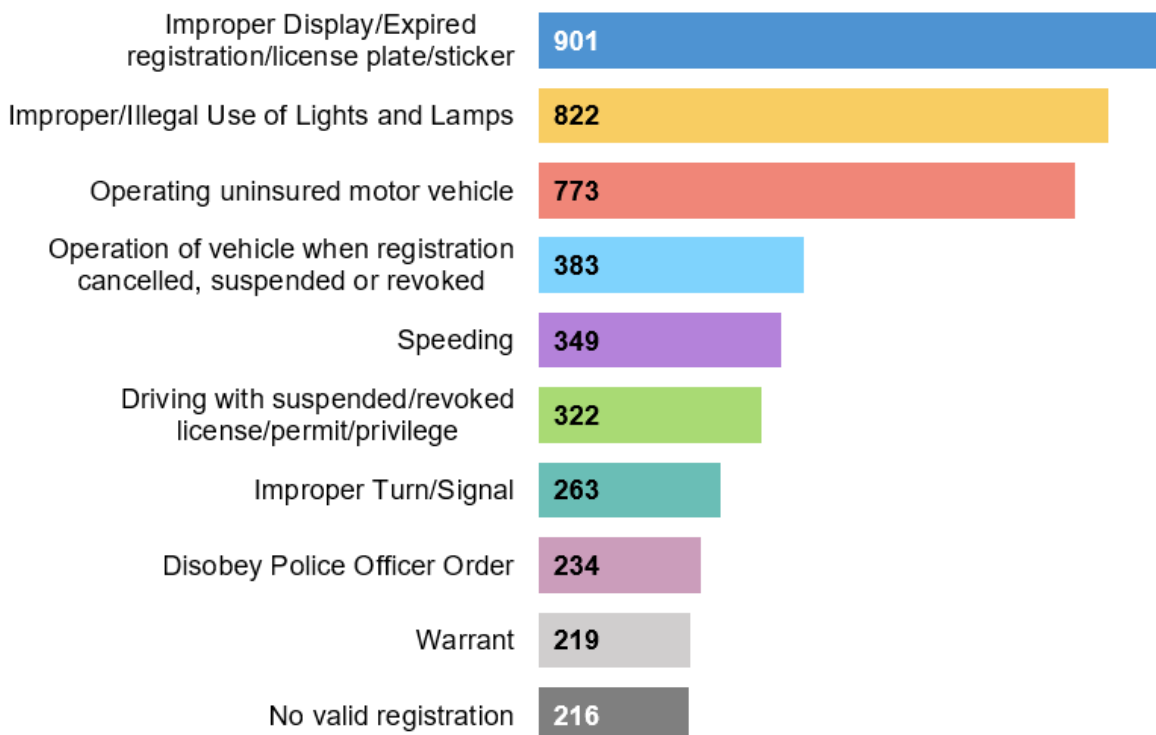

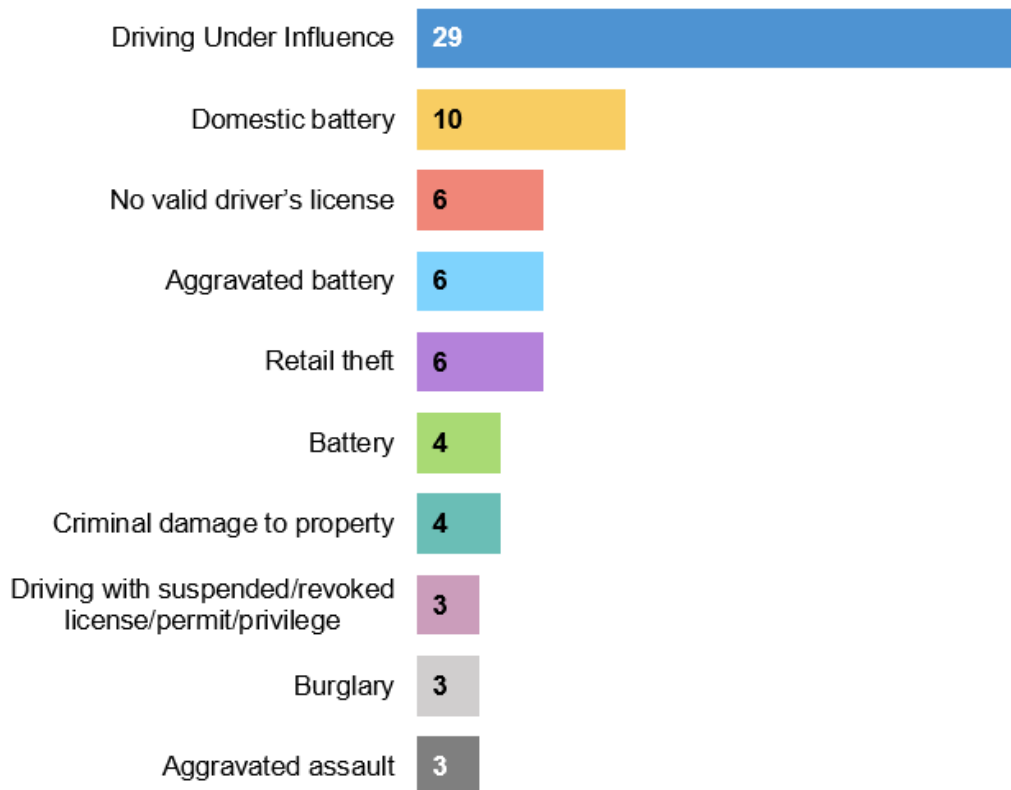

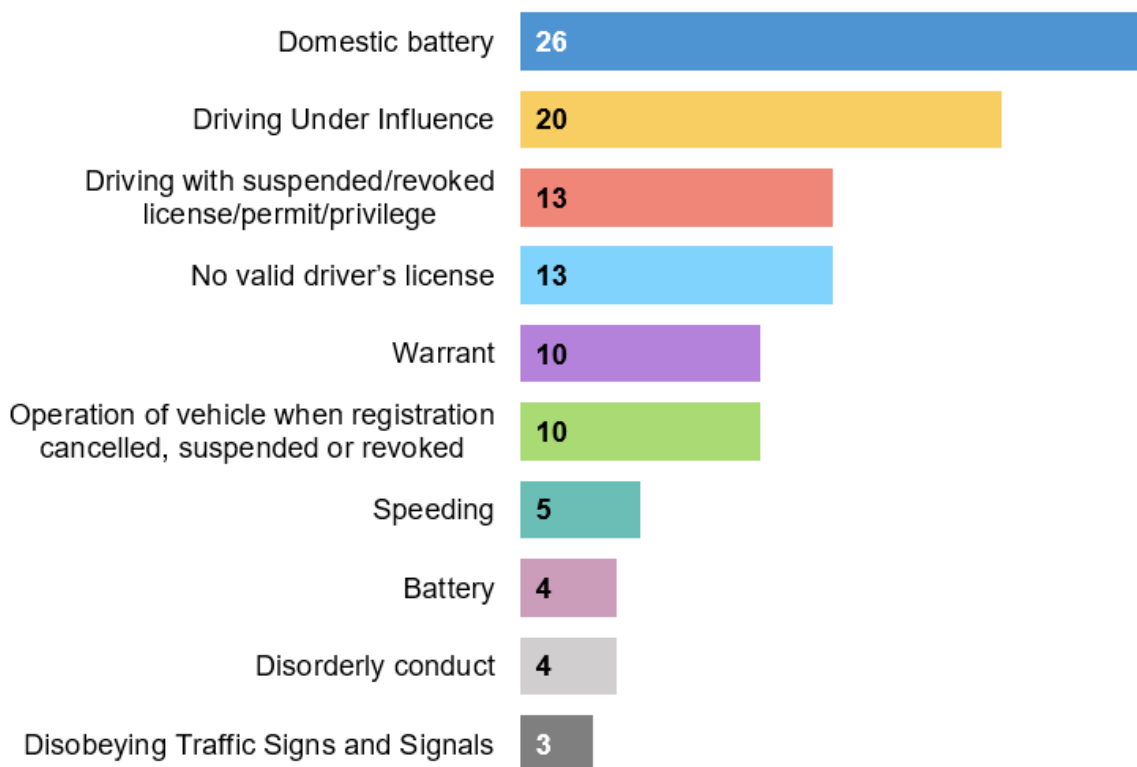

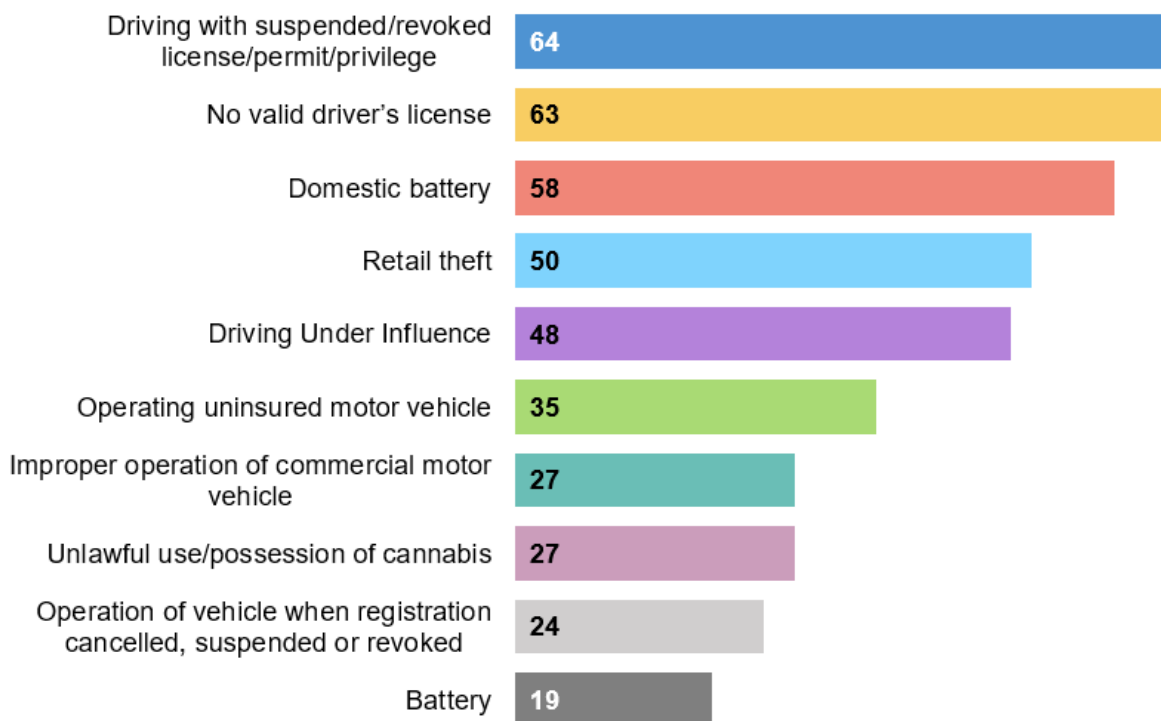

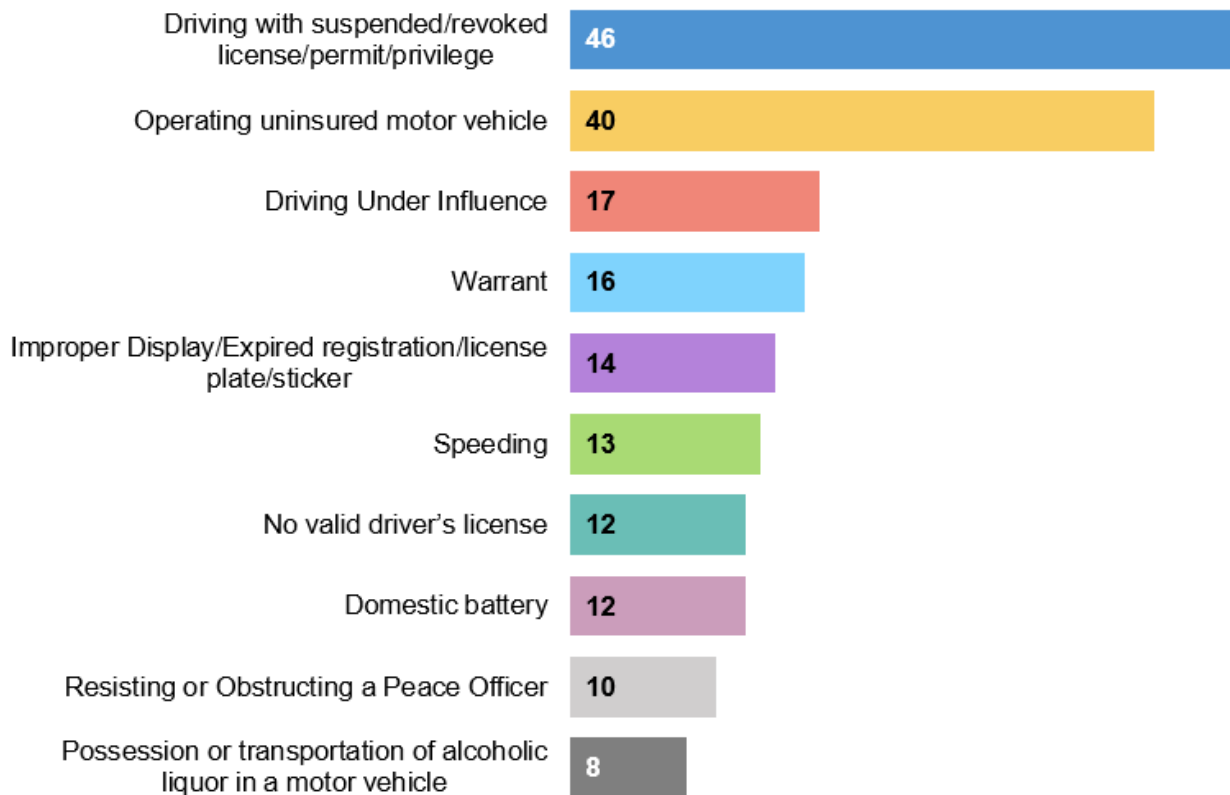

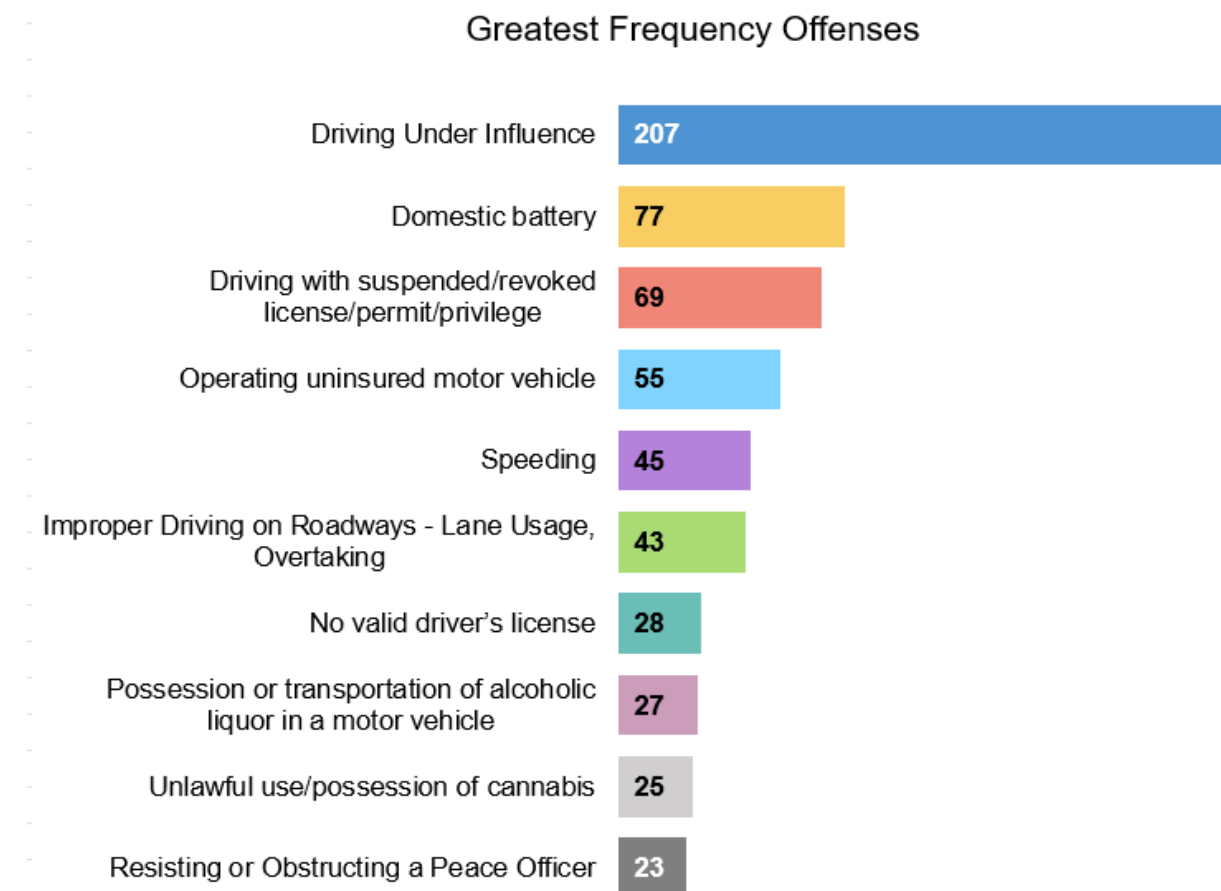

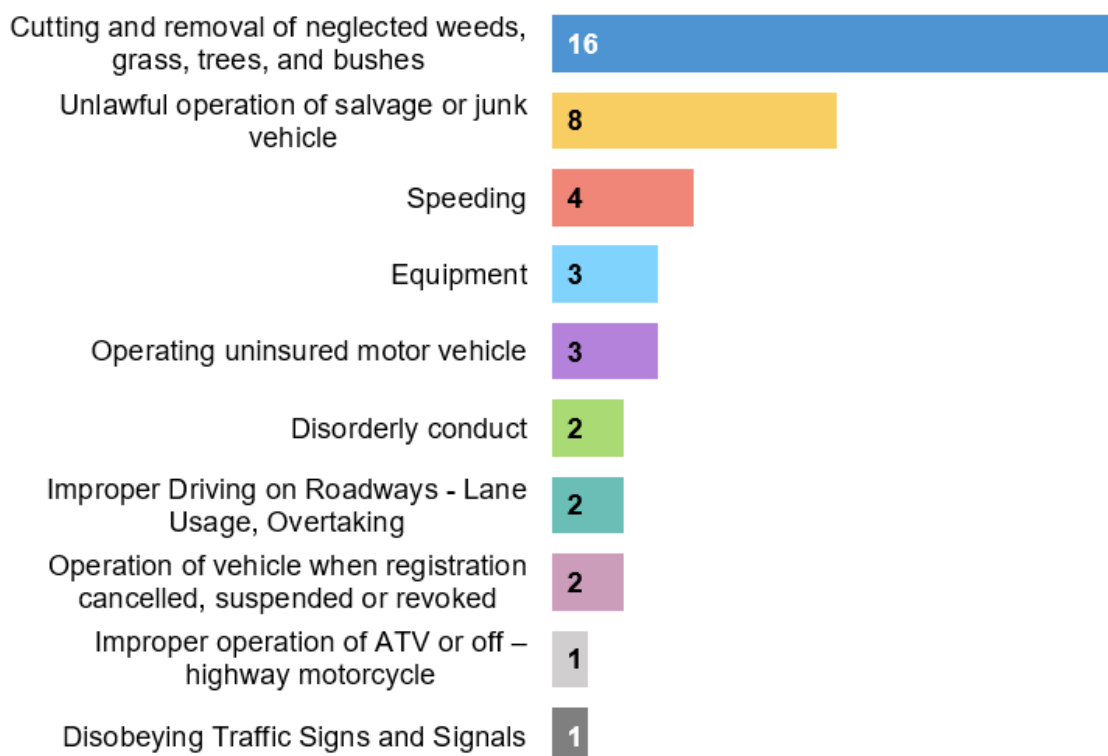

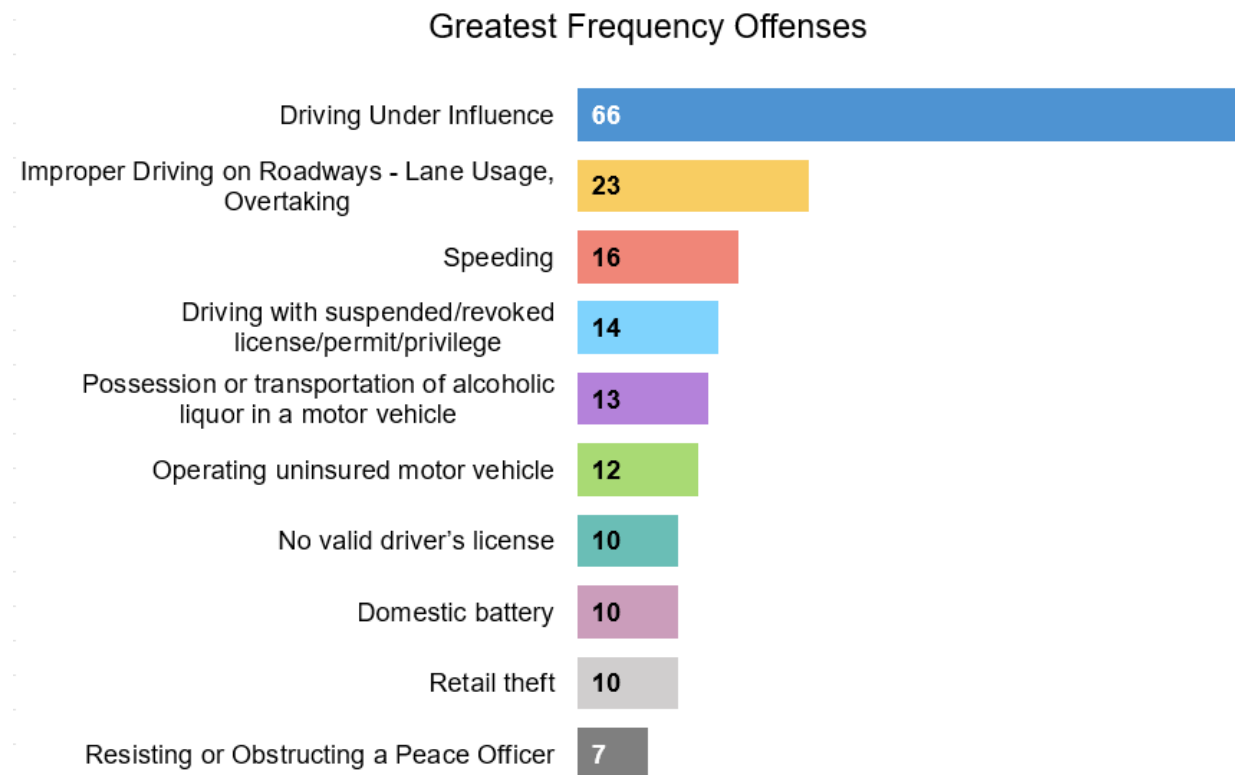

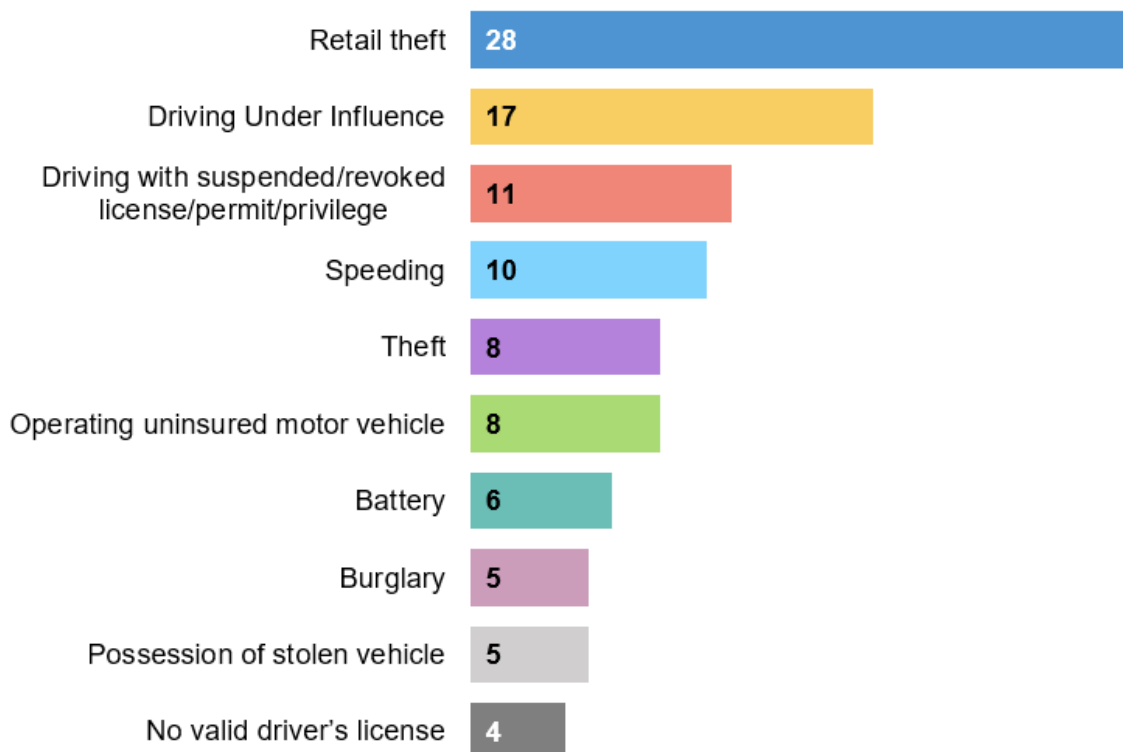

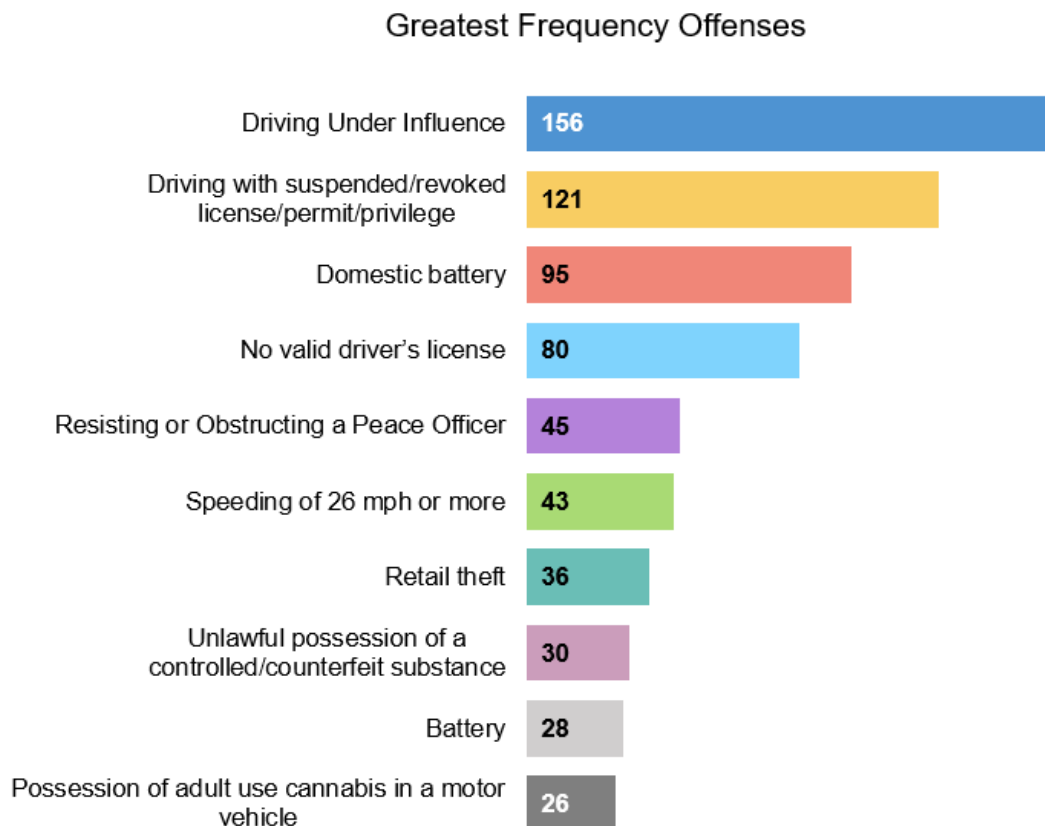

## Department Overview – Illinois Conservation Police Department

---

Illinois Conservation Police Department consists of one hundred fifty-six (156) sworn law enforcement personnel, each equipped with a Getac body-worn camera. An additional sixteen (16) spare cameras are maintained for use in the event of technical issues or damage. The department implemented the Body worn Camera Program on December 20, 2024.

### Technical Issues

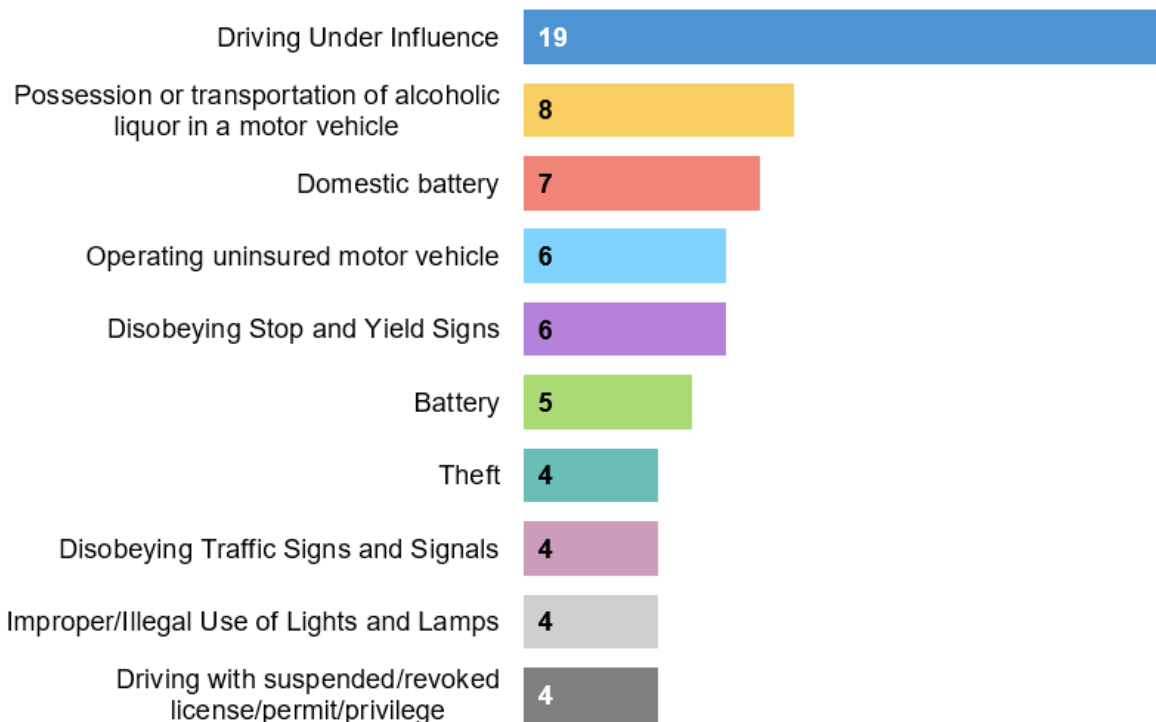

## Department Overview – Jackson County Sheriff's Office

Jackson County Sheriff's Office consists of thirty-three (33) patrol deputies, including five (5) full-time investigators, four (4) school resource officers, one (1) deputy assigned as an investigator to assist the Department of Children and Family Services, and three (3) administrative/command staff: the Patrol Captain, Lieutenant, and the Sheriff. 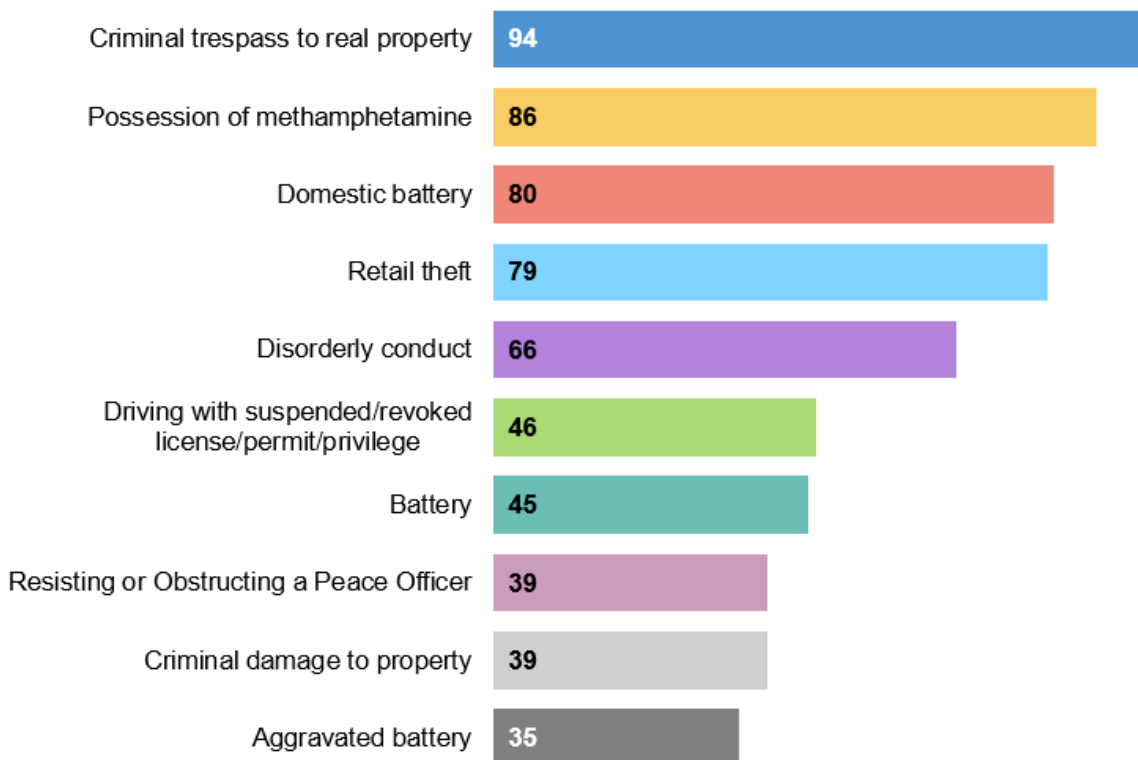

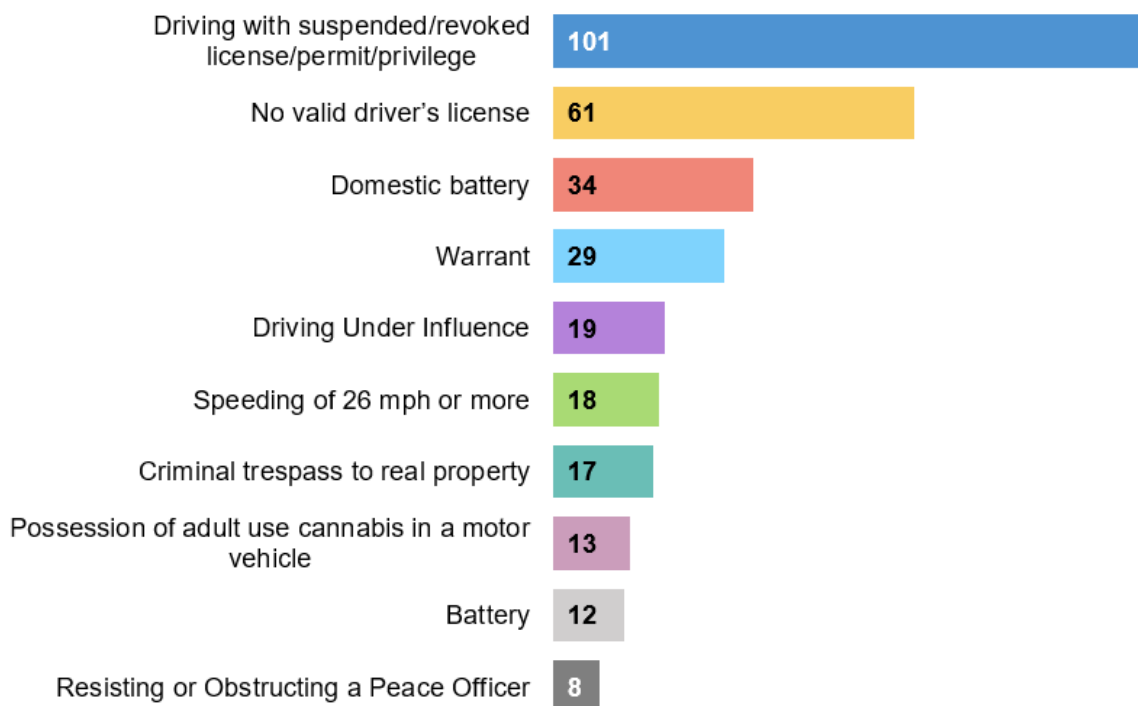

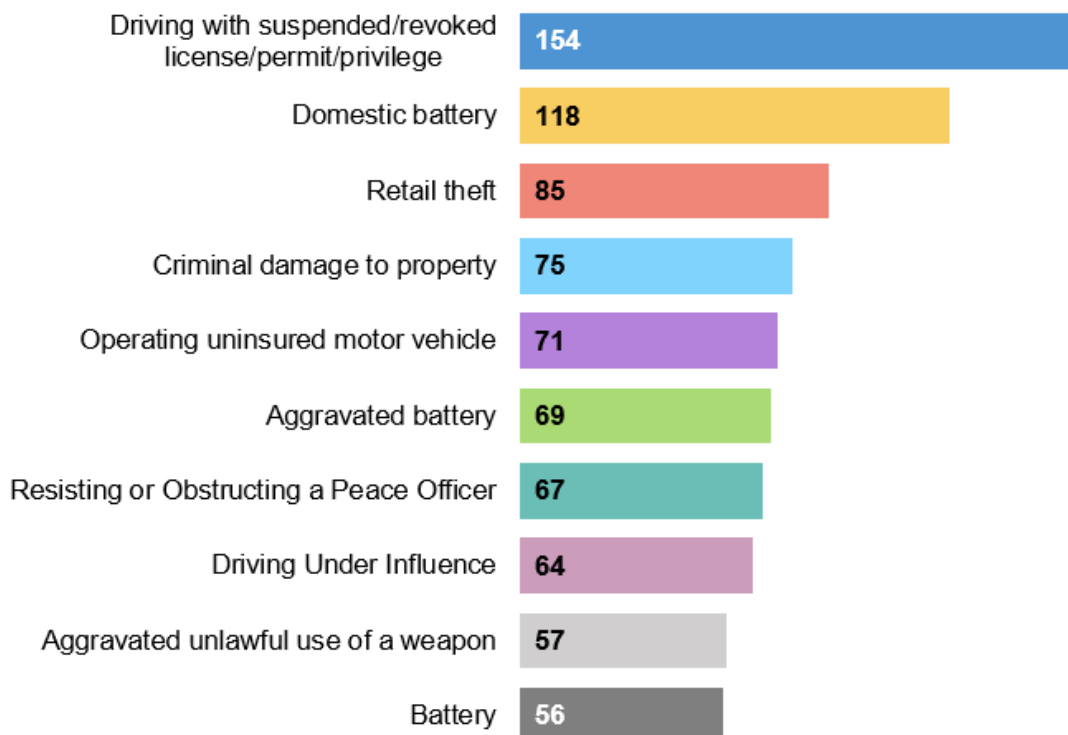

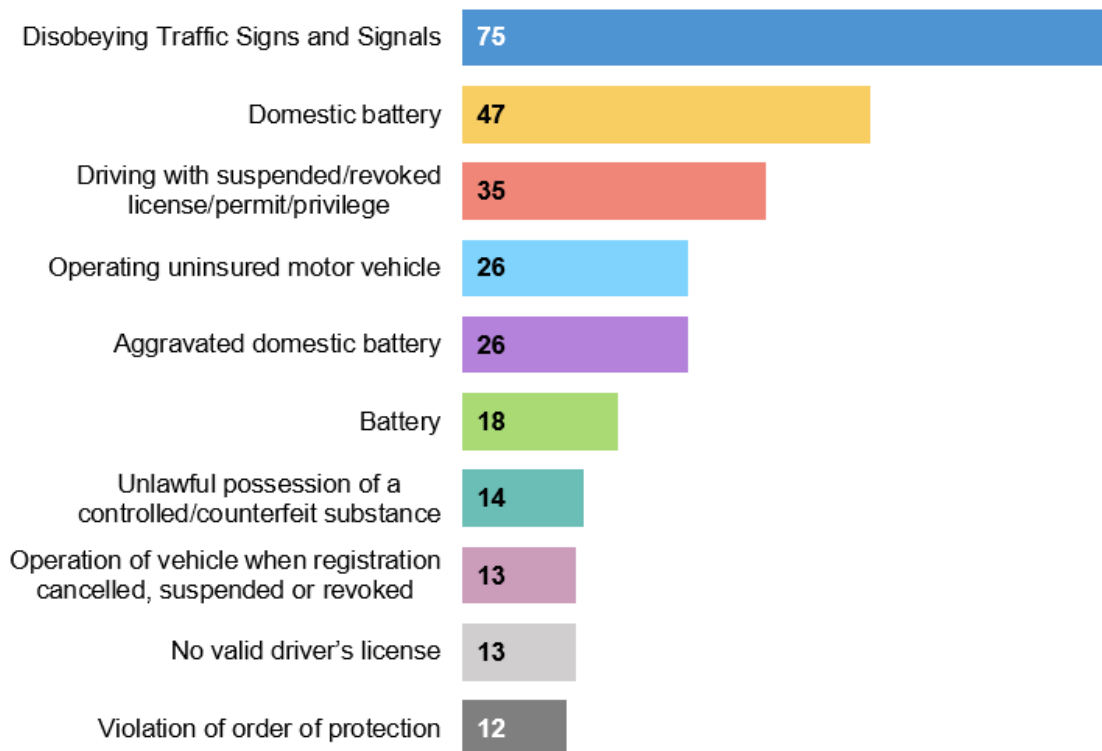

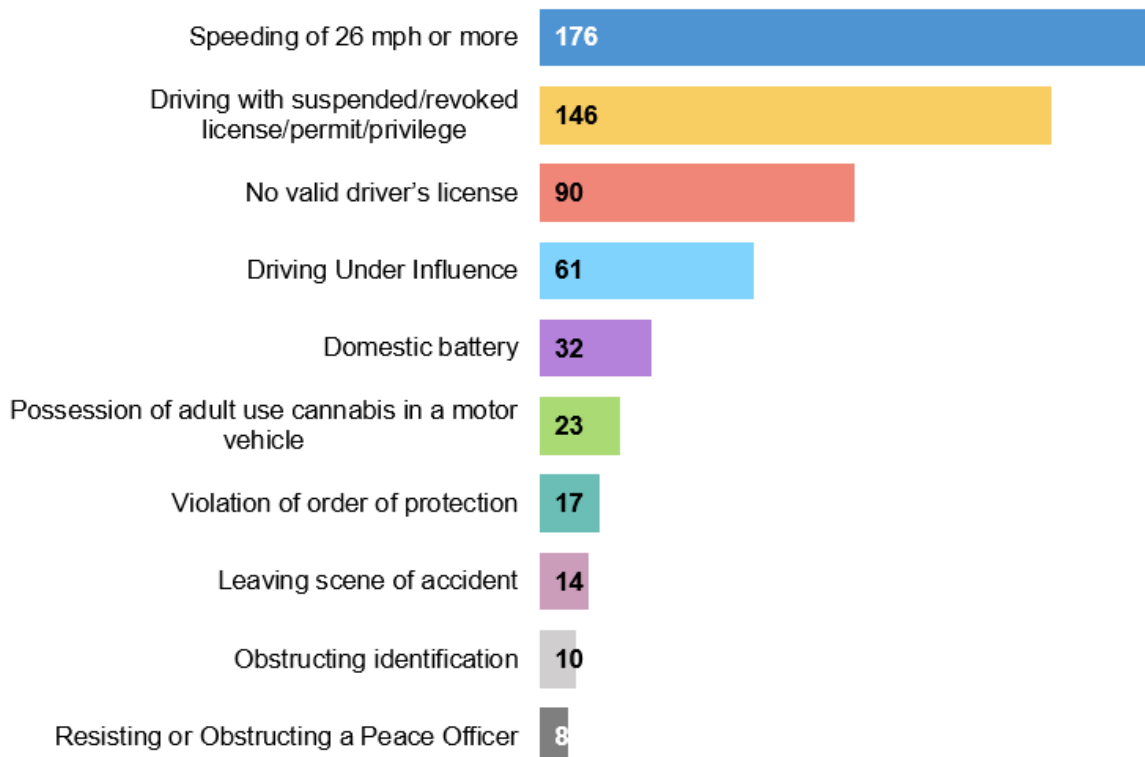

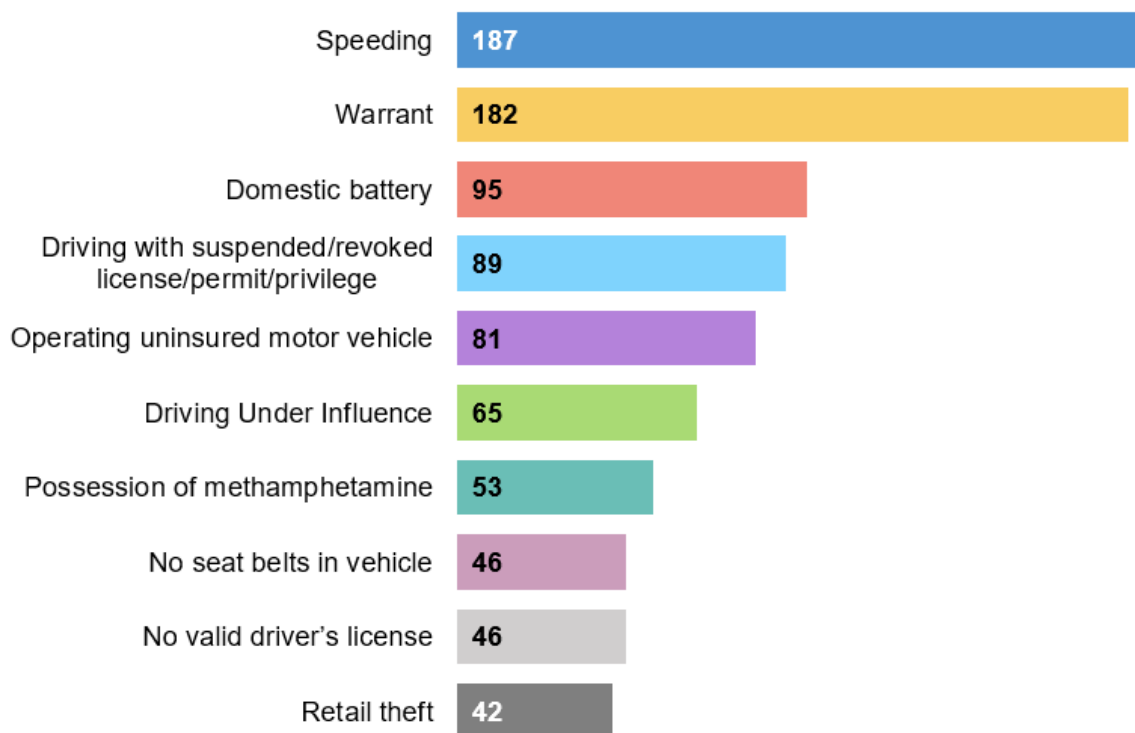

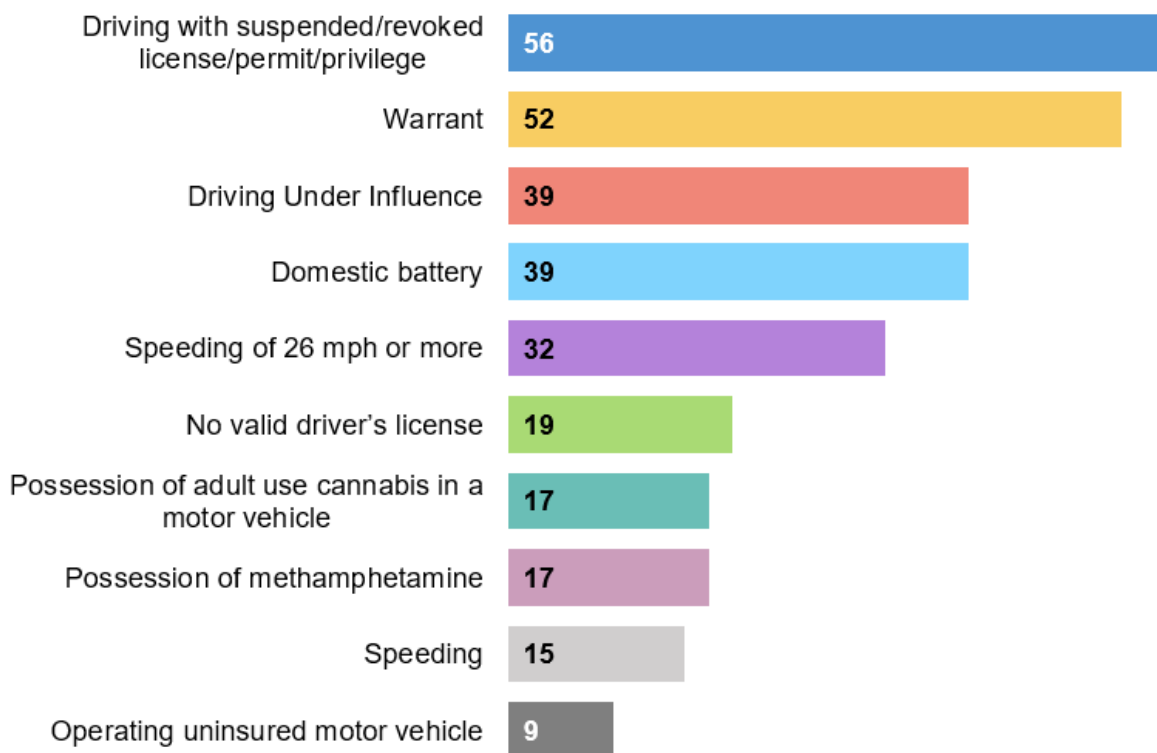

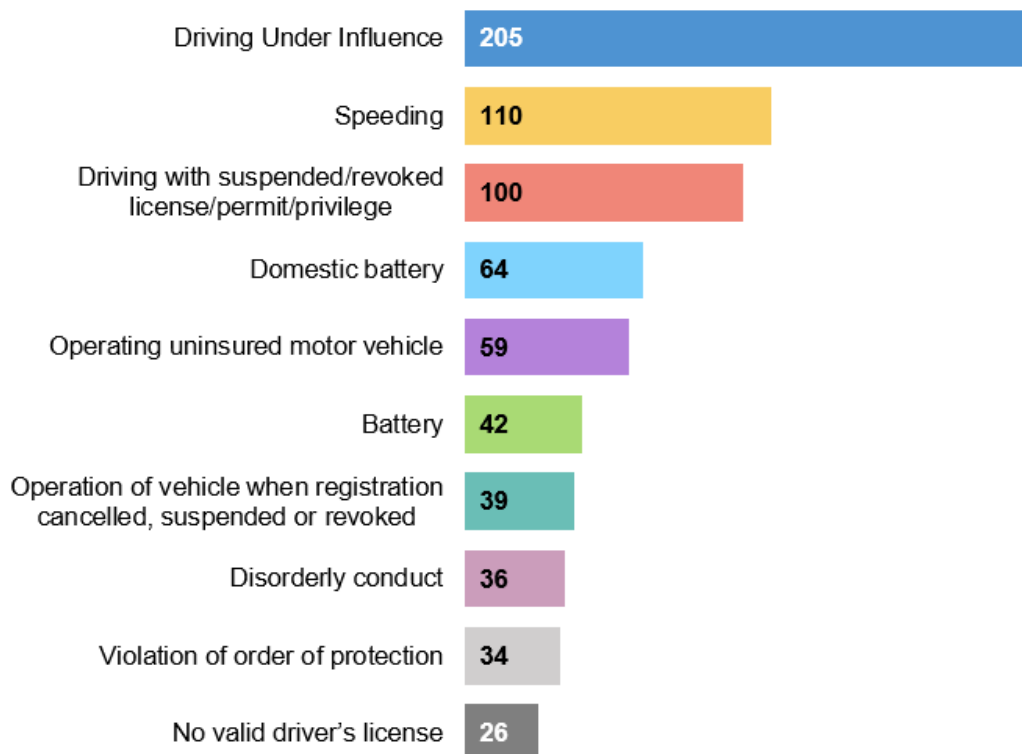

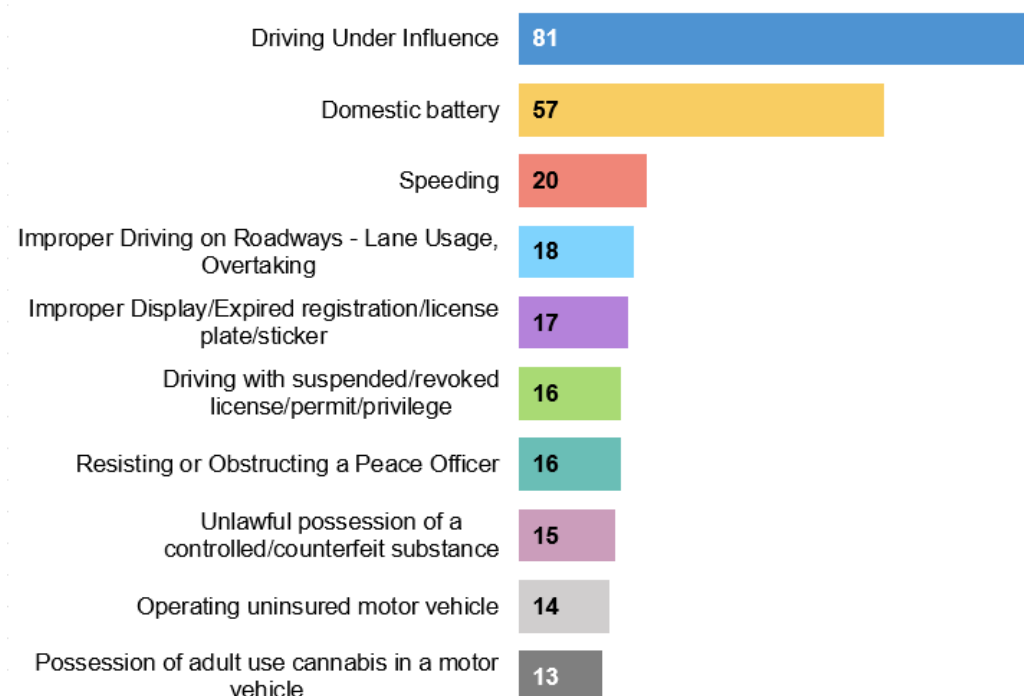

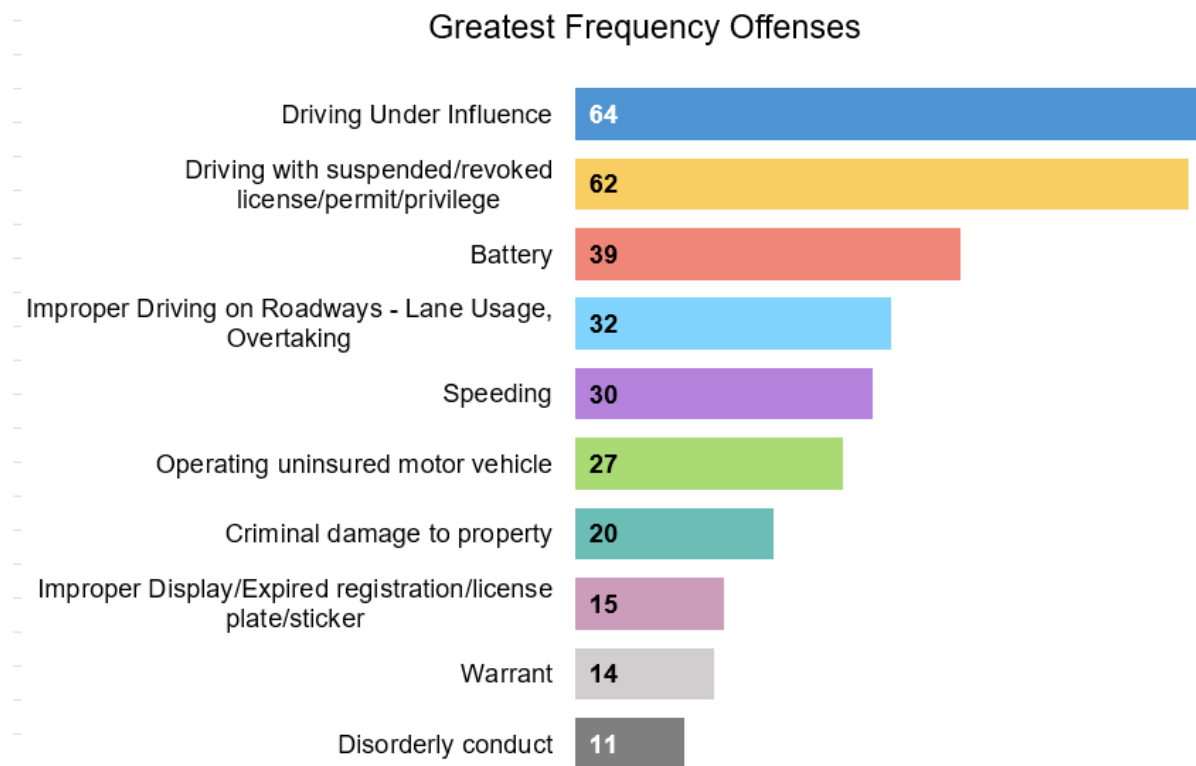

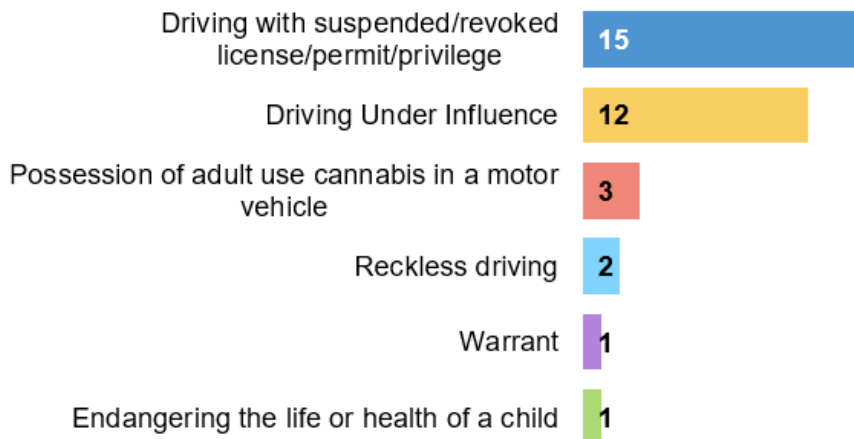

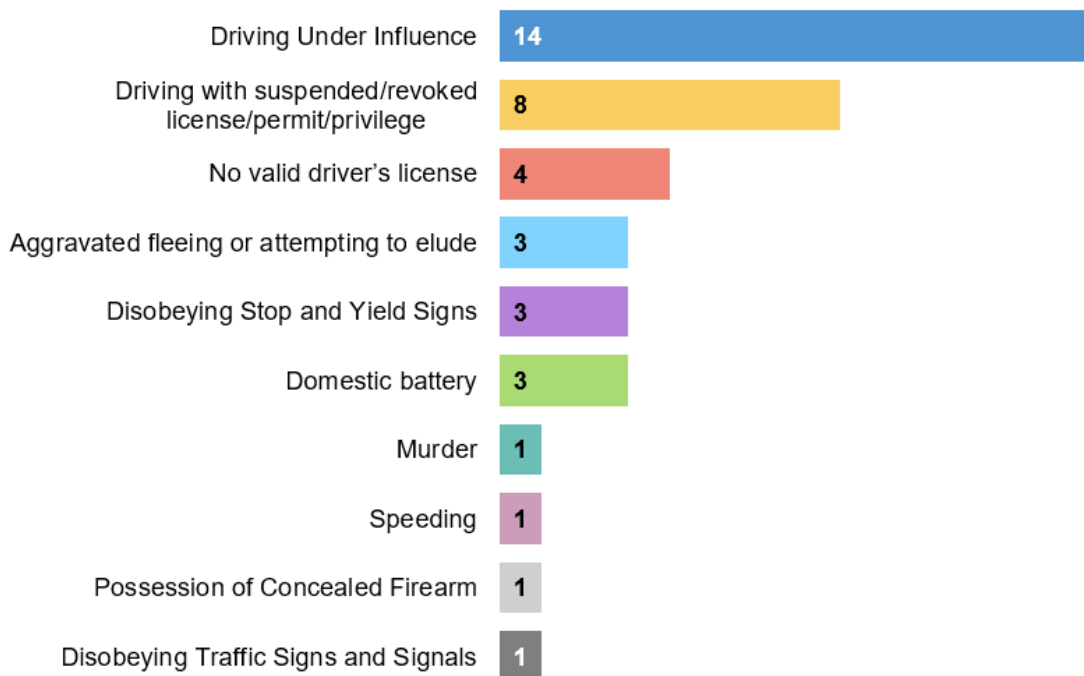

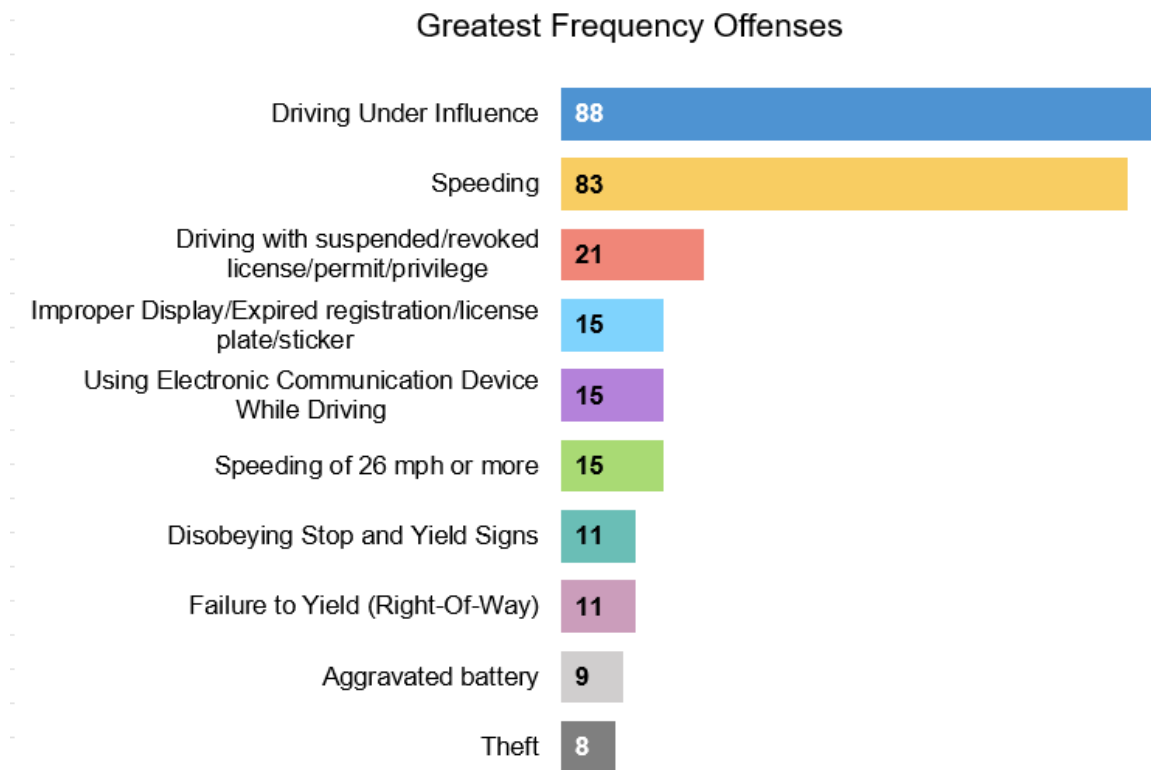

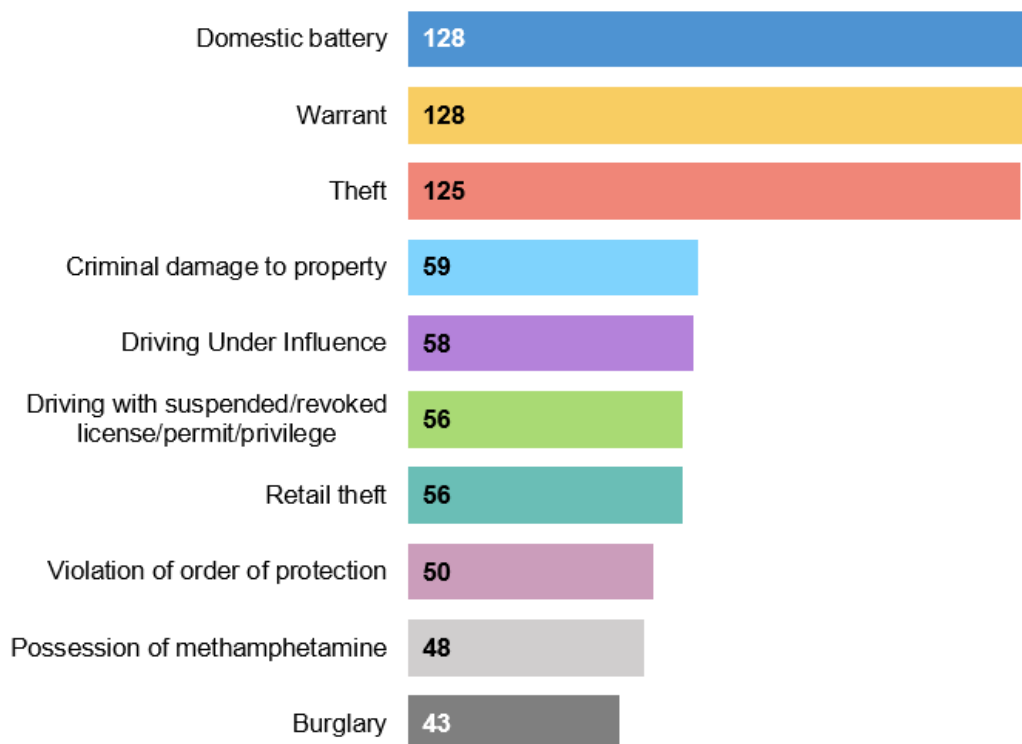

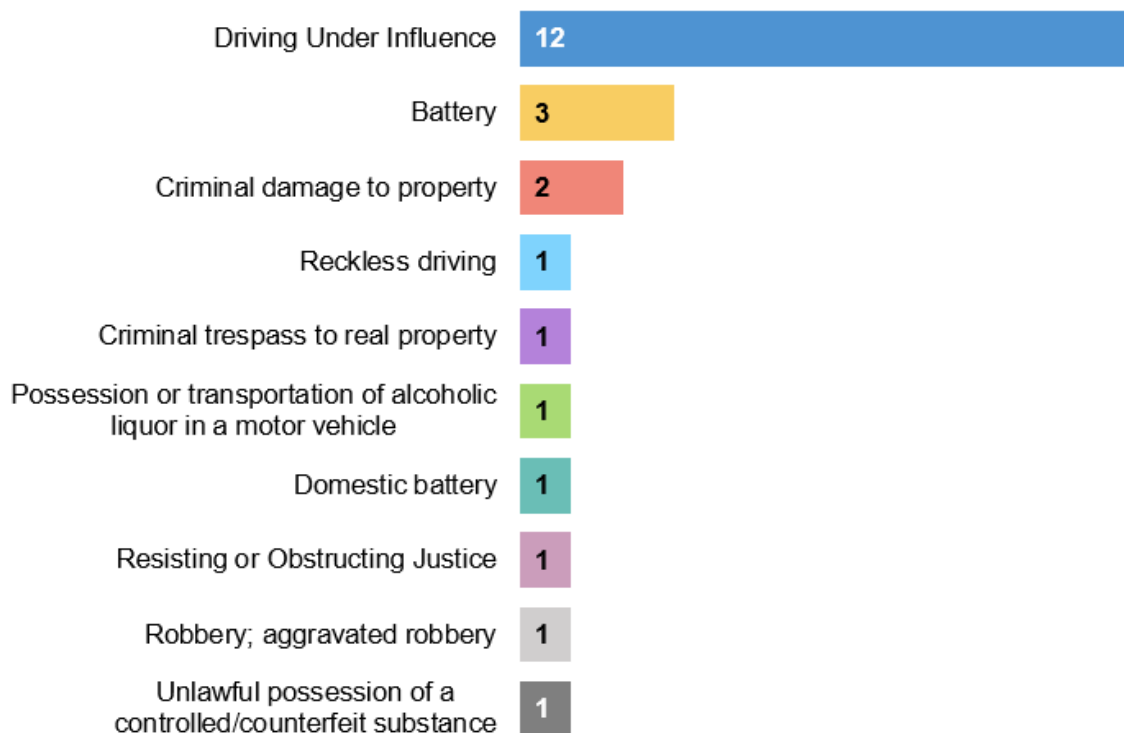

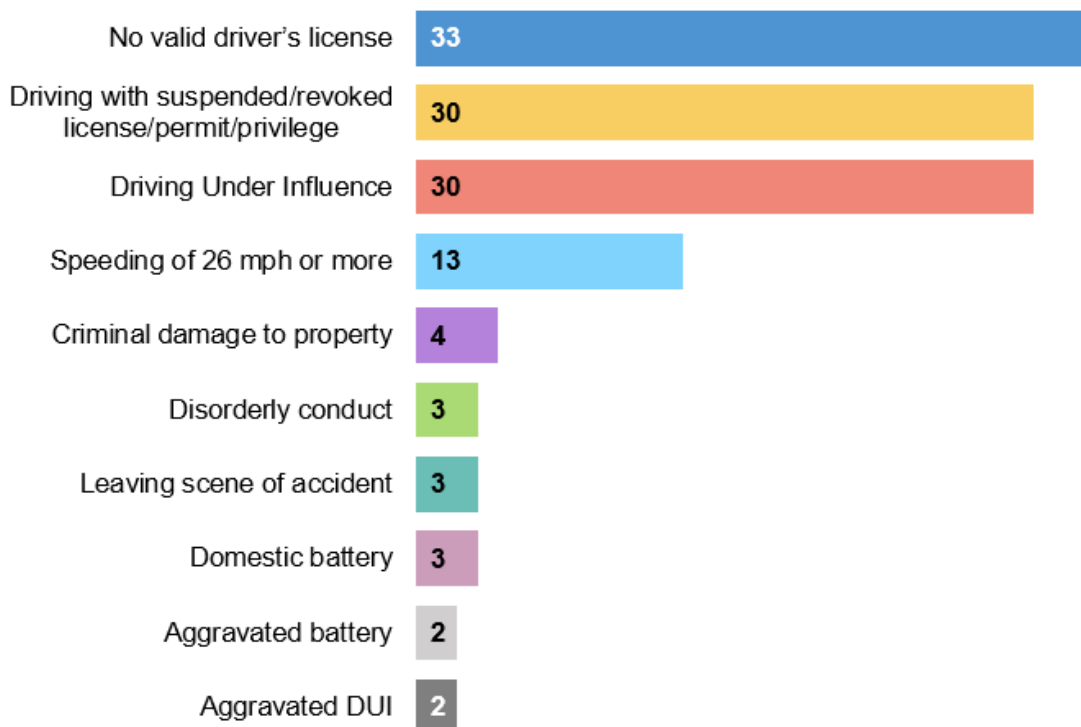

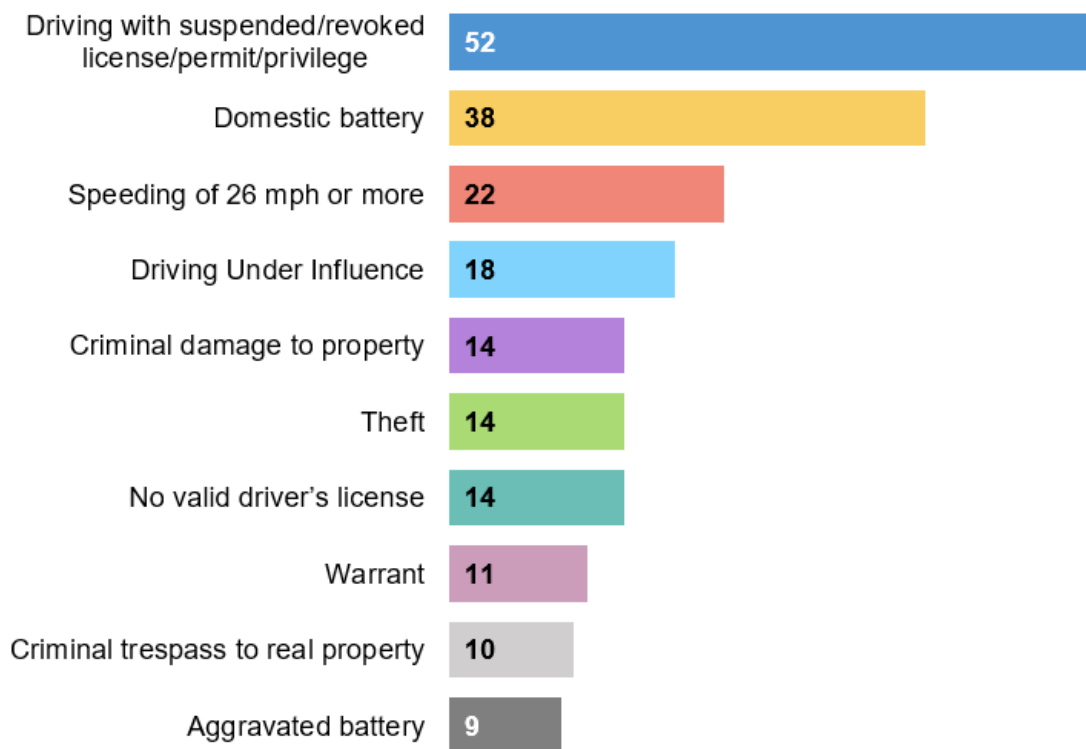

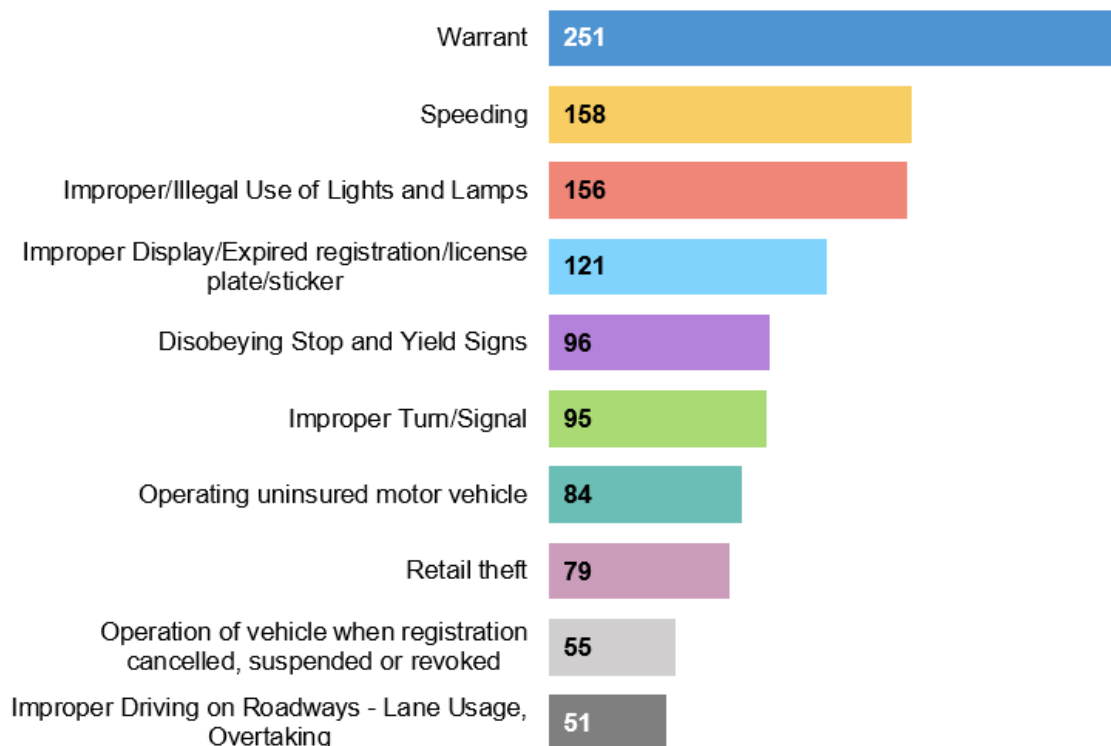

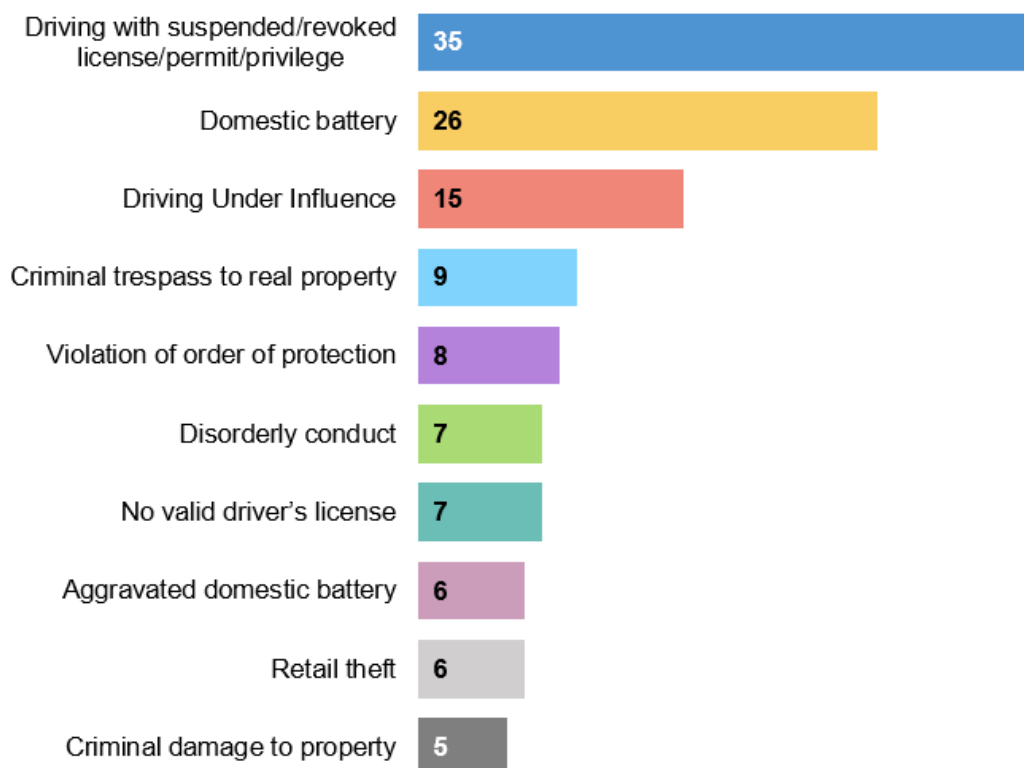

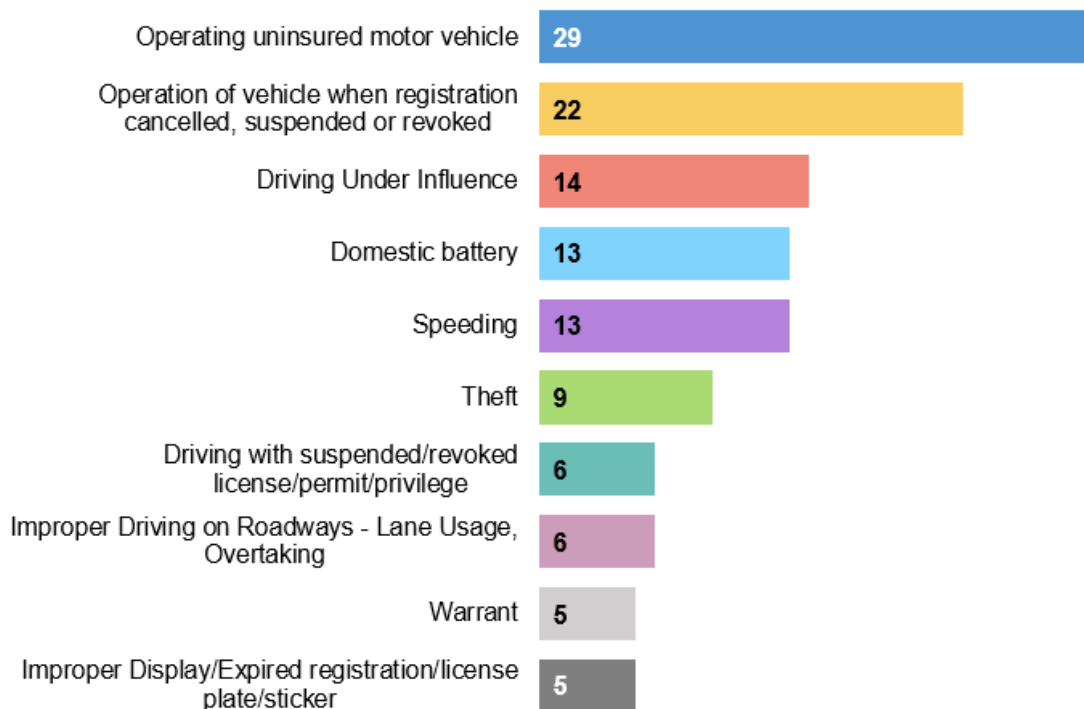

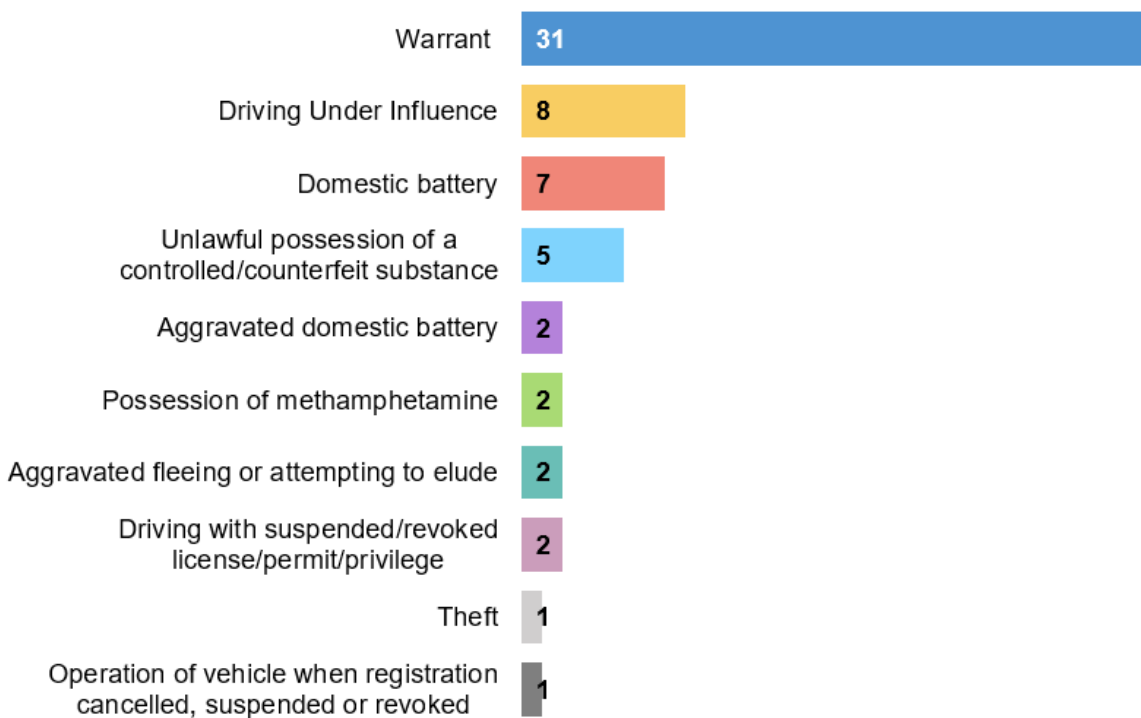

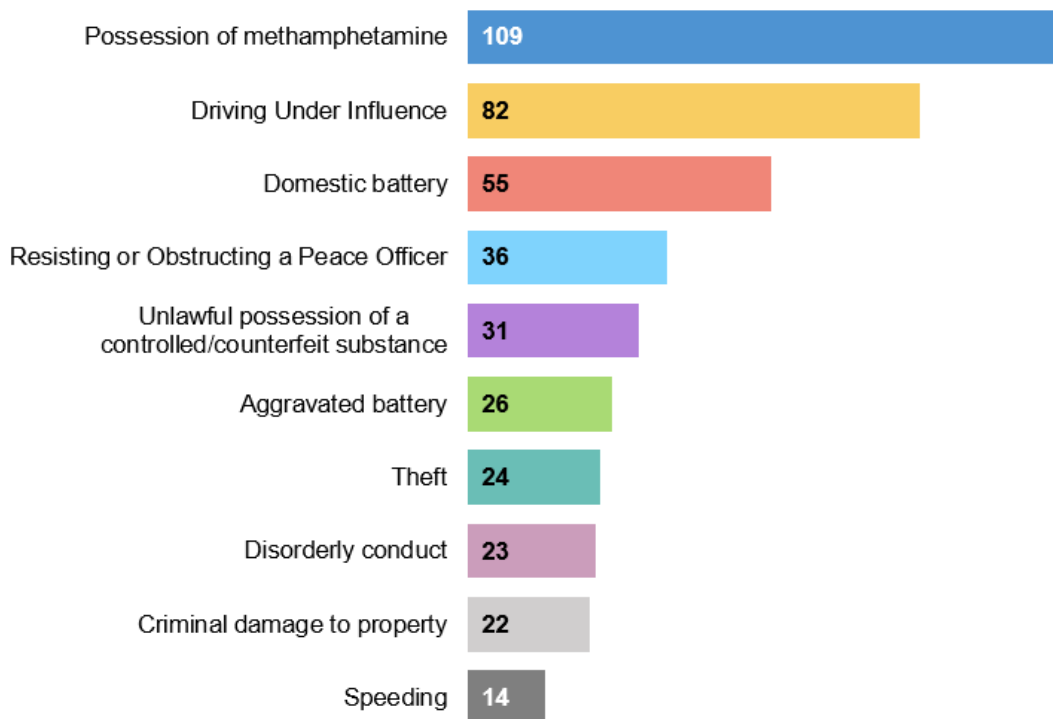

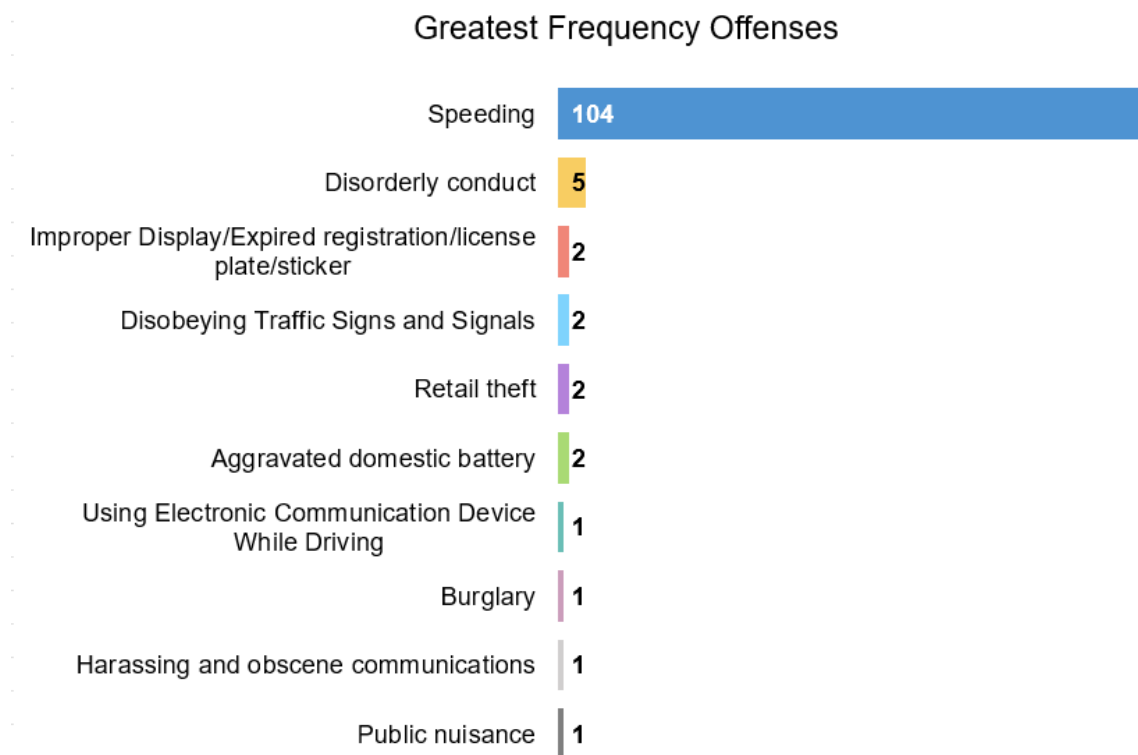

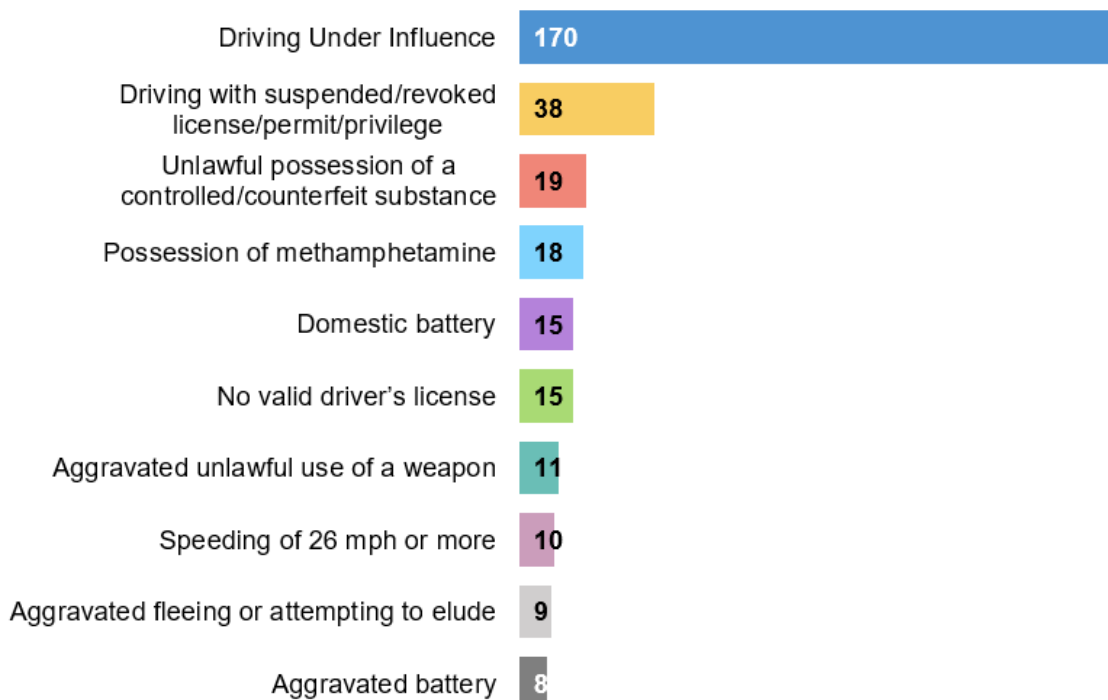

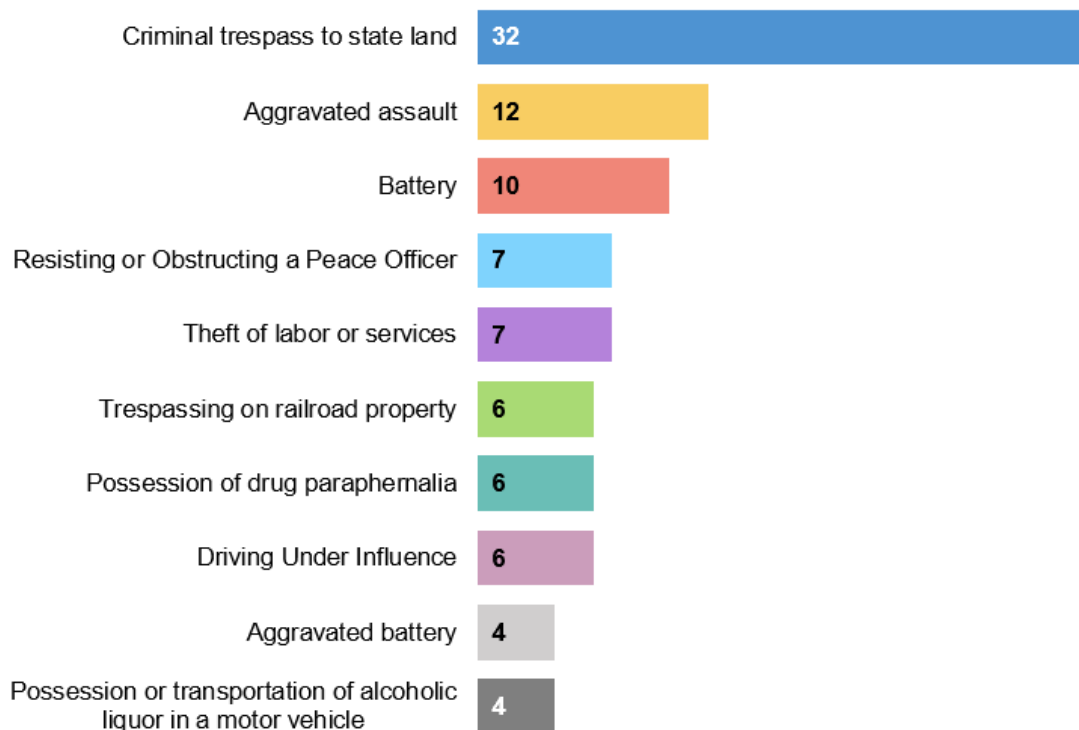

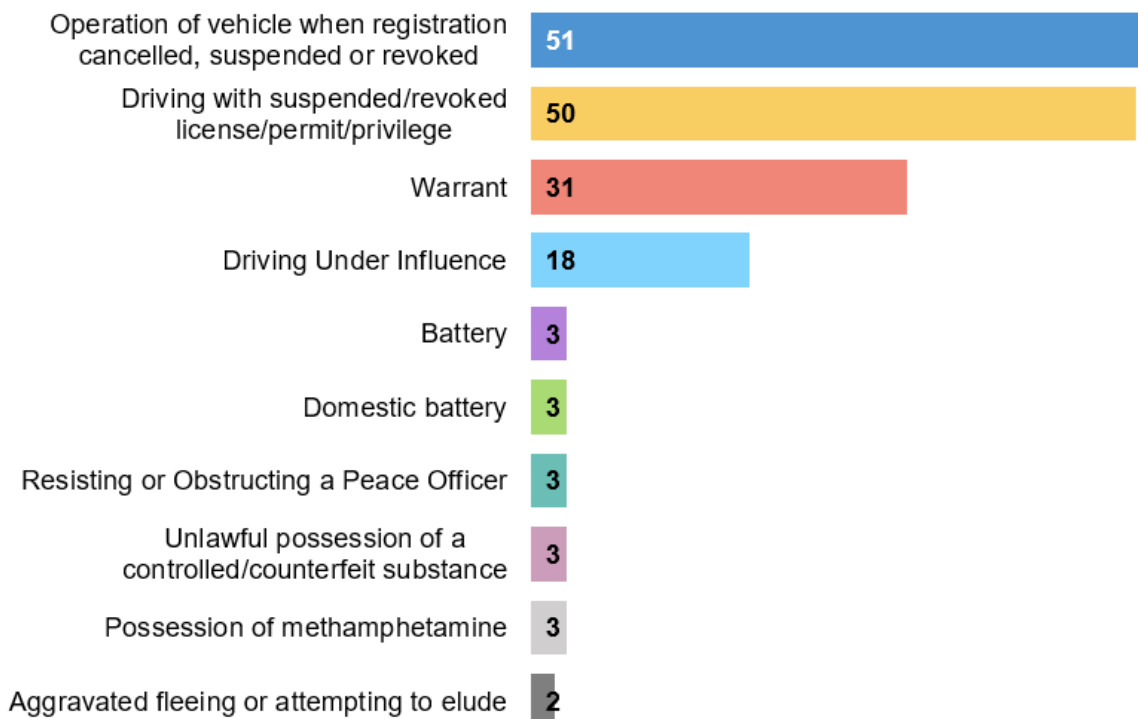

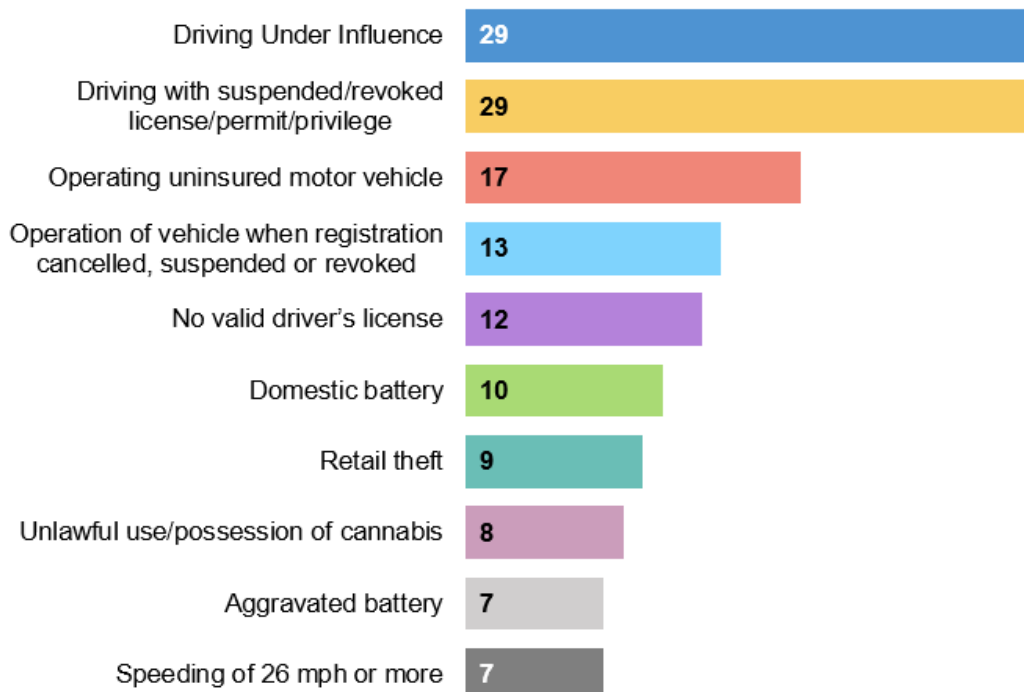

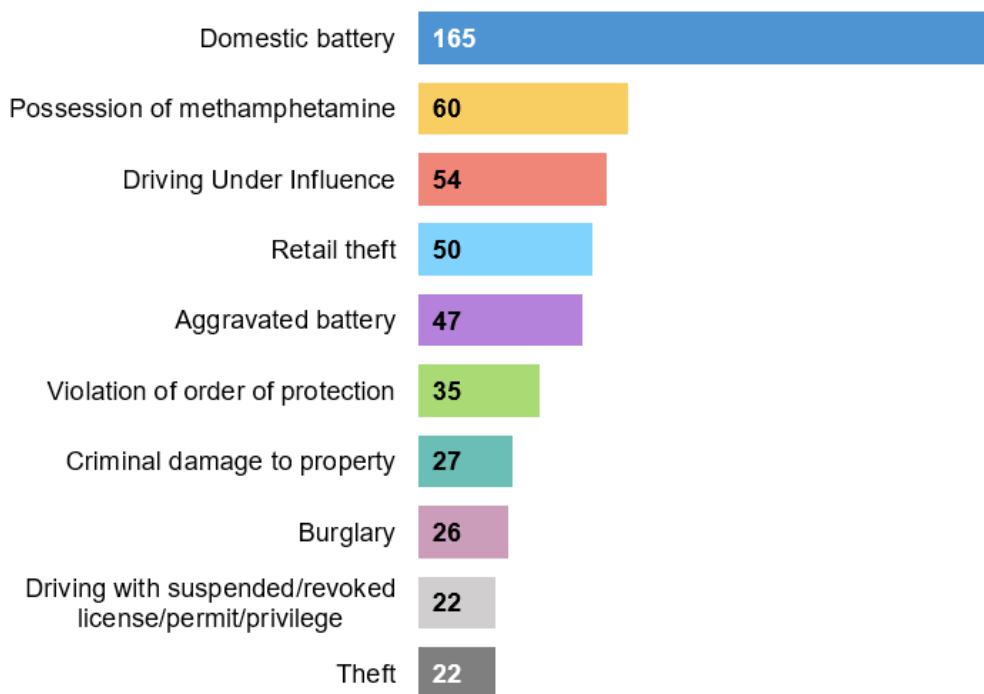

Supervisor of the recording member documents in the report or other documentation if the supervisor reviewed body worn camera recordings prior to completing the report or other documentation.

### Incidents

Between January 01, 2024, and December 31, 2024, Momence Police Department reports responding to three thousand six hundred fifty-five (3,655) calls for service but does not include individual incident data. The top five (5) offenses charged include miscellaneous traffic offenses, driving under the influence of alcohol, driving while license/revoked, no valid driver's license, and domestic battery.

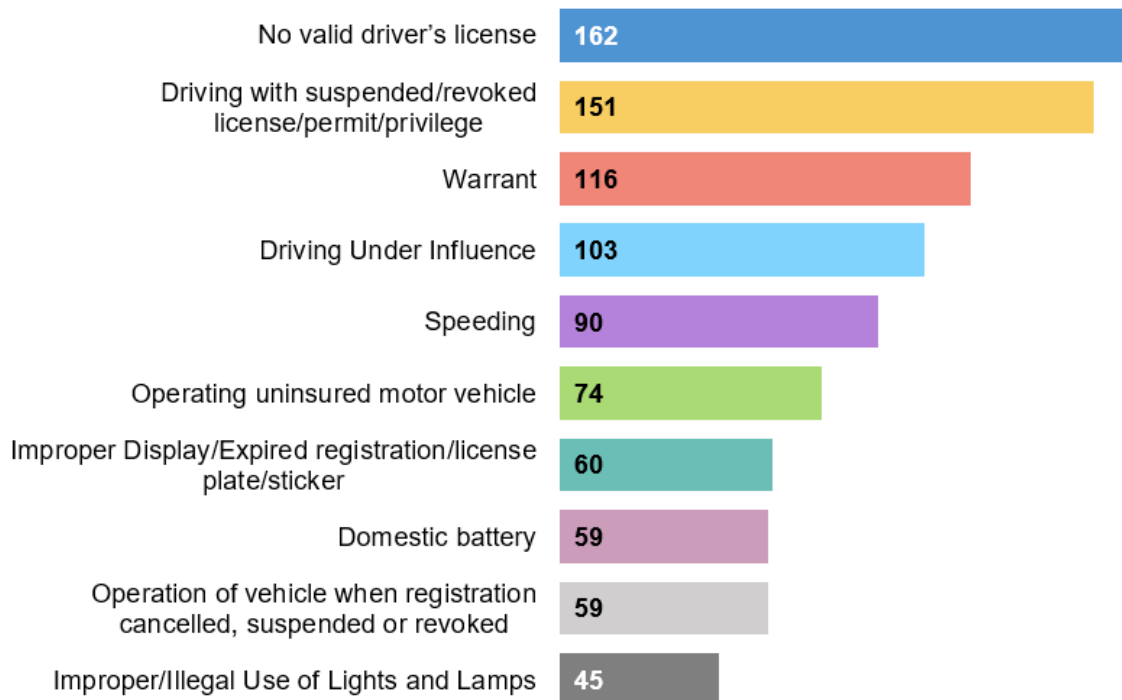

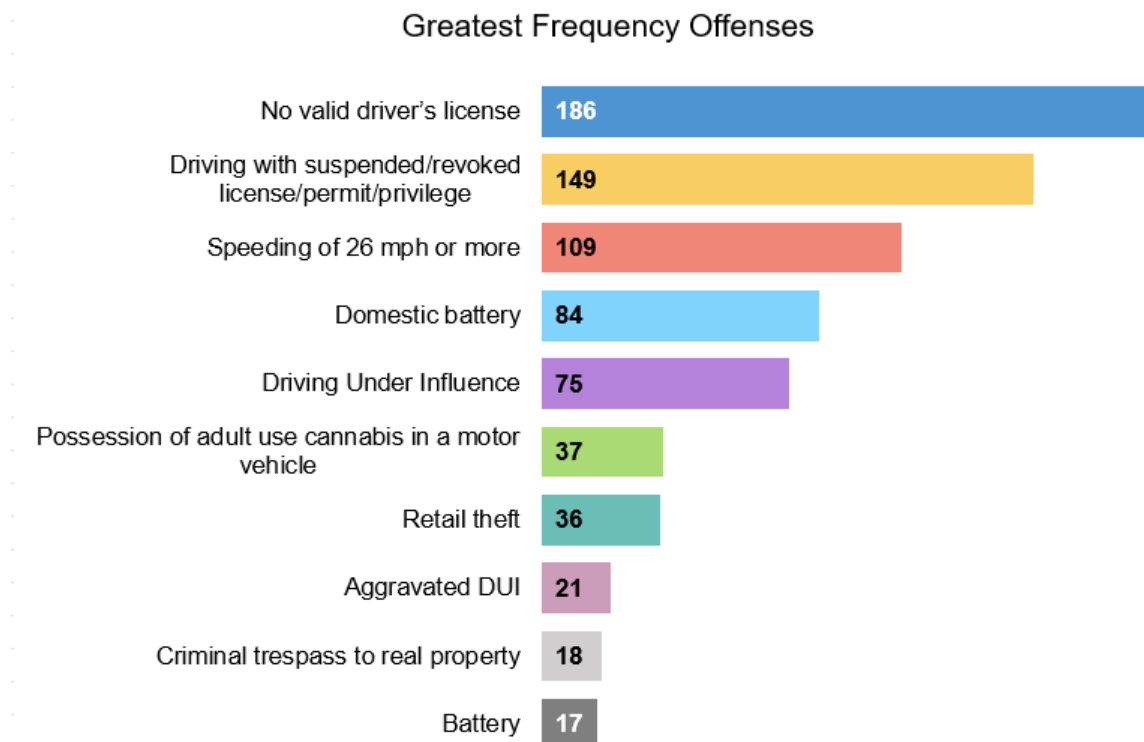

Supervisory personnel are required at a minimum to review two (2) body worn camera videos (one traffic stop and one call for service) for each of their assigned personnel monthly and address any issues noted during the review with the officer in question.

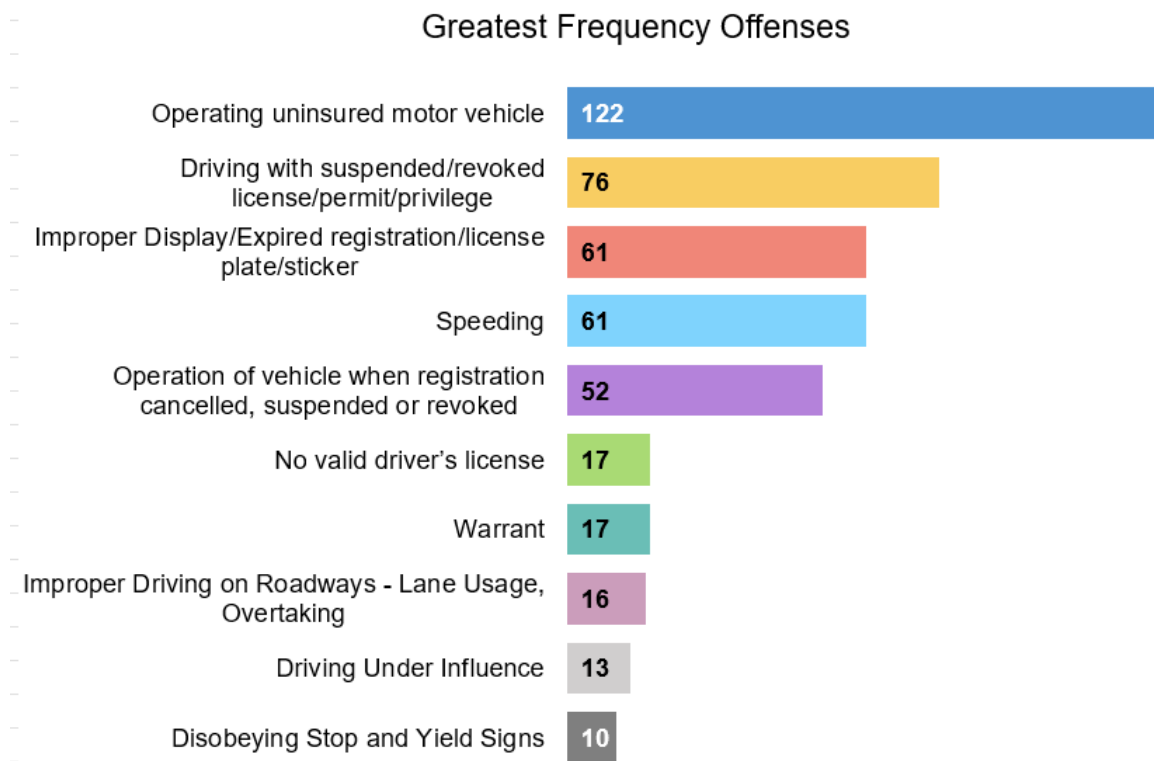

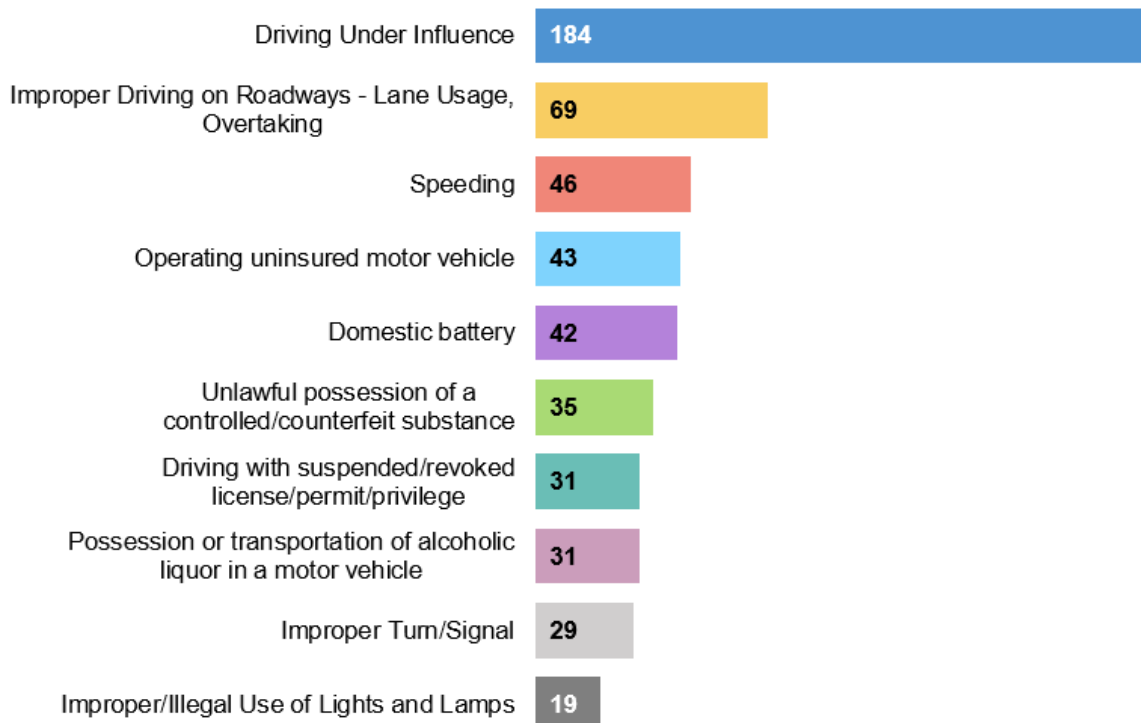
### Review Process

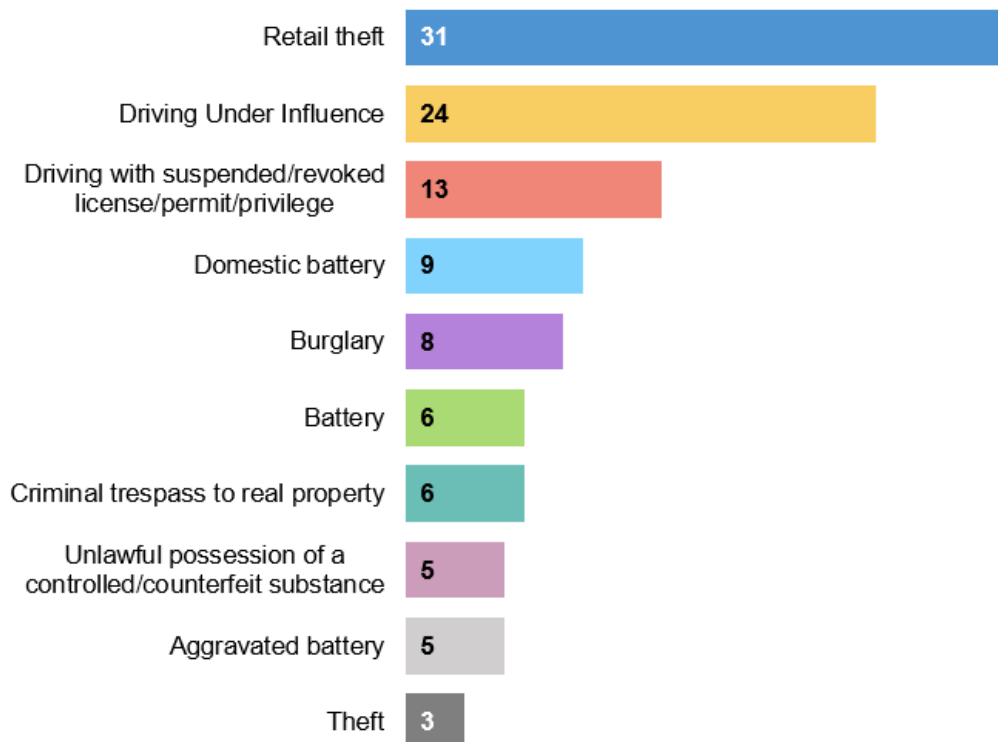

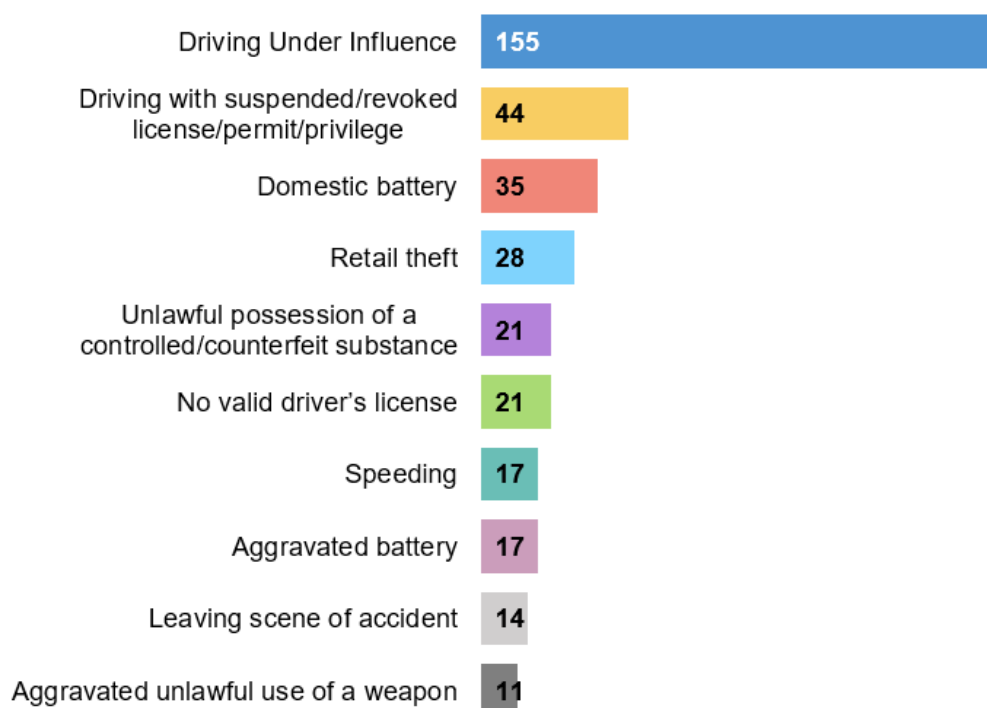

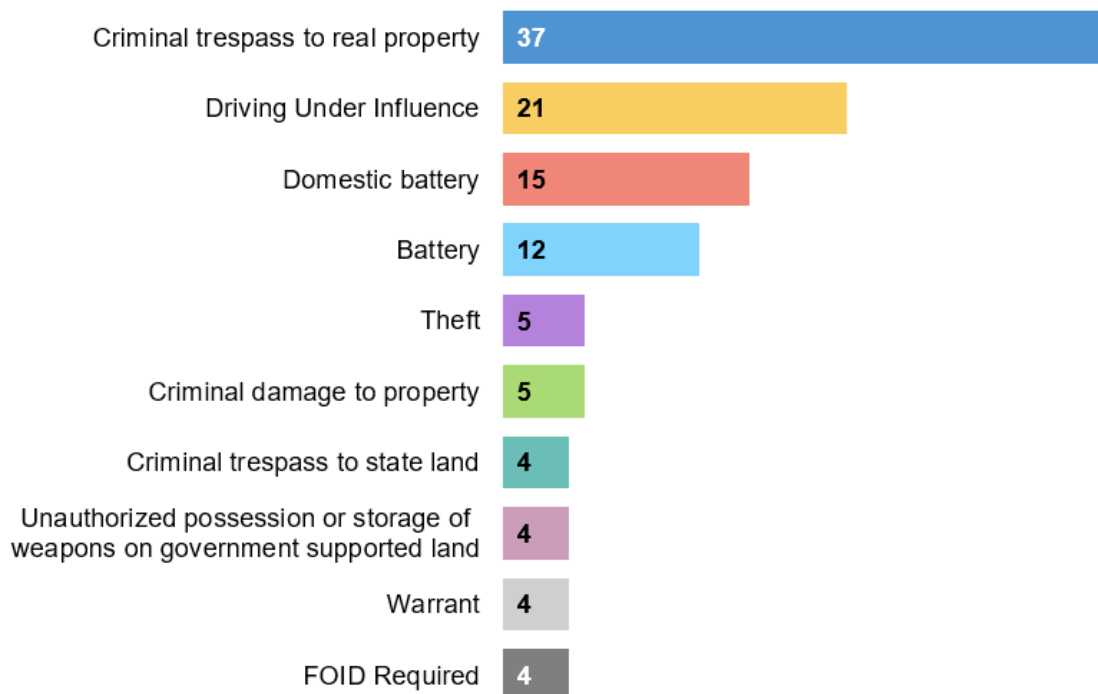

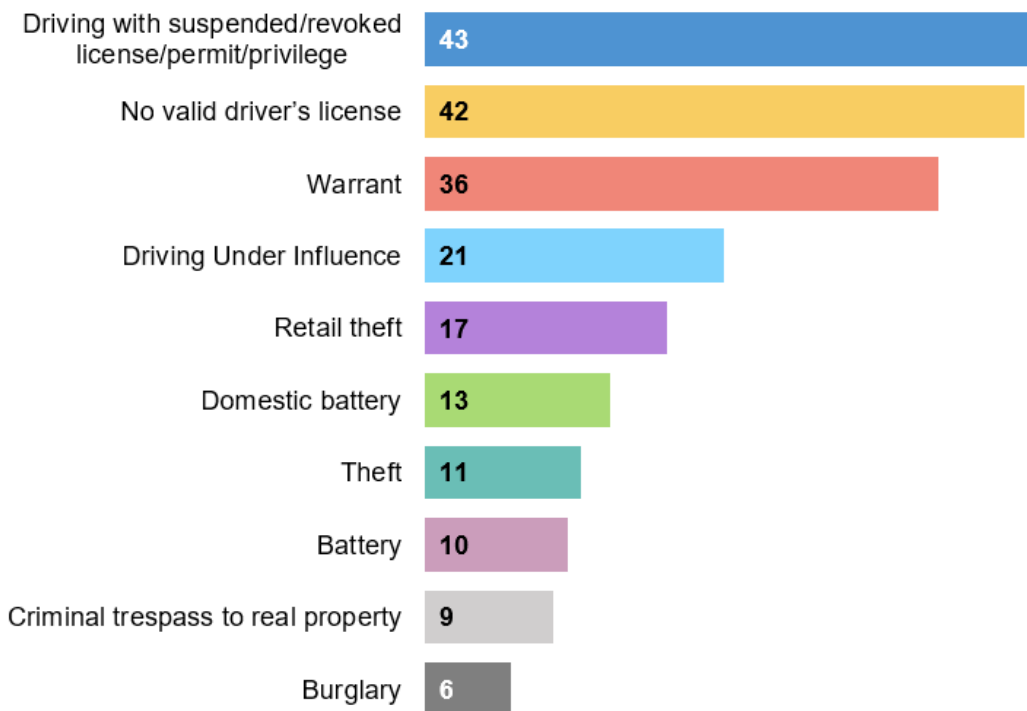

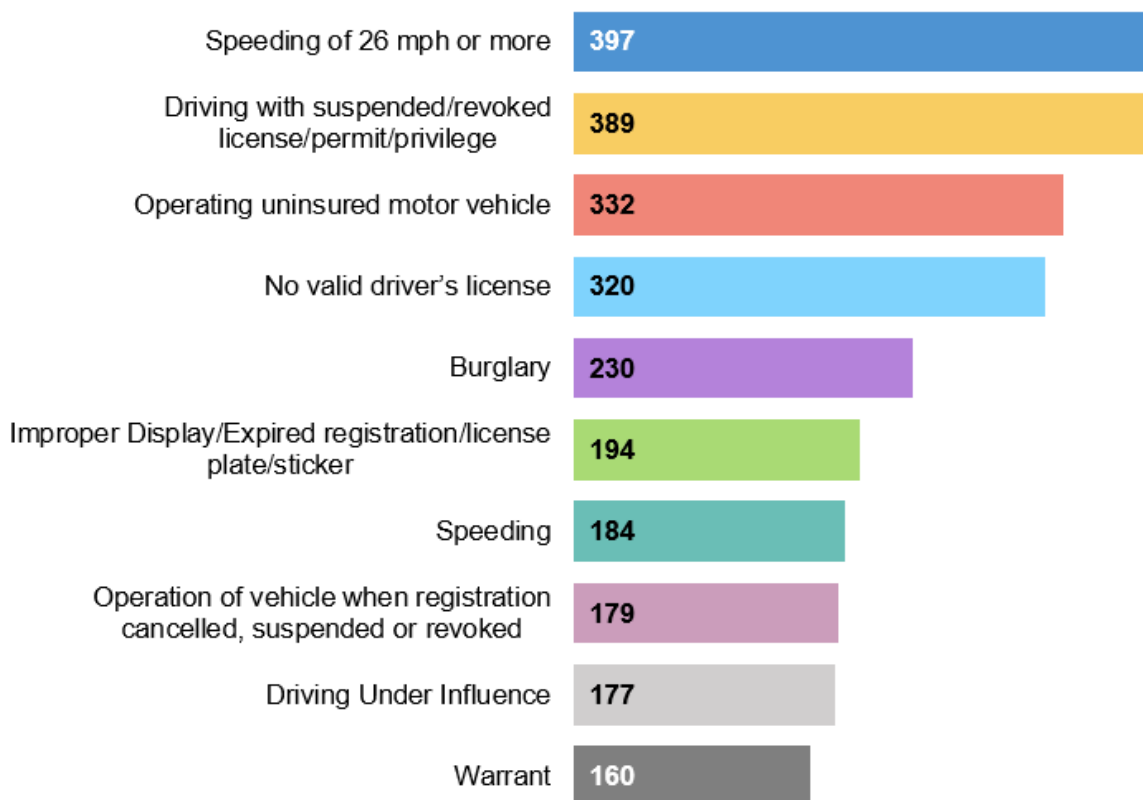

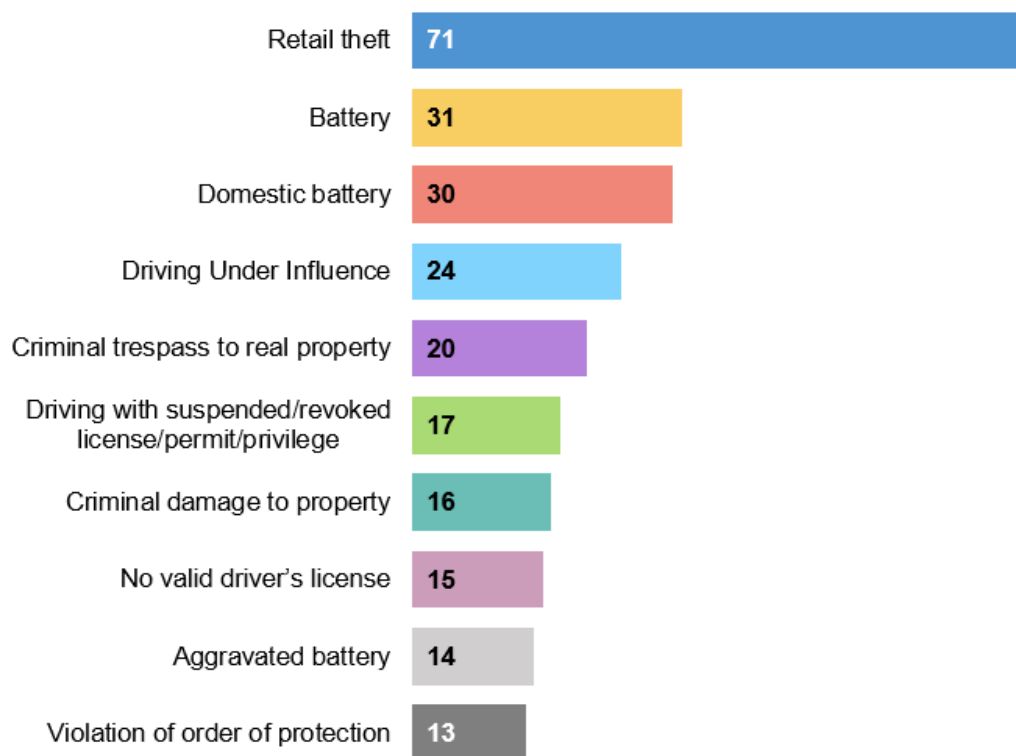
### Review Process

Oak Park Police Department's supervisors review body worn camera footage when an officer's actions necessitate a supervisor's review. This review is mandatory and applies to, but is not limited to, the situations such as, use of force incidents, pursuit situations, officer-involved traffic crashes, and cases of officer injury. Additionally, all video footage is reviewed before being released in response to subpoenas and Freedom of Information Act (FOIA) requests.

Oakbrook Terrace Police Department reports minor issues with body worn cameras including occasional accidental activation which was easily remedied.

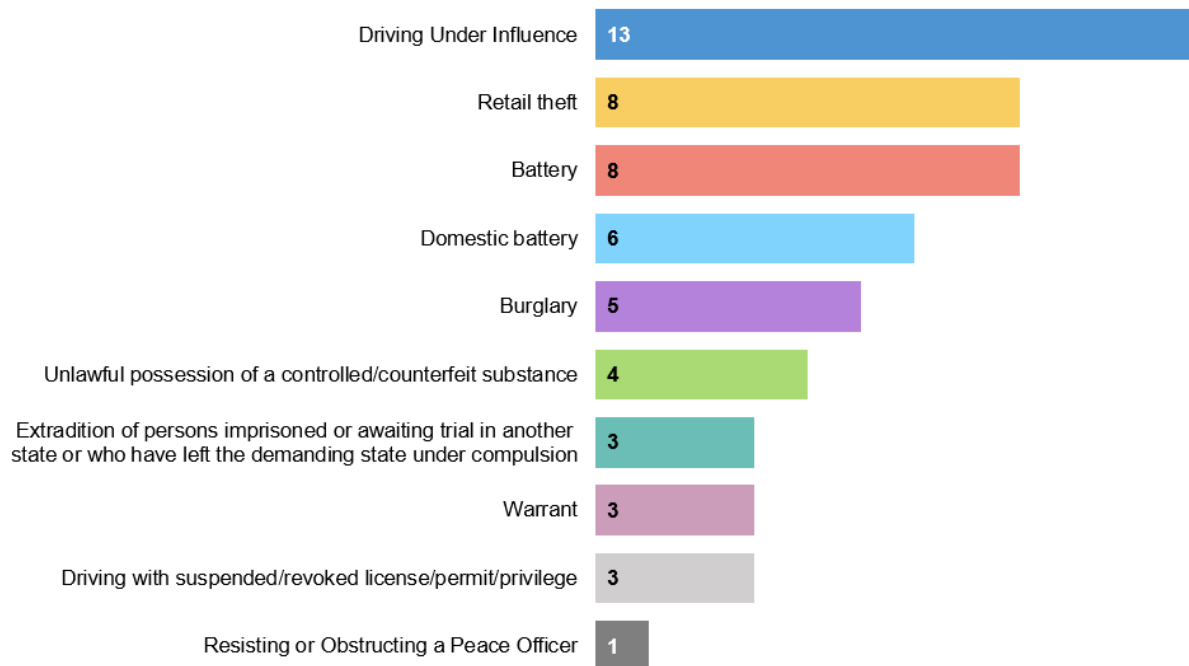
### Review Process

The audit consists of ensuring that all the equipment is functioning properly to include speed and GPS location, and that officers operate the equipment within the department's policy and procedures. Each audit is documented on a prewritten form to include the officer's name, time, and date of when the incident was recorded, the date of when the audit was completed and the name of the supervisor conducting the audit.

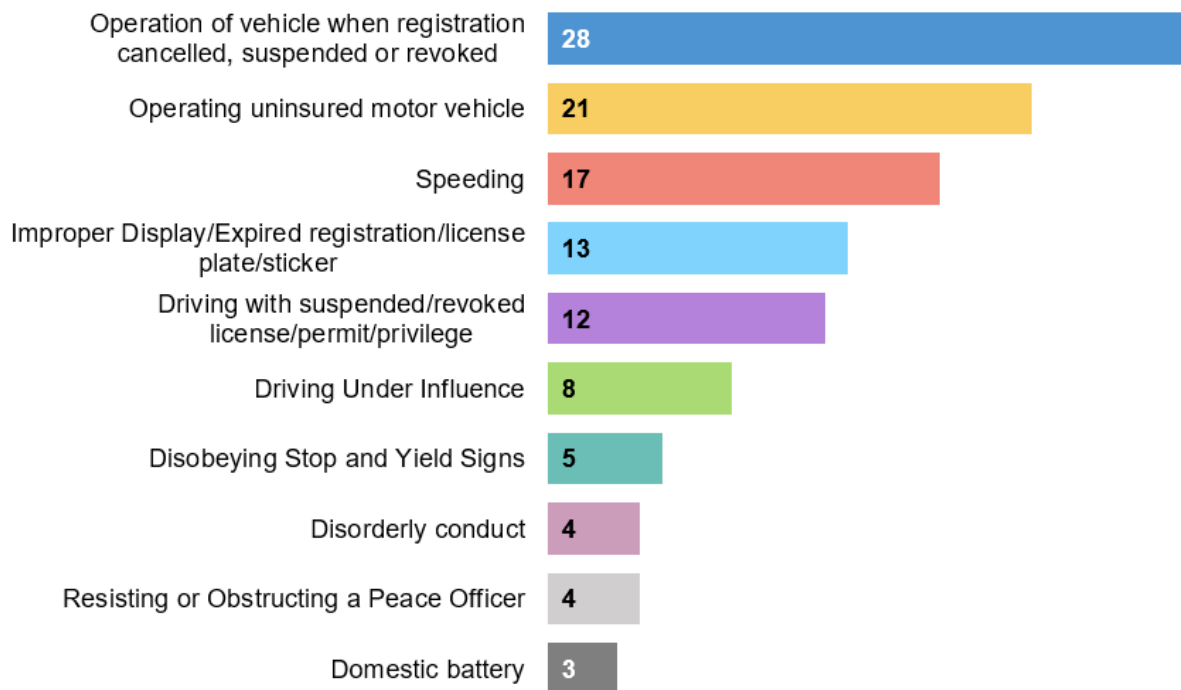

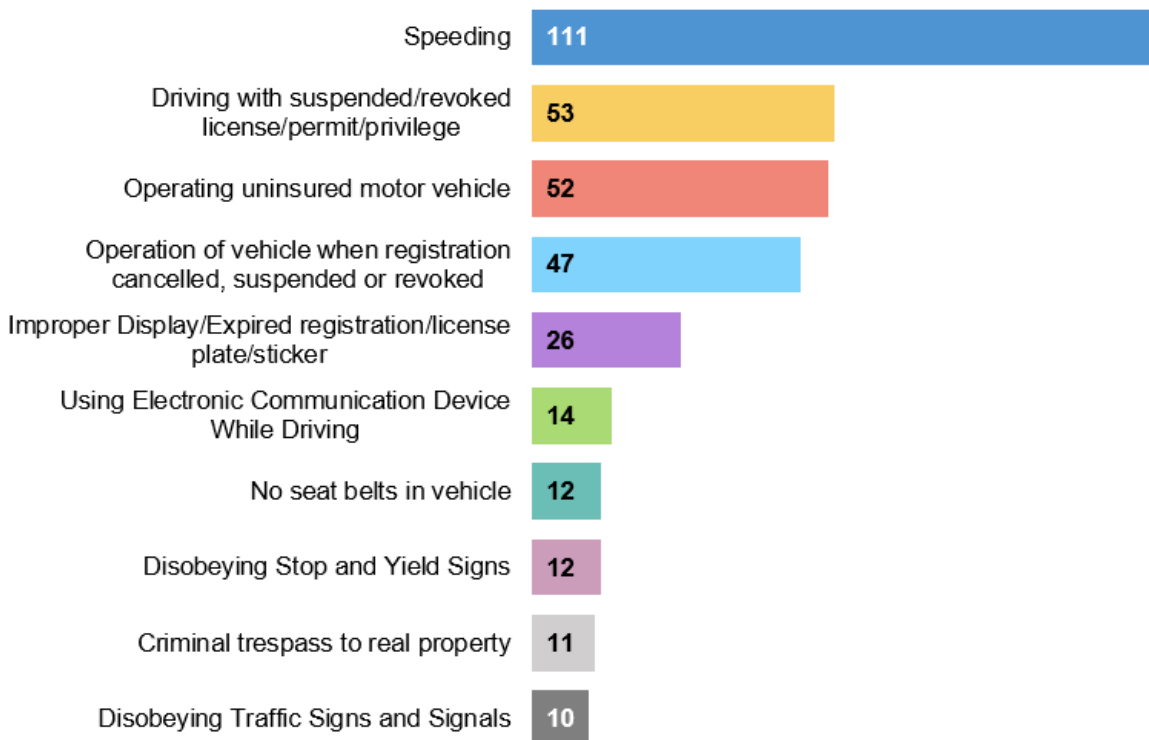

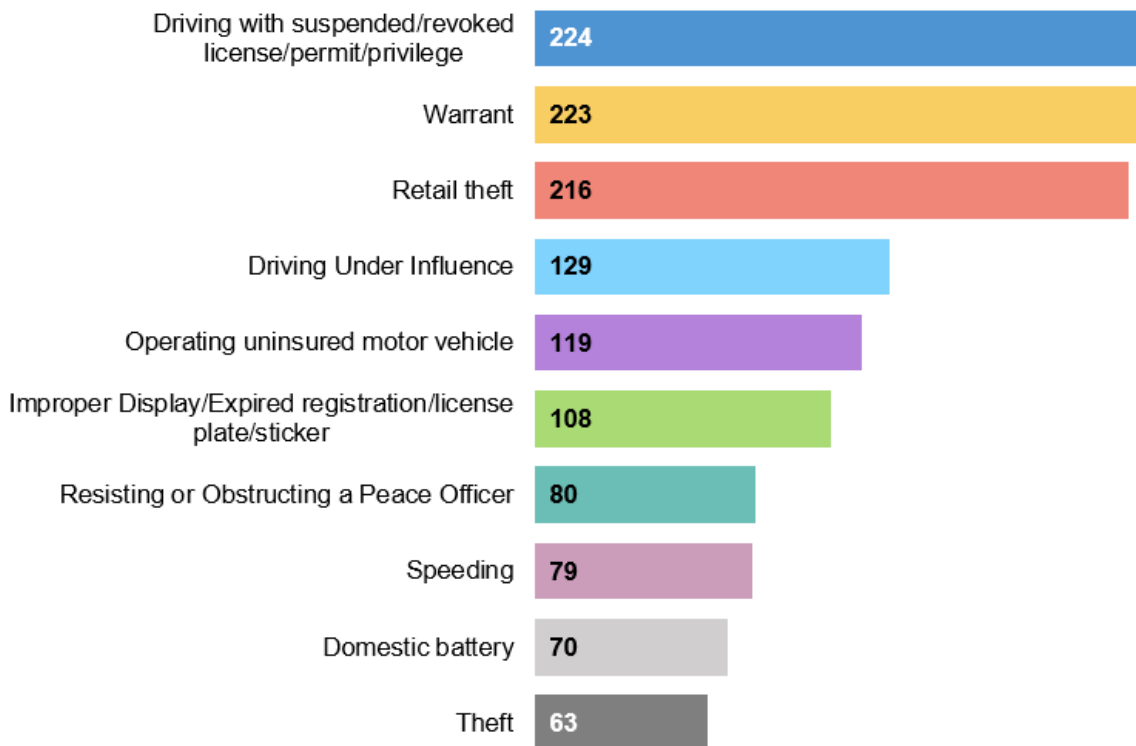
### Review Process

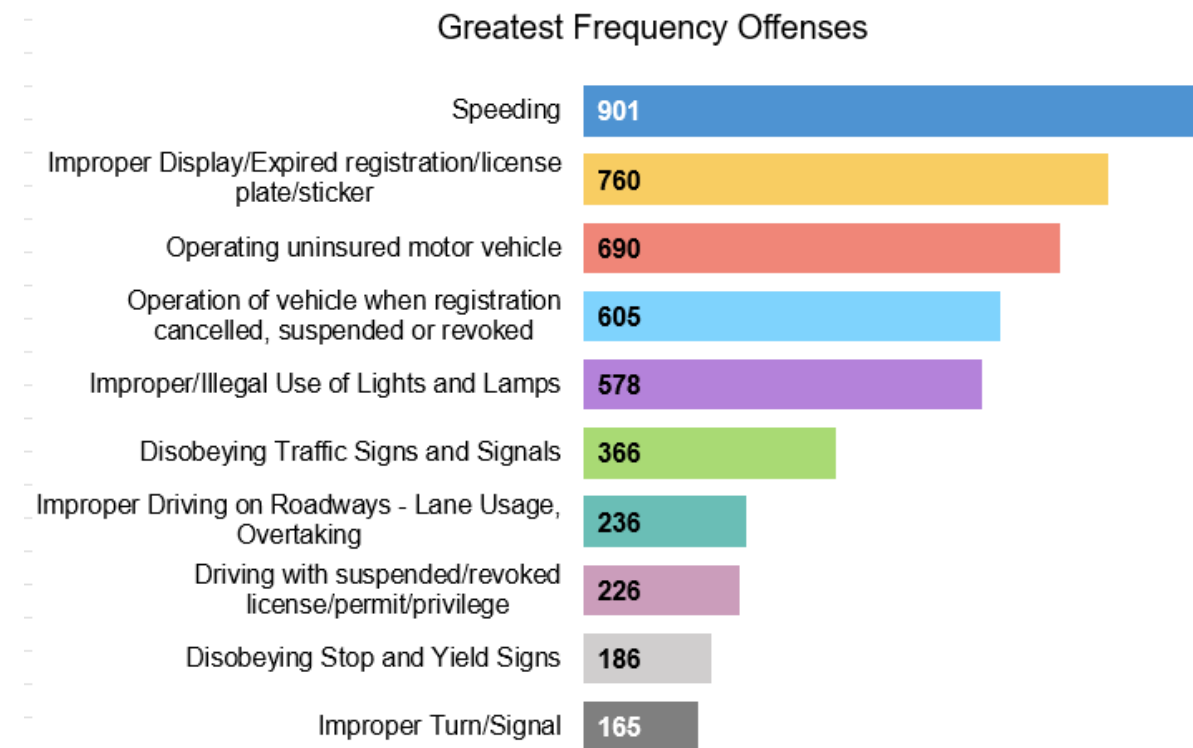

Palatine Police Department's patrol supervisors (three (3) commanders and nine (9) sergeants) review a minimum of ten (10) body worn camera videos recorded by Axon equipment each month. This review process is accomplished through the Axon Performance program, which randomly assigns the requesting supervisor a video that has been recorded by the officers. The purpose of this review is to ensure that the equipment is operating properly and that officers are using the cameras appropriately and in accordance with the policy and training.

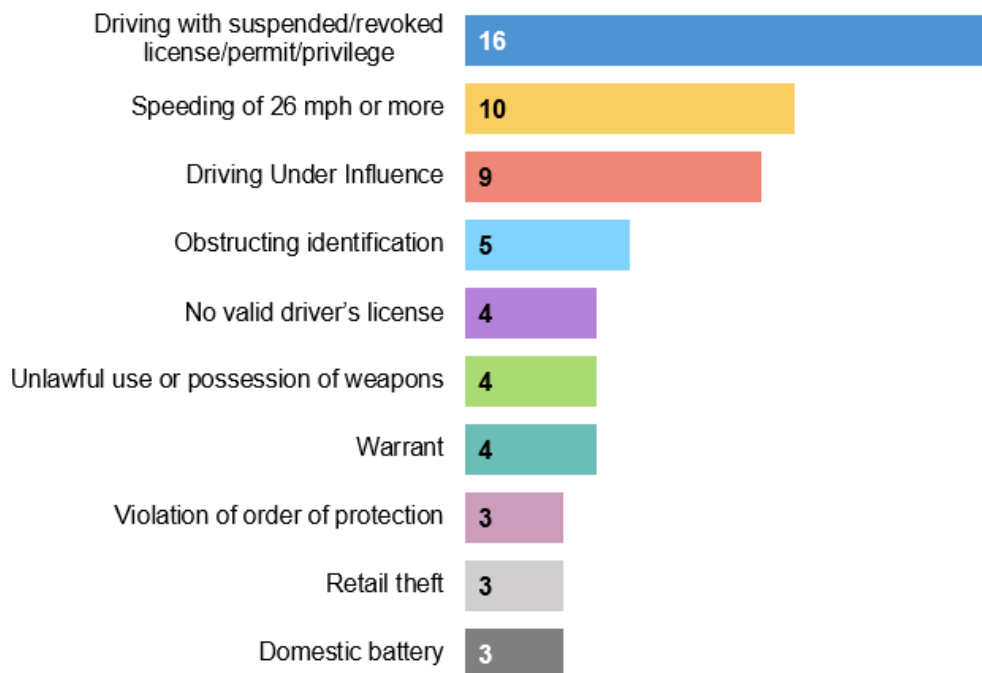

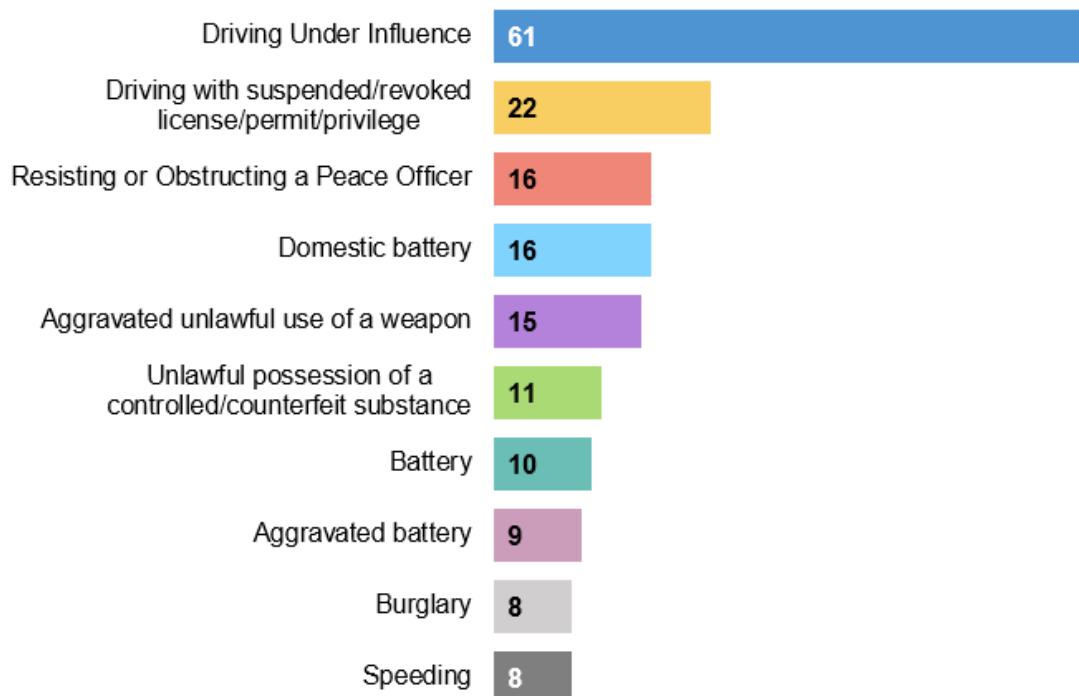

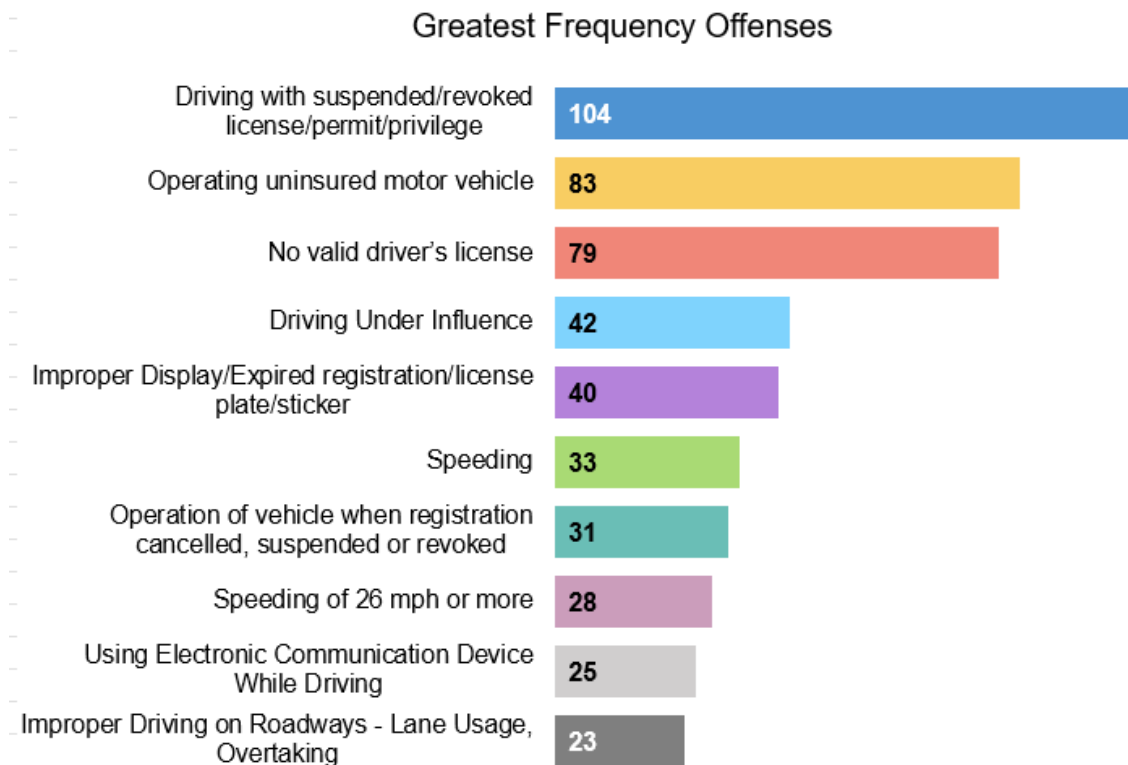

Parkland College Police Department’s sergeants review at least one (1) randomly selected file a month, documented through a Body Cam Monthly Check spreadsheet. The department’s command staff may periodically review records to identify training needs, ensure officer compliance with policy, and fulfil FOIA requests. If a complaint is made and a body worn camera recording exists, a supervisor immediately ensures that the recording is secure. The recording is copied to DVD or USB storage device and given to the Chief for review.

### Incidents

Between January 1, 2024, and December 31, 2024, Parkland College Police Department reports three (3) incidents leading to three (3) offenses charged which include burglary, aggravated assault, and leaving scene of accident.

## Department Overview – Paxton Police Department

---

Paxton Police Department consists of eight (8) full-time officers and two (2) part-time officers who utilize eight (8) WatchGuard Vista body worn cameras.

### **Technical Issues**

Paxton Police Department reports zero (0) technical issues.

### **Review Process**

Paxton Police Department reports no formal body worn camera review process.

### **Incidents**

Paxton Police Department's report does not include incidents data.

## Department Overview – Pecatonica Police Department

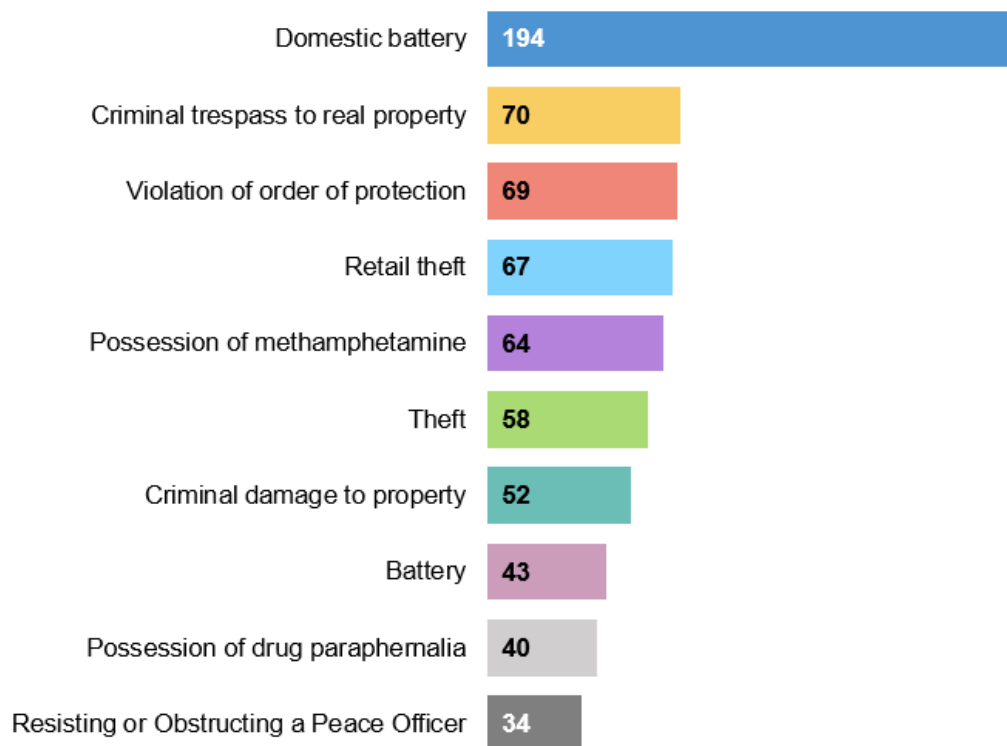

Piatt County Sheriff's Office reports zero (0) technical issues. A few occasional officers made errors were resolved with further training and supervisory oversight.

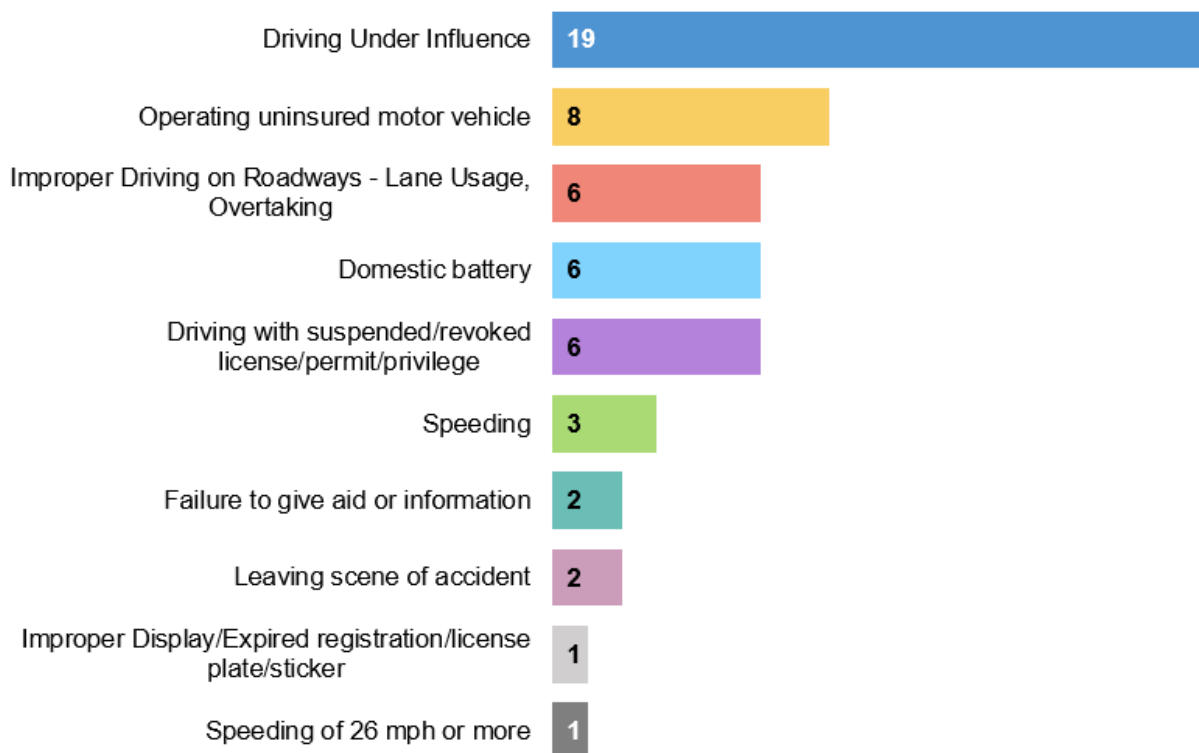
### Review Process

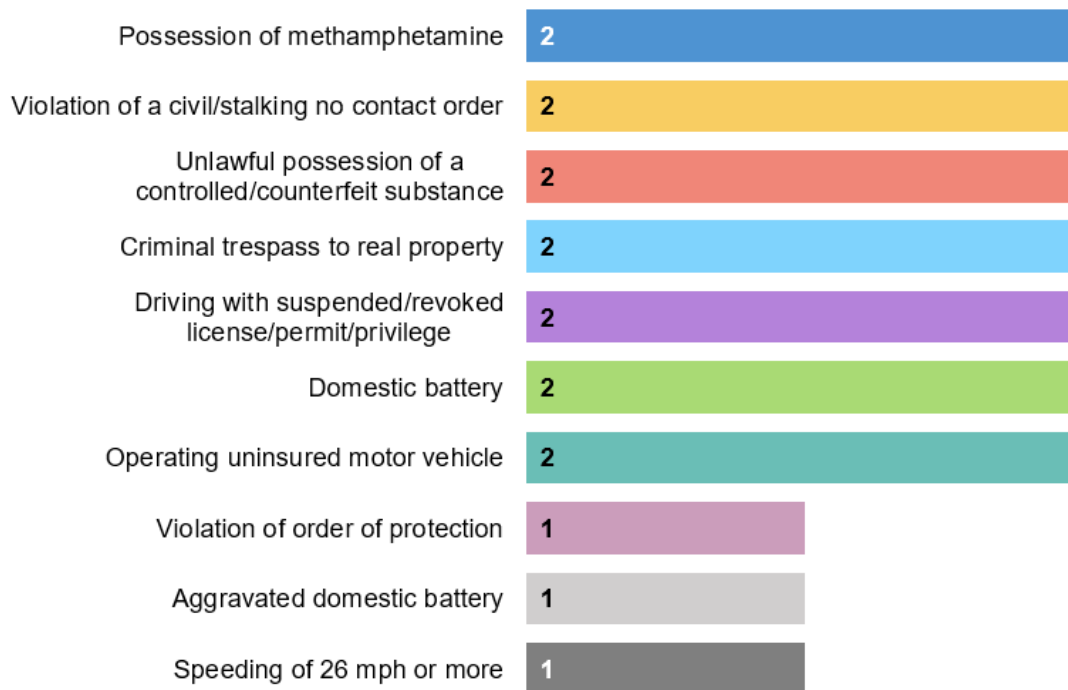

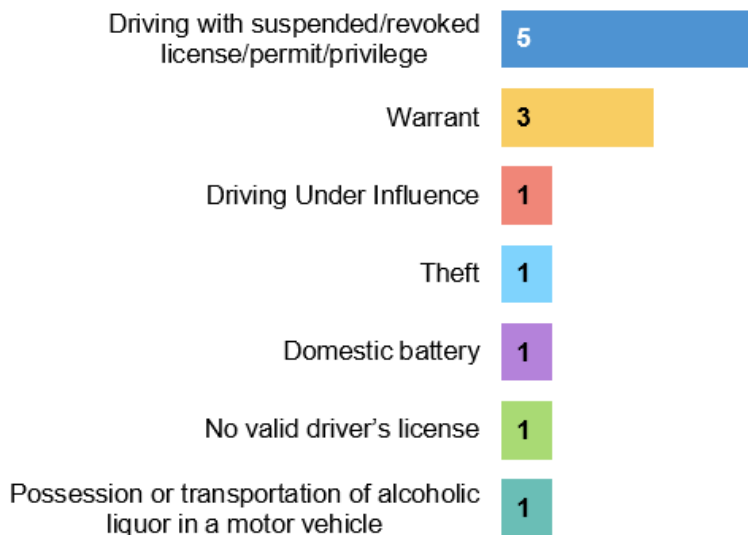

### **Incidents**

Pontoon Beach Police Department's report does not include incidents data.



## Department Overview – Prairie Grove Police Department

Prairie Grove Police Department consists of a Chief of Police and four (4) police officers who utilize four (4) body worn cameras.

### **Technical Issues**

Prospect Heights Police Department consists of twenty-three (23) full-time and one (1) part-time sworn officer who utilize twenty-five (25) Axon Body 4 body worn cameras.

Prospect Heights Police Department's immediate supervisor of each officer is responsible for reviewing two (2) body worn camera videos monthly for every officer under their supervision. Putnam County Sheriff's Office reports zero (0) technical issues.

### **Review Process**

Putnam County Sheriff's Office's supervisors and administrators are authorized to review relevant body camera videos any time they are investigating alleged misconduct or reports of alleged misconduct or whenever such recordings would be beneficial in reviewing a deputy's performance or for a training exercise.

### **Incidents**

Between December 1, 2024, and December 31, 2024, Putnam County Sheriff's Office reports one (1) incident leading to one (1) offense charged which was domestic battery.

## Department Overview – Red Bud Police Department

---

Red Bud Police Department consists of seven (7) full-time officers and four (4) part-time officers. Each officer utilizes a body-worn camera, except for the Chief during administrative duties. The department has two (2) unassigned body worn cameras available for part-time officers.

### **Review Process**

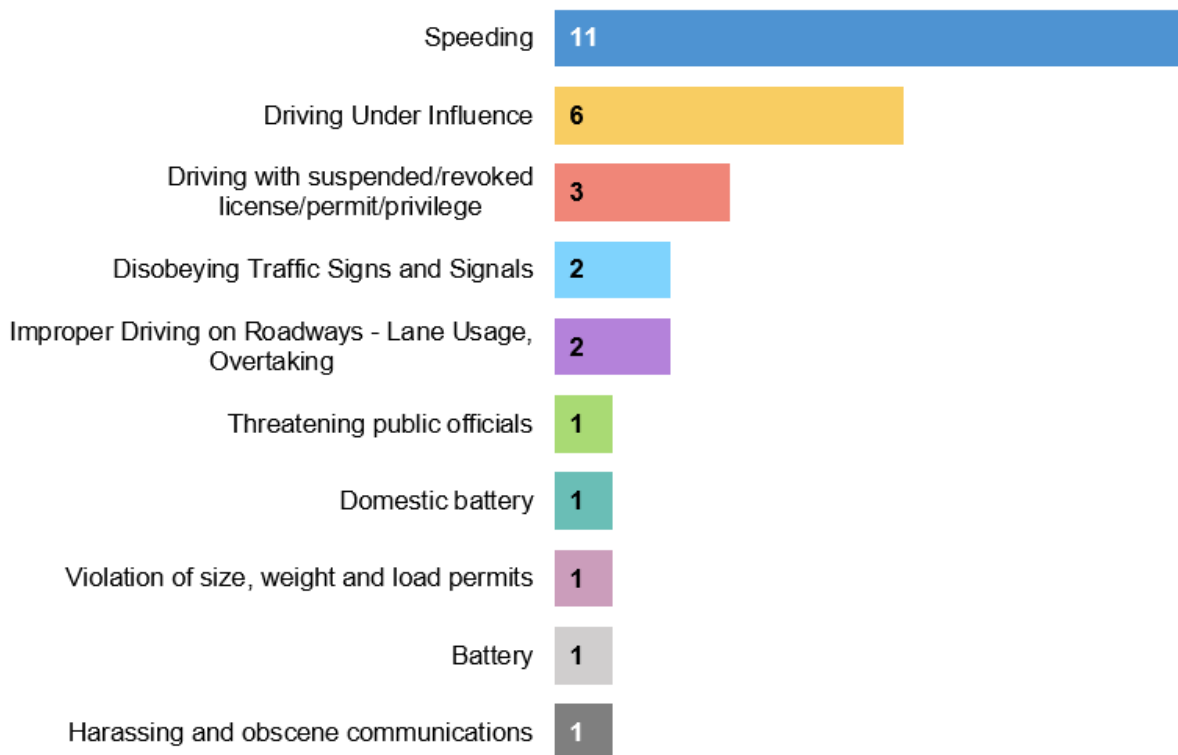

Labeling, redacting, and duplicating of any recording is done by the BWC Coordinator. Recorded files are viewed, upon approval by a supervisor, as part of an official investigation, pursuant to a lawful process, by media personnel, in compliance with public records request, by the recording officer's field training officer for training purposes, and/or by any detective or investigator involved in the investigation of a matter.

The BWC Coordinator randomly reviews ten (10) body worn camera recordings monthly to ensure the equipment is operating properly and officers are using the equipment appropriately and within policy and training. A monthly report is submitted to the Deputy Chief for review.

### Incidents

## Department Overview – Riverwoods Police Department

Riverwoods Police Department consists of nine (9) full-time and eight (8) part-time officers who utilize seventeen (17) Axon Body 4 body worn cameras.

### **Technical Issues**

Riverwoods Police Department reports zero (0) technical issues.

### **Review Process**

The Riverwoods Police Department's supervisors are authorized to review relevant recordings any time they are investigating alleged misconduct or reports of meritorious conduct or whenever such recordings would be beneficial in reviewing a member's performance. ## Department Overview – Rochester Police Department

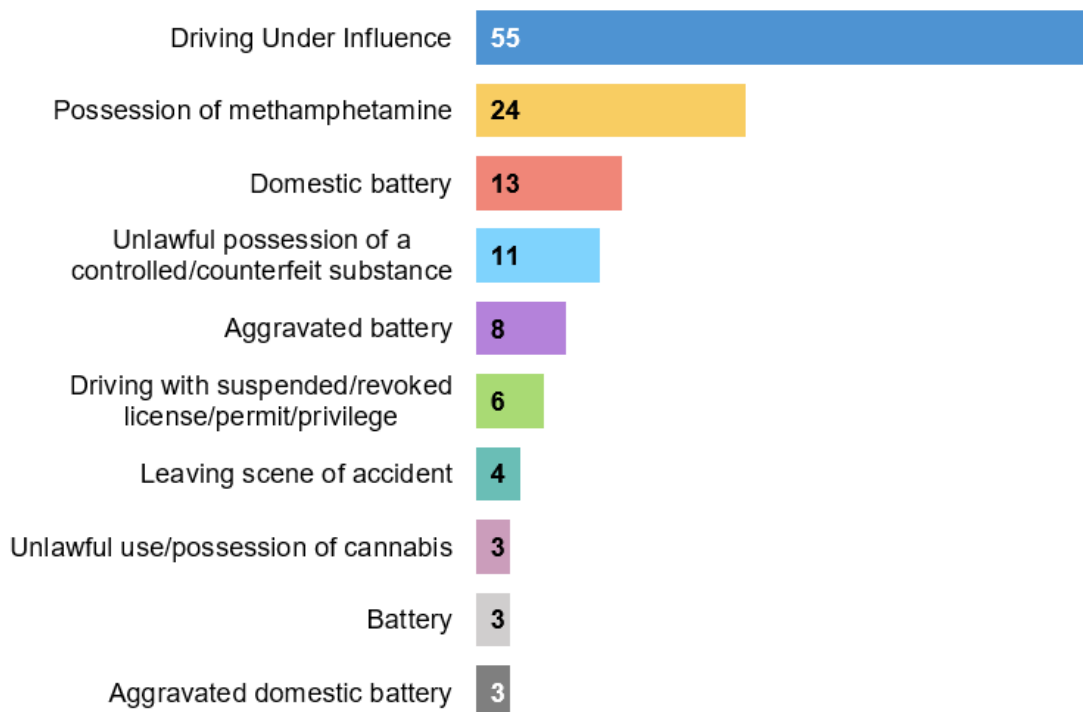
### Review Process

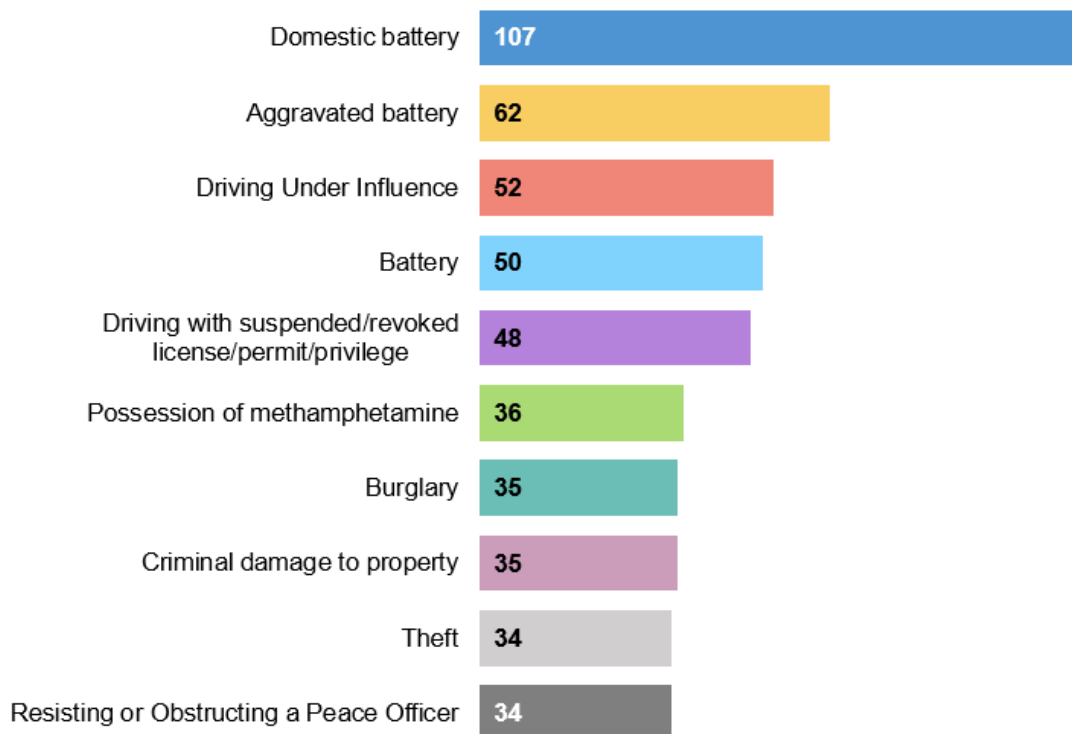

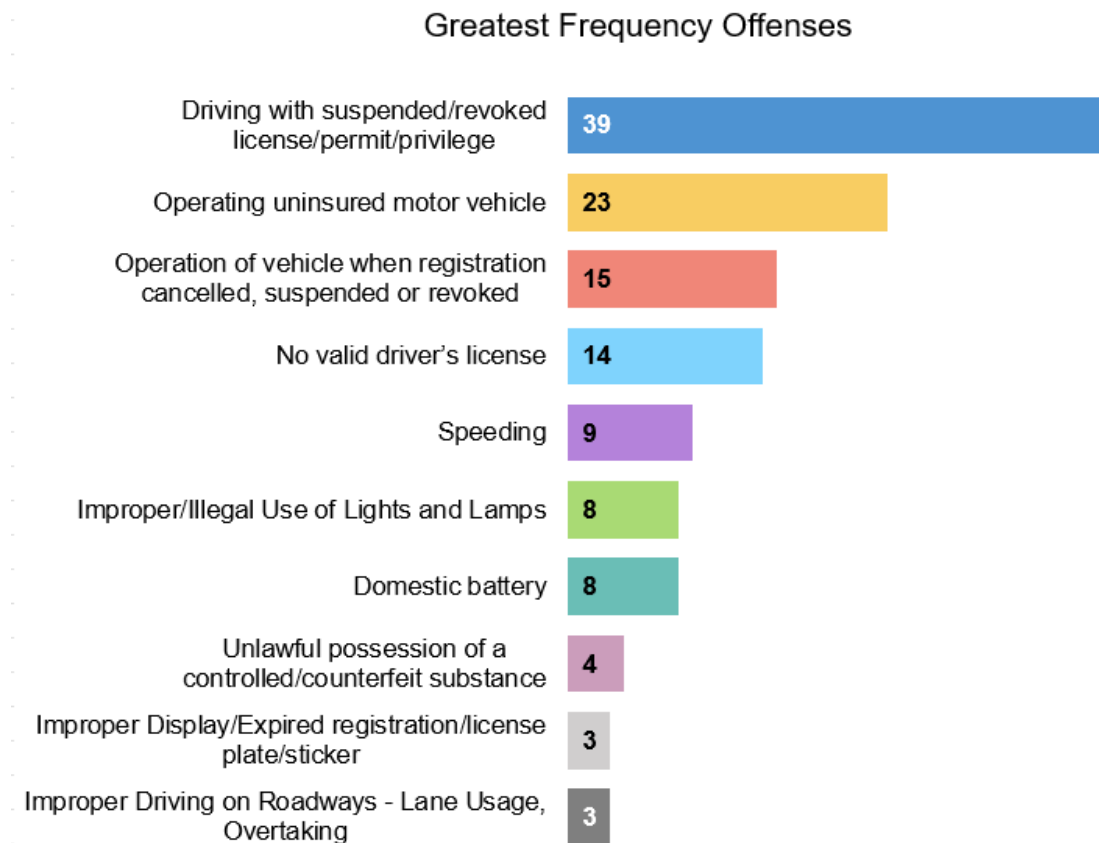

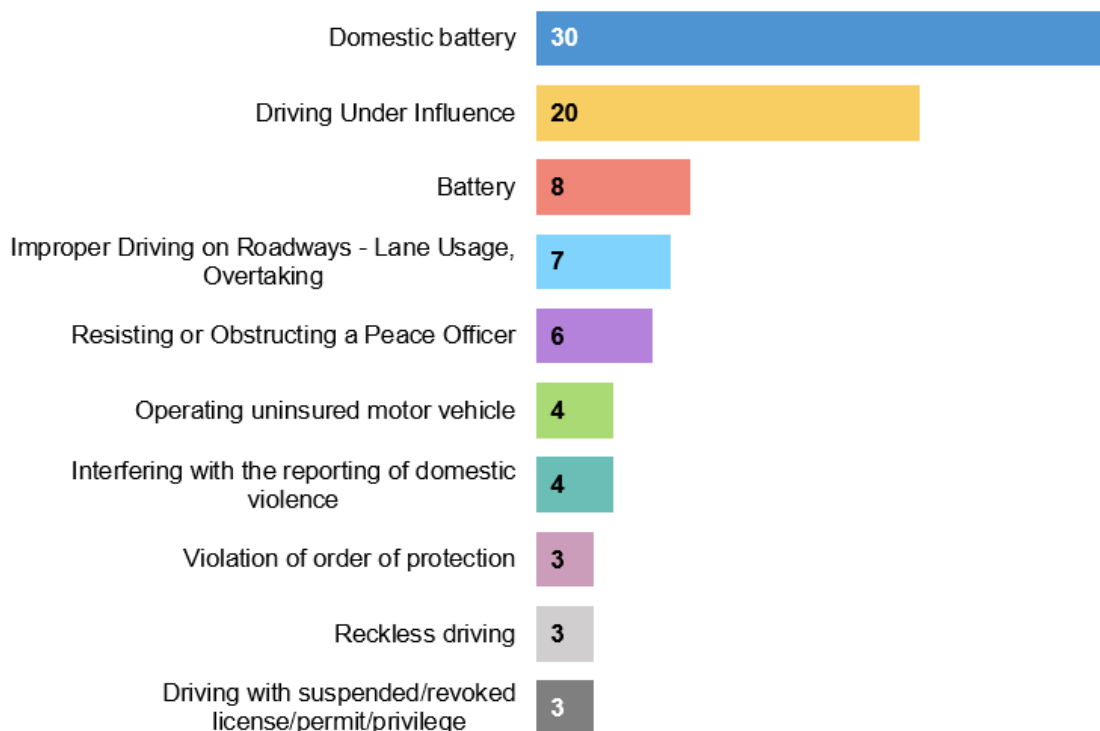

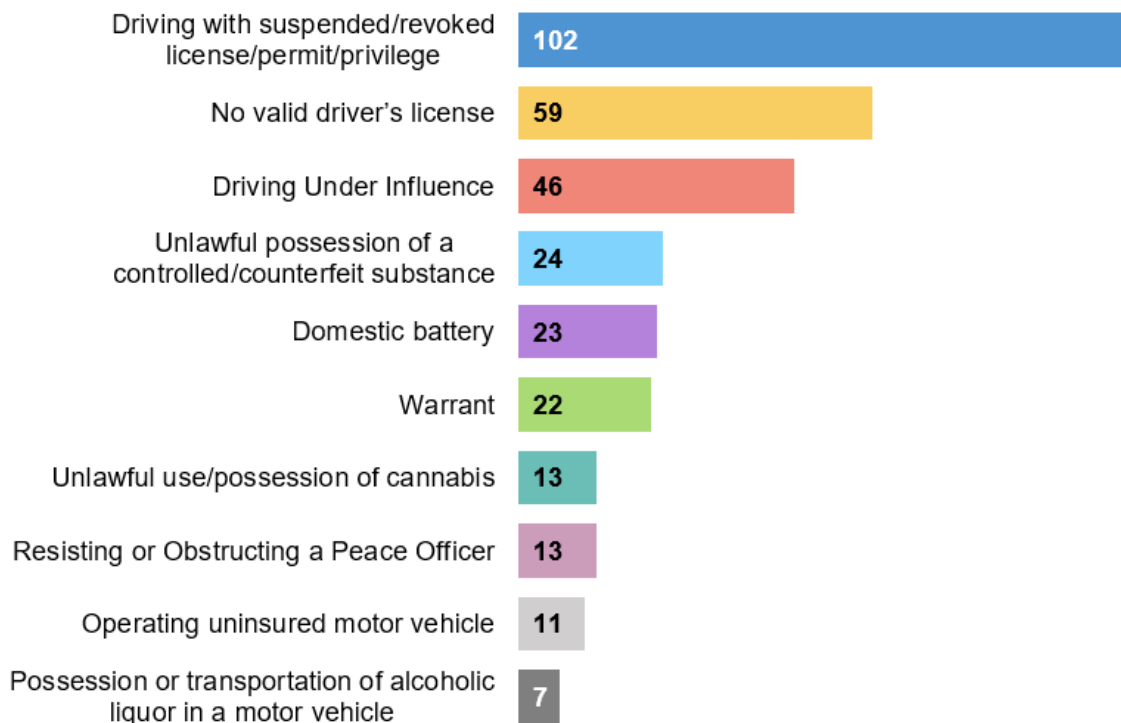

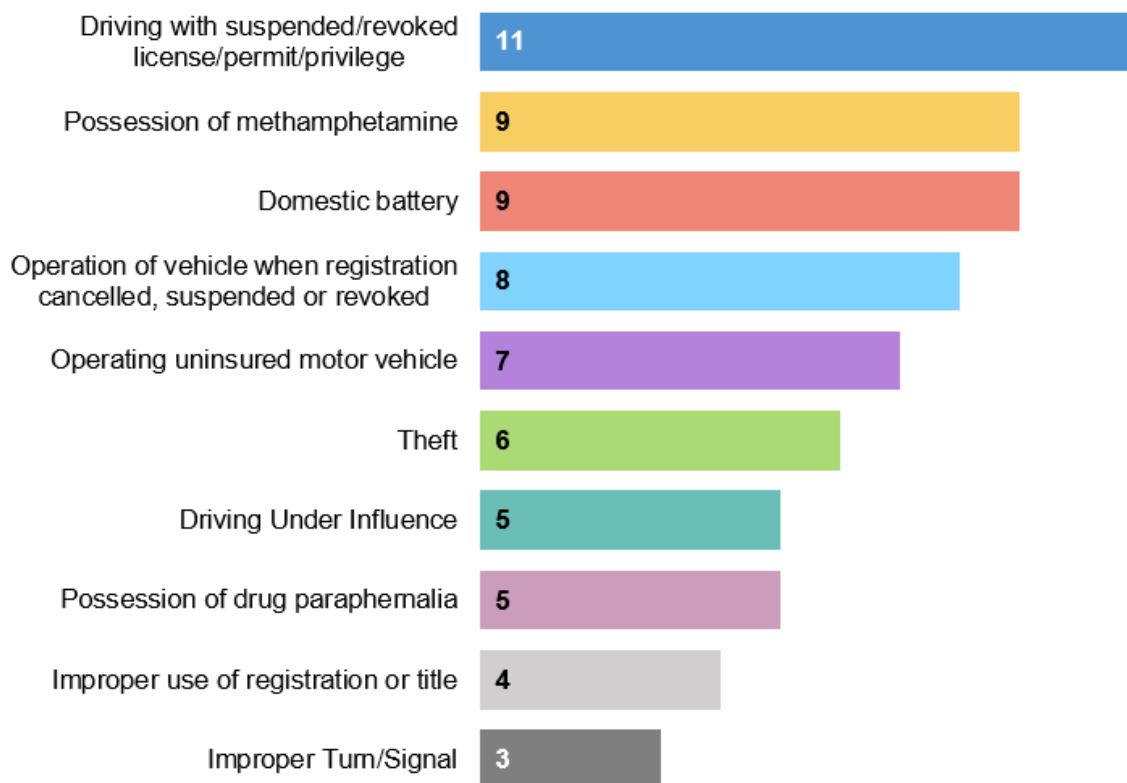

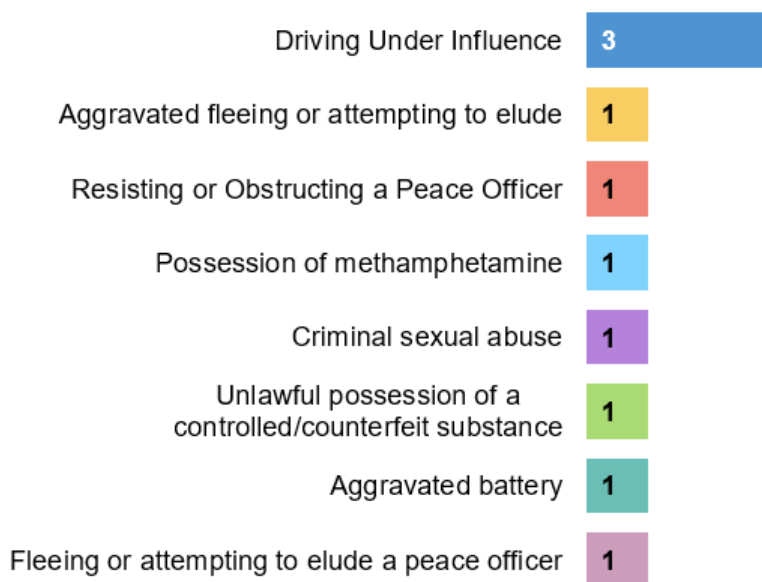

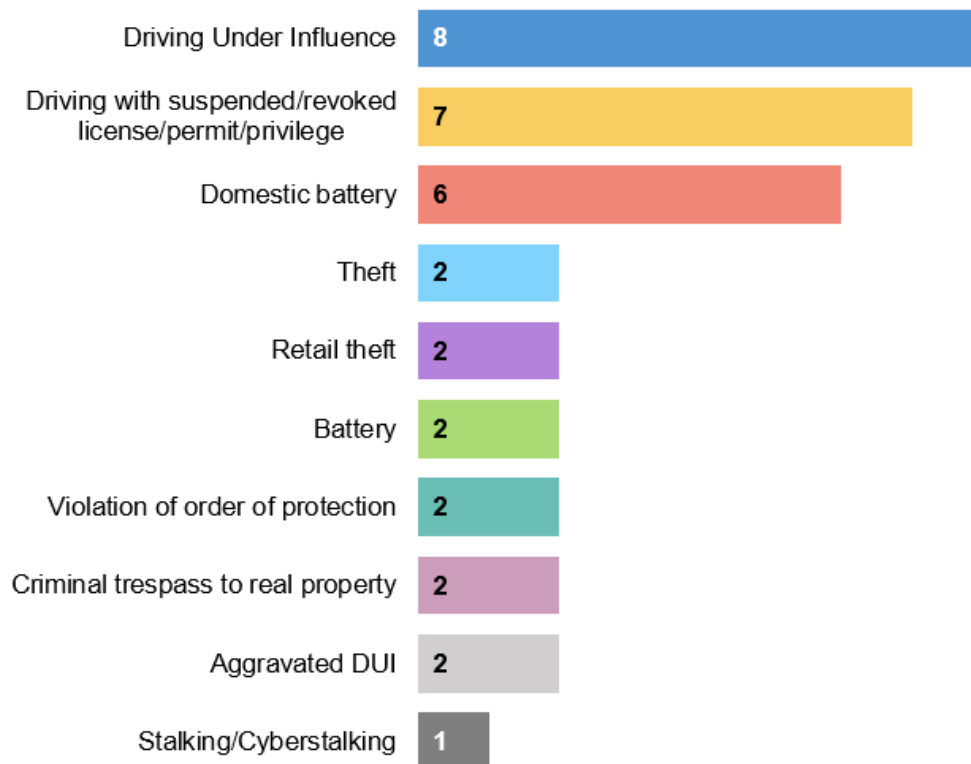

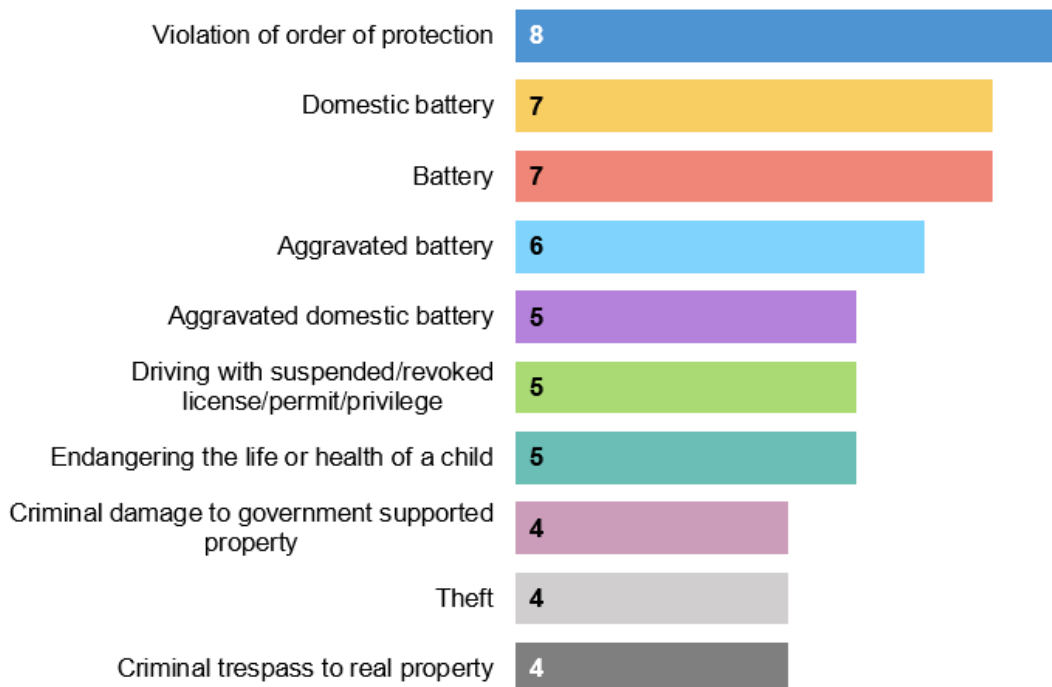

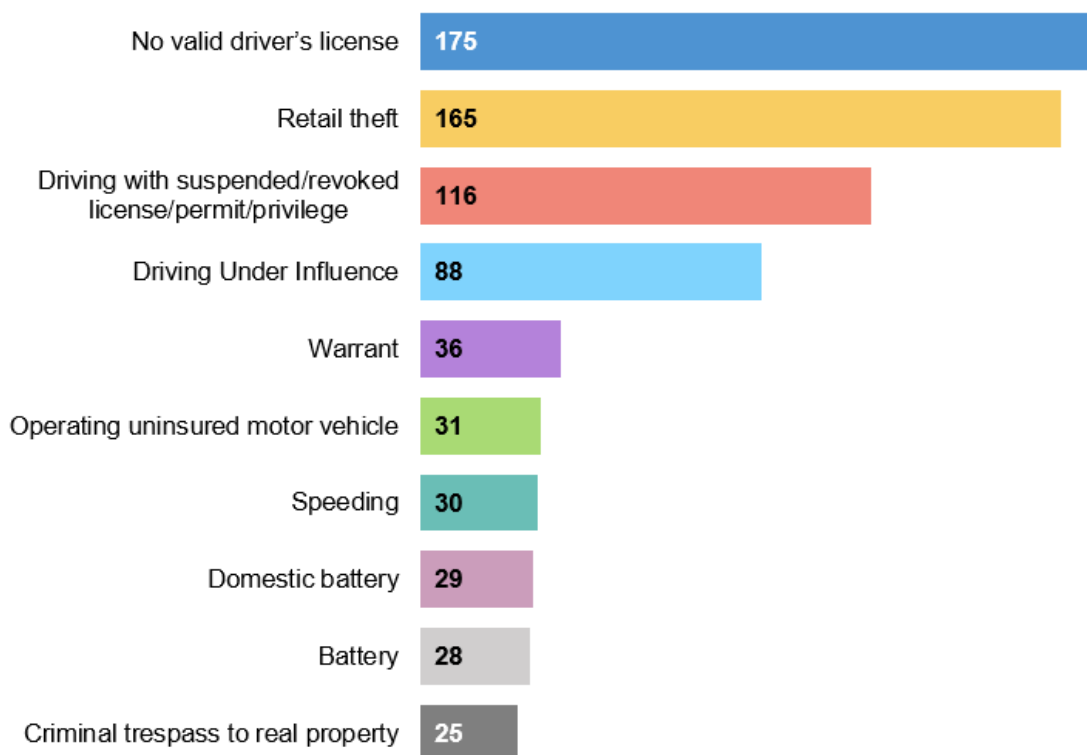

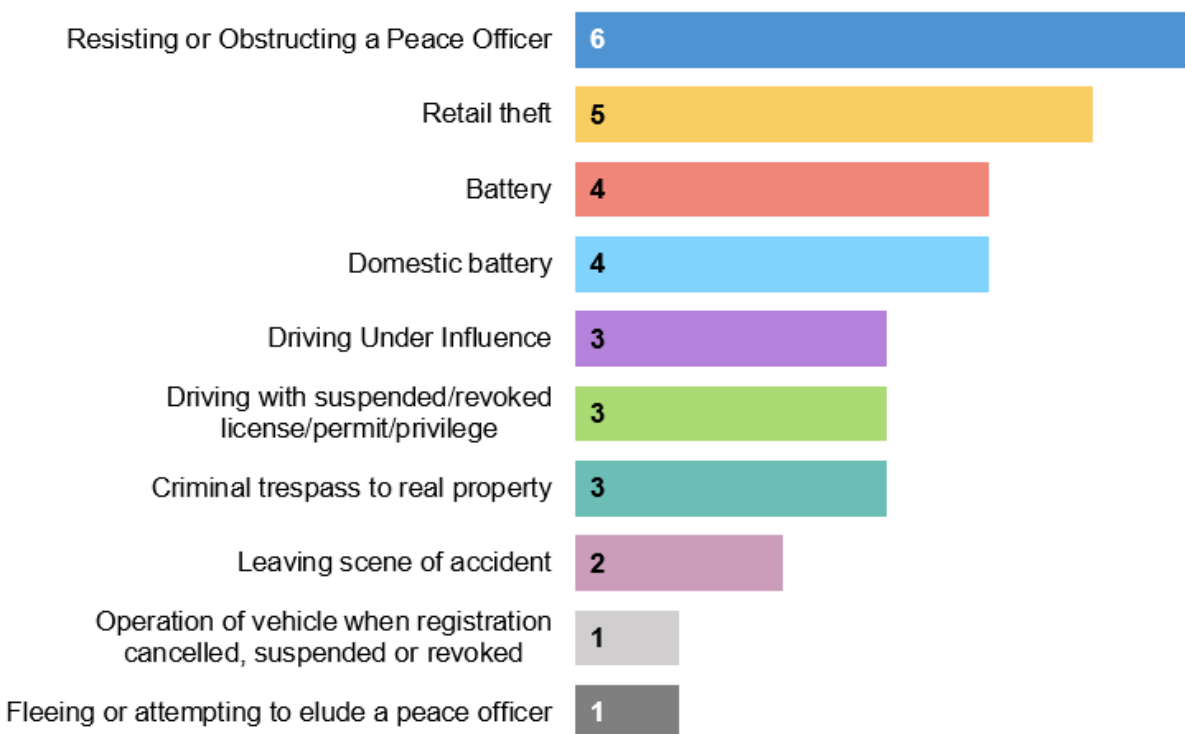

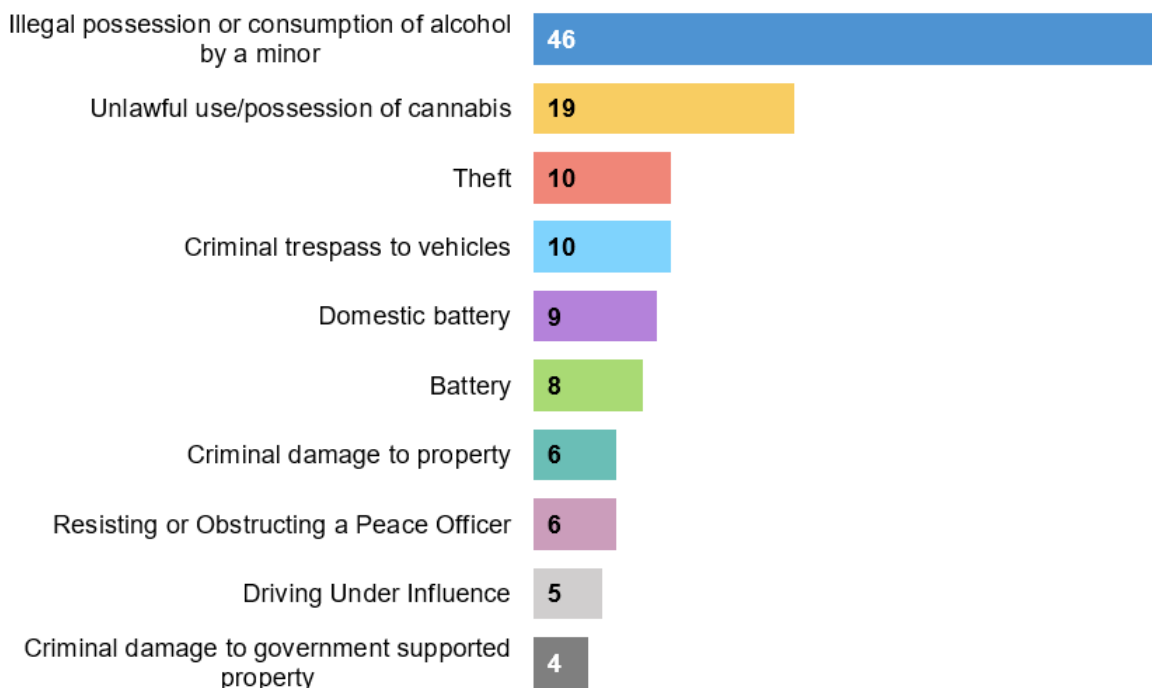

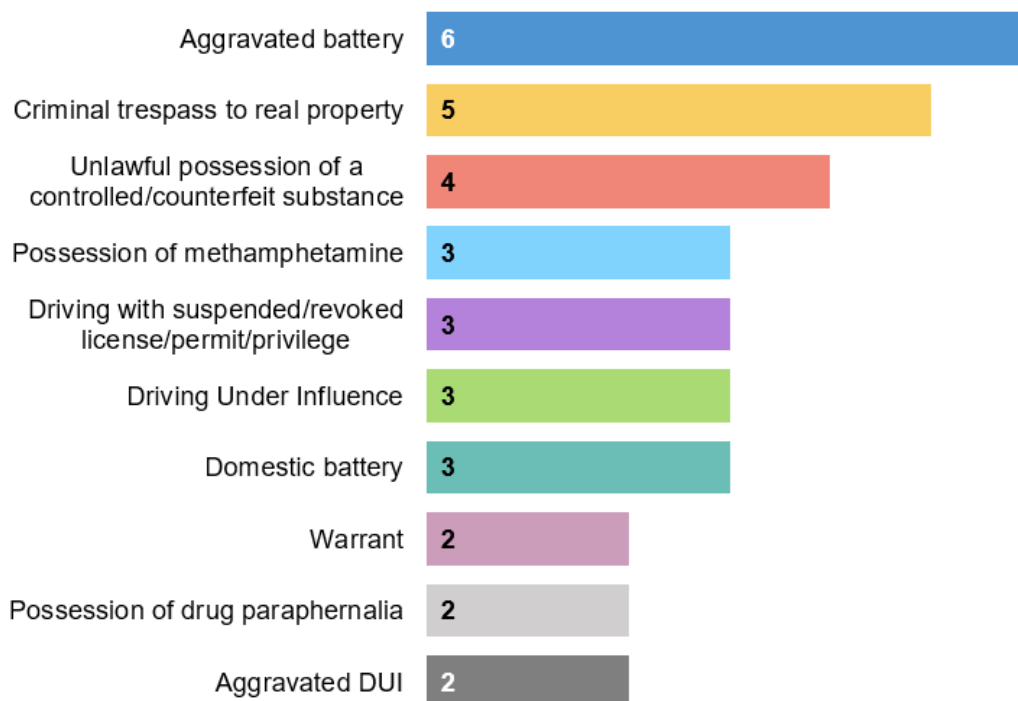

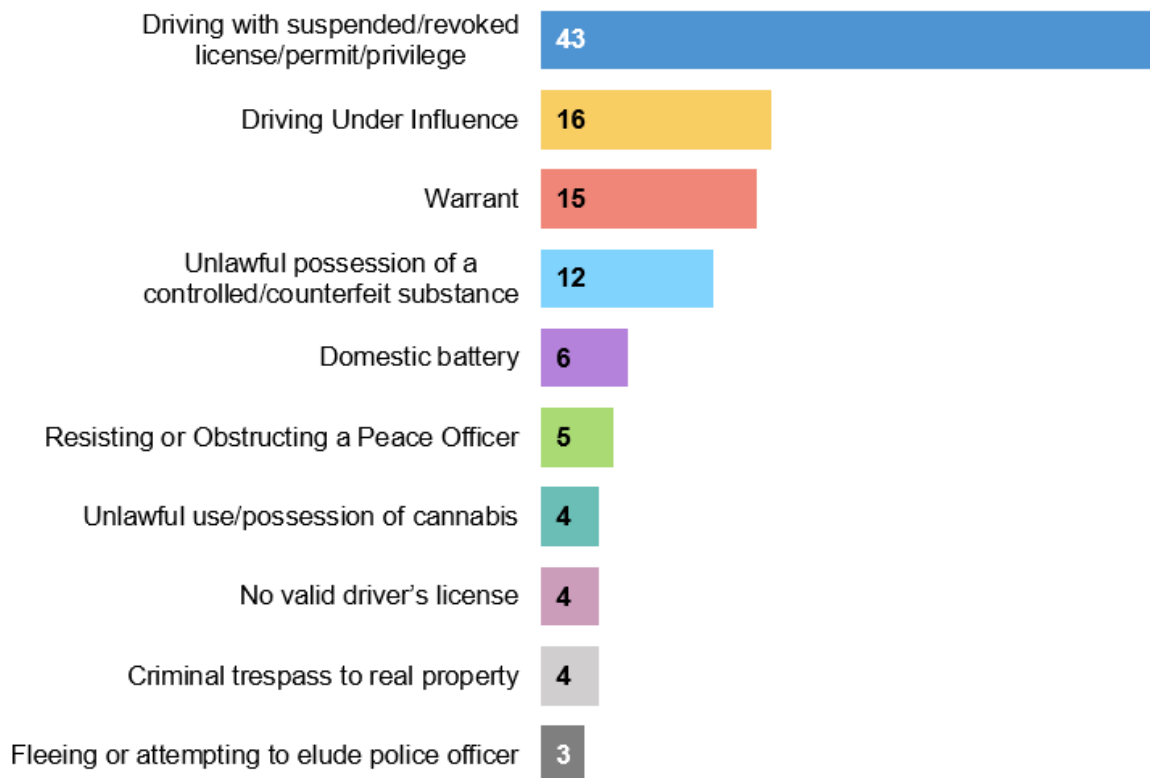

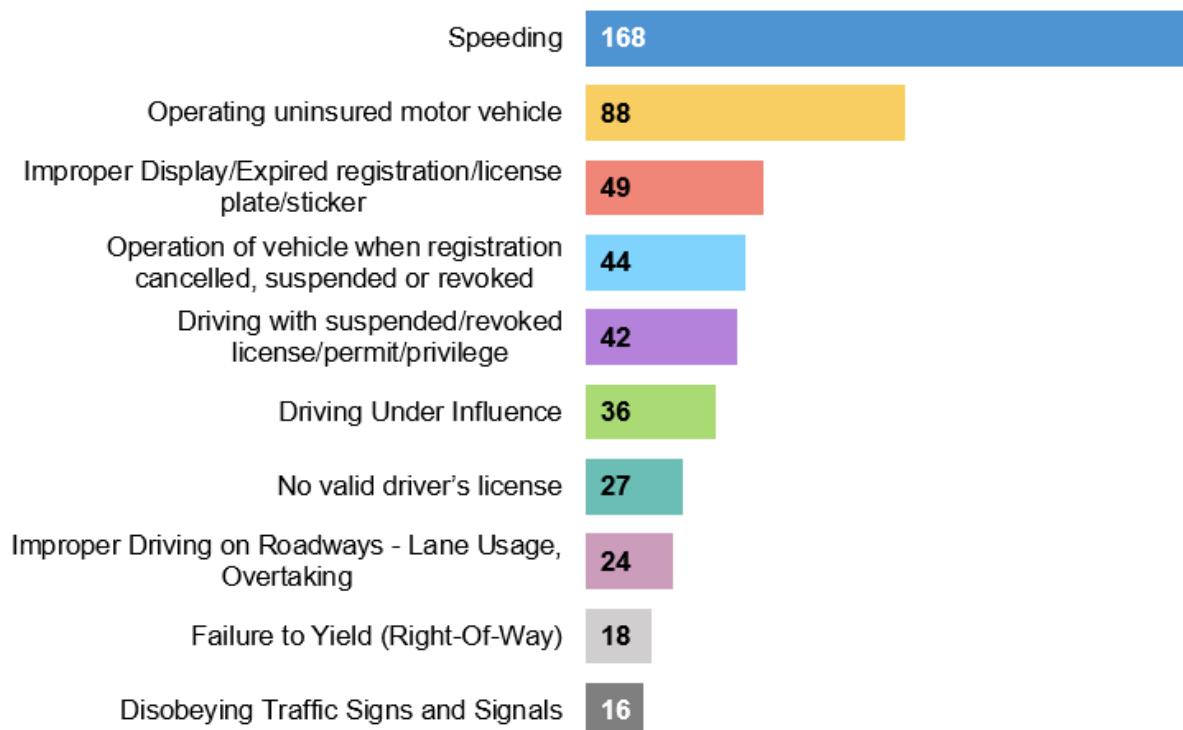

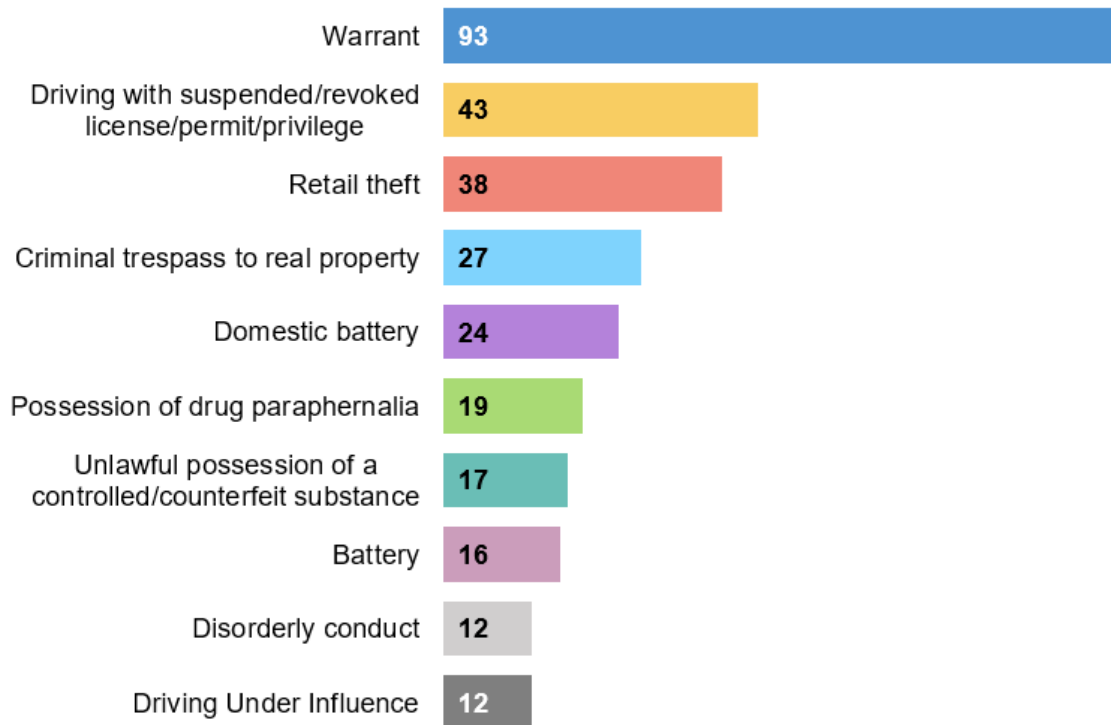

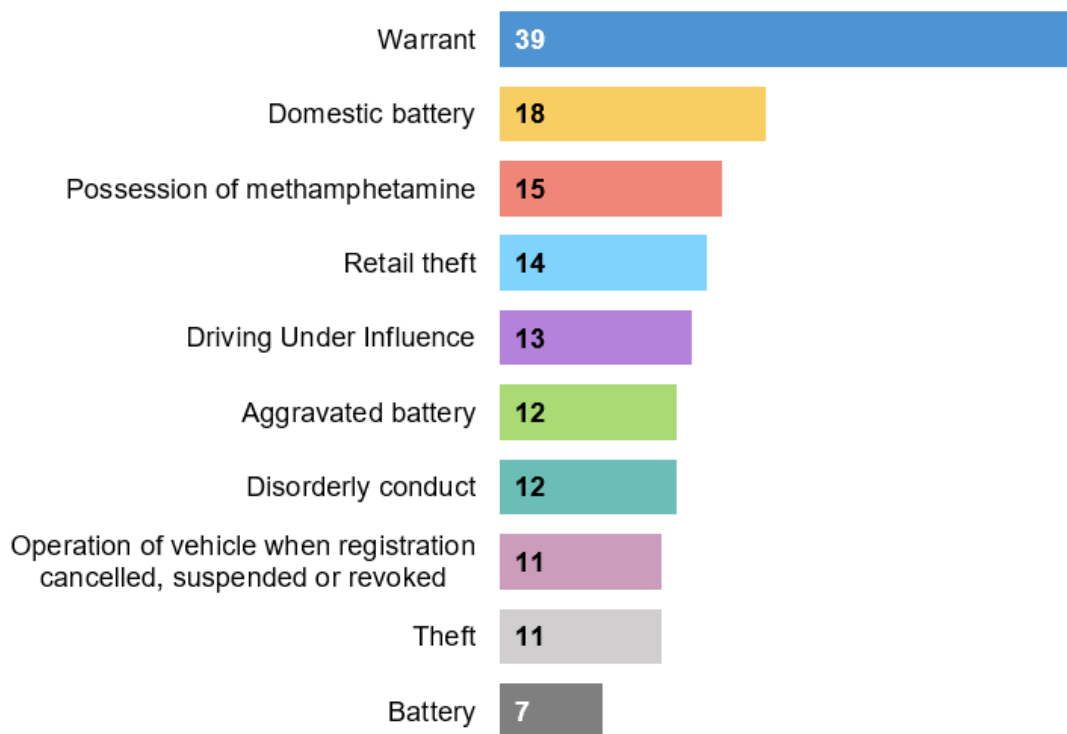

Union County Sheriff's Office reports zero (0) technical issues.

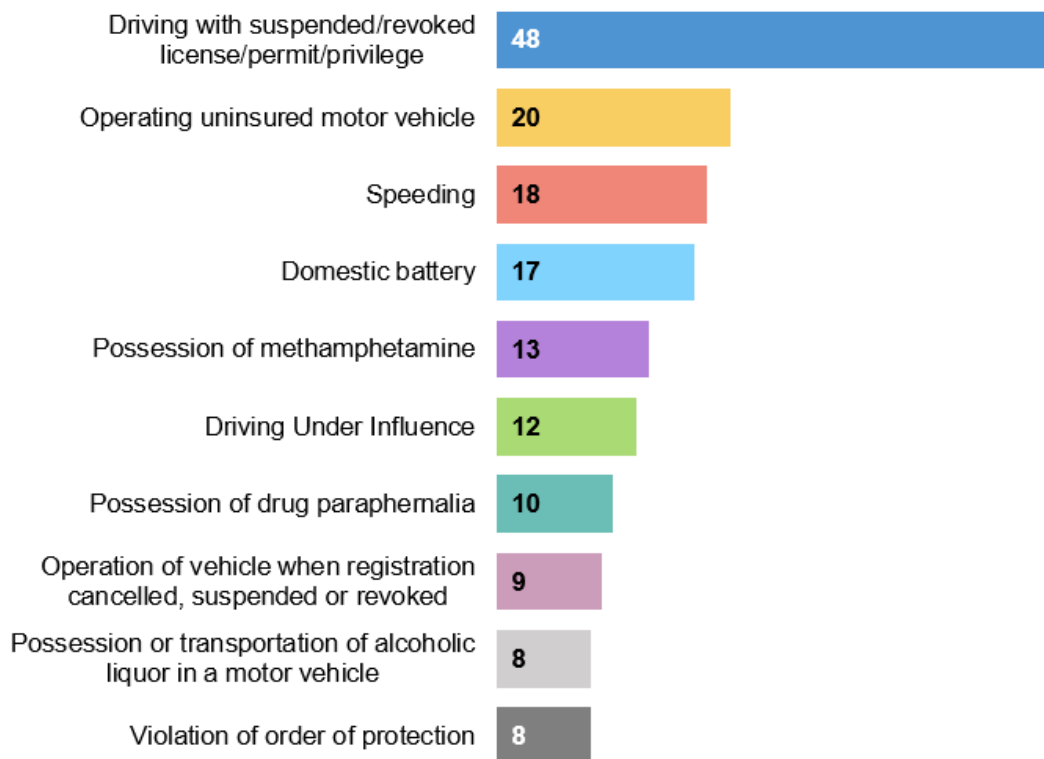
### Review Process

## Department Overview – University of Chicago Police Department

---

The University of Chicago Police Department consists of eighty-eight (88) full-time officers, twenty-three (23) supervisors and two (2) part-time officers who utilize one hundred twenty (120) body worn cameras.

### Technical Issues

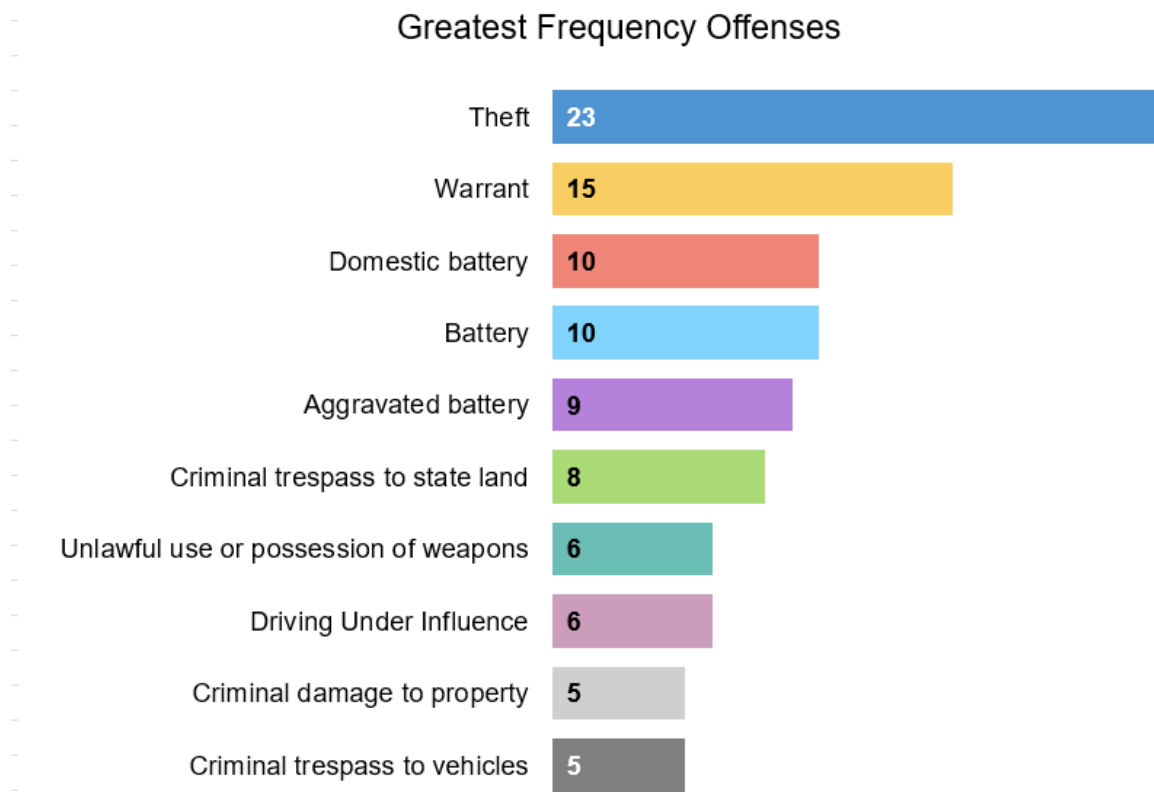
The University of Chicago Police Department reports a few technical issues including connectivity, storage, camera not powering off, reboot, random shut down, download and upload issues, broken battery clip, etc. Technical issues beyond the scope of in-house repairs were sent to the manufacturer for repair or replacement.

### Review Process

The University of Chicago Police Department's supervisors review body worn camera recordings at least quarterly by the Commander of Professional Standards using a minimum random sampling of three (3) recorded law enforcement related encounters or activities. Monthly reviews are also conducted at the shift level, by the sergeant or captain, and forwarded to the Commander of Professional Standards.

### Incidents

Between January 1, 2024, and December 31, 2024, University of Chicago Police Department reports one hundred twelve (112) incidents leading to one hundred twelve (112) offenses charged. Below is a snapshot of the greatest frequency of offenses charged.



## **Department Overview – University of Illinois at Urbana-Champaign Police Department**

---

University of Illinois at Urbana-Champaign Police Department consists of seventy-two (72) sworn officers who utilize seventy-four (74) Axon Body 4 body worn cameras, which includes one (1) spare camera.

### **Technical Issues**

University of Illinois at Urbana-Champaign Police Department reports zero (0) technical issues.

### **Review Process**

University of Illinois at Urbana-Champaign Police Department's supervisors perform periodic reviews of subordinates' body worn camera videos. They review incidents that are tagged as significant events as well as videos that supervisors are aware of as relating to a significant event.

University of Illinois Chicago Police Department reports battery/charging issue with three (3) body worn cameras which were replaced or repaired.

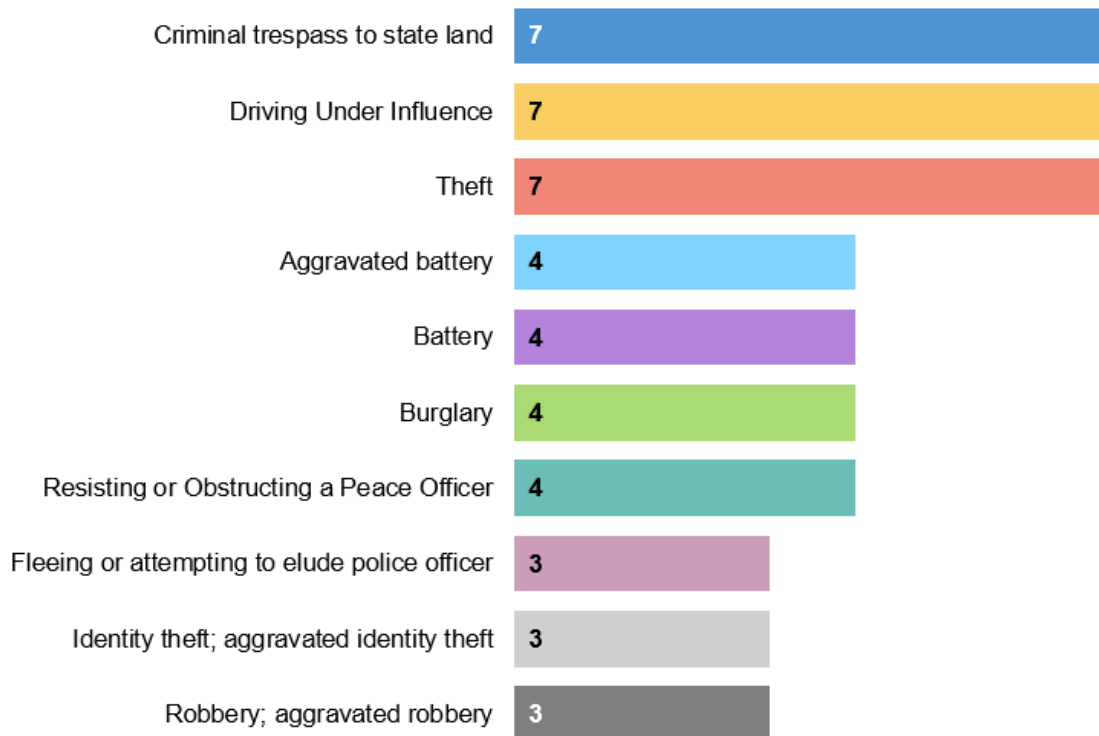
### Review Process

## Department Overview – Vernon Hills Police Department

Supervisors ensure officers utilize the body worn camera according to policy guidelines and videos related to critical incidents are uploaded to evidence.com.

### **Incidents**

Village of Northbrook Police Department's report does not include incidents data.

## Department Overview – Village of Winnebago Police Department

---

Village of Winnebago Police Department consists of eight (8) officers who utilize ten (10) body worn cameras.

### Technical Issues

Village of Winnebago Police Department reports three (3) technical issues with body worn cameras including video footage not uploading to the cloud, integrated license plate readers not functioning properly, and an inoperable camera screen. Each of these issues was addressed in coordination with the manufacturer, local IT department, and Lt. Haff, who worked closely with all parties to troubleshoot and resolve the problems.

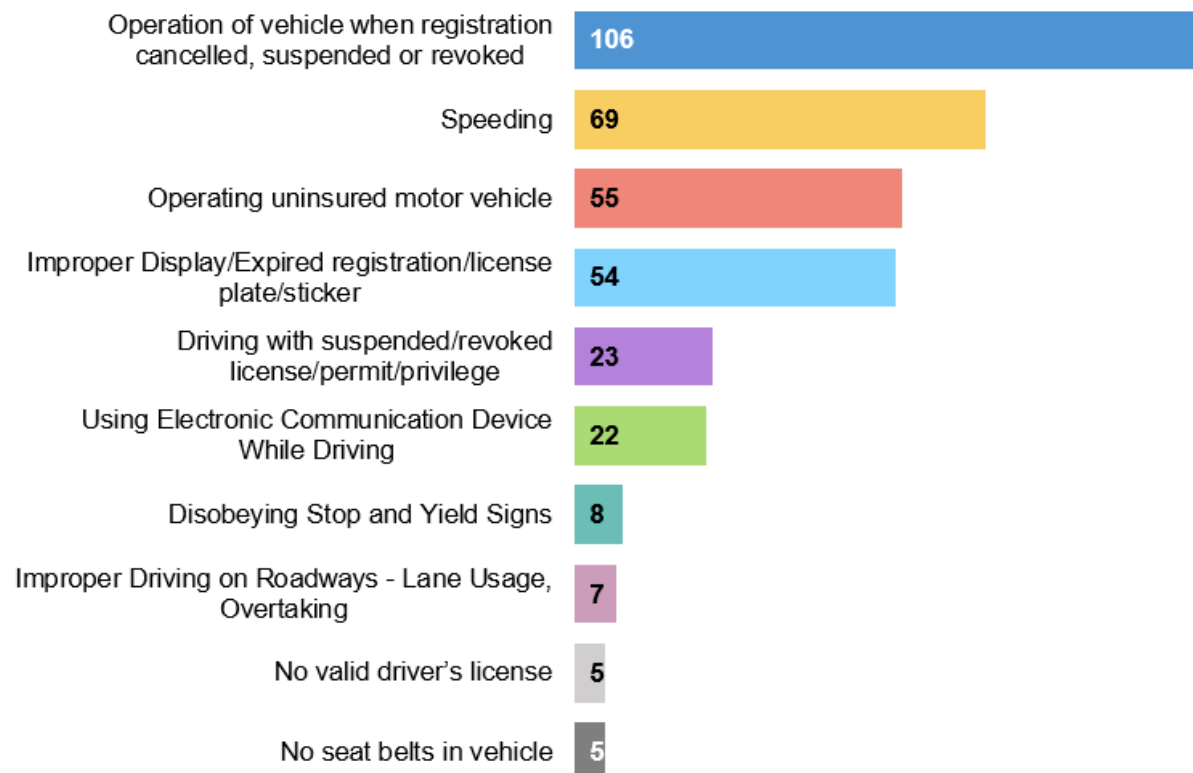
### Review Process

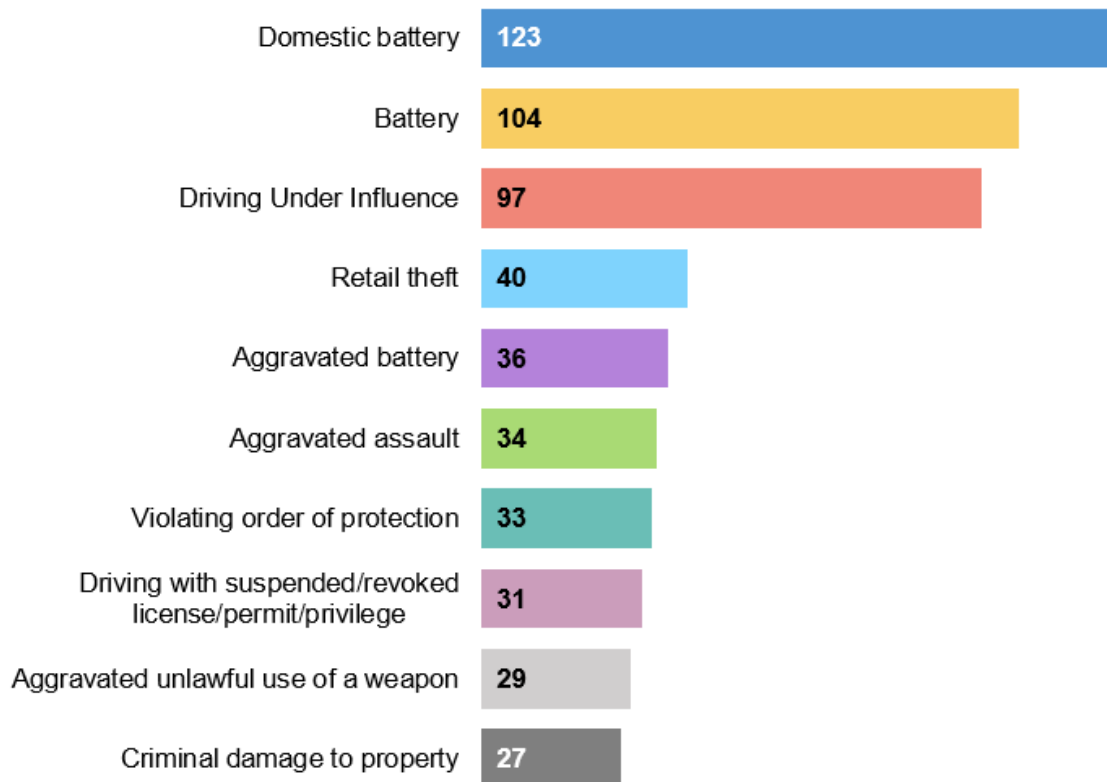

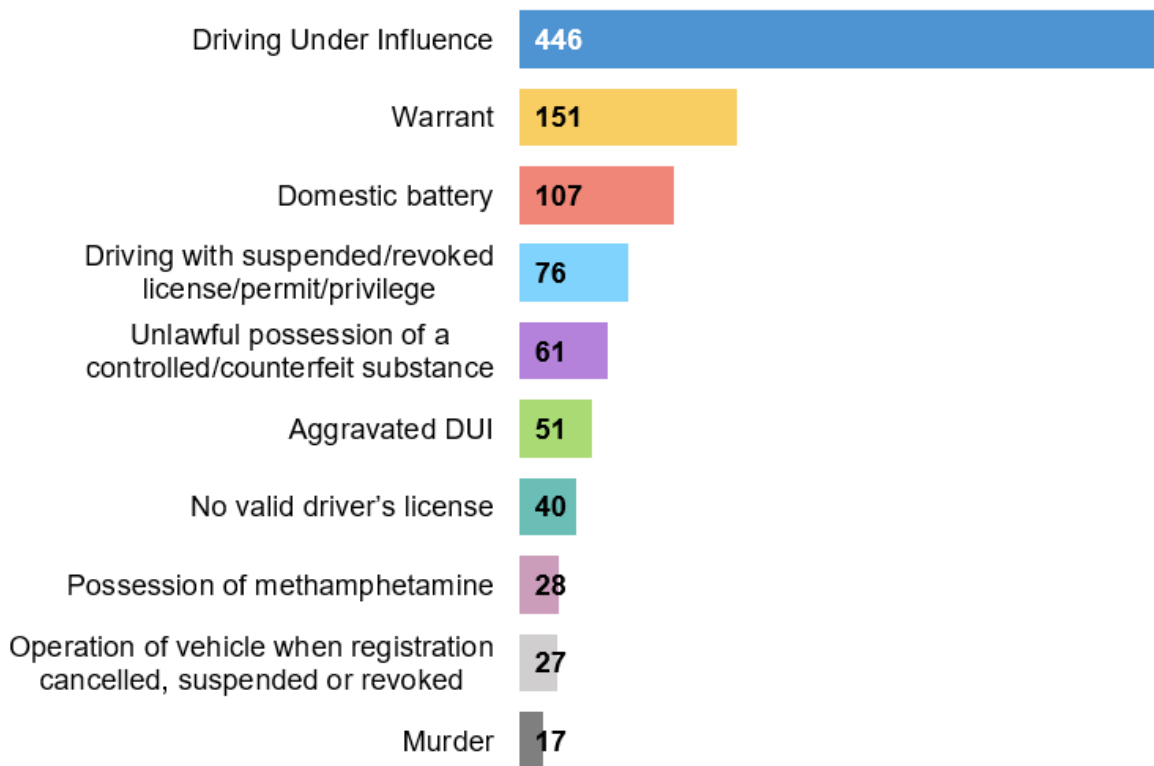

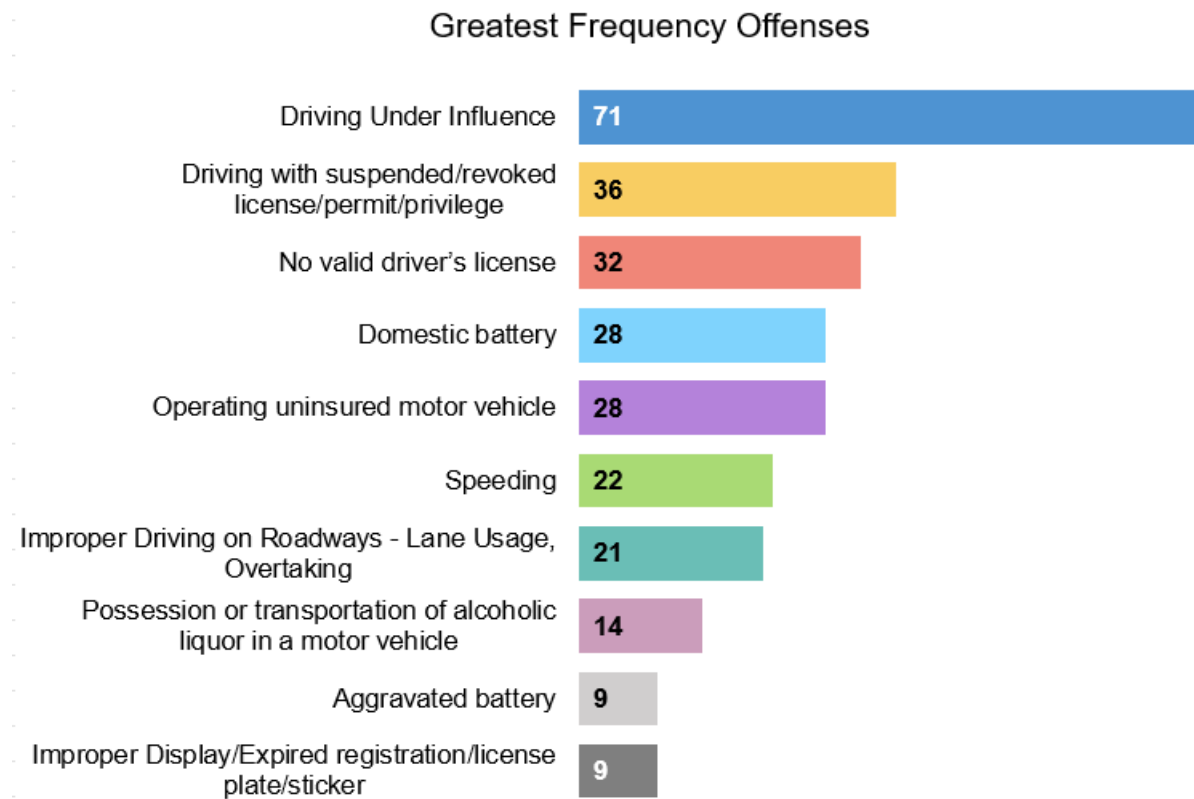

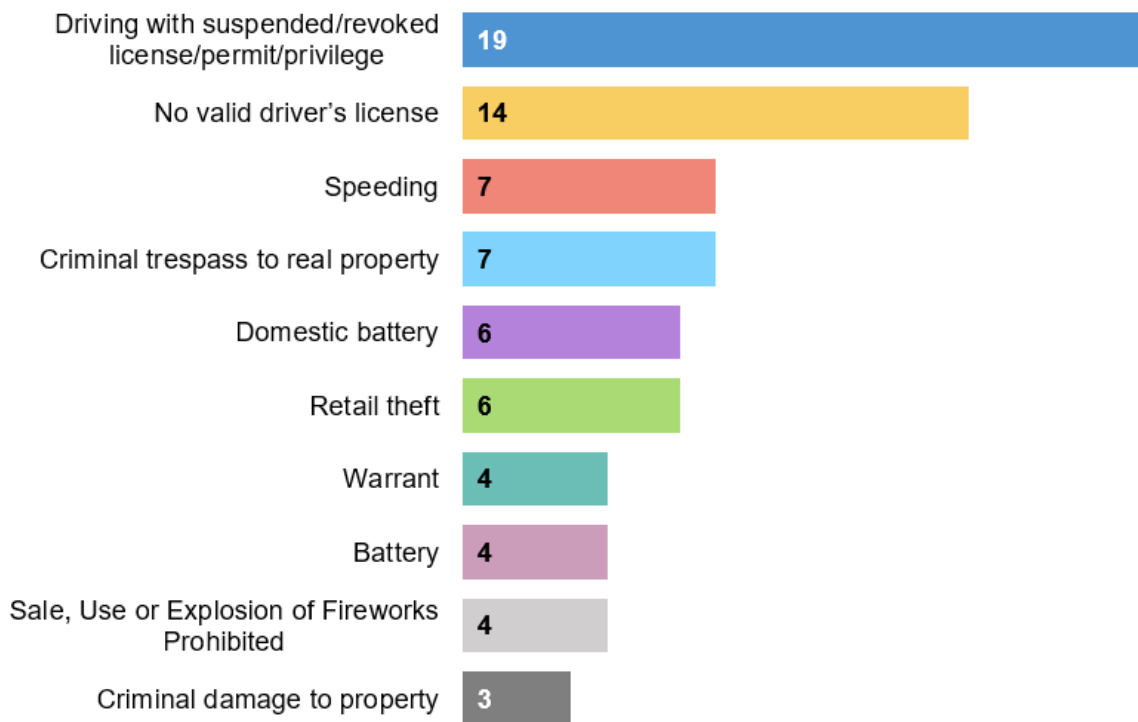

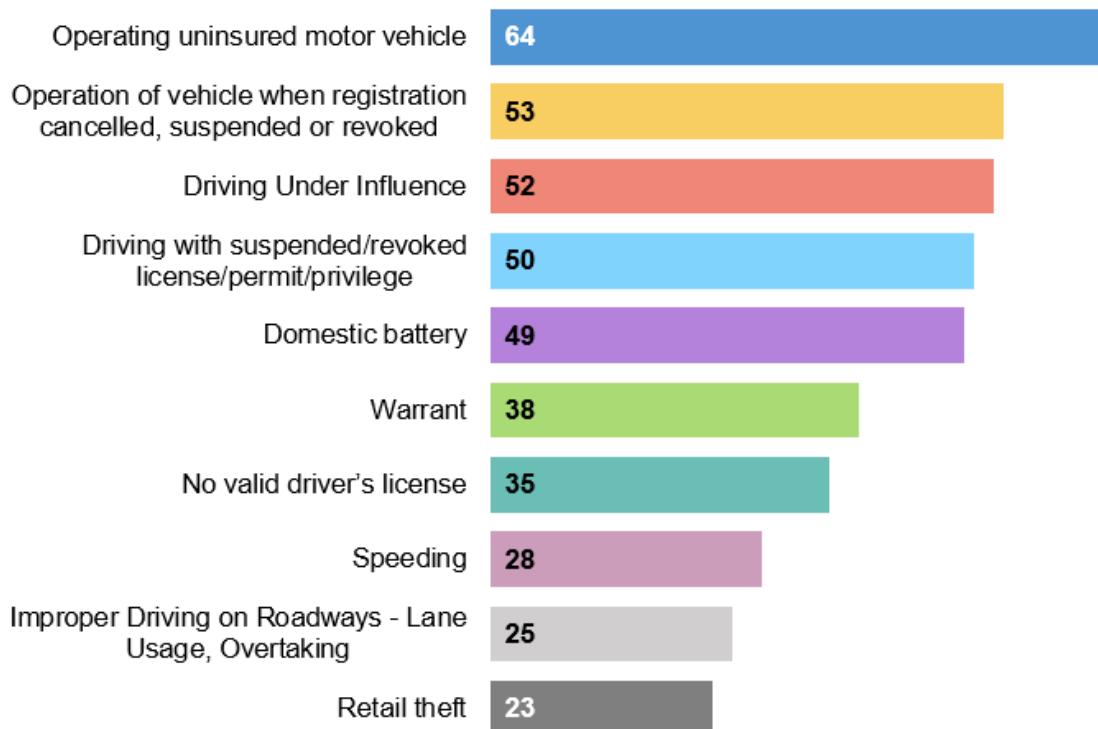

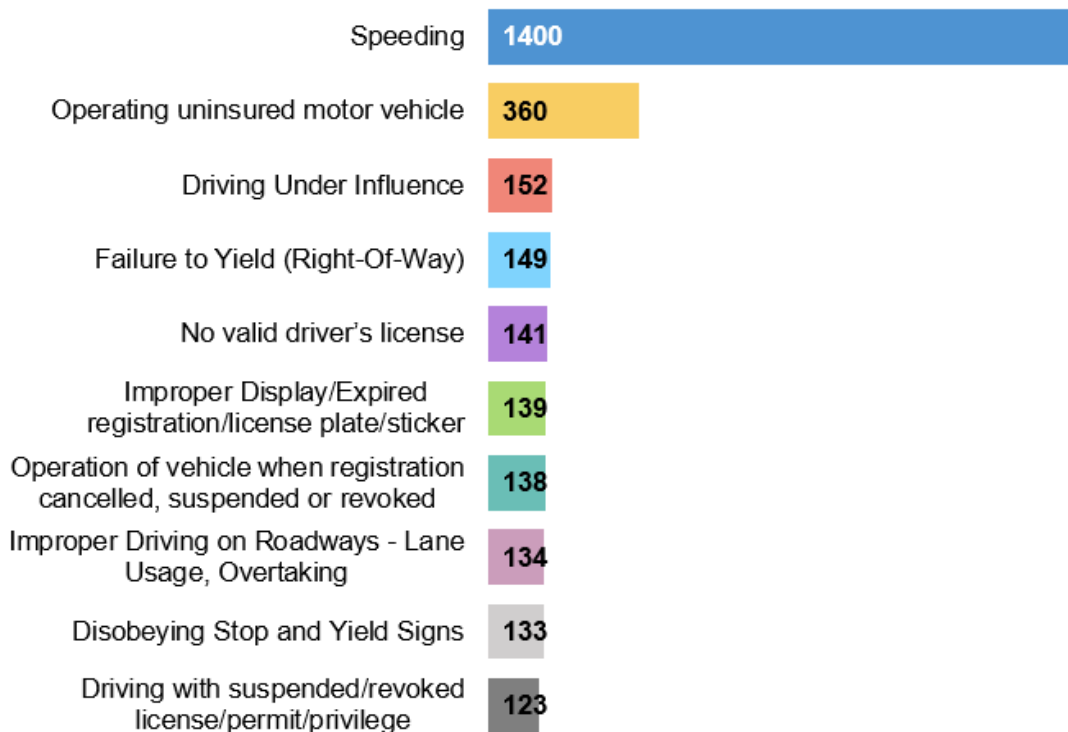
### Review Process

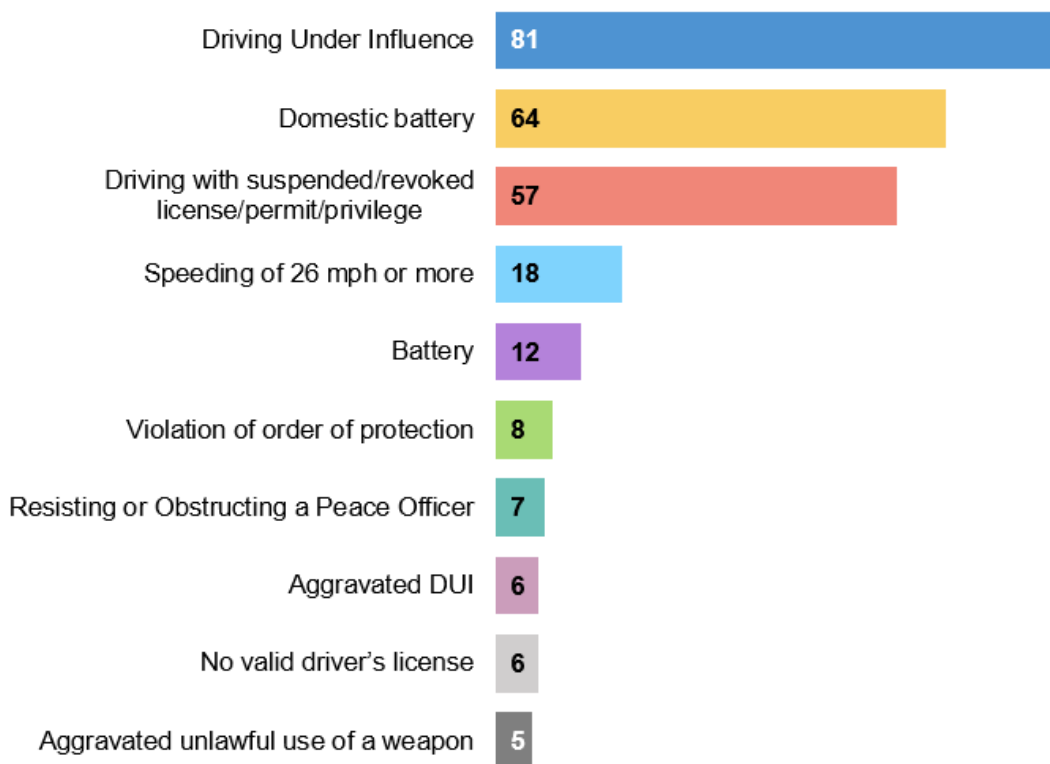

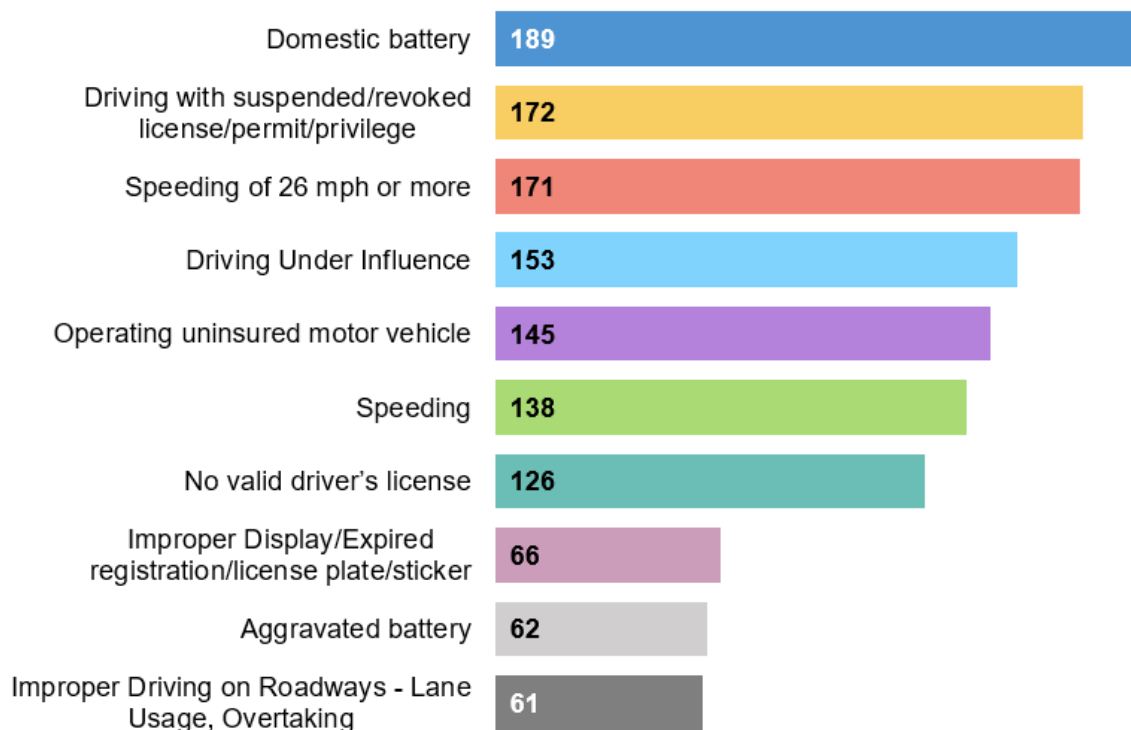
### Review Process

Willowbrook Police Department reports issues with three (3) body worn cameras which were replaced by Axon.

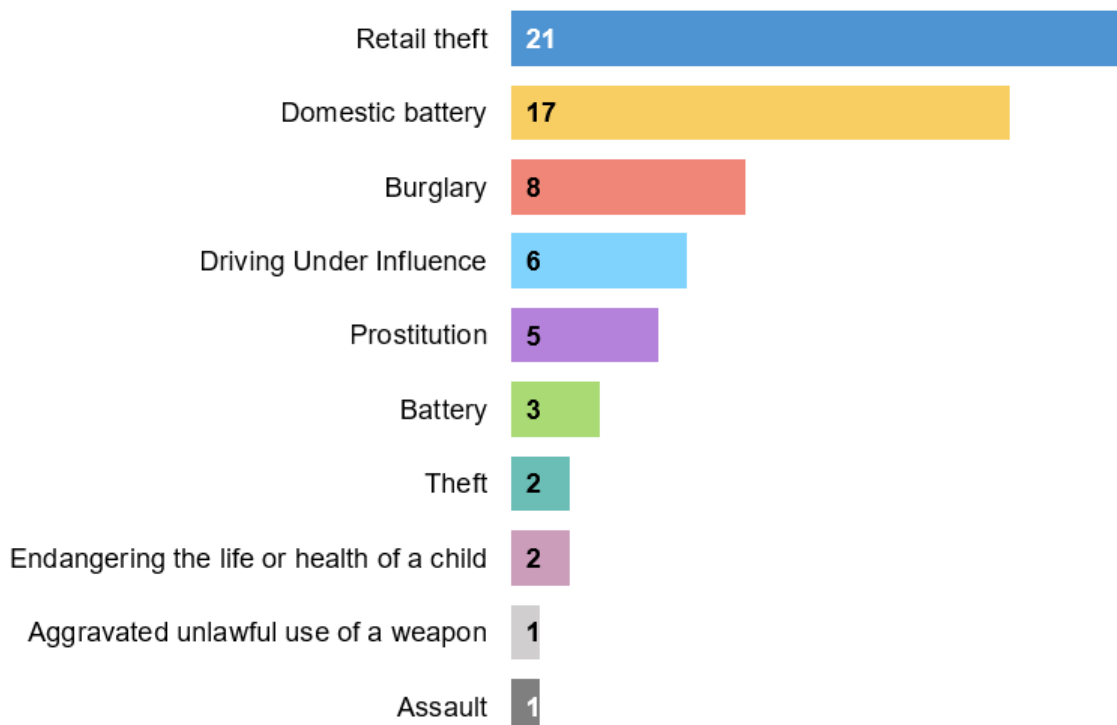
### Review Process

## Department Overview – Winnetka Police Department

Winnetka Police Department consists of twenty-seven (27) sworn officers who utilize twenty-seven (27) Axon Body 3 body worn cameras, and two (2) additional body worn cameras are kept as spare for potential future staffing and to ensure uninterrupted operational capacity.

Winnetka Police Department reports zero (0) technical issues.

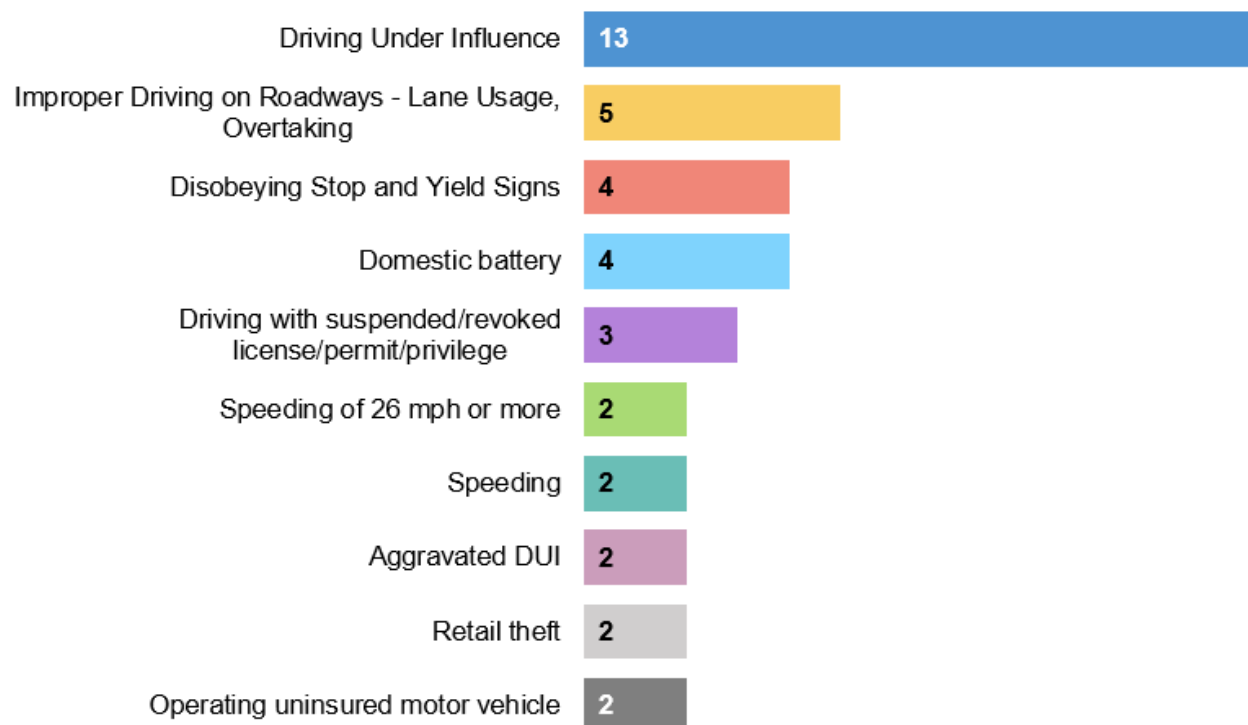
### Review Process

Woodford County Sheriff's Office reports a few issues with battery life.

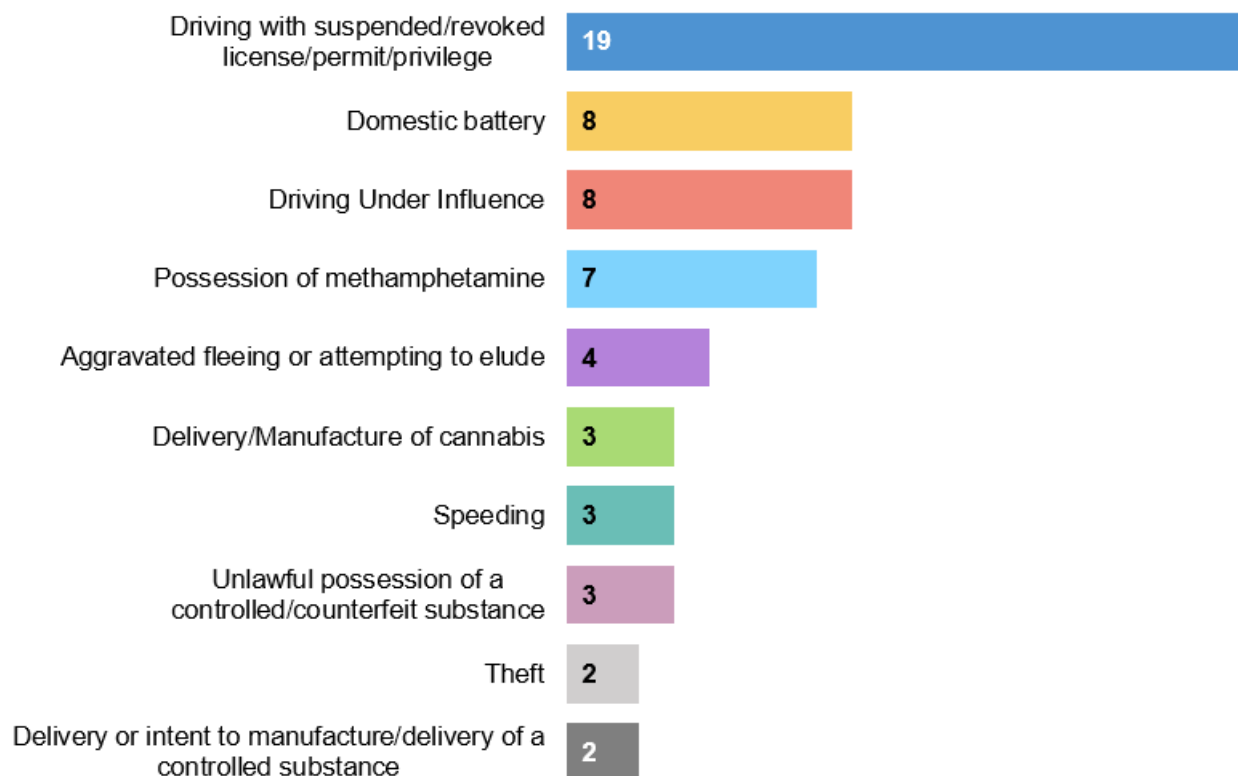
### Review Process

These issues were resolved with the assistance of technical support from the manufacturer, and four (4) body worn cameras with malfunctions were replaced.

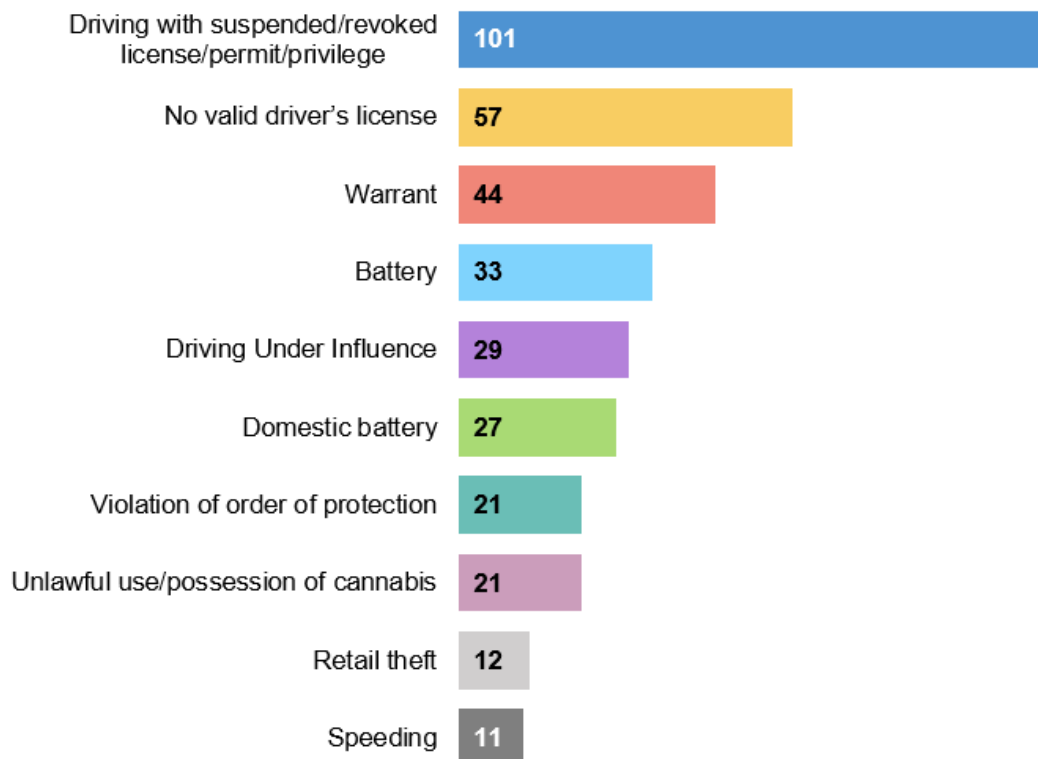
### Review Process
